Cybercrime, climate change new threats to human rights: President Murmu

New Delhi, Dec 11 (GNS) President Droupadi Murmu highlighted cybercrime and climate change as emerging threats to human rights, noting that the growing significance of artificial intelligence (AI) means the culprit could be a non-human but intelligent agent. "As we progress into the future, we are confronted with emerging challenges. Cybercrime and climate change are new threats to human rights," President Murmu said while addressing the Human Rights Day event organised by the National Human Rights Commission (NHRC).

"These challenges underscore the importance of fostering a safe, secure, and equitable digital environment that protects the rights and dignity of every individual. The Information Technology Act (IT Act) of 2000, the IT Rules, 2021, and the Digital Personal Data Protection Act, 2023, address the challenges of privacy in the digital age, balancing technological advancement with individual rights," she said.

"Artificial Intelligence has now entered our day-to-day life, solving many problems and creating several new ones too. The human rights discourse so far has been centred on the human agency, that is, the violator is assumed to be a human being, who would have a range of human emotions such as compassion and guilt. With AI, however, the culprit could be a non-human but an intelligent agent. I leave the matter for you to ponder upon," the President said. She said, "The case of climate change too forces us to review the human rights, thinking at the global level. Polluters of a different place and a different era are affecting the lives of people in another place and another period.

India-Russia friendship higher than highest mountain: Rajnath in meeting with Putin

Maharashtra Cabinet expansion likely by Dec 14; Fadnavis to meet PM in Delhi

Mumbai, Dec 11 (GNS) The Cabinet expansion of the Devendra Fadnavis-led Maharashtra government is likely to take place by December 14, a senior BJP leader said on Wednesday.

Fadnavis left for Delhi on Wednesday, his office said, adding it was a courtesy visit, the first after becoming the chief minister, as he would be meeting Prime Minister Narendra Modi, President Droupadi Murmu and Vice President Jagdeep Dhankhar. Talking to PTI, a BJP leader said the Shiv Sena would not get the home department and was also unlikely to be allocated the revenue portfolio. Talks are getting delayed be-

cause three parties (Mahayuti allies BJP, Shiv Sena and NCP) are involved, the politician said."The cabinet expansion is likely by December 14.

The allocation of home department to Shiv Sena is ruled out. The Shiv Sena may get urban development, but is unlikely to get revenue," said the leader, who did not wish to be named.

The BJP is expected to keep 21 to 22 ministerial berths, including the CM's post, the leader said, adding that four to five ministerial berths may be kept vacant. Shiv Sena leader and Deputy CM Eknath Shinde was not travelling to the national capital, as per his office.On December 5, Fadna-



vis took oath as CM along with Shinde and NCP leader Ajit Pawar as his deputies, after the Mahayuti alliance won 230 of the 288 seats

in the state assembly polls. The Maharashtra Cabinet can have a maximum of 43 ministers, including the chief minister.

Industry should realign itself keeping political, strategic policies in mind: Sitharaman

New Delhi, Dec 11 (GNS) Finance Minister Nirmala Sitharaman on Wednesday said the industry will have to realign its policies keeping in mind political and strategic decisions of the

Outlining the priorities of the economy for the next decade, Sitharaman also said attempts should be made to restore global calm and normalcy and noted that war or any form of disruption should be avoided.

Sitharaman said the economy has to "clawback" more to regain its strength after the Covid pan-

demic and any skirmish or war will impact the supply chains and food value chains. "The world is facing challenges which are reflected in the economy," the Minister said at the CII Global Economic Policy Forum here.

Talking about ways to tackle supply chain disruptions, Sitharaman said currently there is a need to blend economic priorities with politics and strategic

"When we talk about restoring supply chains to frictionless supply chains, let's not forget it's not just economics, it's more than that... We have to build in our own decision making not just in economic sense but also in a political and strategic sense.

"Supply chains will have to be restored but you would have to reset it, realign it, you will have to make sure that it is spread so much that no geopolitical or strategic risks will threaten our wellbeing," Sitharaman said.

She said lessons learnt in the last decade should tell us that the country will have to now realign, and industry will have to realign itself not just on economic principles. There is a need to



blend large, small and medium industries to achieve "scale and spread" and job creation, Sitharaman said. "Industry will have to look at ways to adapt with newer challenges," she said, adding scale cannot be the only criteria.

Delhi elections 2025: Is AAP-Congress reunion on the cards?



New Delhi, Dec 11 (GNS) Until Tuesday there was complete clarity that Aam Aadmi Party and the Congress, former allies in Delhi, will go it alone in the 2025 state elections.But then an image came by, which triggered talks that the two might be rekindling their past affections.

The image was posted by Nationalist Congress Party-SP leader Supriya Sule. It showcased AAP chief Arvind Kejriwal, his trusted parliamentary aide and Rajya Sabha MP Sanjay Singh, his lawyer in the excise scam case and Congress leader Abhishek Singhvi and Congress president Mallikarjun Kharge's right hand man Gurdeep Sappal sitting with NCP-SP chief Sharad Pawar

and other senior opposition leaders. Supriya Sule captioned the image saying, "Joined Hon. Pawar Saheb in a pivotal meeting with @ArvindKejriwal Ji, Sanjay Singh Ji, and @ NCPSpeaks MPs, MLAs, and assembly candidates. Deliberated on critical issues impacting the nation and charted a strategic way forward."The frame became the cause of fresh talks that perhaps Congress and AAP were reconsidering their Delhi poll strategy and may be in talks for a pre-poll alliance.

In 2013, when Kejriwal contested his first election in Delhi and fell short of majority, then the Congress led by ex-CM Sheila Dikshit backed him. It was an alliance the former Congress strategist and former media chief of the party Janardan Dwivedi had warned against.

The result was the Congress lost its base in Delhi where Sheila Dikshit had been a three-term CM. In the next two polls, Kejriwal returned with a thumping majority with Congress candidates even losing deposits.

That said, AAP this time said will contest the Delhi polls alone.

This after Congress and AAP talks for a pre-poll arrangement in the Haryana Assembly polls failed.Kejriwal again made it clear today that AAP was going alone in Delhi. But as they say in politics -- Nothing is final till it is final.



Do not punish Palestinian refugees for UNRWA dysfunction

Recently revealed abuses by top UNRWA management should not be politicised and used as an excuse to defund the agency.

arlier this week, an internal ethics report about the UN Relief and Works Agency (UNRWA) for Palestinian refugees was leaked to both Al Jazeera and the AFP news agency. The report details serious abuses of authority within the agency's senior management team, based on testimonials from former and current staff as well as a variety of other supporting documents.

Most importantly it accuses Commissioner-General Pierre Krahenbuhl and a couple of others from his inner circle of having "engaged in misconduct, nepotism, [and] retaliation". The report also notes that the situation worsened in 2018, following a decision by the United States, UNRWA's largest donor, to cut its funding of the agency.

This allowed the senior management to justify "an extreme concentration of decision-making power in members of the 'clique' ... increased disregard for agency rules and established procedures, with exceptionalism becoming the norm; and continued excessive travel of the commissioner-general".

Many Palestinians were not particularly surprised by the content of the leaked report. Over the years, we have heard many anecdotes about the highly problematic culture of entitlement and abuse perpetuated by well-paid foreign staff at UNRWA and other UN agencies. Apart from nepotism and abuse of power, there are major issues with the distribution of limited financial resources assigned to these bodies. In times of austerity, for example, support programmes are usually cut before the salaries of senior and foreign staff.

High-level employees have also been known to engage in a variety of hypocritical actions, including renting houses stolen from Palestinian refugees in 1948 in Jerusalem (particularly in its popular neighbourhood Musrara) and allowing the UN duty free shop to sell products from illegal Israeli settlements, such as Israeli wine produced in the occupied Golan Heights. This type of misconduct, however, is not unique to UNRWA and has been exposed in other UN agencies and large humanitarian organisations. The revelations of the report are indeed reprehensible and those responsible should not go unpunished. But that does



not mean that UNRWA should be defunded or shut down.

UNRWA as a separate agency dedicated to Palestinian refugees has a special status and function. It was established in 1949 in order to provide relief services for Palestinians expelled from their homeland following the creation of the Israeli state. It now operates in the West Bank, Gaza, Jordan, Lebanon and Syria, and provides some 5 million Palestinians with primary and secondary education, health services as well as various camp infrastructure projects. It also employs about 30,000 people, mostly Palestinians.

UNRWA's mandate to provide for the refugees is repeatedly renewed pending the implementation of UN Resolution 194 which affirms the right of Palestinian refugees to return to their homelands and to receive just compensation. For so many the agency is not only an important lifeline, but an official body which safeguards the Palestinian right of return from all the powers that want to do away with it. Indeed, since Donald Trump took office, efforts to force the Palestinian refugees to give up their right of return have accelerated. The at-

tacks on UNRWA have been incessant and this leaked report has added fuel to the fire. Former US ambassador to the UN Nikki Haley was quick to comment on the report saying that this was "exactly why we [the US] stopped our funding", while Trump's envoy to the Middle East, Jason Greenblatt, tweeted the Al Jazeera article, claiming that "UNRWA's model is broken/unsustainable & based on an endless expanding # of beneficiaries."

Neither of these statements is true; the funding was cut to collectively punish the Palestinians and their leadership and the dysfunction of the UNRWA is no worse than any other UN agency. The US is taking its lead from Israel, who since its establishment has sought to eliminate the Palestinian refugees' right of return. At the beginning of this year, for example, the Israeli government announced that it would be closing down UNRWA-run schools in occupied East Jerusalem which serve over 3,000 Palestinian children in direct violation of the 1946 Refugee Convention. Nir Barkat, then Jerusalem's Israeli mayor, claimed that they were putting "an end to the lie of the Palestinian refugee problem". Clearly a systematic culture of abuse is at work at the highest echelons of the UNRWA which needs to be confronted and addressed. However, this report cannot and should not lead to more funding cuts. Both the Netherlands and Switzerland have unfairly suspended aid to the agency in light of this report.

The millions of Palestinian refugees and the Palestinian employees, many of whom are struggling to provide for their families, should not be collectively punished for the offences and selfishness of UNRWA's top management, many of whom are foreigners. Holding accountable those responsible for the mismanagement of the agency is crucial, as many fear that the powerful people exposed in this report will simply be recycled within the UN system, only to continue their misconduct at another agency. Meanwhile, the focus should be shifted back to the seven million Palestinians who live in perpetual exile from their homeland, many facing secondary displacement. It is their wellbeing and their right to return that should be the top consideration of donors.

The Pakistan game plan

VERSHADOWING the seemingly positive interaction between India and Pakistan on the Kartarpur corridor and difficulties in working out the modalities for consular access to Kulbhushan Jadhav are Pakistani attempts at shifting the global narrative from its involvement in terrorism to the Kashmir situation following PM Imran Khan's Washington visit last month. Pakistan obviously feels that President Trump's offers to mediate or arbitrate on J&K and his comments on the violence in the state have provided it an opportunity to turn the spotlight to India's internal policies and actions in the state as well as its refusal to engage it in a comprehensive bilateral dialogue.

An insight into Pakistan's perspective of how India has succeeded in managing the narrative and also indicative of what it believes it is up against was provided in foreign minister Shah Mahmood Qureshi's comment at a media briefing in Islamabad last week. Qureshi said, 'We saw how after 9/11 India very cleverly and expertly started painting the right to self-determination movement with a hue of terrorism,' adding that 'how India with its new alignment [in the region] and market position was able to have the other countries look the other way.'

There is no doubt that the attraction of the Indian market is a factor ensuring that many important countries do not want to tread on India's toes. Aware that India will never countenance mediation in J&K, international players either carefully avoid offering it or emphasise that their offer is contingent on both India and Pakistan accepting it. That, of course, is a no-brainer, for the pre-requisite of any mediation is the voluntary acceptance of the process by the parties concerned. Despite the somewhat dramatic nature of Trump's offer, the US establishment has emphasised that both countries must accept it. Thus, while Pakistan will routinely call for mediation, it will have to live with disappointment.

It is also significant that the US State Department was quick to stress - and this aspect has not received the attention that it deserved — that Kashmir is a bilateral issue. In its very first statement after Trump's July remarks, it noted, 'While Kashmir is a bilateral issue for both parties to discuss, the Trump administration welcomes Pakistan and India sitting down and the United States ready to assist.' The important word is 'bilateral'. It puts paid to consistent Pakistani attempts to portray it as an international issue to be resolved in accordance with the UN resolutions. No country will attempt to invoke the UN path on J&K, except in meaningless multilateral resolutions such as those of the OIC.

Pakistan will keep harping on these themes but its real focus to change the narrative will be to highlight the situation in the Valley in the context of human rights and India's refusal to engage in a serious dialogue to address outstanding issues. Its entire thrust will be to persuade the international community that India's stand of no talks as long as terrorism continues is only a ruse to continue its nonengagement approach. In addition, it will and, indeed, already is reverting to its old position of its inability to pay sufficient attention to its western border because of tensions along its eastern one. Since Imran Khan's visit it is gearing itself to go all out in these directions.At this stage, America desperately needs Pakistan to quickly get out of the Afghan mess. Hence, Pakistan will be indulged with soothing messages. India should simply shrug them off as it should any interlocutor who seeks to suggest how India should address the situation in the Valley. Also, it should dismiss those who may advise that an India-Pakistan dialogue should take place with reiterating its reasonable demand that Pakistan should end terrorism. Interestingly, this is a point that the US is also indirectly making.

What India has to actively promote is that Pakistan's sponsorship of terror on Indian territory shows it to be an irresponsible state; no nuclear state has ever acted so with any other nuclear state. In this context, it must also emphasise the doctrine of pre-emption spelt out immediately after the Balakot strike. That doctrine correctly asserts that escalation towards the possibility of armed conflict that can assume dangerous proportions begins not with a kinetic response to a terrorist strike but is embedded in the sponsorship of terror itself. And Pakistan's traditional warning against India's use of conventional armed force under a nuclear overhang is only a pretext for continuing to use terror as part of its security doctrine. In order to counter the international community's sentiment that it should end the use of terror, for the new Indian approach of using kinetic force makes it much too dangerous, Pakistan is in the process of shifting arguments.

The plot of the latest escalation in the Gulf involving the United States, the United Kingdom and Iran seems increasingly repetitive like a badly written political thriller.

On May 12, shortly after the secondary US sanctions kicked in, forcing many countries to reconsider their dealings with Iran, four commercial vessels were attacked off the coast of the United Arab Emirates. A month later, two tankers were hit by explosions in the Gulf of Oman. The US and the UK accused Iran of perpetrating the attacks, Iran denied.

Then on June 20, the Iranian Revolutionary Guard Corps (IRGC) shot down an American drone that - it alleged and the US denied - had entered the Iranian airspace. Less than a month later, Washington alleged and Tehran denied that it destroyed an Iranian drone approaching a US aircraft carrier in the Gulf.

Meanwhile, on July 4, British forces seized an Iranian tanker in Gibraltar, which London claimed and Tehran denied, was carrying oil to Syria in breach of European Union sanctions.

Two weeks later, the IRGC impounded a British-flagged tanker, which - Tehran claimed and London denied - had violated international maritime rules.

Notice the pattern - not only in terms of actions and reactions, but also in terms of allegations, counter-allegations and denials? In the age of Trump, everyone seems entitled to their own claims, alternative facts and expert opinions.

Following this pattern, all three - the US, the UK and Iran - have decried and denounced, dug in, doubled down, and cautioned about serious consequences, all the while insisting that war must be avoided. Iran has been putting its bets on US aversion to military escalation - and that may last as long as President Donald Trump thinks he is going to win the next election. The Islamic Republic has taken this opportunity to confront its historical archenemy, taking great pride and pleasure in eliciting sharp condemnations from Washington. But if badgering America is satisfying, bullying the "old colonial fox", Britain, is even more so. Iranians' hostility and distrust of Washington goes back decades, but their distrust and disgust with Britain go back even further. As former British Foreign Affairs Minister, Jack Straw, has pointed out in his latest book The English Job, British involvement in Iran has a centuries-long traumatic history.It has not only resulted in deep historical distrust of the British

authorities, but even spawned a common phrase in Persian - "when things go wrong, it's always an English job", which Straw aptly uses for the title of his book.

In his own words, he summarises two centuries of British interference in Iranian affairs as follows:"We bribed and cajoled Iran to do our will throughout the 19th Century and early part of the 20th Century and, if that didn't work, we landed troops. We invaded Iran in the First World War, helping cause a catastrophic famine in the process. In the Second World War, with the Russians, we jointly occupied the country for five years from 1941-6. We deposed a Shah in 1941 and installed his weaker, more compliant son."When the Iranian parliament waged an eight-year struggle to nationalise BP's huge refinery and vast network of oil wells, MI6 and the CIA responded by organising a successful coup against the elected prime minister, Mohammad Mossadegh, in August 1953. We helped prop up the Shah in the mid and late 1970s, even when it was obvious that he was losing popular support. Catastrophically so, in fact.

"But the worst was to come in 1980, when Iraq's newly appointed president, Saddam Hussein, decided, without any justification, to invade Iran. Millions on both sides lost their lives in the bloody war that followed." (The UK supported Iraq in the war that shaped many of today's Iranian leaders.) These are clear and categorical admissions by a former British official, who served as an MP for three decades, and home and foreign secretary for nine years. Unfortunately, Straw seems to explain and at times justify much of this as realpolitik; empires acting as empires do, whether in competition with the Russian empire to secure the western gateway to India and other Far East

colonies, or simply in pursuit of trade monopolies. He even justifies Israel's possession of nuclear weapons. Straw also spends much more time explaining, rather superficially and selectively, Shia Iranian political history (for example, drawing heavily on hateful and sectarian writings of Iranian-American academic Vali Nasr), instead of analysing the mindset and mechanisation of British foreign policy.

He also says close to nothing about - let alone apologise for - his and his government's support for the disastrous 2003 invasion and occupation of Iraq which had far-reaching consequences for Iran - an invasion he claimed he could have stopped. And when it comes to the master of the "English job", Tony Blair, Straw mentions him as much as he does British ambassador Dominick Chilcott's puppy, Pumpkin - twice and in passing.

But to his credit, the former British official doesn't hesitate to come after the late premier Winston Churchill for his support and enthusiasm for the 1953 British-American-instigated coup in Iran. This, despite the fact that he is the ultimate national hero of newly elected Prime Minister Boris Johnson.Many have rushed in recent weeks to compare Johnson with Trump, including the US president himself.

Yes, Johnson does have a reputation for deception, populism and xenophobia, but he aspires to be compared with his historical idol.Reading Johnson's exhaustive book The Churchill Factor: How One Man Made History, one could see how the new prime minister has tried to fashion his political career around the Churchill persona he admires so deeply.Johnson cherishes Churchill's vast intellect and experience, praises his fluid ideological leanings, ap-

preciates his love for his wife, job, and empire, and adores his decisive leadership during World War II and his defence of Europe and democracy, notwithstanding the damage inflicted on Iran and other nascent democracies. He also unabashedly justifies his enthusiasm for war and even defends his long warmongering record.

Johnson, who tried to prove that contrary to the Marxist theory of "historical materialism", leaders like Churchill were able to shape and change the course of history with their visionary leadership, hopes also to redefine modern British history and its relations with Europe.But as the Marxist cliche goes: history repeats itself the first time as tragedy, the second time as farce.

Ironically, a few days after Iran impounded a British tanker, Johnson adopted a British initiative for a European maritime force to be deployed to the Gulf, and at the same time, established a "war cabinet" ready to use "all means necessary" to force the UK out of the EU by the end of October.

I hate to break it to premier Johnson, but 2019 is not 1939, the EU is not Nazidominated Europe, Britain is no longer an empire, Trump is no Roosevelt, and he is no Churchill. The last is meant as a compliment. Johnson does have a chance not to end his time in office in disaster. He could pull off a more peaceful and less imperialist "English job" by working closely with Europe to defuse the crisis in the Gulf, instead of dispatching more British naval destroyers - a move reminiscent of colonial times. He may also cooperate diplomatically with international and regional actors to contain and restrain Tehran's aggressive posturing. But all that will only be possible if he is first able to get a united Britain out of the Brexit mess he helped create.

I said before the game I really wanted to score even more today," Soucek said. "He's been here since I came here. He is really my favourite. I said it would be tough for me to play without him. "I'm happy



that he is doing fine. He is a massive player and he is in my heart. It was really tough for us."I was so scared what was going to happen. It was a really tough week for him, his family and us."
