RS proceedings adjourned till Monday amid ruckus over noconfidence notice against Dhankhar

▶ Dhankhar said he was a farmer's son and he would not 'show weakness'.

New Delhi, Dec 13 (GNS) The opposition's move to seek the impeachment of Vice President Jagdeep Dhankhar led to pandemonium in the Rajya Sabha on Friday. With opposition and treasury benches clashing and the Chairman wading into the issue, the proceedings of the House, which have been marred because of the issue and the Adani controversy, were adjourned in the first hour itself. Before the adjournments, Dhankhar said he was a farmer's son and he would not 'show weakness'. "Day in and day out there is only a campaign against the Chairman....it's a campaign not against me; it's a campaign against category to which I belong," he asserted. The Chairman, before adjourning the proceedings at around 11.45 am till Monday, appealed to Leader of the Opposition in the House Mallikarjun Kharge and Leader of the House JP Nadda to come to his chamber to find a way out to end the logjam. "I appeal to you, Khargeji, please spare time, accept my prayer, and see me in my chamber



today. The same request I am making to the Leader of the House also... I will try to navigate things so that we are able to work as members of the House. I would expect Kharge Ji to respond. Let us meet in my chamber and find a way out," Dhankhar said. To this, a visibly angry Kharge retorted, "How can I respect you? You are insulting me". As he was speaking, the Chair adjourned the proceedings till Monday. Trouble arose after BJP's Radha Mohan Das Agrawal raised a point of order and narrated the procedure related to the no-confidence motion against the Vice President of India, who is an ex-officio Chairman of the Rajya Sabha.

Pay attention to Bangladesh, act to end Hindus' misery: Uddhav Thackeray to PM Modi

Mumbai, Dec 13 (GNS) Shiv Sena (UBT) president Uddhav Thackeray has called upon Prime Minister Narendra Modi to take note of the severe atrocities being perpetrated on the Hindus in Bangladesh and immediately intervene in the matter.

"Why is the government silent on the atrocities on the plight of Hindus in Bangladesh? The Opposition has been raising the issue in Parliament for the past few days on the injustice being meted out to the minority Hindus there, but nothing is being done by India," Thackeray said on Friday.

Speaking to mediapersons, he said a couple of months ago when the Bangladesh cricket team had come to India (September-October), Aditya Thackeray had demanded that we should not play with them, but the government



kept mum and did nothing about it. "We want to know why the PM is not saying anything on this. Hindus are being targeted daily, the ISKCON Temple was burnt, their leaders were arrested and subjected to action, but we are silent," Thackeray said. Taking a jibe, Thackeray said that "on behalf of all the Hindus in the country", he was appealing to the PM that just as he had taken action in the Ukraine crisis, he should do the same in Bangladesh to ensure that the attacks on Hindus stop there."There is no point in making slogans like 'batenge to katenge, fatenge, marenge,' etc.

What the collapse of the Syrian regime says about the Arab region

n December 8, after a rapid offensive that lasted less than two weeks, Syrian opposition forces entered Damascus and declared the end of Bashar al-Assad's regime. The Syrian president and his family are believed to have flown out in an unknown direction just before the rebels entered the capital.

The uprising against the Syrian government that ended the half-century of al-Assad family rule should be seen as among the most important political turning points in the modern Arab region since the end of World War II and the creation of Israel in 1948. It marks a definitive break with the legacy since the 1950s of military-anchored Arab autocrats who have long dominated and ravaged Arab societies.

Many rightly celebrate the overthrow of al-Assad, and many others wonder what will happen next given the involvement of various local and external powers in Syria. The Syrian people know they want a decent life, to be treated with respect and to be heard. We should humbly watch them bring a new and stable order to their country and stop the Western silliness of analysing what the length of a beard means or entertaining conspiracy theories.

It is critical now to reflect on what the devastating tale of Syrian governance and civil war mean. Syria under the Assads was neither unique nor the work of just a few local brutes. Rather, it is an example of the widespread legacy of heavy-handed, often vicious, Arab state power that has ravaged the region and demeaned its people for half a century, with the help of regional

and great powers and assorted nongovernmental groups.The al-Assad regime was the longest-lasting military-based, foreign-backed, and family-anchored autocratic government to dominate the Arab region, which devastated its people, economy, and national integrity.

The Syrian experience reveals all the debilitating hallmarks of shared Arab autocracy, which persist widely and must be systematically rooted out of our societies. These include a lack of genuine pluralism and accountability through credible participatory institutions; top-heavy rule anchored in military and police brutality, mass imprisonment, torture, and death; centralised economic planning that breeds corruption among the elite and deep quality-of-life disparities across the land; and no structural connections between the citizens and the state that could generate policies that reflect the consent and will of the governed.

The 1952 Egyptian revolution of Gamal Abdel Nasser initiated the destructive legacy of military-run Arab governance, which expanded more quickly after Israel's 1967 defeat of Arab armies. Bashar al-Assad's father, Hafez, was among a cohort of Arab officers who seized power in the following two decades in various Arab countries and proceeded to drive them into the ground.

These self-imposed officers could neither wage war nor govern effectively during their decades of rule. As a result, since the 1990s, most Arabs outside the few wealthy oil producers have suffered steady declines in their opportunities for decent education and healthcare, jobs, access to sufficient food, water, and electricity, and other basic necessities. Regional surveys reveal over and over again that a small percentage of Arabs (mostly in the oil-producing states and among small elites elsewhere) live comfortable lives, while the majority enjoy neither political rights nor a decent material life. Inequality and poverty within Arab societies continue to rise.

Through repression, Arab governments have transformed their citizens into passive, voiceless, impotent consumers, many of whom seek to or do emigrate. Repression has generated intense anger, fear, and desperation among their citizens. They have responded by challenging the state, joining its corrupt system, or retreating from it into smaller tribal, religious, or ideological groups they form to protect themselves and survive in the face of dangers from their own state, Israel, or foreign powers.

The most potent Arab movements that challenged the militarised power model were Islamist - both armed and peaceful. In Syria, when a peaceful protest movement was met with brutal military force, the uprising quickly transformed into a civil conflict, which undermined national cohesion, allowed the proliferation of armed groups and ushered in interference from foreign powers.

What has happened in Syria should be a wake-up call for all Arab autocrats. The region cannot endure long the reality that not a single Arab state has been credibly validated by its own people through constitutional or electoral means.I've experienced and journalistically chronicled the conditions



of Arab societies and citizens for over half a century, and I conclude that not a single Arab country has passed the four cardinal tests of stable statehood, genuine sovereignty, citizenship, and sustained and equitable human development. We would be fools to miss the signals that Syria sends the world about every ordinary citizen's indomitable will to live in freedom and dignity. And we would be complicit in denying these to Arabs if we continue business as usual with the existing state and economic systems that have mostly failed their people.

It was, of course, the predictable coda of a coward who, having caused so much grief, loss, and suffering for so many decades, sought refuge in a place far away from the

scene of his long list of horrific and lethal crimes against decency and humanity. So, al-Assad now calls Russia, not Syria, home. He is a guest of his welcoming patron, Russian President Vladimir Putin – fittingly, another fugitive from justice accused of war crimes. Syria's odious man on the run brought along, no doubt, a healthy sum of looted money or gold to finance the comfortable life that he and his complicit partner, Asma, are accustomed to.

Meanwhile, exhausted Syrians – who, for the moment, are celebrating a dictator's sudden demise - will try, as best they can, to recover and rebuild in the wake of a grinding civil war that disfigured their beloved homeland year after debilitating year.

Peddapalli, Dec 13: Ramagundam Police Commissioner M.Srinivas stated that the schools have been started under the name of "Work Site School" with the aim of imparting corporate education to the children of migrant workers working in brick kilns.

Ramgundam Police Commissionerate Range Peddapalli Zone Basant Nagar Police Station Ramgundam Police Commissioner M.Srinivas under the authority of child labor system, eradication of picket work, compulsory education for the children of laborers as the main objective of the Police is the condition of children of laborers who are making and carrying bricks together with their parents in brick kilns.

Talk to the owners brick by brick. The Commissioner of Police along with the police officers started the "Work Site School" class rooms which were set up with the main objective of ensuring the welfare of the workers and ensuring that their children are not turned into labourers.

Later, the CP said... Migrant workers have left own state and come thousands of kilometers away to work in brick kilns. Their children are also staying with them and becoming future workers. He said that the migrant workers left the state to work in



the brick kilns for the sake of crores of rupees, and it was not right for the workers and their children to work in the kilns without their education. He said that schools have been started to provide corporate level education by talking to the employers so that they have a golden future.

The CP said that the police department will provide their contribution for the future of the children, with the good intention of providing quality education to the children, it has been set up like private schools. He said that there are 70 children in the work site here and teachers from Orissa have also been arranged to teach

them in Orissa language from first class to 5th class. Similarly, CP said that work site schools will be set up soon in brick buildings under Ramagundam Police Commissionerate.

Books and other materials were distributed to the students themselves. CP said that he wants all the children to study well and do high jobs.

Hyderabad, December 13; National BC Dal president Dundra Kumaraswamy has warned that the central government should take up the caste census in the census as soon as possible or else all the BCs will besiege the national capital Delhi like the farmers' movement.

He asked the central government to stand by BCs who are being neglected in all fields. Dundra Kumaraswamy demanded that the Centre's careless attitude towards BCs should be stopped and justice should be done.

Various BC associations, leaders, public association leaders and intellectuals participated in the meeting organized at the National BC Dal office in Kachiguda.Dundra Kumaraswamy said that just as the farmers wanted to besiege the national capital for their demands,

BC leaders and unions will also besiege New Delhi. Dundra Kumaraswamy said that they strongly believe that justice will be done to the BCs only with the caste census in the census and that the government at the center is wasting time by doing injustice to the BCs.

Caste is the strong cultural foundation of Indian culture, India became such a great country only when many castes came together. Among such castes, many BC castes are still not receiving minimum support.

Shubman Gill toasts old Gabba memories as he prepares to make new ones

▶ The India batter has looked good in his two innings this series but will want a few more runs to show for it

Brisbane, Dec 13 (GNS) It didn't take long for the memories to come flooding back for Shubman Gill. People forget he played a big part at the Gabba in 2021. Only 21 years old, playing his third Test match, he walked out into perhaps the most intimidating stage Australia had to offer - their captain Tim Paine had made a point to remind them of that when they were able to salvage a draw in Sydney earlier - and looked like he belonged.Gill at his best is comes with a volume warning, because when he hits the ball, it just reverberates around the ground. Sometimes you feel like you could pick out his shots with your eyes closed because the connection is so crisp. Early in India's chase of 329,

he hit Mitchell Starc off the back foot all along the ground through cover and on commentary former England cricketer Isa Guha exclaimed, "Crunched! Sound off the bat. Shubman Gill. Wow!" It is unmissable. The 91 he made at the top of the order set India up for the miracle that followed.

"Definitely very nostalgic when I came here," Gill said on the eve of this year's Gabba Test against Australia. "The whole team was coming and just walking to the stadium again after 2021 win, felt very nostalgic." Apart from that natural gift, he seems very well attuned to the vagaries of batting. He understands how things can go wrong and spends ages in the nets trying to fix them. He also understands how

things can go right. Former India coach Ravi Shastri recently spoke about how Gill had gone up to Rishabh Pant at tea on the final day of the 2021 Gabba Test and pointed out that Australia might resort to Marnus Labuschagne's legspin to tide them through to the second new ball and that was a time to cash in. (Labuschagne bowled only one over though)

"When you are out there one of the challenges is can you play the game how you want to play the game irrespective of what's happening on the other end or what's happening on the scorecard and I think I faltered in the first innings around because of that," Gill said, "Because what happened on the other end I kind of took that on me.



At 18, Gukesh conquers chess world

New Delhi, Dec 13 (GNS) At 18 years, six months and two weeks, Indian grandmaster Gukesh Dammaraju became the youngest world chess champion defeating reigning champion Ding Liren of China in game 14 of the world title match in Singapore on Thursday.

He will be crowned the chess champion at a ceremony on Friday. For Gukesh, dethroning Ding in the last game of the hard-fought 14-round classical format matchup by 7.5 points against his rival's 6.5, was the culmination of a childhood dream of bringing back the coveted title to India.

As a seven-year-old chess enthusiast in 2013, Gukesh had seen first Indian world chess champion Viswanathan Anand lose his title to Norwegian Magnus Carlsen in the match played in the customary sound-proof glass box room at Chennai.

Ever since, the son of an ENT doctor and a microbiologist mother nurtured the dream of competing in that glass box — also called the fishtank by the chess grandmasters where outsiders can see you but you can't see them. He finally did so and came up trumps. "In 2013... I watched Vishy sir lose. I was young but that vision has stayed in my memory. The title was taken away from India.

I wanted to be in the same glass box and bring back the title. That has been my dream for the past 10 years or so to be in the glass box.



And my best moment, before this, was when I entered the glass box for the first game," he shared after winning the title. It was a befitting birthday gift for Anand, who turned 55 yesterday.

Gukesh replaces Russian grandmaster Garry Kasparov as the youngest world champion. Kasparov was 22 when he won the title. Gukesh is also the 18th world champion — Wilhelm Steinitz was the first to win the crown in 1886.

This is Gukesh's record third world tournament victory in a calendar year. He won the Candidates tournaments, making him eligible to challenge Ding, and later was part of the Indian team that won the gold at the Chess Olympiad. This is also perhaps India's biggest win against

China at the world stage where both countries compete on an equal footing — unlike athletics that is dominated by China and hockey that is balanced towards India.

Gukesh showed a remarkable display of aggression and novelty throughout the championship. He kept pressing for a win in a rook-bishop pawn endgame theoretically drawn at the grandmaster level.

Playing with white, Ding had opened with reverse Grunfeld opening — where his light coloured bishop is fianchettoed to control the h1-a8 diagonal. This control had proved decisive in game 12 when he beat Gukesh. But not today. Gukesh produced a surprise sixth move by placing his kingside knight on e7 to support the queenside which was left weak in game 12.

ICC to finalise hybrid model for Champions Trophy with PCB chief on Saturday



New Delhi, Dec 13 (GNS) The ICC top brass is likely to finalise the hybrid model modalities for the Champions Trophy during a virtual meeting with Pakistan Cricket Board (PCB) chief Mohsin Naqvi on Saturday, it has been learnt.It has been agreed in principle that neither India nor Pakistan will travel to each other's country for ICC events. Hence, India and Pakistan will play in Dubai during the 2025 Champions Trophy which will

be held from February 19 to March 9.The tournament will feature eight teams, divided into two groups. The top two teams from each group will advance to the semifinals. The PCB had said that it was willing to accept the hybrid model only if the same arrangement would be made for all ICC events, awarded to India and Pakistan.It means that when India will host the 2025 Women's ODI World Cup, Pakistan will not travel to the neighbouring

nation and play against them at a neutral venue. During the 2026 men's T20 World Cup, to be cohosted by India and Sri Lanka, India will not be able to play the marquee clash against Pakistan at home and instead travel to Colombo for the high-voltage clash. "There's a virtual meeting tomorrow which ICC chairman Jay Shah will join from Brisbane. It is expected that ICC will make an official announcement after that," an ICC official told.

2 factions in golf body set to hold separate elections

New Delhi, Dec 13 (GNS) The Indian Golf Union (IGU) is mired in faction fights. The falling out between IGU president Brijinder Singh and secretary general Harish Shetty has meant that both factions will end up holding elections with different electoral rolls and returning officers. The Shetty group, in fact, has already finished holding its election — Shetty was elected as president alongside Basant Kumar Repswal as

secretary general on Wednesday. The Singh-led group will hold the election on December 15 after the Delhi High Court refused to intervene in a petition filed by the Bengal Golf Association challenging its removal from the electoral roll and the changing of returning officer Justice (retd) OP Garg at the last moment. Singh changed Justice Garg after first removing BGA and four other units that were likely to side with Shetty in the elec-

tions. He appointed Justice Permod Kohli and then finally Justice (Retd.) Rameshwar Singh Malik for the elections. The Delhi High Court refused to interfere with the election process as elections are to be held within days. "Having heard learned counsel for the petitioner, IGU, and the Union of India, I am of the view that it is inappropriate at this stage to interfere with the election process. The poll is scheduled to be held



in five days, and any controversy can be raised in challenge to the election results, rather than during the process," Justice Prateek Jalan said in his order.

Mbappe, Vinicius on target as Real Madrid beat Atalanta 3-2

Madrid, Dec 13 (GNS) Real Madrid's big stars turned on the style to revive the Spanish giant's faltering Champions League title defense. Galacticos Kylian Mbappe, Vinicius Junior and Jude Bellingham all scored in a thrilling 3-2 win at Italian league leader Atalanta. But Madrid still had to ride its luck as Mateo Retegui fired over from in front of goal in stoppage time when handed a golden chance to level the game. It was only Madrid's third win in the competition's revamped league phase and leaves the 15-time champion in the

unseeded playoff positions in 18th place. "It's a very important win. Not everyone wins here. We suffered and competed. In the Champions League, you have to suffer," Madrid coach Carlo Ancelotti said. "It's still difficult to finish in the top eight, but we have two games left to earn points." Six-time champion Liverpool leads the way after maintaining its perfect record in Europe this season with a 1-0 win against Girona. Like Madrid, Paris Saint-Germain also picked up a much-needed win, beating Salzburg 3-0 to sit in the

last playoff spot in 24th place. Bayer Leverkusen is second after a 1-0 win over Inter Milan, while Aston Villa beat Leipzig 3-2 and is third. The top eight teams advance directly to the round of 16. Positions nine to 24 face a playoff to reach the next phase. Real response

After three losses in its opening five games of the league phase, the pressure was mounting on Madrid. Questions were also being asked of Mbappe after his uncertain start since his offseason move from PSG. But he produced a moment of class



to fire Madrid 1-0 up after 10 minutes at Gewiss Stadium — controlling the ball with his left foot.

Treesa-Gayatri keep semis hopes alive
