Indian Constitution has stood test of time: Sitharaman

New Delhi, Dec 16 (GNS) India's Constitution has stood the test of time in the last 75 years of its existence, even as most of the 50 countries that framed their Constitution around the same time have rewritten or changed features of their Constitutions, Finance Minister Nirmala Sitharaman said on Monday.Initiating the discussion on the 'Glorious Journey of 75 Years of the Constitution of India' in the Rajya Sabha, she paid homage to the 389 members of the Constituent Assembly, including 15 women, who took up the arduous challenge and prepared the Constitution for India in a very challenging environment. The Constitution of India "has stood the test of time," she said. "Today we are extremely proud of the way India's democracy is growing." As the country marks the 75th year of its Constitution, "it is time to reaffirm our commitment to build India, that is Bharat, that

shall uphold the spirit enshrined in this sacred document," she said. Stating that India and its Constitution stands out in a separate league of its own, Sitharaman said post second World War, over 50 countries had become independent and they had their Constitution written."But many have changed their constitutions, not just amended them, but literally changed the entire feature of their constitution. But our Constitution has stood the test of time, of course, it yielded itself to very many amendments," she said, adding the amendments were the need of the hour.Chairman Jagdeep Dhankhar said time would not be a constraint and as many speakers willing to speak would be accommodated by extending the duration of the discussion. IUI vs IVF: Understanding Your Options for Success

While less invasive and more affordable than IVF, IUI offers a lower success rate per cycle—typically ranging from 10% to 20%.Dr Manjunath adds, "IVF, offering a 55-65% success rate for women

under 35, is preferred for complex cases like tubal blockages or severe male factor infertility." For more complex fertility issues, such as blocked fallopian tubes or severe male infertility, IVF is often the preferred choice.IVF involves fertilizing eggs outside the body and then transferring the embryos into the uterus. With advanced technologies, IVF has a much higher success rate, especially for women under the age of 35, with success rates ranging from 55% to 65%. It offers precision and can address a wide variety of fertility challenges, including issues that IUI cannot solve."While IUI is cost-effective, IVF ensures higher precision through advanced techniques like embryo freezing." Says Dr Manjunath. IUI is a more cost-effective treatment option, but IVF offers a higher level of precision through techniques such as embryo freezing, genetic testing, and sperm injection, making it suitable for more complicated cases. IVF allows for better control over the fertilization process and offers the ability to preserve embryos for future use, providing greater flexibility.

Speaking out of turn

T will never be known for certain if Germany's naval chief Kay-Achim Schönbach would have had to resign 10 days ago if he had spoken respectfully about Russian President Vladimir Putin in Berlin, Brussels or Paris, instead of in New Delhi.

Vice-Admiral Schönbach said at the Manohar Parrikar Institute for Defence Studies and Analyses (MP-IDSA) in New Delhi that Putin needed to be treated as an equal by the West. 'It is easy to give him the respect he really demands — and also probably deserves.' His comments created a storm in the western world and he put in his papers to 'avert further damage' as he put it.

It is reminiscent of the military governor of the American Occupation Zone in Germany, General Dwight D Eisenhower's famous remarks at a post-World War II mass rally in Paris, where he spoke in glowing and respectful terms about the 'great people' without naming them. Charles de Gaulle, then chairman of the Provisional Government of the French Republic, who was present, assumed — as did the huge crowd — that the US army's Chief of Staff was speaking of the French people. The crowd clapped in delirious delight and de Gaulle beamed proudly.

No, Eisenhower clarified later. He was speaking of the German people, what a great people they were, as they are today too, without doubt. It is tempting to think what fate would have befallen Eisenhower if there was Facebook, Twitter and WhatsApp in 1945 when he had spoken in praise of the defeated Germans. Would Eisenhower have got the marching orders from President Harry Truman, like the German naval chief? Perhaps. But instead, Eisenhower went on to become the first Supreme Allied Commander in Europe and then the 34th US President.

It is an understatement to say that Germany has been less than enthusiastic about helping Ukraine in that country's ongoing war of nerves with Russia. While the US and a host of NATO countries have been supplying deadly weaponry to Kyiv, Germany has baulked at doing anything of that kind.

Ukraine's government was livid last week when Germany responded to pleas for help with little more than 5,000 helmets to be used in the eventuality of a combat with Russia. To add insult to injury, as it were, Germany's defence minister, Christine Lambrecht, told Ukrainians that they should see this farcical German contribution to war efforts as proof that 'we are on your side'.

Are Ukrainian soldiers supposed to headbutt the well-trained, well-equipped Russian forces with these helmets if Putin sends in his troops across the border, a German political figure of Ukrainian descent asked on Twitter. It was one of many such sarcastic responses to the German defence minister's military aid announcement.Schönbach said in New Delhi that Putin was not 'interested in having a tiny strip of Ukrainian soil' and that he knew he could split the European Union over Ukraine. It may be this last part of his statement which cost the Vice-Admiral his job because it hit home. Germany is the stand out within the EU on getting Putin to back down on his opposition to letting Ukraine join the western alliance.

So when Schönbach talked about Russia's ability to divide Europe, he appeared to confirm worries in the US that Germany was, in fact, the stumbling block to a unified EU stand against Moscow's policies. That is the truth which Germany's ruling politicians have been trying to paper over. Lambrecht, therefore, was left with no option but to let her Chief of Navy go.

Many of the things the Vice-Admiral said at the MP-IDSA would not have to be said at all anywhere in Europe. Here are some examples. Schönbach described himself as 'a very radical Roman Catholic'. Such an explanation of identity is not called for in interactions at high levels within Germany or elsewhere in Europe. A statement of that kind has relevance only in a non-Christian country and while addressing people who are not of any Abrahamic faith. Yet, hearing such a statement from a European military professional can be jarring, especially when the wounds left by the ethno-religious conflicts in former Yugoslavia continue to impact the continent.

In worse taste was his assertion that Russia was also a 'Christian country, even if Putin is an atheist, it doesn't matter.' The inference it left behind was that in any quarrel between Christian and non-Christian societies, Germany would cast its lot with the Christians. It is possible that was not what Schönbach had in mind. As he explained, he was talking about China and its emergence. But China is not a Christian country, nor is India. Given Germany's pre-World War II history, such statements can be disconcerting. Its impact was amplified because he said those things in New Delhi. Such statements would not be made in Europe because these truths are self-evident there.

Afghanistan's economy is collapsing, the United states can help stop it

s an Afghan American, I have worked for the last 20 years to try to help the people of my home country overcome economic woes and build a more prosperous economy for all. Right now, those hopes are in jeopardy. Afghanistan faces one of the most acute crises I have seen in my career - and the antidote remains locked in New York.In August, the United States froze \$9.1bn of Afghanistan's national reserves held at the Federal Reserve Bank of New York. As a result, the economic situation in the country has deteriorated rapidly. The people of Afghanistan are increasingly unable to afford basic goods, its currency is facing hyper depreciation, and its already fragile economy is on the brink of collapse.Make no mistake, a catastrophe is imminent. The Central Bank of Afghanistan is supposed to conduct monetary policy operations to control the US dollar to the afghani exchange rate and keep inflation at bay. It has historically leveraged this auction process to produce remarkably stable exchange rates and inflation for a developing economy, in the single digit percentages. But with no access to its dollar-denominated reserves, the Central Bank is not able to perform this critical market stabilising function.Due to a heavy reliance on imports, the Afghan economy is dependent on the US dollar to function even in normal times. With rising demand for foreign currency and reports of 30 percent depreciation of the afghani against the dollar, the effective price of imported goods has increased by at least 20-30 percent over the last few months.In a country already devastated by the twin crises of war and COVID-19, the desperate lack of dollars in the market is leaving importers unable to pay for their shipments. Food is becoming scarce and grocery stores are unable to fully restock. As prices rise, people are rushing to withdraw and spend their savings before the bank-

who still have jobs. A growing number of Afghans are suffering from hunger, poverty, and a lack of access to basic goods and services. In short, the country is in a total humanitarian crisis. While this will devastate every Afghan, the Taliban government in Kabul will avoid the worst of it. They will blame the US for the country's economic woes - and so long as they can point to the assets held frozen under US control, the people will believe them. The choice for the US government is simple: continue down the path that would lead to total economic devastation for millions of people or do what is needed to help the Afghan people. I propose that the US allow the Central Bank of Afghanistan limited, monitored, and conditional access to \$150m per month from Afghanistan's foreign reserves - roughly half of

what the Central Bank would auction off monthly in the past. This common-sense policy would unfetter the bank to fulfill its role of maintaining price stability and prevent this imminent crisis. The US would have the ability to verify how these funds are used via one of the independent international auditing firms that are still operating in Afghanistan. The transactions between the Central Bank and commercial banks take place on an electronic exchange where each transaction and its value are automatically recorded. If the US finds any misappropriation, it can cut off the funds at any moment. After all, the vast majority would still be deposited at the New York Federal Reserve. This type of leverage is a win-win for the US.The Central Bank is an entity independent from the Afghan government. For decades, it

has helped to achieve and maintain price stability and advance the economy, all the while remaining a beacon of hope and prosperity for Afghanistan. But if it is not allowed access to its reserves, that could all be lost. As the recent US engagement with the Taliban on the peace deal has shown, Washington has the power to negotiate many issues of national interest without hurting the economic future of the people of Afghanistan. Afghans deserve to be safe and prosper in their land. But right now, US policy is holding them back. The US must allow the Afghan people access to their own reserves in a monitored, common-sense way, or the country will collapse. We have the power to lift the Afghan people out of this crisis. For the sake of both my home and my adopted country, I hope we act on it.

Science-based growth part of Netaji's vision

HE year-long celebration to mark the 125th birth anniversary of Netaji Subhas Chandra Bose has begun with the unveiling of a 'hologram statue' of him under the colonial-era canopy near the India Gate in New Delhi. A 28-ft-tall three-dimensional image of Netaji is being projected on a near-transparent holographic screen to create a visual effect of a statue, till the one cast in stone gets ready and is installed.

However, not far from this holographic tribute to the national hero stands a living monument signifying his biggest contribution to free India — the now-defunct Planning Commission. It is ironic that while technology is being used to perpetuate Netaji's memory, his ideas of economic planning based on science and technology, industrialisation and cooperative federalism have been quietly buried under the new edifice of the National Institute of Transforming India (NITI) Aayog.

During Netaji's birth centenary year (1997), the Planning Commission published a booklet titled 'Subhas Chandra Bose: Pioneer of Indian Planning'. Madhu Dandavate, who was the Deputy Chairman of the Planning Commission, wrote that Netaji's thoughts on economic planning were still relevant and that 'much of what he had advocated was still to be translated into reality'.

For instance, Netaji had advocated a strong Central government for rapid economic growth powered through industrialisation but by affording provinces 'a large measure of autonomy'. The Netaji centenary coincided with the formulation process of the Ninth Five Year Plan, for which the United Front government held consultations with state governments and also with Panchayati Raj Institutions and civil society. Twenty-five years later, as we celebrate another landmark anniversary of Netaji, we have neither any such pretension left nor the Planning Commission.Netaji was not only a pioneer of economic planning but also a strong believer in the application of science and technology for development. Physicist Meghnad Saha was a senior of Bose at the Presidency College and the two remained in touch thereon.

Their ideas on several issues converged as Bose entered active politics. Saha had advocated the need for national planning in the columns of his journal, Science and Culture. Bose, as the Congress president, piloted the idea of establishing the National Planning Committee (NPC) at the Haripura session of the Indian National Congress in 1938 and invited Saha to join the process.

NPC, according to historian Robert S Anderson, was to be originally chaired by Mokshagundam Visvesvaraya who had already demonstrated the power of industrialisation through economic planning in Mysore.

Saha then convinced Visvesvaraya not to accept the offer as the panel would otherwise be seen as an academic exercise within the Congress party, a section of which was opposed to heavy industries. Thus, Bose wrote to Nehru to head NPC for it to be a success.

Saha got Bose to commit to a greater role for science and scientists in national development in India of future. At a meeting of the Indian Science News Association which Saha had founded, he pointedly asked Bose if the Congress party was committed to promoting science-based industrialisation and to set up a National Research Council.

'National reconstruction will be possible only with the aid of science and scientists,' Bose assured. He also supported the idea of a research council to conduct research aimed at applying science and technology in the process of industrialisation.

It was at this meeting in August 1938 that Bose made this famous statement that India could not afford to wait for a slow industrial revolution like Britain but needed 'a forced march as in Soviet Russia'. By this time, the NPC had already started guiding the Congress ministries in the provinces, and Bose declared that 'when we have a national



government for the whole country, one of the first things we will have to do is appoint a National Planning Commission'. Bose complimented Science and Culture for publishing articles on problems directly related to industrialisation.He wanted India's industrial policy to focus on 'mother industries' like power, metal production, machine and tools manufacture, transport, and basic chemicals. Scientific industrial research, according to Bose, should be 'free from government control of every kind'. Bose's thoughts on promoting infrastructure industries and autonomy for scientific institutions remain relevant.

The working of NPC stands out as an example of a truly national venture in which leading scientists, technical experts, industrialists, officials of provincial governments all participated. It also included a representative of the All India Village Industries Association, to counter the view that NPC was advocating heavy industries at the cost of cottage industries. The NPC worked through 29 sub-committees on different sectors like energy, education, public finance, land policy, population, engineering industries, communications, transport, scientific instrumentation and so on. Another sub-panel was formed on 'census and statistics' to collate and provide data necessary for the planning exercise. Each sub-committee was given a deadline to complete the task, and periodic reviews were held at the NPC secretariat in Bombay, despite the exigencies of the ongoing freedom movement. The NPC provided a broad outline as well as sector-specific strategies, identifying problem areas and possible solutions. For instance, it laid down that all 'key industries' such as defence must be state-owned, while public utilities could be owned by some organ of the state like a local board or public trust. The state ownership should be through an 'autonomous pubic trust' to ensure public ownership and control while avoiding inefficiencies associated with full state control.

Key problem areas were identified in different sectors, like the need for developing indigenous drug industry and nitrogen fertilisers were emphasised by the sub-committee on chemical industries. The panel recommended setting up a National Chemical Laboratory. To tackle under-nutrition and malnutrition, the sub-committee on population suggested the formation of a Central Nutrition Board and regional boards attached to it, and propagation of modern birth control methods. 3rd Test: Australia's quicks rattle India on stop-start day in Brisbane

▶ India 51 for 4 (Rahul 33*, Starc 2-25) trail Australia 445 (Head 152, Smith 101, Carey 70, Bumrah 6-76) by 394 runs

Brisbane, Dec 16 (GNS) Only 33.1 overs were possible on what may have been the stop-startiest day in the history of Test cricket, featuring as many as eight stoppages for rain, but Australia kept alive their hopes of going 2-1 up with two days remaining at the Gabba. They stretched their first-innings total to 445 on the morning of day three before Mitchell Starc, Josh Hazlewood and Pat Cummins ripped out India's top order over the remainder of the day's play, in between the many rain breaks.India went to stumps at 51 for 4, 394 runs adrift of Australia, and their first target when the Test match resumes will be to get to 246 to avoid the follow-on. If they get there, they dramatically improve their chances of getting to Melbourne with the series still level. Rain is expected on days

four and five as well, so Australia may be battling time if they're forced to bat again. Australia's last three wickets added 40 runs to their overnight 405 for 7.

There were brief spells of rain either side of the 17.1 overs they took to do so as well as one in between, after Jasprit Bumrah removed Pat Cummins to pick up his sixth wicket of the innings and his 50th in Tests in Australia. Alex Carey, who had raced to 45 on the evening of day two to keep Australia's advantage intact after a threewicket burst from Bumrah, brought up his half-century and played some resplendent strokes - including an effortless six over wide long-off off Akash Deep - before he was last out for 70. He was out to Akash Deep, who finally got a wicket with the 53rd false shot he had induced in the innings.

Delhi Capitals and Gujarat Giants were involved in a bidding war for Simran before the latter raised the bar to net her. Simran, 22, is a middle-order batter. She played a few matches for UP Warriorz during the 2023 WPL season. She made 176 runs in 11 matches for Mumbai in the Senior Women's T20 Trophy in October-November.

All-rounder Dottin, who is currently in India with the West Indies team for the white-ball series, was the costliest among overseas players and was bought by the Giants for the second time in the auction.

'We are in transition' -Bumrah defends India's bowling show

He was bowling well and he has picked up a fair few of the wickets. In this game, I think I'll give him credit that he had a little bit of a niggle but he still kept on bowling and still helped the team because he knew if he goes inside and he doesn't bowl, then that team will go under pressure. So I think he has got a great attitude and he has got a fighter spirit that the team loves.

Hamilton, Dec 16 (GNS) Kane Williamson's superb century led New Zealand to a gigantic lead over England on a third day which swung from potential tragedy for the tourists to bizarre comedy for all concerned."Tragedy" is often misused to describe events which are far from it and probably over-states the hamstring injury which forced Ben Stokes from the field mid-over and kept him out of action for the rest of New Zealand's imposing innings.But "comedy" perhaps understates the scenes which followed as England, with Ollie Pope standing in for Stokes as captain, resisted taking the second new ball until 13.4 overs after it was due, 1.4 of those bowled by Harry Brook by the time it was delivered to the middle.Brook had bowled 14 overs in Tests prior to this game, eight on England's previous tour of New Zealand at the start of last year when he claimed his only wicket - Williamson caught behind, no less - and six overs during the 2023 Ashes. The first delivery of this short



spell had Mitchell Santner seeing the funny side as he jabbed it away from his face, then

grinning some more after he launched a six over long-off four balls later.
