Odisha Govt extends crop damage registration deadline by two more days Current Affairs

Bhubaneswar, Dec 30 (GNS) In a move to assist farmers impacted by the recent unseasonal rainfall, the Odisha state government has extended the registration period for crop damage compensation claims by an additional two days. The new deadline for registration is now set for midnight on January 1, 2024, announced Chief Minister Mohan Charan Majhi on Monday. The extension comes as a relief to numerous farmers across the state who have struggled to register their crop losses within the original timeframe.

Speaking to reporters a day after visiting the rain-affected regions in Ganjam, Gajapati, and Nayagarh districts, where he met with local farmers and personally assessed the extent of the damage, Majhi emphasized that the government's support would continue unabated as part of its ongoing efforts to mitigate the hardships caused by the unseasonal downpours.

"After reviewing the situation on the ground and hearing from the farmers, we have decided to extend the registration period by two more days. This will give farmers ample time to complete the necessary procedures to apply for compensation," the CM said. Farmers whose crops were damaged in the recent rainfall can now register their losses through the 'Krishi Rakshak App' or by calling the toll-free number 14447.

Meanwhile, Deputy Chief Minister Pravati Parida, while addressing concerns about network issues and connectivity challenges, reassured the public that all registration efforts would be taken into account, including 'missed calls,' which will still be treated as successful registrations.

"Even if a farmer cannot connect through the toll-free number, their missed call will still be recorded, and the registration will be valid," Parida clarified. "Despite some concerns about network issues and connectivity challenges, we will ensure all registrations are processed," she added. The DCM urged farmers to spread the word and help others who may be unaware of the process. "It's critical that no one is left out in seeking the help they need."

This registration extension is exclusive to farmers in Odisha, following a request made by the state government to the Union government. "The Union government has agreed to extend the registration period solely for Odisha, recognising the unique challenges faced by our farmers. We are doing everything in our power to ensure that all affected farmers are compensated for their losses," Deputy CM Parida stated.

Candidates suspect massive corruption in Bihar PSC exam: Prashant Kishor Nation

Patna, Dec 30 (GNS) Jan Suraaj Party founder Prashant Kishor on Monday claimed to have learnt that "thousands of crores of rupees have changed hands" for posts to be filled up by the Bihar PSC exam, cancellation of which is being demanded by many candidates. The former close aide of Bihar Chief Minister Nitish Kumar also expressed dismay over refusal of his ex-mentor to "utter a single word" on the stir which has been going on for nearly two weeks."The candidates are protesting in biting cold, braving baton charge by police and water cannons. The CM is away in Delhi, and having a good time. He did not utter a single word when reporters in the national capital approached him with queries on the stir," Kishor told reporters here. Recalling the previous day's demonstration which was addressed by him, Kishor said till about 4 PM, he kept telling the candidates to look forward to a statement from the chief minister who might take

a stand that could break the stalemate. "But he kept mum," Kishor claimed."Today, I am sharing something that I have been hearing for some time. The protesting candidates believe that BPSC's reluctance to order a fresh examination stems from the fact that crores of rupees have already changed hands. Posts to be filled up through the December 13 test had been put on sale," the Jan Suraaj Party founder said. Notably, nearly five lakh candidates had appeared at more than 900 centres across the state for the Combined Competitive Exams.At one of the exam centres in Patna, hundreds of candidates boycotted the test alleging that question papers were "leaked". This was refuted by the Bihar Public Service Commission, which saw a "conspiracy" to get the exams cancelled at work, even though re-examination had been ordered for more than 10,000 candidates who had been assigned the Bapu Pariksha Parisar, which was at the centre of the controversy.

n November 30, Iraq's Electoral Commission finally announced the results of the October 10 legislative elections. It confirmed that Shia cleric Muqtada al-Sadr's political bloc had secured 73 out of 329 seats in Parliament, thus emerging as the election winner. Meanwhile, its rival the Shia al-Fatah alliance - which is affiliated with Iranbacked militias of the Popular Mobilisation Forces (PMFs) - lost ground in the vote and has decided to reject the results.

These tensions within the Shia political elite have opened the door for a new political arrangement in which Iraq's leading Kurdish parties could play a significant role. Sadr has already indicated that he will not deal with some groups within al-Fatah and the State of Law party of former Prime Minister Nouri al-Maliki, and will instead seek "a national majority government" through an agreement with the main Sunni and Kurdish political forces.

If Sadr's effort is successful in producing a stable government, it could strengthen the Kurds' hand in Iraqi politics and help resolve long-standing disputes between Baghdad and the semi-autonomous Kurdistan Region of Iraq (KRI). Such a positive outcome, however, would depend on the ability of the main Kurdish parties to keep a united front in talks, which would mean overcoming their internal fragmentation and rivalries.

Intra-Kurdish tensions

Since the early 1990s, Iraq's Kurdish region has been ruled by a power-sharing consensus between the Kurdistan Democratic Party (KDP) and Patriotic Union of Kurdistan (PUK), both of which command Peshmerga military forces loyal to them. In recent years, however, the PUK has been losing ground to KDP and newly emerged parties, which has undermined this arrangement. In fact, the October election skewed even further the balance of power in KDP's favour.Of the 63 seats won by Kurdish parties in the new parliament, 31 are held by the KDP and just 18 by the PUK. In a significant development, the KDP managed to win 2 seats in each of the PUK's heartlands - Kirkuk and Su-

These results will have significant implications for the relations between the two parties, especially on coming up with consensus candidates for the Iraqi presidency and governorship of Kirkuk. Since the fall of Saddam Hussein's regime in 2003 following the US invasion, the post of Iraq's president has been allocated to a representative of the Kurdish community through a power-sharing agreement with the Sunnis and Shia. And then another arrangement dating from the same period between the KDP and the PUK granted the right to choose the candidate to the latter in exchange for the KRI's presidency going to a KDP figure.A similar inter-party consensus was established regarding the governorship of Kirkuk, which was held by a Kurd until 2017. Although Kirkuk is part of the "disputed territories", which have a significant Kurdish population but are not part of the KRI, it has traditionally been seen to fall within PUK's sphere of influence, given that many of its leaders hail from the province.But the KDP no longer sees a reason to heed past arrangements, especially since it perceives the

powerful leaders of the PUK as having betrayed it in the aftermath of the 2017 Kurdish independence referendum, when PUK Peshmerga withdrew from Kirkuk, as Shia militias sent by Baghdad to "punish" the Kurdish leadership advanced. The Iraqi government then appointed an Arab as the new governor. The KDP now wants a say in both the appointment of the new president and the new Kirkuk governor.

The core PUK, meanwhile, still believes that it has the military power to resist any attack on its interests. In February 2019, the KDP and the PUK reached an agreement to nominate a new Kurdish governor, but it has not been implemented yet for two reasons.

First a conflict between the faction of PUK leader Lahur Talabani and Masoud Barzani, leader of the KDP, has prevented the two parties from coming up with a consensus candidate. Second, the continuing presence of pro-Iranian Shia militias in the province and Baghdad's reluctance to concede to the appointment of a new governor are also major challenges.

However, recent changes within the PUK may increase the chance of convergence between the two Kurdish parties. Both the KDP leadership and the current leadership of the PUK are united in opposition to Lahur Talabani, who was removed from his post as co-president of the PUK in July this year. In early November, the PUK's Political Bureau confirmed his expulsion from the party, which paves the way for the PUK's other co-president, Bafel Talabani, to officially abolish the copresidency system and take the reins of the party. This could open the door for a more comprehensive deal with the KDP in Kirkuk, the Iraqi presidency and other

outstanding issues. An opportunity for Kurds

In the October 10 election, Kurdish parties increased their seats in the Iraqi parliament from 58 to 63. Sunni factions have around 70 seats in total, but unlike the Kurdish parties, they do not have that much power on the ground and do not directly run the Sunni regions. For this reason, the Kurds have more potential to play a king maker's role.In a "national majority government" with the composition Sadr envisions, Kurdish parties would have the opportunity not only to increase their number of posts, but also to transform from being a participant in the Iraqi cabinet to a real decision-maker.

Apart from increased leverage in negotiating government posts, the improved electoral performance of the Kurdish parties could also help them in negotiations on a number of thorny issues with Baghdad.First, there is the question of budget allocation and the distribution of oil profits. In 2014, amid tensions between then KRI President Masoud Barzani and the former Iraqi PM Nouri al-Maliki, Baghdad decided to cease allocating the Kurdish portion of the national budget, accusing Erbil of not delivering the agreed amount of oil to the State Organisation for Marketing of Oil.

Since then, several agreements have been signed, but failed to resolve the dispute. In June this year, Baghdad and Erbil reached a new deal, which resulted in the former sending 200 billion dinars (\$137m) per month to the Kurdistan Regional Government (KRG). However, this agreement is only valid for this year's budget, so the Kurdish parties will have the opportunity to renegotiate within the government formation talks. Second, there is the question of the "disputed territories", which include the province of Kirkuk and over a dozen districts in Nineveh, Diyala and Salahaddin provinces. The status of these areas was supposed to be settled by the KRI and Baghdad after the Iraqi constitution was promulgated in 2005, but that never happened. During the fight against ISIS, KRI's Peshmerga forces were able to take control of some of these areas, but in the aftermath of the referendum, they were forced to withdraw. Since then, there has been very limited administrative, security and political cooperation be-

tween Baghdad and Erbil in these areas, with the pro-Iranian armed groups dominating the security landscape.In the October elections, Kurdish parties performed quite well in these areas, with all five new seats won in disputed territories in Nineveh, Salahaddin, and Diyala provinces.

Kurdish parties now have six out of 12 seats in Kirkuk, and 11 out of 31 seats in Nineveh. Increased Kurdish political representation in these areas can help in negotiations over their status. What the KRG can realistically hope to secure is Baghdad's approval to appoint a Kurdish governor for Kirkuk and joint security administration in the disputed territories.

Increased ISIS activity in these areas makes such security coordination all the more necessary, but that would have to involve reaching some kind of a settlement with the pro-Iranian militias currently deployed in these areas. That could be hard to achieve, unless Sadr changes his mind about isolating al-Fateh and other Shia factions.Regardless, a "national majority government" could be a significant opportunity for the KRI's leadership to secure important gains. But if they do not unite in pursuit of the best interest of the Kurdish community, then their failure can come back to haunt them.

Like the majority of other traditional political forces, the leading Kurdish parties have also seen declining support. While the KDP increased its parliamentary presence by six seats, the number of votes it received actually fell by more than 100,000 votes in KRI's provinces compared to the 2018 election. A new party, the New Generation attracted the votes of a large number of disgruntled Kurds, winning nine seats. This, along with persistent protests across the KRI in the past four years, reflects the growing discontent among Iraq's Kurdish population towards their leaders. If the Kurdish traditional leadership fails to secure major gains for its people from the advantageous position it finds itself in at the moment, another outbreak of popular anger may follow soon.

taking care not to 'offend' Hindu sentiment

Who are we kidding here?

e are a good, self-respecting de-mocracy, and there should be no two opinions about it. We have a fine Constitution, fundamental rights, a legal code left behind by Macaulay, and a judiciary which is safeguarding the basic structure of the Constitution, a role which the judiciary has acquired for itself. We can talk about rights and politics without whispering. We take umbrage when people outside — meaning foreign think tanks — criticise us for our 'down-sliding democracy'. I was happy to see the Foreign Minister put up a fine defence over a recent such report.

So far so good. But antipathy to such reports, and the brimming over of 'patriotism' should not make us myopic. As far back as October last year, the Swedish V-Dem Institute, based in Gothenburg university, had stated that India's democratic processes were on a path of steep decline. India was almost put in the same league with Brazil, Poland, US (oh those halcyon Donald Trump days!) and Hungary. Brazil under Bolsonaro and USA under Trump were Indian favourites last year, remember. The report talked of 'shrinking space' for media, civil society and the Opposition. "India has continued on a path of steep decline, to the extent it has almost lost its status as a democracy," the report said. Nothing could be more damning. Freedom House, now a bête noir among our right-wing "intellectuals", also downgraded us as a 'partially free democracy' and one under siege. Have we come to this? And if we have, we can at least listen to them without fulminating.

The Geneva-based UN Human Rights Council's Working Group, in a report, criticised the incarceration of the pregnant Jamia Millia activist Safoora Zargar and stressed on her 'deprivation of rights'. She is an MPhil student. It called for political prisoners to be 'released unconditionally'.Let the world come and see our elections. They are free and fair. But what of the aftermath? MLAs are won over or purchased. How do we explain this phenomena to the world? In Puducherry, a BJP Lt Governor, who had lost woefully in elections against Kejriwal, was given a free hand to stymie the working of an elected government, till the Chief Minister and the Lt Governor were both thrown out. In Delhi, the Lt Governor and CM tussle, which started in 2014, was settled by a five-member Bench of the Supreme Court in 2018, which ruled in favour of the elected government. Now tables are being forcefully overturned through astonishing legislation, which says in effect that 'Delhi government means Lt Governor'. After two humiliating rebuffs (BJP won just eight seats in a House of 70), power has been snatched, going against the SC ruling. What does the Delhi government do now? Wrap files in red tape with notings, "LG may kindly approve".

And what if he doesn't? If the BJP were ruling would such a Bill have been thought of?Amartya Sen was nudged out of the Nalanda University and Bhanu Pratap Mehta from Ashoka University. What message are we sending to the world? We don't need the very best, especially if what they say is contrary to the non-intellectual elite that rules us today. How long can the establishment just showcase Swapan Dasgupta? As ex-Bolsonaro supporters, we have not much right to claim we are doing enough for climatology. No wonder our police arrested Disha Ravi, a climate activist, on February 13 on sedition charges! Ten days later, she was released on bail. I was in Bengaluru the day an upright judge sentenced Jayalalithaa to four years' imprisonment and a fine of Rs100 crore in a disproportionate assets case. The corruption reeked to high heavens. The High Court acquitted her later on the plea that the trial judge's calculations were wrong! Today political parties are swearing by her in the coming elections. This too is a part of our democracy. Reports said that 70,000 men from the Central armed police forces were being sent to West Bengal for election duty.

I rushed to my atlas. Were we declaring war? It couldn't be on our friend Bangladesh. Then a bright idea struck me — happens once a year or so. The Home Minister must have suddenly caught the human rights bug, and so we were moving into Myanmar on behalf of Aung San Suu Kyi. I pondered over the thought, and another bright idea struck me — that meant two in a row! War in erstwhile Burma was unthinkable. The force, 70,000 if you please, was being despatched to fight Mamata Banerjee! The Election Commissioners did not turn a hair. They could be bald, always a possibility. Looks a bit of an unequal contest, 70,000 in camouflage fatigues, Election Commission, formidable Home Minister, NRIs with money, and the army of TMC turncoats against one lady on a wheel chair. Hallelujah!But much more sensational is the eight-page letter of the former Mumbai Police Commissioner, Param Bir Singh. He alleges that Maharashtra's Home Minister, Anil Deshmukh, from Pawar's NCP, asked assistant inspectors, etc, to muster up a hundred crores a month from dance bars and the like. Hain? Weren't we better off during the days of Sultana Daku? Wasn't Chicago better off in the days of Al Capone and Sherwood Forest more peaceful, sylvan almost, in the days of Robin Hood and Friar Tuck?

Of 'diminished' comrades and Congress

ndia has sought quicker extradition of Kim Peter Davy alias Niels Holck, from Denmark. This happened on the diplomatic stage when Danish Prime Minister Mette Frederiksen was in India and holding bilateral talks with her Indian counterpart Narendra Modi. She also hailed Modi as an 'inspiration' and both sides held significant parleys on green politics to Afghanistan. The Kim Davy issue actually brings into focus the good old Congress-Communists relationship in India -- even till the mid-1990s. On December 17, 1995, a large consignment of illegal arms including AK-47 rifles and ammunition were dropped from an Antonov An-26 aircraft and was scattered in the Purulia district of West Bengal. One need not go into the merits of the allegation that the Congress had conspired to oust the erstwhile Jyoti Basu government in West Bengal. The Marxists' forte was too strong and of course Basu was very powerful and also left to himself, a very popular leader in his state. But things have changed a lot since then. Now the Congress party's base has shrunk and Communists have, in an ironical turn of events, vanished from West Bengal. For someone born in 1970 and having seen the hero-cult image of Basu, this journalist had never imagined that the CPI-M could be ever a 'Zero-MLA' strong or weak party in Bengal ever. But this has happened. In 2021 assembly elections, both the CPI(M)-led Left Front and Congress strengths in the 294-member state legisla-

ture have been reduced to zero. Now, it is Mamata Banerjee all the way. Importantly, she is seen as 'more Left than the Left' and hence she thrives. Her outfit -- a splinter organisation from the mother' Congress is now trying to have its footprint in different parts of India, including in far off Goa. In general, over the last few years, the Congress has lost its base across the country. But in the process, the grand old party of India has turned 'more Left'; and in more ways than one. It started with the JNU protest in 2015 and also on other issues Rahul Gandhi is trying to emulate the language of the comrades. Here comes the new challenge. Just as the two communities with the same 'historical and cultural' origins may not necessarily evolve in the same ways, the two political parties trying to fashion a 'modern pro-Communist' look cannot see the growth simultaneously either. Historians often liken the Hindu civilisation for having shared 'affinities' at the very initial stage with Mesopotamia. But the respective journey and growth trajectories have been different. Hence as and when the Indian National Congress and Communist growths are discussed, we have to see why both have lost ground. This brings us to debate a very important chapter of Indian politics. The shrinkage of bases of the Congress party and the Indian Communists have also largely created ground for the growth of Hindu fundamentalist forces, like the BJP. Even the rise of regionalist stars like Mama-

performance by the Congress and the Communists.In the 2021 polls, the Trinamool Congress' 200-plus haul would not have been possible had not Congress and Leftists lost all their seats. This downward slippery journey of Indian communists and Congress have also unnerved minorities such as Muslims and Christians. The decline is not only electoral but also in exerting influence on the sociopolitical mindset. In the regions where they are losing their grip, the pro-Hindu BJP has gained ground -- of course rising on the 'Moditva phenomenon'. The religious minorities could have been happy about atheism (the Communists) losing ground. But they are irked as a worse and more dangerous form of political ideology has gained power. The BJP with its commitment to make India a nation of 'Hindu hegemony' is now the major opponent of Mamata Banerjee in Bengal. It has 18 of the 42 Lok Sabha seats and three years back, it came to power in Tripura as well by ousting its Communist government in another red bastion. The BJP's 'growing support base' in Kerala also essentially means dwindling popularity of Kerala's two traditional political alliances -- UDF (led by the Congress) and the other LDF, led by Leftists. One need not be a bitter rival or detractor to point out that even in Kerala comrade Pinarayi Vijayan has tinted the Communists' red flag with the hues of saffron, the colour associated with Hindu forces. In other words, he is

with the so-called progressive Communist ideas. The Leftists are good at giving a spin to events and they may thus describe this appeasement of Hindu sentiment or religion as pragmatism. What could happen if Kim Davy is extradited, would be debated another day. The Communists could be anti-religion, but they have long been the real custodians of a secular polity where nearly 80 per cent of its 1.3 billion people are Hindus. The minorities see a protector in Communist leadership although in Kerala, the CPI(M) for long was also known as a pro-Hindu party. Then, you had the Muslim League and the Congress party with a good support base among Catholics. The electoral data in the last 15 years or so shows that of the three national elections and some state assembly elections -- not only have the Communists weakened but there has been a steady rise of the BJP, including in West Bengal and Tripura. The trend has been modest in Kerala too. In other words, the weakening of Communists signals the rise of Hindutva-ridden macho nationalism. But pragmatism, as they say, is often a good political substitute for naked opportunism. Thus, the Marxists in the southern state of Kerala have actually sparked off a 'power struggle' between Kerala's two dominant minorities — the Muslims and the Christians. Out of a population of 36 million, Muslims and Christians together constitute about 40 per cent in this state.



India lose seven in the final session, Australia snatch 2-1 series lead

Melbourne, Dec 30 (GNS) Early in the final hour at the MCG, Australia won an epic Test that had been played in front of a record crowd to take a 2-1 lead in the Border Gavaskar Trophy, having snared seven wickets in the final session when it appeared India were on track to save the game.

Yashasvi Jaiswal defied the home side for 208 deliveries before falling to the herculean Pat Cummins while hometown star Scott Boland made three key incisions to secure one of Australia's most significant victories of recent history.

Nathan Lyon claimed the final wicket, when he pinned Mohammed Siraj lbw, sparking wild celebrations for the home side: a margin of 184 runs did not do justice to the tension and drama of the final day and the importance of the result to this Australia team who have turned their fortunes around after the crushing opening defeat in Perth.

After India had slid to 33 for 3, Jaiswal and Rishabh Pant added 88 in 32 overs to take India into the final session with seven wickets in hand, but Travis Head burgled the wicket of Pant and Australia seized their moment as India lost 7 for 34. The quick bowlers were immense, Mitchell Starc bowling in the mid-140kph region despite a back niggle, while Cummins and Boland added further chapters to previous MCG

the Border-Gavaskar Trophy with victory in Sydney. For Australia, a win in the final Test - and a 3-1 margin - would secure their spot in the WTC final alongside South Africa who qualified yesterday with their own gripping victory over Pakistan.

Featuring across 13 Tests in the calendar year, Bumrah delivered his best-ever annual tally - 71 wickets — finishing the year with more Test wickets than any of his counterparts," ICC said on its website. ICC rated Bumrah's match-defining spells at Perth, to guide India to a 295-run win, among his most memorable performances.

No Indian among nominees for ICC Women's Cricketer of the Year award


