THAILAND. More than 250 schools in Bangkok were closed on Thursday due to pollution, authorities said, as officials urged people to work from home and restricted heavy vehicles in the city.Seasonal air pollution has long afflicted Thailand, like many countries in the region, as colder, stagnant winter air combines with smoke from crop stubble burning and car fumes.Level of PM2.5 pollutants -- cancer-causing microparticles small enough to enter the bloodstream through the lungs -hit 122 micrograms per cubic metre. The World Health Organization recommends 24hour average exposures should not be more than 15 for most days of the year.Bangkok authorities said earlier this week schools in areas with elevated levels of PM2.5 could choose to close.And by Thursday morning, 194 of the 437 schools under the Bangkok Metropolitan Authority had shut their doors, affecting thousands of students.st since 2020, when all schools under BMA authority closed over air pollution.Another 58 schools out of the 156 under the Office of the Basic Education, a central government body, had also decided to close by Thursday.

There are several other schools in the capital under different authorities, and private establishments, but figures for them were not available.

Children are especially vulnerable to the impacts of air pollution, but rights advocates warned that closures disproportionately affect the most vulnerable students

Angeles as new blazes ignite in southern California

LOS ANGELES. Evacuation orders vere lifted Thursday for tens of The Palisades Fire was more than threequarters contained, and the Eaton Fire was 95% under control Thursday. The two fires have killed at least 28 people and destroyed more than 14,000 structures since they broke out Jan. 7.Rain was expected to start Saturday, according to the National Weather Service. Officials welcomed the wet weather, but crews also were shoring up hillsides and installing barriers to prevent debris flows as residents returned to the charred Pacific Palisades and Altadena areas.

The California fires have overall caused at least \$28 billion in insured damage and probably a little more in uninsured damage, according to Karen Clark and Company, a disaster modeling firm known for accurate post-catastrophe damage assessments. On the heels of that assessment, California Republicans are pushing back against suggestions by President Donald Trump, House Speaker Mike Johnson and others

that federal disaster aid for victims of wildfires should come with strings attached. The state Legislature approved a more than \$2.5 billion fire relief package Thursday, in part to help the Los Angeles area recover from the fires. Trump plans to travel to the state to see the damage firsthand Friday, but it isn't clear whether he and Democratic Gov. Gavin Newsom will meet during the visit.thousands as firefighters with air support slowed the spread of a huge wildfire churning through rugged mountains north of Los Angeles, but new blazes erupted in San Diego County, briefly triggering more evacuations.Southern California is under a red flag warning for critical fire risk through Friday.

The area has been facing constant challenges in controlling the fires, as dangerous winds gained strength again Thursday.The Hughes Fire broke out late Wednesday morning and in less than a day charred nearly 16 square miles (41 square kilometers) of trees and brush near



Castaic Lake, a popular recreation area about 40 miles (64 kilometers) from the devastating Eaton and Palisades fires that are burning for a third week.Crews made significant progress by late afternoon on the Hughes Fire, with more than onethird of it contained. Two new blazes were reported Thursday in the San Diego area. Evacuations were

ordered but were later lifted after a brush fire erupted in the late afternoon in the wealthy enclave of La Jolla near the University of California, San Diego, School of Medicine.

Further south, near the U.S.-Mexico border, another blaze was quickly spreading through the Otay Mountain Wilderness, home to the

endangered Quino checkerspot butterfly and other unique species In Ventura County, a new fire briefly prompted the evacuation of California State University Channel Islands in Camarillo. Water-dropping helicopters made quick progress against the Laguna Fire that erupted in hills above the campus of about 7,000 students. The evacuation order was later

downgraded to a warning.Rain is forecast for the weekend, potentially ending Southern California's monthslong dry spell. Winds are also not as strong as they were when the Palisades and Eaton fires broke out, allowing for firefighting aircraft to dump tens of thousands of gallons of fire retardant.

That helped the fight against the Hughes Fire in the Castaic area north of Los Angeles, allowing helicopters to drop water, which kept it from growing, fire spokesperson Jeremy Ruiz said."We had helicopters dropping water until around 3 a.m. That kept it in check," he said.

'Blatantly unconstitutional': Federal judge blocks **Trump's executive order redefining birthright citizenship**

Decision prevents Trump administration from taking steps to implement executive order for 14 days. Meanwhile, parties will submit further arguments about merits of Trump's order.

SEATTLE. A federal judge on Thursday temporarily blocked President Donald Trump's executive order redefining birthright citizenship, calling it "blatantly unconstitutional" during the first hearing in a multi-state effort challenging the order. The 14th Amendment to the Constitution promises citizenship to those born on U.S. soil, a neasure ratified in 1868 to ensure citizenship for former slaves after the Civil War. But in an effort to curb unlawful immigration, Trump issued the executive order just after being sworn in for his second term on Monday. The order would deny citizenship to those born after February 19 whose parents are in the country illegally. It also forbids U.S. agencies from issuing any document or accepting any



state document recognizing citizenship for such children.Trump's order drew immediate legal challenges across the country, with at least five lawsuits being brought by 22 states and a number of immigrants rights groups. A lawsuit brought by Washington, Arizona, Oregon and Illinois was the first to get a hearing."I've been on the bench for over four decades. The 14th Amendment was ratified in 1868, in the aftermath of the Civil War, to ensure citizenship for former slaves and free African Americans.

How Microsoft powered Israel's war machine in Gaza: Report

World. Leaked internal documents reveal Microsoft's role as a major purveyor of cloud services and artificial intelligence (AI) technology to the Israeli military, with its support picking up pace after Hamas's October 7 attack on Israel ignited the Gaza conflict.A joint investigation by the Guardian, +972 Magazine, and Local Call details how Microsoft bolstered its relationship with Israel's defence establishment following the unprecedented Hamas assault, signing deals worth at least \$10 million. These agreements reportedly provided thousands of hours of technical support, alongside expanded computing and storage services.The Israel Defense Forces (IDF), facing increased demand for computing power after launching its offensive in Gaza, turned to tech companies to scale its infrastructure, triggering a "gold rush" As firms vied for military contracts, Microsoft offered steep discounts to edge out rivals.According to one military commander who spoke to the Guardian, this marked a shift toward "the wonderful world of cloud providers."The documents, first obtained Drop Site News, show the IDF's reliance on Microsoft, Amazon, and Google for data storage and intelligence analysis grew sharply. Between June 2023 and April 2024, Microsoft's cloud storage usage within the military surged by over 155 per cent, peaking before the Rafah offensive in May 2024.Microsoft's Azure platform and ChatGPT-maker OpenAI's language model tools accounted for nearly 75 per cent of the IDF's usage. These services supported combat and intelligence activities, including projects with Unit 8200, the IDF's elite surveillance division, and Unit 81, which develops advanced spy technology. The tech behemoth was frequently involved in sensitive and highly classified projects. It played a role in maintaining "Rolling Stone," a system that tracks the movement of Palestinians in the West Bank and Gaza. During the military operation in Gaza, Ofek, an air force unit responsible for managing databases of targets for strikes, relied on Microsoft's communication and messaging systems. The leaked files also detail Microsoft's provision of AI tools like Lavender, which reportedly analysed data on 2.3 million Gaza residents to identify potential Hamas connections. The system flagged about 37,000 Palestinians as suspects, according to Tel Avivbased +972 Magazine. The revelations come as Google also ramped up its support to Israel's Defence Ministry, offering increased access to its AI technologies

Living in a cage': **Checkpoints in Israel**occupied West Bank proliferate after Gaza ceasefire

TAYBEH. Father Bashar Basiel moved freely in and out of his parish in the occupied West Bank until Israeli troops installed gates at the entrance of his village Taybeh overnight, just hours after a ceasefire began in Gaza.

We woke up and we were surprised to see that we have the iron gates in our entrance of Taybeh, on the roads that are going to Jericho, to Jerusalem, to Nablus," said Basiel, a Catholic priest in the Christian village north of Ramallah.

Ramallah. All over the West Bank, commuters have been finding that their journey to work takes much longer since the Gaza ceasefire started."We have not lived such a difficult situation (in terms of movement) since the Second Intifada," Basiel told AFP in reference to a Palestinian uprising in the early 2000s.He said he was used to the checkpoints, which are used to the checkpoints, which are dotted along the separation barrier that cuts through much of the West Bank and at the entrances to Palestinian towns and cities.

Massive LA wildfires slow down after days of devastation

World. Evacuation orders in Los Angeles were lifted for thousands of residents on Thursday after firefighters succeeded in slowing down the spread of massive fire. The hilly region still remains under a red flag warning for critical fire risk until Friday, with strong winds challenging containment efforts. The Hughes Fire, which erupted near Castaic Lake on Wednesday, quickly engulfed a vast green patch of almost 41 square kilometres of trees and brush.

Firefighters had made significant effort by Thursday afternoon, containing about a quarter of the blaze. The lake, a popular creation spot situated at the distance of 64 kilometres from the sites of the weeks-old Palisades and Eaton fires, also remains under threat.Meanwhile, two new fires broke out in San Diego County on Thursday. A blaze in La Jolla, near the University of California, rompted temporary evacuations before being

brought under control.

Another fire near the US-Mexico border spread rapidly through the Otay Mountain Wilderness, home to endangered species like the Quino checkerspot butterfly.Rainfall, which is forecasted for the weekend, has ignited hopes of relief from the months-long dry spell."We had helicopters dropping water until around 3 a.m., which kept the fire in check." said fire spokesperson Jeremy Ruiz. While nearly 54,000 residents in the Castaic area remain under evacuation warnings, no homes

or structures have been reported damaged. Among those affected was Kayla Amara, a nurse from Valencia. She rushed to a friend's home in Castaic's Stonegate neighbourhood to

retrieve belongings but found herself hosing down the property as the fire grew. 'It's been stressful with those other fires, but

now that this one is close to home it's just super stressful," she said. The Palisades Fire is now

almost 75 per cent contained, while Eaton Fire is 95 per cent under control. These two devastating blazes, which began earlier this month, have claimed 28 lives and destroyed more than 14,000 structures.California officials are preparing for potential debris flows as rain approaches, particularly in the Pacific Palisades and Altadena areas, where damage is extensive.

Syria's economic pains are far from over despite Assad's ouster

DAMASCUS. Samir al-Baghdad grabbed his pickax and walked up a wobbly set of stairs made of cinderblocks and rubble. He is rebuilding his destroyed family house in the Qaboun neighborhood near Damascus.

The traditional building, which once housed his family, parents and some relatives, had a courtyard decorated with plants and tiled floors where guests were received. But the house, like scores of others nearby, has been reduced to heaps of rubble during years of civil war.Al-Baghdadi can't afford to hire workers or rent a buildozer to clear the debris and fix the house. He makes just about enough money as a mechanic to feed his family. But he's desperate to rebuild it because he is struggling to pay skyrocketing rent for an apartment.

'Economic opportunities are basically nonexistent," al-Baghdadi said, sitting on a pile of rubble and debris where the house's entrance used to be. "So we're going to slowly rebuild with our own hands."Although Syrian President Bashar Assad was toppled last month in a lightning insurgency, the country's dire economic conditions that protesters decried have not changed. The economy has been battered by corruption and 13 years of civil war. Coupled with international sanctions

and mismanagement, inflation skyrocketed, pulling some 90% of the country into poverty.

Over half the population—some 12 million people-don't know where their next meal wil come from, according to the UN World Food Program. With no sign of a full-scale withdrawal of international sanctions and continuing caution among potential overseas investors, the honeymoon period for the country's new rulers could be short-lived.

Qaboun, just a stone's throw away from the city center, and other eastern Damascus neighbourhoods became rebel strongholds in 2012, when the country's mass protests against Assad spiraled into all-out war.It suffered government airstrikes and artillery fire, and at one point Islamic State group extremists. In 2017, government forces reclaimed the neighbourhood, but when al-Baghdadi tried to return in 2020, security forces kicked him out and forced him to sign a pledge to never return, saying it was a security zone that was off limits. After Assad's fall, al-Baghdadi was finally able to return.Like many, he was euphoric and hoped it would pave the way for better times despite the many challenges that lay ahead, including rampant power cuts and fuel shortages.For years, Syrian

families have relied on humanitarian aid and remittances from family members living abroad to survive.n top of the gargantuan costs of rebuilding the country's destroyed electricity, water and road infrastructure,



is needed to restore its battered money agriculture and industrial sectors to make its hobbled economy productive again. The United Nations in 2017 estimated that it would cost at least \$250 billion to rebuild Syria. Some experts now say that number could reach at least \$400 billion.Wealthy Gulf countries have pledged to build economic partnerships with Syria's new interim rulers, while Washington

has eased some restrictions without fully lifting its sanctions. The US Treasury Department issued a six-month license authorizing some transactions with Syria's interim government While it includes some energy sales, Syrians say it isn't enough.Sinan Hatahet, an economic researcher at the Washington-based Atlantic Council think tank, said the US actions were the "bare minimum" needed to show good faith to Damascus and aren't enough to help Syria jumpstart its economy. 'It doesn't help the private sector to engage Hatahet said.

The restrictions on trade, the restrictions on reconstruction, on rebuilding the infrastructure are still there."While countries are hesitant to make more impactful decisions as they hope for a peaceful political transition,

many Syrians say the economy can't wait. Without jobs, without huge flows of money and investments ... these families have no way of making ends meet," Hatahet said. The executive director of the World Food Program echoed similar sentiments, warning Syria's neighbors that its food and economic crisis is also a crisis of security. "Hunger does not breed good will," Cindy McCain said in an interview during her first visit to Damascus

UN Chief Calls for AI Integration in Global Education Focused on Humanity

RNS: On the occasion of the International Day of Education, UN Secretary-General António Guterres reaffirmed education as a fundamental human right and crucial for both individual and societal development. In his message, he underscored the importance of education in unlocking potential and driving economic growth, while also addressing the opportunities and risks associated with technological advances, particularly Artificial Intelligence (AI).

acknowledged Guterres AI's potential to enhance education by providing greater access to information and learning tools for students and teachers but also warned about the risks of misalignments between human intentions and AIdriven impacts. He called for careful and ethical use of AI in education, emphasizing that human rights and agency must remain central to its development.



This year, UNESCO is focusing on AI's role in education, with Director-General Audrey Azoulay urging increased investment in training for both teachers and students. She highlighted the importance of ethical principles to guide AI deployment in schools and the need for AI to complement, not replace, human elements of learning. However, the use of AI in education remains divisive. Data from UNESCO reveals that while over two-thirds of secondary school students in high-income countries are using AI tools, only 10% of educational institutions have formal guidelines for AI use. Additionally, nearly 40% of nations have imposed restrictions, such as mobile phone bans in schools, as part of efforts to control new technologies. The UN also highlighted the persistent barriers to educa-

tion, with 250 million children and youth still out of school globally. Despite progress, issues like gender inequality, conflict, and social barriers continue to prevent access to quality education for many children.

In closing, Guterres emphasized the need for education systems worldwide to keep humanity at the center, ensuring safe, inclusive, and high-quality education for all.



the Sangam in Prayagraj. Can Arvind Kejriwal and his team bathe in the Yamuna? The person who turned Yamuna into a dirty drain should not be forgiven by the people." He went on to highlight the progress Uttar Pradesh has made in recent years under his leadership.Referring to the ongoing Kumbh Mela in Prayagraj, Yogi said, "Over 10 crore devotees have bathed at Sangam between January 13 and 23. The city now boasts improved infrastructure with better roads, electricity, rail and air connectivity. The UP and central governments jointly invested Rs

7,500 crore for the Maha Kumbh, generating over Rs 2 lakh crore for the state's economy and creating thousands of jobs." The CM accused Arvind Kejriwal of being the "biggest criminal" responsible for Delhi's decline. He stated, "Except for the MDMC area, the rest of Delhi is suffering from worsening road conditions, sewage issues, and poor sanitation. The roads are riddled with potholes, garbage is rampant, and sewage flows freely on the streets. The tanker mafia exploits the city's

Ajit Pawar Attends Meet, Rearranges Seating For 'Distance' From Sharad Pawar

Pune. Maharashtra Deputy Chief Minister Ajit Pawar on Thursday attended the annual general body meeting of Vasantdada Sugar Institute (VSI) for the first time since the NCP split in 2023 but sat at an arm's length from NCP(SP) chief and the institute's chairperson Sharad Pawar. Ajit Pawar is a member of the Pune-based VSI, a prominent research institute of the sugar industry. While the two were supposed to sit next to each other as per the initial arrangement, the Deputy Chief Minister moved his nameplate one chair away, allowing state cooperation minister Babasaheb Patil to sit between them. "Babasaheb wanted to speak to Pawar saheb. I can speak to him (Sharad Pawar) anytime. Even if I sat one chair away, my voice is loud enough for someone further away to hear," the deputy Chief Minister explained when asked about this seat rearrangement.

The NCP chief also held a closed-door meeting with Sharad Pawar and other leaders, including



NCP MLA Dilip Walse Patil. Asked about his absence from the annual general body meetings of VSI over the past two years, Ajit Pawar attributed it to his work commitments, adding in a lighter vein that he was "busy thinking about how to get the maximum number of my members elected".

The closed-door meeting centred on issues of the sugar industry and was attended by representatives from agriculture, excise,

cooperation, and energy departments, all of which are closely associated with the sugar sector, he pointed out.

NCP (SP) MLA Rohit Pawar said "the two captains coming together for a discussion must be welcomed". Oueried about this meeting, Maharashtra BJP chief and state minister Chandrashekhar Bawankule said he did not know if the discussion was political in nature. "If it was political, then Ajit dada had to discuss it among the Mahayuti. If it was personal, then it was

Lives, not machines: Human cost of overwork

- While Infosys founder Narayana Murthy keeps advising the young generation—the bunch of software engineers and other techno-managers to work for 70 hours a week, Larsen and Toubro chairperson SN Subrahmanyan has begun to plead for a 90-hour workweek, including Sundays, to promote competitiveness and efficiency.
- Never mind that, as far as the findings of the International Labour Organisation are concerned, India ranks 13th among the world's most overworked countries! Furthermore, 62 per cent of the Indian employees experience severe burnout-three times the global average. And this is one of the top occupational risk factors contributing significantly to disease and early death.Have these corporate bosses forgotten so early the tragic tales of the death of Anna Sebastian Perayil-a 26-year-old Ernst and Young employee in Pune — because of workrelated stress? No, it is not an aberration. As the 'Healthy Work Survey' conducted by the USbased Centre for Social Epidemiology reveals, there are more than 1,20,000 deaths caused by work stress every year in the world. There are three reasons why we must resist this sort of insensitivity, or the act of reducing a human being into a mere 'resource' for enhancing the mythical 'productivity'.First, as the kind of work most of us are compelled to do for survival or economic mobility, far from being inherently fulfilling and creative, causes alienation, estrangement and existential anguish.Converse with a software engineer sitting in front of the laptop in a tiny cubicle, fulfilling the ever-expanding 'targets' and, thereby, spending sleepless nights; engage with an employee in a crowded bank, counting cash from 9 am to 5 pm without a breathing space; or, for that matter, talk to a delivery boy running like a horse to supply — quickly and instantly — what the affluent classes from their gated societies order. It is quite unlikely that they will say that they are happy with what they do. They do it because they have to survive, pay the house rent, give their medical insurance premium or send their kids to schools.In fact, asking them to work more, or to teach them the lessons of 'hard work' is the worst form of psychic violence the insensitive corporate elites can inflict on them. The fact is that most of us are psychologically wounded and feel extreme form of alienation and boredom in our workplaces. However, for these business tycoons, it seems, we are nothing but mere 'resources', to be extracted continually till we break down.Second, when these corporate elites lecture on long working hours for India's economic prosperity, they safely forget to mention that without distributive justice, the nation's prosperity will mean essentially the prosperity of the select billionaires, or a tiny section of the upwardly mobile professional class, like techno-managers, doctors in private hospitals, and real estate entrepreneurs. Thanks to an Oxfam report, we know that the top 10 per cent of Indian population holds 77 per cent of national wealth. Is it, therefore, surprising that India has 185 billionaires — the third largest in the world after the US and China? Keep your eyes open and see the manifestations of this gross inequality.

For instance, while Narayana Murthy's net worth is not less than \$520 crore, the estimated total package for a fresher at Infosys is Rs 3-to-5 lakh per annum. While the Ambanis can spend Rs 5,000 crore for their son's lavish wedding, it is exceedingly difficult for a construction worker to earn more than Rs 700 per day, or a delivery boy Rs 13,000 per month. Is it because they are lazy? Or, is it because the system that the corporate elites seek to hide is inherently violent and exploitative?In this context, I must say that it is equally important for people like us - I mean middle class, university-educated professionals who are complaining against this kind of long working hours — to look at ourselves critically, accept our hypocrisy and admit that we, too, do not necessarily behave nicely, eg with the entire brigade of domestic helps. Quite often, we pressure them to work even on holidays or in festive seasons.

Budget shouldn't disappoint as economy is on an even keel

The govt still has to keep financing capital investment and infrastructure. It should give up the thought that it can step back so that the private sector can take over.

THE Union Budget looks ahead for several key pointers: signals for key sectors of industry and agriculture; public investment in foremost infrastructure sectors like electricity, roads and railways; how the fiscal scene (the government's own finances) is likely to fare during the year; and, of course, the average citizen's keenness to find out if the income tax burden will go up or down.

With inflation under control and growth going steady at 6 per cent plus, there is no serious concern over the economy and the tax collection. There are, however, some imponderables. Will we be able to keep buying Russian oil at a decent price with US sanctions being tightened?But the overarching concern and the

greatest imponderable is the way in which the country and the world will cope as the planet gets hotter and extreme climate events like drought and floods keep coming. And what it will do to agriculture, from which many poor people eke out an existence. The expectation is that the fiscal deficit in the coming financial year will be pitched lower at 4.5 per cent from the likely deficit in the current fiscal of 4.8 per cent. This will bring the number in line with the medium-term fiscal goal. From this, it is clear that we are looking at a small realignment and not a serious overhaul.As against this, a sharper change will be sought and expected in capital expenditure, seeking to take it

up by 12-13 per cent to Rs 11 lakh crore. This is because where the capital spending goes matters a lot to roads, highways and railways. Plus, there is an expectation that interest-free loans for capital expenditure will continue to be passed onto the states so as to raise regional infrastructure growth.Capital expenditure will be delivered because the revenue part will be expected to coast along evenly. This will be enabled by indirect taxes growing at 8.8 per cent, with the GST (goods and services tax) expected to grow by 10.5 per cent, reflecting a resilient domestic consumption.Direct tax revenue, in good part from taxes paid by companies out of their profits, will grow healthily at 11.8 per cent as the base of companies will grow, with the economy growing healthily and corporate profitability remaining stable. With the economy

expected to remain on an even keel, let us examine what individual industries have mentioned in their wish lists as they have met government representatives so as to build a castle firmly anchored in the ground and not in the air. Technology moves forward with funding and incentives for research and development (R&D). The tech sector, which is rolling in money, still seeks government support as hugely important new sectors are emerging, like artificial intelligence, block chain and quantum computing. These can transform daily life as well as businesses and enable future growth.Right behind is the healthcare sector, without whose robustness the people will not be



healthy or be able to provide the skills that will be the sinews of technology. And the way to begin is at the bottom, with rural healthcare facilities. These will have to be revolutionised by telemedicine, which will deliver better care at controlled costs. If we jump to the top of the sector, the aspects we see before us are pharmaceuticals and medical equipment. India is already the global leader in affordable medicines, which have to go up the ladder as new chemicals or molecules are invented all over the world. These must be made in India and these will have to be offered at the village level itself, through prescriptions generated by telemedicine. And there will have to be cameras and scanners to capture the images which will have to be generated. This will need the government to help out.To transform countryside education, it must go hand in hand with

healthcare. Students of high schools and colleges should be able to access the digital knowledge world and download e-books so that the age of the photocopier is left far behind. The government must to develop the IT backbone and take it to villages so that youngsters can use their smartphones, which will have to work as mini libraries. And, of course, the smartphones will perform with signals from towers or satellites. The need for power and signals for smartphones brings us back to infrastructure. Along with power, the villages will need roads, which must lead to highways and railway lines so that youngsters can easily go to coaching schools to prepare for competitive examinations and those who

do well can go and live in towns where better jobs are offered.In sum, the government still has to keep financing capital investment and infrastructure. Even after this much-belated rebalancing, described as RB-1.0, we have just around 30 per cent force level deployed against China, our main adversary on the northern borders. Out of the balance, 30-40 per cent is deployed to combat the proxy war in J&K.

Notwithstanding the recent agreement on the restoration of patrolling in Depsang and Demchok, it is imperative to maintain vigil and enhance the deployment levels. The army is reportedly working on RB-2.0. The critical determinant for such rebalancing is whether the designated forces — the Central Armed Police Forces (CAPFs) and police would rise to the challenge and free the army for addressing the primary challenge. The CAPFs, with around 10,45,750 personnel, comprise seven formidable forces for maintaining law and order, internal security (IS) and counter-insurgency (CI) and protecting the borders. They can be broadly grouped as per their functions. The Central Industrial Security Force (CISF) is meant for industrial and airport security. The Ministry of Railways also has a 75,000-strong Railway Protection Force (RPF). The question is whether the overburdened Ministry of Ĥome Affairs (MHA) should give control of the CISF to the designated ministries of aviation and industry, like the RPF. The Central Reserve Police Force (CRPF) is mandated to beef up the state police forces for maintaining law and order and internal security. It was created as a reserve to the state police forces. Besides the regular constabulary, most states have around 10 armed police battalions, funded by the Central government, with a shared understanding

-

on their deployment. These are also referred to as the Rapid Action Force (RAF). Then, there are the Border Security Force (BSF), the Indo-Tibet Border Police (ITBP), the Sashastra Seema Bal (SSB) and the Assam Rifles (AR). Their mandate is border management (BM). The Kargil Review Committee in 1991 had enunciated the principle of 'one border, one force' for border management and it recommended

that the CRPF be dedicated for internal security. Consequently, rationalisation was attempted: the BSF for Pakistan and Bangladesh, the ITBP for China, the SSB for Nepal and Bhutan and the AR for Myanmar.

Each border has its own challenges. There is the problem of narcotics delivery by drones in Punjab, cattle and human trafficking on the Bangladesh border and terrorist intrusions in J&K. The Pakistan border is properly fenced in the International Border (IB) sector and has a modified fencing along the Line of Control (LoC). The Bangladesh border is approximately 80 per cent fenced, but it has treacherous riverine and jungle stretches. Except for the 60-odd km out of 1,643 km, the border with Nepal, Bhutan, Tibet — the Line of Actual Control (LAC) — and Myanmar is unfenced.Border management has two categories: border guarding or patrolling on

settled borders and border defence on active frontiers (LoC and LAC), where the BSF and ITBP work in supportive role with the army.

The Assam Rifles is dual-tasked for the Myanmar border and the counter-insurgency role in the NE. It is paramilitary in nature as the officer cadre is from the army on a deputation basis. The challenges of managing internal security and counter-insurgency are such that battalions of the CRPF, BSF, ITBP, SSB

and AR are deployed in Manipur, reflecting the firebrigade response of mustering whatever and whoever is available.

The force mix in J&K is similar, though the Rashtriya Rifles (RR), CRPF and J&K Police have become the main components. However, the recent induction of Assam Rifles units in J&K is indicative of the firefighting approach. The reputation of the AR — the



original mainstay of North-East — has been tarnished in Manipur. It is not only unfortunate but also shortsighted. If there are black sheep in a force, fix them by all accounts, but why trash the 189-yearold legacy?The National Security Guard (NSG) or Black Cat Commandos are on the other end of the spectrum. They do specialised counter-terrorism work, including hostage rescue.The combined strength of the CAPFs and the armed police

battalions matches that of the army in numbers. They also enjoy similar benefits in pay and perks and wear a similar uniform. They have recently even created similar sounding HQs, like the Command HQ, further adding to confusion. The first and foremost requirement is empowerment of the CAPFs for their designated roles. It is predicated on the implementation of the police reforms recommended

by the Prakash Singh Committee. They have been duly reiterated by the Supreme Court.While the states have not implemented the suggested reforms, the Union government can set the pace for empowering the CAPFs and police in states ruled by NDA governments.Next, the CAPFs have roles that require specialisation and force ethos. The use of the CAPFs as a cadre management avenue for senior ranks in the IPS needs to be reviewed. Para-dropping in CAPFs at apex ranks and shifting of DGs degrade cadre cohesion. The CAPFs must have their own integral cadres, like the Coast Guard. The army, too, should yield control of the Assam Rifles.

Regarding the border defence role, the BSF on the LoC and the ITBP on the LAC should operate under the undiluted operational control of the army.

- Additionally, the large-scale deployment of the CAPFs for elections has impacted their availability for other mandated tasks. The electoral process should be made less dependent on the CAPFs, with the police and Home Guards shouldering the challenge.
- The influx of infiltrators as an electoral issue has resulted in the counter-accusation that border management is ineffective and porous.

बचाव के उपाय – डॉक्टर संजय के अनुसार जब टंड ज्यादा बढ़ जाए तो उससे बचने के लिए कुछ बातों का ध्यान रखना जरूरी है। सुबह टहलने वाले लोग मौसम के अनुकूल अपने समय में बदलाव करें। ज्यादा सुबह न निकलें। ज्यादा दूरी तक न टहलें। जो लोग ब्लडप्रेशर, हार्ट, शुगर आदि के मरीज हैं वे डॉक्टर से जरूर सलाह लें।

खाने में क्या लें – मौसमी फल, सलाद एवं आंवले जरूर लें। सलाद में भी प्याज एवं टमाटर ज्यादा से ज्यादा लें।

लक्षण – जब अपने शरीर में अप्रत्याशित बदलाव महसूस करें । जैसे ज्यादा पसीना आना, घबराहट, चक्कर आना एवं सीने में दर्द महसूस होना । पेट खराब एवं उल्टी होना ठंड लगने के लक्षण हैं । जैसे ही इसका अहसास हो, डॉक्टर के पास तुरंत जाएं ।

आमतौर पर लड़कियों का वजन शादी से पहले तीन कारण से बढ़ता है– भागदौड़, तनाव और लगातार पार्टी। इसी तरह शादी के बाद वजन बढ़ने के तीन मुख्य कारण हैं– प्रेग्नेंसी, शादी के बाद परिवार, घर और अन्य जिम्मेदारियों में इतना व्यस्त हो जाना कि खानपान पर ध्यान न दे पाना, पति के साथ उनकी तरह ही पोर्शन लेना, जाने–अनजाने वे एक्स्ट्रा कैलोरी ले लेती हैं। एक बार फैट शरीर पर चढ़ने लगता है तो उसे रोकना काफी मुश्किल होता है। बेहतर होगा अगर पहले से ही खानपान की कुछ आदतों पर अमल किया जाए और डाइट प्लान बनाया जाए। अगर आप शादी से पहले और बाद में अतिरिक्त वजन को हटाना चाहती हैं तो यहा दी गई बातों पर गौर फरमाएं।

शादी से पहले

अपने दिन की शुरुआत नींबू मिले गर्म पानी से करें।
इसमें ऋश किए हुए पुदीने के पत्ते भी मिला सकती हैं।
जब भूख लगे सूप या जूस पिएं।

 लंच/डिनर में होलग्रेन सीरियल, दालें या ग्रिल्ड फिश या चिकेन के एक टुकड़े के साथ लो फैट प्रोबायोटिक दही, सलाद और एक बोल स्टीम्ड रंगीन सब्जिया लें।

- शादी से एक महीने पहले अचानक पांच किलो वजन घटाना भी ठीक नहीं है। अगर ऐसा चाहती हैं तो इसके लिए आपको शादी से छह महीने पहले अपने आहार पर ध्यान देना होगा। इसका सीधा असर आपके बाल और त्वचा पर पडेगा।

Australian Open 2025: Seventh seed Novak Djokovic retired from his semi-final match against Alexander Zverev at the Rod Laver Arena after losing the first set.

New Delhi On Thursday, Djokovic, reportedly, also cancelled his training session, mostly as a precautionary measure before the all-important semi-final. In the match against Zverev, Djokovic again came in with his leg taped-up. This time around, after he couldn't come up trumps in the first set, he decided to throw in the towel. In the first set, Djokovic got three chances to break Zverev's serve, but could not convert any of them. Zverev dominated him with eight aces and 24 winners, but Djokovic managed to hold his nerve and take the set into a tiebreak.

At 6-6, it was even stevens before Djokovic lost the set after an unforced error. Djokovic was looking for his 11th title in the hard court



major and his 100th win in the Australian Open, but the veteran has to wait for a year to achieve the landmarks.Djokovic has had his fair share of trouble with injuries in the last 12 months. Last year at Roland Garros, he withdrew due to a right-knee injury ahead of his quarterfinal match against Casper Ruud. He also missed the ATP Finals in Turin, Italy, due to an injury.As far as Zverev is concerned, he advanced to his maiden final at Melbourne Park. In the summit clash to be held on Sunday, January 26, Zverev will be up against the winner of the second semifinal between World No.1 Jannik Sinner and USA's Ben Shelton.Back in 2020, Zverev lost to Dominic Thiem in the US Open final. Last year, it was Alcaraz who got the better of him in the grand finale of the French Open. Zverev will be looking to come out on the winning side in his third appearance in a final at Grand Slams.

I never liked such words. He was giving me a threat. Aaj ke baad, tujhe kabhi khilaunga nahi. Wasim Akram also came in. He was our bowling coach, so he calmed things down. He said 'You are the captain. Cool down' He understood, he knew what was happening. He had said good things about my talent a few years ago," Tiwary said.Gambhir, who now serves as India's head coach, has often been a divisive figure in cricket. His no-

nonsense attitude and strict approach have drawn criticism from players and commentators alike. Recently, Tiwary openly criticised Gambhir's appointment as head coach following India's Test series defeats to New Zealand and Australia.
