Who Lost, Who Won After Selloff Linked To DeepSeek Slams Markets

World. The world's 500 richest people, led by Nvidia Corp. co-founder Jensen Huang, lost a combined \$108 billion on Monday as a tech-led selloff tied to Chinese AI developer DeepSeek sent major indices plunging. Billionaires whose fortunes are linked to artificial intelligence were the biggest losers: Huang saw his fortune fall \$20.1 billion, a 20% drop, while Oracle Corp. co-founder Larry Ellison's \$22.6 billion loss was larger in absolute terms, but represented just 12% of his fortune, according to the Bloomberg Billionaires Index. Dell Inc.'s Michael Dell lost \$13 billion, and Binance Holdings Ltd. co-founder Changpeng "CZ" Zhao shaved \$12.1 billion.Tech-sector titans as a group saw \$94 billion of wealth evaporate - roughly 85% of the Bloomberg index's total decline. The Nasdaq Composite Index fell 3.1%, and the S&P 500 dropped 1.5%

Hangzhou-based DeepSeek has been developing AI models since 2023, but the company first came onto the radar of many Western investors this weekend as its free DeepSeek R1 chatbot app topped download charts worldwide. So many new users piled in that DeepSeek struggled to keep the app online, suffering outages and forcing it to restrict signups to users with Chinese phone numbers.DeepSeek's dark-horse entry into the AI race, which it says cost just \$5.6 million to develop, is a challenge to Silicon Valley's narrative that massive capital spending is essential to developing the strongest models. That delivered a serious blow to billionaires whose fortunes are tied to the Western AI supply chain that's been the equities market's biggest driver over the past two

Similar Playbook

Soaring valuations for so-called AI hyperscalers including Meta Platforms Inc., Alphabet Inc. and Microsoft Corp. - have generated billions in wealth for their owners since OpenAI unveiled ChatGPT in November 2022. These companies have for the most part operated on a similar playbook: Spend huge sums to develop and run AI systems by hoarding topof-the-line semiconductors and the energy supplies needed to run them.

Astronomers Discover How Massive Black Holes Create Their Own Meals

World. The universe's most massive black holes fuel themselves by cooling gas around them, astronomers have found. Using data from NASA's Chandra X-ray Observatory and the Very Large Telescope (VLT) in Chile, researchers have demonstrated how black hole outbursts trigger a self-sustaining feeding process.

The study, published in Nature Astronomy and led by Valeria Olivares from the University of Santiago de Chile, examined seven galaxy clusters. At the centres of these clusters lie enormous black holes, weighing millions to billions of times the Sun's mass. These black holes feed on surrounding gas, releasing powerful jets that cool the gas and form filaments.

The research found that outbursts from black holes cool hot gas, forming narrow filaments of warm gas visible as glowing threads. Turbulence in the gas plays a key role in this cooling process. Some of the warm gas flows back into the black hole, fuelling more outbursts and continuing the cycle.

One key discovery was that the brightness of hot gas is linked to the brightness of warm gas in the clusters' centres. When the hot gas shines brighter, the warm gas glows more intensely, confirming how black holes feed on surrounding gas.

Two galaxy clusters - Perseus and Centaurus - offer a striking visual of this phenomenon. Perseus Cluster: The hot gas appears bluish-purple with solid pink filaments, while surrounding galaxies shine brightly. Centaurus Cluster: The gas has a softer, diffused look,

with filaments showing delicate, feathery textures. Both clusters display central black holes surrounded by glowing filaments of gas, a visual representation of the self-sustaining feeding mechanism. The study noted similarities between the gas filaments in galaxy clusters and the tails of "jellyfish galaxies," where gas is stripped as galaxies move through their surroundings. This unexpected connection suggests a shared process across different cosmic phenomena.

The research brought together experts from Chile, the US, Australia, Canada, and Italy, leveraging advanced tools like the VLT's MUSE (Multi Unit Spectroscopic Explorer) instrument to create 3D views of the universe. NASA's Chandra programme, managed from Alabama, provided the X-ray data critical to this discovery.

'Will deport illegal immigrants': Indian-origin Ruby Dhalla after joining Canada PM race

She officially entered the race to replace Justin Trudeau as the Liberal Party leader and potentially the next prime minister of Canada.In another post, Dhalla shared a video on X, where she said, "Thank you so much, thank you to God, I am so grateful to all of you. We are on the verge of creating history by electing the first woman of color as the leader of the Liberal Party and the next prime minister of Canada." Dhalla also added. "Phase 1 is over, we go on to phase 2 and engage with liberals all across the country, who have signed up as members of our party. I'm incredibly excited to be officially accepted as a candidate by the Liberal Party. My candidacy will engage an entirely

US Immigration officers say 'the worst go first,' but now there's no 'free pass'

Trump's second presidency and his efforts to crack down on illegal immigration, federal officers are operating with a new sense of mission, knowing that "nobody gets a free pass anymore."A dozen officers from Immigration and Customs Enforcement gathered before dawn Monday in a Maryland parking lot, then fanned out to the Washington suburbs to find their targets: someone wanted in El Salvador for homicide, a person convicted of armed robbery, a migrant found guilty of possessing child sexual abuse material and another with drug and gun convictions. All were in the country illegally."The worst go first," Matt Elliston, director of ICE's Baltimore field office, said of the agency's enforcement priorities. The Associated Press accompanied the officers, who offered a glimpse of how their work has changed under a White House intent on deporting large numbers of immigrants living in the US without permission. People considered public safety and national security threats are still the top priority, Elliston said. That is no different from the

Biden administration, but a big change has already taken hold: Under Trump, officers can now arrest people without legal status if they run across them while looking for migrants targeted for removal. Under Joe Biden, such "collateral arrests" were banned."We're looking for those public safety, national security cases. The big difference being, nobody has a free pass anymore," Elliston said. The number of collateral arrests has fluctuated, he said. By the end of Monday across Maryland, ICE had arrested 13 people. Of those, nine were targets and the other four were people ICE came across during the course of the morning.f those "collaterals," one had an aggravated theft conviction. Another had already been deported once, and two others had final orders of removal. Changes to

immigration enforcement under Trump The administration highlighted the participation of other agencies in immigration operations over the weekend, including the FBI, the Drug Enforcement Administration and the Bureau of Alcohol, Tobacco, Firearms and Explosives, which



are part of the Justice Department.

Emile Bove, the acting deputy attorney general, observed arrests Sunday in Chicago, a sign of the Justice Department's growing involvement.ICE's daily arrests, which averaged 311 in the year ending Sept. 30, stayed fairly steady in the first days after Trump took office, then spiked dramatically Sunday to 956 and Monday to 1,179. If sustained, those numbers would mark the highest daily average since ICE began keeping records. Trump also has lifted longtime guidelines that restricted ICE from operating at "sensitive locations" such as schools, churches or hospitals. That

China Zoo Sells Tiger Urine As A Cure For Rheumatism, Sparks Backlash

World. A zoo in southwestern China's Sichuan province has raised safety concerns by selling tiger urine as a purported treatment for rheumatism. The Yaan Bifengxia Wildlife Zoo, a popular tourist attraction, is offering bottles of "medicinal tiger urine" from Siberian tigers for 50 yuan (Rs 596) each, South China Morning Post reported. The bottles, containing 250g of urine, claim to have a therapeutic effect on conditions like rheumatoid

arthritis, sprains, and muscle pain. The recommended application involves mixing the urine with white wine and applying it to the affected area with ginger slices. According to the zoo's instructions, the tiger urine can also be consumed orally, but users are advised to stop taking it if they experience any allergic reactions.

A staff member from the scenic area revealed to The Paper that the urine is collected from a basin after the tiger urinates, but it remains unclear whether the urine undergoes any disinfection process before being sold to customers The staff member disclosed that sales

In 2014, the zoo allegedly awarded tiger urine as a prize to celebrity contestants on an outdoor reality show. pharmacist from Hubei Provincial Traditional Chinese Medicine Hospital has since come forward to debunk the medicinal claims surrounding tiger urine. 

There were no raids or any law enforcement actions at other Gurdwaras in New York and New Jersey either, said Mr Nijjar who is with the Sikh Cultural Society representing the Coastal Northeast and was the chairman of its public and media committee.He attributed the misreporting to "some sort of misunderstanding and miscommunication" and "just basically word of mouth type of thing that" gets

New York. Sikh community leaders have Rajwant Singh, the chairman of the Sikh Council on Religion and Education, discounted the reports of the raids or visits to the temples by immigration or other agencies. The Sikh community in New York and New Jersey has good relations at "all levels of government representatives, including the Justice Department and the White House", he said. The community has "contributed immensely to the local life and has helped many people during COVID and the service continues" and that is appreciated, Mr Singh said.Mr Nijjar said that Gurdwaras have good relations with government agencies and his own temple, for example, holds regular meetings with officials who visit at the Gurdwara's invitation to discuss community matters.President Donald Trump's administration last week withdrew a policy against

US President Donald Trump's brash populism has always involved incongruence: the billionaire businessmanpolitician stirring the passions of millions who, regardless of the economy's trajectory, could never afford to live in his Manhattan skyscraper or visit his club in south Florida. His second White House is looking a lot like the inside of Mar-a-Lago, with extremely wealthy Americans taking key roles in his administration.

The world's richest man, Elon Musk, is overseeing a new Department of Government Efficiency. Billionaires or mega-millionaires are lined up to run the treasury, commerce, interior and education departments, NASA and the Small Business Administration, and fill key foreign posts."He's bringing in folks who have had great success in the private sector," said Debbie Dooley, an early 2015 Trump supporter and onetime national organizer in the anti-establishment Tea Party movement. "If you need to have brain surgery, you want the proven brain surgeons." Others raise concerns about conflicts of interest at odds with Trump's

pledge to fight for "forgotten men and women" in a country where the median household net worth is about \$193,000 and median annual household income is about



ISRO Set to Mark 100th Launch with GSLV F-15 Carrying NVS-02 Satellite



Sriharikota: Indian Space Research Organisation (ISRO) is set to achieve a major milestone with its 100th launch on Wednesday, marking a significant moment in India's space exploration history.

At 06:23 AM, the GSLV F-15 rocket will lift off from the Satish Dhawan Space Centre in Sriharikota, carrying the NVS-02 navigation satellite into the Geosynchronous Transfer Orbit (GTO).

The NVS-02 satellite is part of

the second-generation Navigation with Indian Constellation (NavIC) system.

NavIC is India's regional navigation satellite system designed to deliver precise Position, Velocity, and Timing (PVT) services to users within India and up to 1,500 km beyond its borders. This launch will further enhance India's navigation capabilities.

The GSLV-F15, which is equipped with an indigenous cryogenic stage, will be the

eighth operational flight of the GSLV series.

Tomorrow's mission also marks the 100th launch from ISRO's spaceport at Sriharikota, underscoring the country's growing presence in space technology.

Dr. V. Narayanan, Chairman of ISRO, expressed his excitement for the upcoming milestone. Earlier in the day, the ISRO Chairman visited the Tirumala Temple to offer prayers for the success of the mission.

Jharkhand DGP Issues Guidelines to Combat Fraudulent APK Apps in Cybercrime

Ranchi: Jharkhand's Director General of Police (DGP) Anurag Gupta has issued important advice to Superintendents of Police (SPs) on how to protect against fraudulent APK (Android Application Package) apps that are used in cybercrime.

He also encouraged the SPs to share these tips with the public to help raise awareness about the issue.

The DGP's guidelines were shared during a review meeting held at the State Police Headquarters, where discussions focused on security measures related to fake APK apps. APK files are used to distribute and install apps on Android devices, but cybercriminals often hide malware and viruses in these files, making them look like legitimate applications. When users unknowingly download these apps, the criminals can steal personal information, access banking details, and even gain remote control of devices to carry out their crimes.

During the meeting, the SP of Jamtara gave a presentation on strategies to combat cybercrime, explaining how these fraudulent apps operate.

DGP urged SPs to share this information with the public and take action to protect users from these threats.

To help people stay safe, DGP Gupta advised downloading apps only from trusted sources like official app stores, installing reliable antivirus software on devices, and

avoiding apps from unverified sources. He also recommended keeping systems updated regularly and being cautious when using public Bluetooth or Wi-Fi.

People were advised to be cautious about suspicious calls, advertisements, or links and to turn off automatic downloads on their devices.

Finally, the DGP encouraged everyone to participate in police-run awareness campaigns aimed at preventing cy-

'One Nation, One Time'

India to Enhance Time Accuracy with NavIC-Linked Atomic Clocks, Boosting Efficiency and Security Across Critical Sectors

New Delhi: India is set to overhaul its timekeeping system, transitioning from GPS-based synchronization to a more precise method using the Navigation with Indian Constellation (NavIC) linked with atomic clocks. This shift, expected in the coming months, will ensure that Indian Standard Time (IST) is maintained with millisecond accuracy through a network managed by the National Physical Laboratory (NPL).

The NPL, located in Faridabad, will receive reference time directly from NavIC satellites. This time will be distributed through optical fibre links to regional centres in Ahmedabad, Bengaluru, Bhubaneswar, and Guwahati. Each of these centres is equipped with atomic clocks to maintain ultra-accurate time. Once fully operational, devices

such as smartphones and lap-

tops will rely on this unified time system rather than pulling data from various GPS-linked sources. This move is part of the government's plan to establish "one nation, one time," bringing greater consistency and preci-

sion to timekeeping across the ready been completed. Atomic clocks are now installed at four

The initiative was conceived af-

ter the Kargil War when India's reliance on foreign satellite data highlighted the need for an independent navigation system. The project has been under development for approximately seven years, and most of the technical groundwork has al-

regional centres, with a successful test of the NavIC link with NPL conducted a few months

Currently, work is underway to align the clocks across all centres with the Faridabad facility, with adjustments being made to account for any data transfer delays via optical fibre cables.

Atomic clocks, known for their unmatched precision, lose only one second every 100 million years, making them ideal for this project.

Critical sectors like power grids, telecommunications, banking, defense, and transportation will greatly benefit from synchronized operations, improving efficiency and resilience against cyber threats. Additionally, new draft rules have been issued, making IST the official time reference for legal, administrative, commercial, and official purposes across the country. However, exceptions will apply to fields like astronomy, navigation, and scientific research, with prior government approval required.

Penalties will be imposed for violations of these new rules, ensuring compliance with the updated time standard.

Trump says PM Modi may visit US next month after 'productive' phone call

New Delhi. A day after accusing Haryana of mixing poison in the Yamuna river that supplies water to Delhi, the AAP government has doubled down on its charge and taken up the issue with the Election Commission. Delhi Chief Minister Atishi said this morning the water is no longer treatable and sought the poll body's intervention.

"Ammonia levels continue to be 6 times above normal in Yamuna waters, at the point it is entering Delhi from Haryana. Such levels are extremely toxic for the human body. This water cannot be treated and supplied to the people of Delhi. Otherwise, their lives will be at risk," said the Chief Minister.

Harvana had denied the AAP's charges and threatened them with a defamation case. Atishi said in her letter that the water treatment plants belonging to the Delhi Jal Board can treat ammonia up to 1 ppm level but ammonia levels in the water coming from Haryana to Delhi are



700% above the treatable limit. This has curtailed the water supply in the city by 15-20%, she said, warning that high levels of ammonia in drinking water can lead to a public health crisis and cause kidney damage.

The Chief Minister had alleged yesterday the BJP resorted to such a drastic step out of fear of losing the upcoming elections. "In Hinduism, there is no bigger sin than stopping water. The people of

Delhi will answer the BJP for this sin on February 5," she had said.

Arvind Kejriwal, the AAP chief, added the BJP wants to keep the people of Delhi thirsty for its "dirty politics", and nothing could be more disgusting than this. "The poison that is being mixed in water and sent cannot even be cleaned in the water treatment plant. For the safety of the people of Delhi, water supply has to be stopped in many areas," said the AAP boss who has promised to return as the Chief Minister if his party wins the February 5 elections.



In memory of our Amrita, the legend

Hungary and India have two common icons. First, someone who is noted in academic circles though somewhat little known outside: the scholar Korosi Csoma Sandor, better known as Csoma de Koros. His connection with the Himalaya was strong and intimate. He travelled and lived in Ladakh and was perhaps the first European to visit and write about Zanskar. In 1827, he moved to the secluded monastic village of Kanum, in today's district of Kinnaur, where he lived for more than three years. A tradition, though unverifiable, maintains that while going through the ancient manuscripts at Kanum, his hands would freeze in winter's bitter cold and often had to be prised open. Among his many accomplishments was the first Tibetan-English dictionary. The second person is someone many of us know about: Amrita Sher-Gil, whose Hungarian mother, Marie Antoinette Gottesmann, was an opera singer. The father was Umrao Singh Sher-Gil of Majitha — who apart from an aristocratic lineage, was one of the pioneers of photography in India, especially portraits.

We all like our little place in the sun. Even if this comes from an all-too distant and a rather wobbly hook to hang one's claim to fame. For the moment, it comes from the flimsy fact that the venerable Amrita Sher-Gil and I share the same date of birth, in late January. That priceless nugget was pointed out a couple of years back when the Liszt Institute of the Hungarian Embassy to India was holding a celebration of the artist's work. During the course of conversation with the institute's director, one learnt that they did not have access to an absolutely wonderful copy of the long-gone art magazine, The Usha. In undivided Punjab, this was published by the Panjab Literary League from Lahore. Brilliant, but short-lived, the magazine was edited by HL Prasher and DR Chaudhri. The issue of August 1942 was devoted to the remarkable Amrita Sher-Gil who, in her short life, was to impact the art of India and even overhaul some of it. As I have the treasure, one was only too happy to make a copy and send it to the institute, which I'm sure must have put it to better use than it loitering on my bookshelves. On December 5, 1942, Amrita passed away at the age of 28. Barely three days before this, she and one of the editors of The Usha, HL Prasher, had met. She was full of laughter and 'was talking merrily'. She discussed her forthcoming exhibition. Someone suggested that if she really wanted to enjoy the remarks made by visitors to her exhibitions, she should come in disguise and remain incognito. Amrita liked the idea, but the problem was: "What disguise should she choose?" Prasher, tongue in cheek, suggested that she should come dressed as a young Sikh, complete with a turban, moustache and a beard. A pair of spectacles could be thrown in for good measure. That did not happen.

Amrita's parents were in Shimla when a telegram arrived saying that their daughter was very ill. Umrao Singh and Antoinette rushed up to the Summer Hill post office, which was a bare couple of hundred yards from their house, and set up a trunk call to Lahore. At night, another telegram was delivered saying that Amrita had passed away. A heartbroken Umrao Singh Sher-Gil wrote on the death of his daughter: "During those 10 days (after Amrita's death), I often gazed on a watercolour miniature of the Kangra School which Amrita had left on the mantelpiece. It represented a young woman, walking gaily with head averted, oblivious of two deadly snakes lying right in the pathway in front of her. It seemed to me that it symbolised the last phase of her own life in coming to Lahore with buoyant hopes, not aware of death which lurked for her there."After completing the first draft of this piece, one put it aside and started looking for something more on The Usha. Instead, one ended up going down one of the Internet's wormholes to arrive at a crater on the planet Mercury. In 2016, the International Astronomical Union named it in honour of Amrita Sher-Gil. This piece of information led to a revision of what one had written and then, one could not but help continuing along a road that had found a bifurcation. Whenever I am in Delhi, among the few things one tries to do, is visit the National Museum of Modern Art.

IN the merry-go-round world of global politics, here's how the cookie is crumbling this week. US President Donald Trump has told Fox News that he spoke to Chinese President Xi Jinping last week, just before his inaugural, on "Tiktok, trade and Taiwan" and that the conversation was friendly. Now we know that Trump had invited Xi to his inaugural too, but Xi sent Vice-President Han Zheng instead. Moreover, Trump has since both called off his proposed ban on Tiktok as well as his campaign harrumph on imposing tariffs (as high as 60 per cent) on China. We also know that Indian officials in the embassy in Washington DC had requested the Trump transition team, on the eve of the inaugural, for an invite for

Prime Minister Modi to attend. But Trump's men remonstrated, saying there was too much happening and not enough time — some such excuse.Instead, they gave External Affairs Minister S Jaishankar a front-row seat to all the goings-on that afternoon. (No one knows where Han Zheng sat.) The Americans, keenly aware that perception is half of any foreign policy success, also organised a Quad meeting the day after — it sent a message to the Chinese that you may be snapping at our heels, but hey, we have India, Australia and Japan in our pack.

The bigger message to everyone, especially India, is that Naya America has no problems talking to anyone — it's enough to look around you and notice how nations are changing friends faster than the flow of the Ganga at the Maha Kumbh. One month ago, Trump was threatening hell or high water with Xi — he is now purring like a

Siamese cat. And earlier this week, a team from Pakistan's ISI establishment flew to Bangladesh, for the first time since 2009 — mere days after a Bangladeshi military delegation led by Lt Gen SM Kamrul Hassan, the Principal Staff Officer of the Armed Forces Division, flew to Islamabad.In the middle of this churning, the only bond that has remained steadfast is the one that both sides define as being "higher than the mountains, deeper than the seas and sweeter than honey" — the one between Pakistan and China. So dear Reader, as you watch the earth turn on its axis, watch also the shrivelling of old allegiances and the thrill that comes with building new ones. In Punjab, you cast off the old and the unwanted at Lohri, because at Makar Sankranti, when the month of Magh unveils itself, a new world awaits. See what Magh has heralded for

and China, an underlining of old ties between China and Pakistan as well as an unusual intimacy between Pakistan and Bangladesh — they were part of one country, after all, once upon a time, until the world shifted in 1971 and a new nation was born. Now the world is shifting again. It's clear that the ISI is in charge of Bangladesh. Chief Adviser Muhammad Meanwhile, it's a good thing too that PM Modi is Yunus has turned out to be a 'mukhauta' who has played his role as saviour to the hilt — it doesn't matter if and when he moves on, Pakistan has won the latest round in the great game unfolding once again in South Asia. 
Pakistan for a number of reasons. Cross-border terrorism, anyone?

Punjab needs proactive steps, not band-aids



Nabha is a grim reminder of the growing menace. The problem is rooted in unregulated garbage dumps and sites like 'hadda rodi", where animal remains are carelessly discarded, creating a haven for feral dogs. Urban eateries dumping bones and meat waste add fuel to the fire, making

the problem even worse. The authorities appear more reactive than proactive. While the Nabha SDM has



ordered vaccinations and awaits reports, this piecemeal approach won't solve a crisis of this magnitude. Punjab needs a comprehensive action plan involving sterilisation

drives, waste management reforms and education campaigns. Without this, incidents like Nabha will only multiply.

For victims, this lapse is a double blow: suffering both physical trauma and bureaucratic indifference. As rising numbers of canine fury point to a silent emergency of epidemic proportions, Punjab must act decisively. It must collaborate with municipal bodies, health authorities and animal welfare groups to make cities safer for people and animals alike.

How our betis are faring, 10 years on

More attention needs to be paid to enforcing the legal age of marriage and incentivising births after 20 years.

As the Beti Bachao, Beti Padhao (BBBP) initiative becomes 10 years old, an evaluation of the programme leading to the ideal child sex ratio and promoting the empowerment and education of the girl child is fitting. According to the government press note issued on the 10th anniversary of the BBBP, the sex ratio at birth (SRB) has improved from 918 in 2014-15 to 930 in 2023-24. Also, the girls' enrolment in secondary education has improved from 75.5 per cent to 78 per cent during the same period. Additionally, women have been empowered through skilling, economic initiatives and widespread community engagement. While saluting these achievements, one must step beyond to understand how much women's lives have changed, for the better or worse. Comparisons need data and India relies on different surveys and data bases. They include the civil registration system, the sample registration system (annual) and the National Family Health Surveys (NFHS). The NFHS surveys (2015-16 and 2019-21) are the most reliable sources to compare and comment on wider issues as they provide a rich source of information. Because, after all the numbers are crunched and digested, ultimately, the true barometer of women's progress is their status in society. While measuring this, some things matter more than the others. One of the important determinants is her age at the time of marriage. This is because it is her health and her understanding of both childbearing and child-rearing that has an impact on generational health. The first questions that should stem from BBBP is whether the age of marriage of girls has gone up and whether teenage pregnancies have come down. This is because girls who marry young remain socially isolated and are denied the fruits of education.Despite the Prohibition of Child Marriage

Act (2006), the practice of child marriage remains widespread. Though the NFHS data reveals a decline in child marriages, their number remains high. Child marriages have reduced from 47 per cent (in 2005-06) to (26 per cent) in 10 years and in the next five years, to around 23 per cent. Given the size of our country, 23 per cent is still unacceptably

While more girls may have been saved from being aborted, the benefits of poshan (nutrition) and padhai (education) would have eluded most girls who were married before 18. Because, among other factors, it is in the teenage years that anaemia is at its peak and has cascading effects on the patient's health.

The second important goal that BBBP has rightly focused on is curbing the practice of female foeticide. What is the status on that? The ideal child sex ratio, according to the WHO, is 950 girls to 1,000 boys. As per the latest NFHS-5 data, the ratio has gone up from 919 girls to 929 girls for every 1,000

boys born. This is good progress, but the data for many states remains far from satisfactory. According to figures released by the Government of Haryana, the sex ratio was recorded at 905 girls for 1,000 boys in the first 10 months of 2024. The districts of Gurugram (859), Rewari (868), Charkhi Dadri (873), Rohtak (880), Panipat (890) and Mahendragarh (896) were the worst performers, all recording a below-900 sex ratio. Despite economic progress, many Haryanvis still want sons. Exhortations alone will not change the overall picture of saving the girl child.A declining sex ratio means that female foetuses are being killed in the womb. Several other



states also have a child sex ratio less than 932, as per the NFHS-5. They include Rajasthan, Jharkhand, Punjab, Telangana, Maharashtra, Bihar, Goa, Himachal Pradesh, Odisha and Tamil Nadu. Delhi and Chandigarh, too, have adverse sex ratios.It shows that education and wealth, if anything, exacerbate the demand for sex determination, underscoring the craving for sons. At the same time, there has been a perceptible improvement in states like Andhra Pradesh, Uttar Pradesh, Gujarat, Madhya Pradesh and West Bengal. They are hovering nearer the WHO ideal. It indicates how much of the progress rests with the state leadership. A right-thinking chief minister can do wonders by giving primacy to BBBP

and related health programmes.

It is a matter of comfort that the Health Ministry has extended the National Health Mission by five years. Started in 2005, the NHM has done more to improve the health indicators of women than any other programme. Among the achievements relevant in the context of women's status is the decline of India's fertility rate to below the replacement level. Though it is cause for fresh worry about what will happen to the states that are aging, the plus side is that except for the identified districts mainly in Uttar Pradesh and Bihar the days of unwanted and repeated child births are over. It is a great blessing for women.

Side by side, institutional births, that is births under medical supervision, have increased phenomenally. An institutional birth benefits women hugely as it ensures that they undergo

antenatal check-ups and are sensitised and skilled in spacing out children, which also staves off unwanted pregnancies. As a result, maternal and infant mortality have reduced substantially. The increase in poorer households' access to clean drinking water, improved sanitation (toilets) and clean cooking fuel have also impacted women's lives for the better. Though they may not be directly related to BBBP, they give much reason for satisfaction. Taking the important indicators into account and without making BBBB a separate vertical silo, it is apparent that women's status has improved. The question is how much and in what respect.

नयी दिल्ली। सोने के वैश्विक बाजार की निगह रखने वाले संगठन गोल्ड (डब्ल्यूजीसी) ने आगामी बजट में सोने पर आयात शुल्क में किसी प्रकार की बढ़ोतरी न करने की सिफारिश की है और आगाह किया है कि शुल्क बढ़ने का उद्योग तथा अर्थव्यवस्था पर प्रतिकूल असर पड़ सकता है। डब्ल्यूजीसी के क्षेत्रीय मुख्य अधिशासी अधिकारी (सीईओ) सचिन जैन ने सोने पर शुल्क में पिछले कमी सकारात्मक प्रभाव उत्पन्न करने वाला फैसला बताते हुए कहा, ÷आगामी बजट में आयात शुल्क में किसी भी वृद्धि का प्रतिकूल प्रभाव पड सकता है, जिससे तस्करी में वृद्धि, घरेलू सोने की कीमतों में

वृद्धि और उद्योग को पीछे धकेलना पड़ सकता है।' उन्होंने एक बयान में कहा,





कुदरत की कारीगरी

स्नोफ्लैक्स बनने की शुरुआत छोटे-छोटे डस्ट पार्टिकल्स या पॉलेन पार्टिकल्स के वॉटर वेपर के संपर्क में आने से होती है। ये वॉटर वेपर इन पार्टिकल्स के ऊपर इकट्ठी हो जाती हैं और जब ठंडे वातावरण में ये जमती हैं तो छोटे-छोटे आइस क्रिस्टल जैसे नजर आने लगते हैं। ये छोटे-छोटे क्रिस्टल सीड्स की तरह होते हैं जिनसे स्नोफ्लैक्स का जन्म होता है। तुम्हें यह जानकर आश्चर्य होगा कि ये छोटे आइस क्रिस्टल नेचुरली अरेंज होकर हेक्सागोनल यानी सिक्स साइडेड स्ट्रक्चर बना लेते हैं। इस तरह के सिक्स साइडेड आइस क्रिस्टल ही 'स्नोफ्लैक्स'' कहलाते हैं। चूंकि स्नोफ्लैक्स के आस– पास की हवा से ये अधिक वजनदार होते हैं इसलिए कुछ समय में अपने-आप गिरना भी शुरू हो जाते हैं।



NEW DELHI. Brazilian defender Danilo has left Juventus by mutual agreement to terminate the player's contract, the Serie A club said on Monday. Danilo has scored nine goals in 213 appearances since joining the Serie A club in 2019. The Brazilian defender chose to leave the club before his contract expires in June. His last appearance in the Italian league was against Venezia in December of last year."Dear Bianconeri, I don't even know where to begin. I knew this day would come sooner or later, but one is never ready for goodbyes. Five and a half years have passed, but to me, it feels like an entire lifetime," Danilo posted on his social media."... What fills me with a sense of pride, in some way, is that I have never



changed my way of being, nor my way of defending the most important club in my history."To our fans, I apologise for the moments when I may have let you down. Never for a lack of effort, dedication, or hard work... Thank you for everything, a hug from the captain, goodbye!"

Danilo, a member of Brazil's 2018 and 2022 World Cup squads, has won one Serie A title, one Italian Super Cup and two Italian Cups with Juve.Juventus shared images of Chelsea defender Renato Veiga arriving for a medical. The 21-year-old Portuguese international is expected to join on loan. Meanwhile, Danilo, who spent 13 years in Europe and won league titles with Porto, Real Madrid, Manchester City, and Juventus, is on the move. Danilo departs one Club World Cup-qualified team for another, heading to the inaugural 32-team tournament, set to kick off on June 14 in the United States. Flamengo has been drawn into a group with Chelsea, Le3n, and Espérance. Juventus, meanwhile, will face Manchester City, Wydad, and Al Ain in their Club World Cup group.

Australian Open: Djokovic climbs in rankings, lucky loser gains big after dream run

Australian Open: Novak Djokovic climbed one place up to No.6 in the ATP rankings. Paula Badosa returned to the top 10 while lucky loser Eva Lys made her debut in the top 100 of the WTA rankings after advancing to the fourth round at Melbourne Park.

New Delhi 24-time Grand Slam champion Novak Djokovic has climbed one place up to No.6 in the latest ATP rankings. The Serb advanced after Daniil Medvedev lost two places to be ranked No.7 in the world. Djokovic currently has 3900 points to his name and is below Jannik Sinner (11830), Alexander Zverev (8135), Carlos Alcaraz (7010), Taylor Fritz (5050) and Casper



Djokovic had a heartbreaking end to the Australian Open 2025 after injury cut short his campaign. After the first set of the first semi-final against Zverev, Djokovic retired and shook hands with the chair umpire. Later, the 37-year-old confirmed that he had

a muscle tear. Diokovic was also troubled by a leg injury during the quarterfinal against Alcaraz. Germany's Eva Lys, who advanced to the Round of 16 in the hard court major, made her debut in the top 100 of the WTA rankings. Lys jumped 37 places to No.91 in the rankings. Lys went into the tournament as a lucky loser after Anna Kalinskaya withdrew due to a virus. The 23-year-old was given about 10 minutes' notice to prepare and from there on, she went on to beat Kimberley Birrell, Varvara Gracheva and Jacqueline Cristian. In the fourth round, World No.2 Iga Swiatek beat Lys 6-0, 6-1 at the Rod Laver Arena. Lys was a part of the Qualifiers where she lost to Australia's Destanee Aiava in the second round. The youngster also got a prize money of \$420,000 after her exit in the Round of 16.

Paula Badosa returns to top 10

Spain's Paula Badosa made her return to the top 10 of the WTA rankings after her impressive campaign in the Australian Open. Badosa made her maiden appearance in a Grand Slam semi-final where World No.1 Aryna Sabalenka beat her in straight sets. Eight months

Neymar, who joined Al Hilal in August 2023 for a reported fee of 90 million euros, is now reportedly on the brink of rejoining his boyhood club,

The move to the Saudi Pro League generated immense excitement as Neymar followed Cristiano Ronaldo and other global icons in heading to the Gulf nation. However,


Arriving at the Arun Jaitley Stadium on Tuesday morning, Kohli participated in multiple group running and fielding drills, and even played touches of football along
