'We Are Trying To Mainstream Mental Health', Says J.P. Nadda

Bengaluru: Union Health and Family Welfare Minister and BJP President, J.P. Nadd, said on Friday that efforts are being made to mainstream mental health in the country. He was delivering a speech during the golden jubilee celebrations of the National Institute of Mental Health and Neurosciences (NIMHANS) in Bengaluru held in the institution's auditorium. Union Minister Nadda said, "I am happy that NIMHANS is providing mental healthcare to lakhs of people, and the footfalls are increasing. About 21 lakh lab investigations

are conducted annually,

and people visit the facility from every corner of the country. This demonstrates the care and quality services ensured NIMHANS."He further highlighted that NIMHANS is ranked among the top 200 hospitals in the world.

"This is one of the first institutes of national importance to receive NABH accreditation, which speaks volumes about the patient care provided," Nadda said while praising the hospital. Under the visionary leadership of Prime Minister Narendra Modi, the Union government initiated the National Men-



tal Health Programme in 2022."As part of this initiative, we are refocusing efforts to mainstream mental health and position the country as a primary service provider in this field," Union Minister Nadda added."We understand that along with infrastructure, human resources are also limited. These limited resources need to be developed,

and we must ensure that India becomes a leading mental healthcare provider. An important step in this direction is the introduction of Tele Manas. Currently, there are 53 centres across India, and NIMHANS has trained 2,000 counsellors. Keeping India's diversity in mind, counselling is offered in 20 different languages, ensuring swift and effec-

tive communication," he said."Annually, more than 1,000 students are trained for Tele Manas at NIMHANS. I want to assure the President that NIMHANS will follow her guidance in letter and spirit as we move forward," added."When we complete 50 years, it's a time for celebration but also an opportunity to set a new direction and introspect. She said that often the health issues of girls and women are ignored in comparison to boys and men."Any such delay, especially in the case of cancer, could be critical," she said. She also called for a "patient-centric and equitable, along with being world-class" healthcare system for cancer patients. Further, the President called the need to spread awareness on the causes, diagnosis and treatment of cancer, as many cases occur either due to "ignorance of the patient and family or due to financial constraints". "This delays the diagnosis and treatment of diseases, worsening the outcomes," she said. Sharing global data on cancer, the President said that in 2022, there were an estimated 20 million new cancer cases and 9.7 million deaths worldwide.

Elaborate Arrangements For PM Modi's Visit To Vizag On Jan 8


Amravati: The Andhra Pradesh government has been making elaborate arrangements for Prime Minister Narendra Modi's visit to Visakhapatnam on January 8, during which he will launch development various projects. Chief Secretary K. Vijayanand on Friday reviewed the arrangements for the Prime Minister's visit with the officials of the concerned departments through a video conference from the State Secretariat on Friday. The Prime Minister is scheduled to lay the foundation for the South Coast Railway Zone in Visakhapatnam.PM Modi will also virtually lay the foundation for the NTPC Integrated Green Hydrogen Hub in Pudimadaka of Anakapalle district. The NTPC will invest Rs 65,370 crore in this project under three phases, according to an official release by the state government. The Prime Minister will also virtually launch the

Krishnapatnam Industrial Hub.

This project, worth Rs 1,518 crore, will be set up on 2,500 acres in the first phase. The project will provide employment opportunities to about 50,000 people. Similarly, the foundation of Bulk Drug Park, which will be set up in Nakkapalli at a cost of Rs 1,876.66 crore on an area of 2,001.8 acres, will be laid virtually. With an investment of Rs 11,542 crore in this park, 54,000 people will get employment opportunities. The Prime Minister will reach the port city in the evening and will hold a road show from Sampath Vinayaka Temple to the Andhra University Engineering College grounds, where he will address a public meeting. The Chief Minister directed the officials of the relevant departments to make fool-proof arrangements for the Prime Minister's visit. Orders have already been issued by the General Administration Department regarding the steps to be taken by the departments concerned. He instructed the Visakhapatnam District Collector and Police Commissioner, as well as the officials of the concerned departments, to make all necessary arrangements. He clarified that the minute-to-minute program regarding the Prime Minister's visit is yet to be finalized, and in the meantime, the arrangements to be made in terms of various departments should be taken up on a war footing. As numerous people and public representatives will come to participate in the road show as part of the Prime Minister's visit, necessary steps should be taken for parking their vehicles. In view of the Prime Minister's visit in the evening, the Chief Secretary directed the officials of the Electricity and Municipal departments to install appropriate electric lights at the road show, as well as the venue and various parking places.

K'taka: Cop Caught In Compromising Position With Woman At Office Washroom; Suspended

Tumakuru: The Karnataka Police have suspended the Deputy Superintendent of Police (DSP) posted with the Madhugiri subdivision, who was allegedly caught on camera in a compromising position with a woman in his office washroom on Friday. The office of the Karnataka Director General of Police (DGP) has issued the suspension orders of DSP P. Ramac handrappa in connection with the incident.A video showing the officer in uniform "romancing" the woman has gone viral on social media in the state, raising serious concerns. According to sources, the victim, a woman came into contact with the DSP from



Madhugiri town, in connection with a land dispute complaint. The victim from Pavagada town approached the police, and the DSP allegedly exploited his position to coerce her into an intimate act. The police officer reportedly took the woman, who had come to complain, to his office washroom to commit the act.It is suspected that a relative accompanying

the woman secretly recorded the incident and circulated the video online.The 35-second footage showed the officer in uniform and the woman noticing a mobile phone recording through a window.It showed an intimate act of the senior police officer in uniform. The video also showed the woman noticing the mobile phone at the window. The inci-

Centralized Pension Payments System Fully Rolled Out in All Regional Offices of EPFO Across India

NEWDELHI: In a landmark move towards enhancing pension services, EPFO completed the fullscale rollout of the new Centralized Pension Payments System (CPPS) under the Employees' Pension Scheme 1995 in December 2024. About Rs. 1570 Crore pension was disbursed to more than 68 Lakh pensioners pertaining to all 122 pension disbursing Regional offices of EPFO for December 2024. The first pilot of the Centralized Pension Payment System (CPPS) was successfully completed in October 2024 in Karnal, Jammu and Srinagar Regional Offices with the pension disbursement of about Rs 11 Crore to more than 49,000 EPS Pensioners. The second pilot was taken up in November 2024 in 24 Regional Offices in which around Rs. 213 crores pension was disbursed to more than 9.3 lakh pensioners. Announcing the successful rollout, Union Minister Dr Mansukh Mandaviya said, "The full-scale implementation of the Centralized Pension Payments System (CPPS) across all Regional Offices of EPFO is a historic milestone. It eliminates the need for physical verification visits and simplifies the pension disbursement process. CPPS is a testament to our commitment to modernizing EPFO services and ensuring convenience, transparency, and efficiency for our pensioners. With this rollout, we are setting a new benchmark in pension service delivery, aligning with the vision of a tech-enabled and member-centric EPFO."

Committed To Make India A Chip Manufacturing Hub, Prepare Skilled Workforce: Ashwini Vaishnaw

Guwahati: The Central government is committed to transforming India into a leading hub for semiconductor manufacturing, while preparing a skilled workforce that meets the evolving demands of the industry, Union Railways and Electronics and IT Minister, Ashwini Vaishnaw, said here on Friday. After inaugurating the National Institute of Electronics and Information Technology (NIELIT), deemed to be a university at 12 locations including five locations in the northeastern states, the minister said the university is set to play a crucial role in equipping students with the necessary skills to thrive in a rapidly changing technological environment.He added that now the meaning of northeast



is "New Engine", to lead the development and growth of the country. At the event, a memorandum of understanding (MoU) was also signed between NIELIT and Tata Electronics Private Ltd (TEPL) to collaboratively enhance the semiconductor skilling ecosystem in India.The MoU was signed by Dr M.M. Tripathi, Director General, NIELIT and Dr Randhir Thakur, CEO and MD, TEPL.The partner-

ship aims to establish skill centres, develop diploma and certification programmes and conduct workshops in semiconductor ATMP (Assembly, Testing, Marking, and Packaging) technologies.TEPL will offer technical expertise and internship opportunities, while NIELIT will focus on education, training, outreach. Both organisations will also jointly pursue research and funding initiatives, with a special emphasis on creating opportunities in the northeastern region, said the government. The minister announced the launch of NIELIT University, highlighting that it is inspired by the vision of the Prime Minister to prepare professionals in cutting-edge fields such as Semiconductor Manufacturing, Artificial Intelligence, Industry 4.0, and Quantum Computing. Vaishnaw said the new campus of NIELIT will be Guwahati, which will focus on semiconductor manufacturing and electronics manufacturing.Assam Chief Minister Himanta Biswa Sarma reiterated Prime Minister Narendra Modi's vision of a future where the entire world will rely on semiconductor chips that are "Made in India" and "Made in Assam."He emphasised the significant potential for the semiconductor industry to thrive in the region, highlighting the necessity for a skilled workforce and trained manpower to support this growing sector."This underscored the commitment to fostering local talent and creating job opportunities, ensuring that Assam plays a pivotal role in the global technology landscape," said Sarma.

NEWDELHI: Prime Minister Narendra Modi on Friday inaugurated the 1,675 newly constructed flats for the dwellers of JJ clusters and handed over keys to eligible beneficiaries at Swabhiman Apartments in Ashok Vihar, Delhi.The inauguration of newly constructed flats marks the completion of the second successful In-Situ Slum Rehabilitation Project by the Delhi Development Authority (DDA). The objective of the project is to provide the residents of the JJ clusters in Delhi with a better and healthier living environment equipped with proper amenities facilities. For every Rs 25 lakh spent on the construction of a flat by the central government, the eligible beneficiaries pay less than seven per cent of the total amount, comprising Rs 1.42 lakh as a nominal contribution and Rs 30,000 for five years of maintenance.

Louis Braille: (The Eye of the Eyeless)

In olden times, the world of the blind was full of darkness. They felt desperate and depressed They could not even dream of gaining knowledge about the world and its ways. Even then there have been some exceptional blind persons in the world who created history by lighting the dark world of blind persons, namely Louis Braille, Homer, Helen Keller, John Milton, Surdas, etc. But generally blind persons wandered in the wilderness like a rudderless boat.

It is the law of nature that darkness is followed by light. The same law brought light in the dark world of the blind. Louis Braille, a blind Frenchman, made the unimaginable a reality by bringing light into the life of the people who lived in perennial darkness. He was born on January 4, 1809 at a small village of Coupvray in France. He was the youngest of the four children of Simon-René Braille and Monique Braille. He was a sickly child, but he grew robust under the devoted care of his mother and family.

Louis was very lucky as he got guidance from his father in the very beginning. During this period, the Abbé Palluy, the priest of St. Pierre Church in Coupvray, started teaching him about the ways of nature. The gentle priest told him the stories from the Bible. He also talked at



length of God and His ways. So, the priest's association played a vital role in Louis' life. Whenever he expressed his desire to read the books, the Abbé Palluy would tell him: "Trust in God, Louis, I feel confident that He has something very special in store for you". Such words encouraged Louis and he would concentrate on "one idea".

Louis Braille was thrilled to learn Captain Barbier's method called Sonography, which dealt with turning different sounds of the French language into dots and dashes. He picked up this idea, but he found this system very difficult. He thought of inventing a special alphabet for the blind out of this method. He had "an idea", and he put his heart and soul to turn it into reality. He worked hard day in and day out to evolve the new system. Sometimes he would sit all night punching his dots into scraps of papers with a sharp tool, called stylus. Ultimately, he attained success in achieving his goal of devising the special alphabet, Braille, and illumined the dark world of the blind.

Louis Braille's life is a great example of not focusing on the disabilitys but the ability. How can a person with a disability have a huge ability? Louis Braille demonstrated it with his imagination and lots of courage. Helen Keller paid a rich tribute to Louis Braille for his invention: "Braille made it a pleasure for me to read ... The world around me shone afresh with treasures." Louis- Braille, in his short life, accomplished such a great task that made him immortal. Like John Milton, he made use of the 'talent' given to him by his 'Maker', and presented his 'true account' to God. It seems as if Ben Jonson had written the following lines in his poem 'The Perfect Life' four centuries ago for Louis Braille. A lily of a day, Is fairer far in May, Although it fall and die that night - It was the plant and flower of Light. In small proportions we just beauties see; And in short measure life may perfect be.

A widening trade deficit due to a rise in imports

compared to exports leads to foreign exchange outflows, weakening the rupee. India's record trade deficit in 2022 due to rising crude oil and gold imports drives rupee depreciation. The fall in the Indian rupee underscores the challenges of maintaining currency stability amid external sector vulnerabilities. Currency fluctuations are triggered by global geopolitical tensions such as the Russia-Ukraine war, rising crude oil prices, and capital outflows, as well as domestic factors such as the fiscal deficit. Effective policy measures are crucial to enhance India's external resilience and stabilize its economy.

Sustained outflows after the September 2024 stock peak weakened the rupee as investors moved to safer assets amid speculation of a rise in US interest rates. Trade deficits, such as the high trade deficit, highlight external dependence on imports, especially for energy, widening the current account deficit during rupee weakness. India's crude oil import bill rose with the rupee depreciation, widening the 2024 trade deficit to close to \$75 billion.

Global events such as tariff threats and the BRICS currency dispute add to volatility by creating

uncertainties for India's external trade and investment. The US President's 2024 tariff warning against the currency plans of the BRICS countries triggered a market sell-off, weakening India's external stability. Heavy reliance on foreign exchange reserves to stabilize the rupee restricts long-term monetary flexibility during sustained global market turmoil.

The rupee exhausted more than \$20 billion in reserves in a single quarter to pull the rupee back to 85.53 in December 2024. A weak rupee constrains domestic monetary policies, raising inflation through costlier imports while reducing fiscal space to address growth concerns. The cost of crude oil imports rose 15% in December 2024, putting pressure on policymakers to effectively balance currency management and fiscal expansion strategies. Protectionist trade measures, such as tariffs or sanctions, can undermine currency stability by disrupting the trade balance. Political instability or conflict between major economies creates volatility, boosting demand for the safe-haven dollar and weakening emerging market currencies. The Russia-Ukraine war led to a surge in global crude oil prices, which put pressure on India's import bill and depreciated the rupee. Tight monetary policies in advanced economies lead to capital outflows from India, putting pressure on the rupee.

The US Federal Reserve's rate hike plan in 2022-23 led to foreign portfolio outflows, which weakened the rupee.

High domestic inflation depreciates the currency value, making exports less competitive and imports costlier. Rising prices of inelastic imports such as crude oil push up India's import bills, weakening the rupee in 2023. A decline in domestic and foreign investment indicates weak economic growth, discouraging currency inflows. In 2024, declining corporate performance and rising stock valuations led to foreign portfolio investment outflows. Central bank interventions to stabilize the currency are limited by foreign exchange reserves and can provide only temporary relief. A late RBI intervention in December 2024 managed to temporarily stabilize the rupee at 85.53 per dollar. A fiscally constrained government reduces its ability to manage external shocks, thereby weakening confidence in currency stability. India's record fiscal deficit during the pandemic limited government measures to boost external resilience. The government's clear stance on currency policies boosts investor confidence and reduces speculative pressure. The RBI governor's ruling out of de-dollarization in 2024 reassured the market, temporarily easing concerns of rupee depreciation.

Measures to strengthen external resilience include boosting exports and focusing on value-added manufacturing and services to increase foreign exchange earnings and reduce trade imbalances. Strengthening

sectors such as pharmaceuticals and IT can help reduce the trade deficit and stabilize the rupee. Reduce dependence on volatile crude oil and essential imports by entering into long-term agreements with diversified suppliers. Expanding crude oil imports from Russia and Middle Eastern countries reduces average oil import costs in 2023. Build strong reserves through sovereign wealth funds and gold accumulation for effective currency stabilization.

According to the Reserve Bank, record foreign exchange reserves of \$600 billion in 2021 helped manage volatility during the pandemic. Enter into agreements to settle trade in local currencies, reducing dependence on the US dollar and mitigating exchange rate risks. The India-Russia Rupee-Ruble Trading Mechanism eased pressure on foreign exchange reserves during the Russia-Ukraine crisis. Prioritize lowcost and long-term borrowings while reducing shortterm external debt to avoid currency risks.India's increased issuance of sovereign green bonds helped attract stable foreign investment while reducing repayment volatility in 2023. A strong external sector is important for India's economic resilience amid global uncertainties. By promoting export competitiveness, ensuring prudent fiscal policy, diversifying foreign exchange reserves, and increasing bilateral trade in rupees, India can reduce currency volatility. A visionary strategy emphasizing structural reforms and global economic integration will ensure long-term stability and strengthen India's position in the global economy.

With the enactment of 'the Prohibition of Employment as Manual Scavengers and their Rehabilitation Act in 2013', the Act of 1993 has become redundant and therefore need to be repealed, an official release stated. The Central has requested the State to place the matter before the State Legislature for adoption of a Resolution to repeal the Act of 1993 as per the procedure prescribed under Art 252. Former India Hockey Coach Jagbir Singh Hospitalised After Suffering A Heart Attack

Rourkela (Odisha): Former India forward and hockey coach Jagbir Singh suffered a massive heart attack and was admitted to a hospital here on Friday. Two-time Olympian Jagbir is in Rourkela for the Hockey India League with Team Gonasika.

Jagbir, who was employed with Air India before retiring a few years back, was rushed to the hospital immediately and his condition is reported to be stable. The 59-year-old Jagbir Singh, who was born in a Sikh family in Agra, Uttar Pradesh, represented India in the 1988 Olympics in Seoul and then the 1992 Games in Barcelona. He played for India between 1985 and 1996, winning a bronze medal in the 1986 Asian Games in Seoul and a silver in the 1990 edition in Beijing. In all, he earned 175 international caps. A top forward of his time, Jagbir coached the Indian men's team in the 2004 Olympic Games in Athens and also worked as a renowned commentator since the 1990s.

I Wasn't In Frame Of Mind To Take Charge, Says Pant On His Defensive Knock

Sydney: India wicketkeeper-batter Rishabh Pant reflected on his defensive of 40 off 98 balls in the fifth Test against Australia on Friday and said he was not in the mindset to take charge of the game. Pant came to bat at No. 5 when India were already reeling at 57/3 in the opening session of the day. Playing according to the demand of the match, Pant took defensive guard and also suffered blows on his body on the green-top Sydney Cricket Ground pitch. "Definitely, it's painful but sometimes you've to do the hard work for the team and that's okay. Not thinking too much about where I got hit. I was just playing the ball to the best of my abilities and that's the only thing I can do and that's what I did," Pant said after the end of play. "This is the first time I've got hit so much (on the body). In cricket, you can't plan anything. Everything happens for the first time at some point of time in your career. That was me today, not thinking about it too much.

"In this innings I was not in a frame of mind where I wanted to take charge of the game because the wicket was doing too much and the kind of situation we're in. While playing inside, I felt like I could play a little bit of defensive cricket. Yes, there's a time to attack but you have to feel that from inside," he added. Commenting on the nature of the pitch, Pant admitted it was difficult to bat on while also acknowledging the need to adjust to the conditions. "I think it should remain the same hopefully for us.
