US Food Authority Chief Resigns Amid Trump's Mass Firings: Report

Washington, United States. A senior US Food and Drug Administration official who recently oversaw the agency's banning of a coloring linked to cancer has resigned to protest "indiscriminate" firings by President Donald Trump's government, reports said Tuesday.Jim Jones, who joined the FDA in 2023, wrote in a letter seen by Bloomberg News that the layoffs of 89 staffers in the food division which he heads will severely hinder efforts to implement Health Secretary Robert F Kennedy Jr's agenda of improving Americans' diets.

I was looking forward to working to pursue the department's agenda of improving the health of Americans by reducing diet-related chronic disease and risks from chemicals in food," he said, but the new administration's "disdain for the very people" needed to make these goals a reality meant it was "fruitless for me to continue in this role."The resignation was first reported by industry publication Food Fix.

Jones's departure comes amid widespread federal job cuts involving thousands of people, as Elon Musk's so-called Department of Government Efficiency spearheads an aggressive downsizing initiative, particularly targeting employees still within their probationary period, which lasts at least a year

Last week, AFP reported that nearly half of an elite team of epidemiologists at the Centers for Disease Control and Prevention (CDC), known as the "disease detectives," were also dismissed. Experts warn that such cuts could endanger public health, especially as concerns grow over the potential for a broader bird flu outbreak in humans.

Iones, who previously served in the Environmental Protection Agency, last month oversaw a ban on Red Dye No 3, a coloring long known to cause cancer in animals but still widely used in thousands of US food products. Health Secretary Kennedy has positioned food industry reform as a cornerstone of his "Make America Healthy Again" initiative, advocating against harmful chemicals and non-nutritive additives while pushing for stricter labeling laws to combat the nation's obesity epidemic.

13-Year-Old Domestic Help In **Pakistan Allegedly Tortured And Killed For Stealing** Chocolates

World. A couple in Pakistan has been arrested for allegedly killing a 13-year-old domestic help for stealing chocolates. According to the BBC, the girl, who goes only by Iqra, succumbed to severe injuries in hospital last week. A preliminary police investigation said she had been subjected to brutal torture before death. An autopsy is being conducted to assess the full extent of her injuries. The girl's employers, Rashid Shafiq and his wife Sana, along with a Quran teacher who worked for the family have been arrested. The teacher had reportedly brought the to the hospital and left after telling that her father had died and her mother was not around.

Iqra's death has triggered a wave of outrage on social media, with the hashtag #JusticeforIqra gaining tens of thousands of views. The incident has also reignited discussions on child labour and the abuse of domestic workers in the country, the BBC reported. Notably, laws pertaining to child labour vary across the country, however, in Pakistan's Punjab, children under the age of 15 cannot be employed as domestic workers. "My heart cries tears of blood. How many... are subjected to violence in their homes every day for a trivial job of a few thousand?" activist Shehr Bano wrote on X. "How long will the poor continue to lower their daughters into graves in this way?" she added.

Some users pointed out that her murder was allegedly triggered by something so minor. "She died over chocolate?" one user wrote on X. "This is not just a crime, it's a reflection of (a) system that enables (the)

rich to treat (the) poor as disposable," said another. Speaking to the BBC, Iqra's father, Sana Ullah, said that his daughter began working as a maid at the age of 8. He said that he had sent her to work because he was in debt. After working for a few employees, the 13-yearold went to work for the couple two years ago, who have eight children of their own. Iqra was earning around \$28 per month.

Pope Francis Has Pneumonia In **Both Lungs, His Condition Remains** 'Complex'

Vatican City.Pope Francis, who was admitted to hospital last week, has developed pneumonia in both of his lungs, the Vatican said Tuesday, adding that the 88-year-old was in "good spirits". "The laboratory tests, chest X-ray, and the Holy Father's clinical condition continue to present a complex picture", the Vatican said in a statement. Francis was admitted to Rome's Gemelli hospital last Friday for bronchitis, but the Vatican on Monday said it was changing his treatment following tests.It said Tuesday that a "polymicrobial infection" which has come on top of "bronchiectasis and asthmatic bronchitis, and which required the use of cortisone antibiotic therapy, makes therapeutic treatment more complex"."The follow-up chest CT scan which the Holy Father underwent this afternoon... demonstrated the onset of bilateral pneumonia, which required additional drug therapy," it said. The pontiff had part of his right lung cut away when he was 21, after developing pleurisy that almost killed him. The Vatican had already cancelled a papal audience on Saturday and said he would not attend a mass on Sunday, although it has yet to announce plans for his weekly Angelus prayer, held on Sunday. Nevertheless, Pope Francis is in good spirits," it added. The pope spent his fifth day in hospital alternating rest with prayer and reading texts, the Vatican said. Francis, the head of the Catholic Church since 2013, was admitted to hospital after struggling for several days to read his texts in public.


Panama holds nearly 300 US deportees from India, other nations as officials work on their return

PANAMA CITY. Panama is detaining in a hotel nearly 300 people from various countries deported under US President Donald Trump, not allowing them to leave while waiting for international authorities to organize a return to their countries.

More than 40% of the migrants, authorities say, won't voluntarily return to their homeland. Migrants in the hotel rooms held messages to the windows reading "Help" and "We are not save (sic) in our country."The migrants hailed from 10 mostly Asian countries, including Iran, India, Nepal, Sri Lanka, Pakistan, Afghanistan, China and others. The US has difficulty deporting directly to some of those countries so Panama is being used as a stopover. Costa Rica was expected to receive a similar flight of third-country deportees on Wednesday.Panama's Security Minister Frank Abrego said Tuesday the migrants are receiving

medical attention and food as part of a migration agreement between Panama and the US.The Panamanian government has now agreed to serve as a "bridge" or transit country for deportees, while the US bears all the costs of the operation. The agreement was announced earlier this month after US Secretary of State Marco Rubio's visit.Panamanian President José Raúl Mulino, who faces political pressure over Trump's threats of retaking control of the Panama Canal, announced the arrival of the first of the deportation flights last Thursday.The confinement and legal limbo the

deportees face has raised alarm in the Central American country, especially as images spread of migrants peaking through the windows of their rooms on high floors



of the hotel and displaying the notes pleading for help. Abrego denied the foreigners are being detained even though they cannot leave the rooms of their hotel, which is being guarded by police. Abrego

said that 171 of the 299 deportees have agreed to return voluntarily to their respective countries with help from the International Organization for Migration and the UN Refugee Agency.UN agencies are talking with the other 128 migrants in an effort to find a destination for them in third countries. Abrego said that one deported Irish citizen has already returned to her country. Those who do not agree to return to their countries will be temporarily held in a facility in the remote Darien province through which hundreds of thousands of migrants have crossed on their journey north in recent years,

Abrego said. The Panamanian Ombudsman's Office was scheduled to provide more details on the deportees' situation later Tuesday.

Ukraine isn't invited to its own peace talks. History is full of such examples and the results are devastating

World. Ukraine has not been invited to a 1. The Scramble for Africa key meeting between American and Russian officials in Saudi Arabia this week to decide what peace in the country might look like.Ukrainian President Volodymyr Zelensky said Ukraine will "never accept" any decisions in talks without its participation to end Russia's threeyear war in the country. A decision to negotiate the sovereignty of Ukrainians without them -- as well as US President Donald Trump's blatantly extortionate attempt to claim half of Ukraine's rare mineral wealth as the price for ongoing US support --reveals a lot about how Trump sees Ukraine and Europe.

But this is not the first time large powers have colluded to negotiate new borders or spheres of influence without the input of the people who live there. Such high-handed power politics rarely ends well for those affected, as these seven historical examples show.

In the winter of 1884–85, German leader

Otto von Bismarck invited the powers of Europe to Berlin for a conference to



formalise the division of the entire African continent among them. Not a single African was present at the conference that would come to be known as "The Scramble for Africa." Among other things, the conference led to the creation of the Congo Free State under Belgian control, the site of colonial atrocities that killed millions. Germany also established the colony of

German South West Africa (presentday Namibia), where the first genocide of the 20th century was later perpetrated against its colonised peoples.

2. The Tripartite Convention

It wasn't just Africa that was divided up this way. In 1899, Germany and the United States held a conference and forced an agreement on the Samoans to split their islands between the two powers. This was despite the Samoans expressing a desire for either self-rule or a confederation of Pacific states with

Hawai'i. As "compensation" for missing out in Samoa, Britain received uncontested primacy over Tonga.

German Samoa came under the rule of New Zealand after the first world war and remained a territory until 1962. American Samoa (in addition to several other Pacific islands) remain US territories to this day.

Europe's Most Active Volcano Is Attracting Thousands Of Tourists. **Know Why**

World. Mount Etna, Europe's most active volcano, is attracting thousands of tourists eager to witness the spectacular lava flows cutting through the snowcapped mountain. The sudden influx of visitors, however, has caused trouble for rescue workers attempting to reach those in need of assistance. This, because the sightseers are blocking the streets. Salvo Cocina, the regional civil protection head for Sicily, has described the booming tourism around the volcano "wild" and "extremely dangerous."People are climbing the Sicilian slopes to get a better view. According to Mr Cocina, eight individuals attempting to reach the peak without a guide were lost for several hours on Monday before rescuers found them. It was also reported that a 48-year-old man fractured his foot after slipping on ice.

Mr Cocina has issued a warning, saying tourists were obstructing rescue vehicles by parking in narrow streets. The continuous presence of rescue personnel, including 4x4 ambulances and other off-road vehicles, is crucial for both the authorised guides leading



Elon Musk Claims Biden Left Sunita Williams In Space For "Political Reasons

Washington DC.US President Donald Trump and his advisor Elon Musk have claimed that NASA astronauts Sunita Williams and Butch Wilmore were "abandoned" at International Space Station (ISS) for "political reasons" and that the previous Biden administration was "going to leave them in space." The remarks were made when Trump and Musk sat down for their first joint interview with Fox News's Sean Hannity. When Hannity asked the President and his advisor about the 'two astronauts that I think were abandoned", Musk said, "At the President's request, we - or instruction, we are accelerating the return of the astronauts, which was postponed, kind

of, to a ridiculous degree.' They got left in space," Trump chimed in. Musk seconded the President's claim and said, "Yes, they were left up there for political reasons, which is not good."When asked about Space X's mission to bring back Sunita Williams and Butch Wilmore, Musk said, "Well, we don't want to be complacent, but we have brought astronauts back from the space station many times before, and

always with success."

When asked about the timeline of the mission, Musk said, "I think it's about -

about four weeks to bring them back." You now have the go-ahead," Trump said. "Yes. Well, thanks to you," replied Musk.Trump then claimed that Musk's company didn't have the go-ahead with



the Biden administration. "He (Biden) was going to leave him in space. I think he was going to leave them in space," the Republican added. The Missionutch Wilmore and Sunita Williams launched to the ISS aboard Boeing's Starliner spacecraft in June 2024. The flight, which was intended to last only 10 days, experienced a rocky journey. After arriving at the space

station, NASA and Boeing worked for weeks to better understand the problems in the spacecraft but it was ultimately decided that it was too risky to return the Startliner with the crew. Following this, in August 2024, the space

agency announced that it had asked SpaceX to bring Williams and Wilmore home aboard the SpaceX Crew-9 capsule. SpaceX, the private company founded by billionaire Musk, has been flying regular missions every six months to allow the rotation of ISS crews. However, on January 20 Musk said Trump had asked him to facilitate the return of the two Boeing Starliner astronauts Sunita Williams and Butch Wilmore, who have been on the space station since June 2024, as soon as possible. The SpaceX CEO claimed that it was "terrible" that the pair were left "stranded" at the International Space Station (ISS) by former President Joe Biden's administration for so long, even though NASA had already roped in

"Blocking them has created a dangerous situation for everyone," he said.Carlo Caputo, the mayor of nearby Belpasso, warned that although Mount Etna appears visually stunning, it poses serious risks. Lava can rapidly evaporate snow. triggering violent explosions of rock and debris due to the released thermal energy.Boris Behncke, a volcanologist with the Etna Observatory who lives on the mountain's flank, told CNN on Tuesday that the lava had descended to about 1,950 meters in elevation, destroying trees near a service rod.

The eruption, which began on February 11, peaked on February 17. It has since reached the Galvarina area of Adrano at an altitude of 2,000 meters, impacting local infrastructure and trees near the service road.

Etna can erupt multiple times in a year or even a month, spewing lava and ash high into the air. In 2021, it erupted so frequently that it grew nearly 100 feet (30 metres) in height.

Malaysia is betting on data centres to boost its economy. But experts warn they come at a price

JOHOR BAHRU. Winson Lau has always had contingency plans. But he wasn't prepared for data centres.Lau relies on water and electricity to operate his thriving export business in Malaysia's Johor province, where he raises a kaleidoscope of tropical fish in rows of aquariums, including albino fish with red spots that can fetch up to \$10,000 from collectors. His contingency plans in the event of an outage involve an intricate system of purifying wastewater through friendly bacteria and an alarm system to quickly switch to backup power.But these measures can't compete with the gigantic, power-guzzling and thirsty data centres being built in Johor. The province is on track to have at least 1.6 gigawatts of data centres at any given moment from nearly nothing in 2019, making it the fastest-growing data centre market in Southeast Asia, according to a report published in April.

Data centres are large, windowless buildings filled with racks of computers that need lots of electricity. To prevent overheating, they

rely on energy-intensive air conditioning systems using pumped water. Increasingly used by tech companies for running artificial intelligence systems, the power demand from future facilities in Malaysia may rise to over 5 gigawatts by 2035, according to researchers at Malaysia's Kenanga Investment Bank. This is more than half of Malaysia's entire renewable capacity in 2023.

Over 95% of the energy available to Malaysia in 2022 was from fossil fuels, according to the International Energy Agency. The country is now the fifthlargest exporter of liquefied natural gas globally. And with planned renewable projects, Prime Minister Anwar Ibrahim said in September that the country was "confident of a surplus of energy" to fuel large projects and keep exporting. But Lau doesn't fancy the chances of his homegrown business competing against the foreign-funded behemoths for energy. Even without data centres, Malaysia is

susceptible to power interruptions because



of storms, including one that lasted 30 minutes last year and killed 300,000 fish, costing Lau over \$1 million. He worries that data centres would result in longer outages. To survive, Lau is moving to Thailand and already scouting potential locations for a new fish farm. "Big data centre is coming, and there is shortage of power," he said. "It'll be crazy." Costs versus benefits

Malaysia is betting that potential economic growth from data centres justifies the risk. Once touted as an Asian tiger on the cusp of becoming rich, its industries shrunk in the late 1990s after the Asian financial crisis. It

has since languished in the middle-income trap. Data centres, the government hopes, will modernise its economy and indirectly create thousands of high-paying jobs.

But experts worry that Malaysia, and others like Vietnam, Indonesia and India vying for billion-dollar investments from tech giants, may be overstating data centres' transformative capabilities that also come at a price: Data centres gobble up land, water and electricity while creating far fewer jobs than they promise. Most data centres provide 30 to 50 permanent jobs, while the larger ones create 200 jobs at most, according to a report by the American nonprofit Good Jobs First.

Add to this the rapid increase in power and water use, and some experts like Sofia Scasserra, who researches digital economies at the Amsterdam-based think tank Transnational Institute, said that tech companies exploiting resources in poorer countries while extracting data from their populations to get rich is akin to "digital

1600 MW Super Critical Thermal Power Plant Soon to Come Up at Chandrapura in Jharkhand

Bokaro: The Damodar Valley Corporation (DVC) is set to begin work on a new 1600 MW super critical thermal power plant in Chandrapura, Bokaro district of Jharkhand.

The plant, consisting of two 800 MW units, is expected to be a significant addition to the region's energy infrastructure.

India Launches 433 Foreign Satellites; 396 deployed in the Last 10 Years

RNS: India is no longer just a follower in the global science and technology landscape, but is now setting benchmarks and leading in multiple fields, asserted Science and Technology Minister Dr. Jitendra Singh in a recent interview.

He highlighted India's leadership role and pioneering innovations across various sectors, with particular emphasis on the country's space sector.

Dr. Singh pointed out the significant transformation in India's space capabilities, noting the surge in ambitious missions and international collaborations. He highlighted the Space Docking Experiment (SpaDeX) as a key milestone in India's technological progress, paving the way for future missions like Ga-

BJP names first-time MLA Rekha Gupta as Delhi Chief Minister, oath today



New Delhi: Rekha Gupta has been appointed as the new Chief Minister of Delhi, following a meeting of the Delhi BJP legislative party on Wednesday evening. Gupta, a first-time MLA, will be sworn in tomorrow at a grand ceremony at Ramlila Maidan, which is expected to be attended by top BJP leaders, union ministers, and dignitaries from various fields.

Later on Wednesday, Gupta met Delhi's Lieutenant Governor, VK Saxena, at Raj Niwas and staked her claim to form the new government.

Gupta, 50, becomes the fourth woman to serve as Delhi's Chief Minister and the second from the BJP after Sushma Swaraj. She won the Shalimar Bagh seat in the recent Delhi assembly elections with 68,200 votes. Gupta, who has been active in politics since her student days with ABVP at Daulat Ram College, Delhi University, served as the President of the Delhi University Students' Union in 1992. She later served as the General Secretary of BJP's Mahila Morcha in Delhi.

A lawyer by profession, Gupta has also held significant roles in local politics, including serving as the Mayor of South Delhi Municipal Corporation and as a Delhi Councillor. She is currently the General Secretary of Delhi BJP. Expressing her gratitude for the party's trust, Gupta pledged to work for the welfare and development of all citizens of Delhi. "I will dedicate myself to serving every resident of Delhi, with honesty, integrity, and commitment," she stated. The oath-taking ceremony will take place at 12:35 PM tomorrow, where Gupta will be administered the oath of office and secrecy by the Delhi Lieutenant Governor. Prime Minister Narendra Modi, Home Minister Amit Shah, Defence Minister Rajnath Singh, and Chief Ministers from around 20 states are expected to attend the event.

Delhi Police has issued a traffic advisory in anticipation of large crowds, with several diversions and restrictions in place to manage the flow of traffic during the ceremony.

Trump Questions \$21 Million Aid to India, Supports DOGE's Decision to Cancel Voter Turnout Fund

Donald Trump has expressed his support for the Department of Government Efficiency (DOGE)'s decision to cancel a \$21 million grant aimed at improving voter turnout in India. During a media briefing, Trump questioned the justification for the financial assistance, stating, "Why are we giving \$21 million to India? They have plenty of money. They're one of the highest taxing countries for us, and we can hardly get in because of their high tariffs."

While acknowledging his respect for India and its Prime



Minister, Trump emphasized, "Giving \$21 million for voter turnout in India? What about voter turnout here?"

The financial aid, which was part of a broader \$486 million budget under the "Consortium for Elections and Political Process Strengthening," was initially allocated by the administration of former President Joe Biden. The grant aimed to influence voter engagement in

India.

DOGE, led by billionaire entrepreneur Elon Musk, an-

nounced the termination of the \$21 million grant, citing concerns about the efficiency of U.S. taxpayer funds being used for overseas political activities. The Department also stated that an additional \$29 million originally earmarked for political initiatives in Bangladesh would also be

scrapped.
In a statement, DOGE explained that these cancellations were part of broader efforts to increase government efficiency and ensure that taxpayer dollars were not being allocated to "questionable" political projects abroad.

Congress faces internal turmoil after BJP's sweep in Chhattisgarh urban polls

As the BJP celebrated its sweeping victory in the Chhattisgarh urban body polls, winning all 10 mayoral seats, the Congress found itself in turmoil, with leaders publicly voicing frustration and blame.

New Delhi. Amid the celebrations of the Bharatiya Janata Party's resounding victory in the Chhattisgarh urban body elections, the Congress has been thrown into introspection and internal discord.

The BJP secured all 10 mayoral seats, widening its lead over Congress and triggering a wave of blame within the party. What began as a post-election analysis quickly turned into a public display of frustration, with leaders and workers taking to social media to voice their discontent.

Former Raipur MLA Kuldeep Juneja did not hold back his disappointment, stating, "If the leadership of the state unit remains the same, I will stop going to the party headquarters. The AICC should make the necessary changes, and I will personally take this issue to Delhi." His remarks did not go unnoticed, as the state unit promptly issued him a notice for dissent. The anger among



party workers has only intensified, with many questioning the leadership's decisions, particularly regarding ticket distribution. Calls for change at the top have been loud, with some Congress members even praising the Rashtriya Swayamsevak Sangh (RSS) for its organisational strength, attributing BJP's continued success to its groundwork.

A party worker, Rahul Kar, openly acknowledged this on social media, writing, "The RSS is the biggest strength of BJP. You can criticise it, but you must also have the courage to admit that it is the biggest reason for BJP's victories across the

Another Congress activist, Kalpana Sagar, pointed to internal favouritism, writing in consecutive posts, "Mayor leader's wife, ward leader's wifethe Raipur body elections were fought with the ambition to secure positions for themselves, and the result is in front of everyone."

"Taking responsibility for this defeat as a matter of morality, the city president should resign with immediate effect," he posted.

Will have ideological fight with Vijay in 2026 Tamil Nadu polls: BJP's Annamalai

Tamil Nadu . Tamil Nadu BJP state president K Annamalai said that his party will have an ideological fight with actor-politician Vijay in the 2026 state assembly elections. He agreed that Vijay was a popular actor and that he would bring certain ideals to the political fight. "For Vijay and other parties, it is going to be an ideological fight. Vijay will bring a certain ideology to the ground. We will bring a certain ideology to the ground. They might have fire power... we also have fire power," Annamalai said. Agreeing that Vijay's popularity is massive, he also pointed out that the ruling DMK were formidable as well, and that regional parties have a strong base in the state. "He already has a far reach and parties like DMK are formidable. It is one of the oldest parties in the country, existing from 1949. The AIADMK is formidable; it was in power several times. We understood what the challenges are but we have built ourselves over the last several years," Annamalai asserted.

Commissioners should be appointed by a panel comprising the Prime Minister, the Leader of the Opposition and the Chief Justice of India until a law is enacted.

Gyanesh Kumar is the first Chief Election Commissioner to be appointed under a new law on the appointment of the members of the Election Commission. His tenure will run until January 26, 2029, days before the Election Commission is expected to announce the Lok Sabha polls.

Besides Gynanesh Kumar's appointment, Vivek Joshi, a 1989-batch Haryana-cadre IAS officer, was appointed as an Election Commissioner. His tenure will run till 2031.

According to the law, a Chief Election Commissioner or an Election Commissioner retires at 65 or can have tenure on the poll panel for six years. In March last year, Gyanesh Kumar and Sukhbir Sandhu were recommended to be appointed as Election Commissioners by a selection panel chaired by Prime Minister Narendra Modi under the

After bail, Rahul Gandhi exempted from court presence in Savarkar defamation case

Congress MP Rahul Gandhi was permanently exempted from appearing in a Pune court in a defamation case against him over his alleged remarks on Hindutya ideologue Veer Savarkar. He got bail last month.

Pune. A Pune court on Tuesday granted permanent exemption from appearance to Congress MP Rahul Gandhi in a defamation case filed over his alleged objectionable remarks on Hindutva ideologue Veer Savarkar, citing his toplevel security and the Leader of Opposition

An application seeking permanent exemption from appearing before the special court for MP/MLA was moved by Advocate Milind Pawar, who is representing Rahul Gandhi (54) in the defamation case, last month.

Pawar said on Tuesday they moved another application to convert the present "summary trial" into "summons trial" so that historical references and evidence can be discussed in the court.

"Summons trial" which entails detailed crossexamination, is a lengthy legal proceeding as compared to "summary trial".

The case, in which the Congress leader obtained bail last month, was filed by a relative of Savarkar. Amol Shinde, Judicial Magistrate



(First Class) presiding over the special court for MP/MLA, in his order, said that the accused is the Leader of Opposition in the Lok Sabha and has to attend several meetings.

Considering that he is a 'Z-plus' protectee and taking into account expenses incurred on his security arrangements (during Pune visit) and also law and order issue if he attends the hearing, the court grants permanent exemption to Rahul Gandhi from appearing in the case, said the order. Last month, the court granted bail to Rahul Gandhiafter he virtually appeared before it in the case filed on a

complaint by a grandnephew of Savarkar.

The complaint stemmed from a speech the Congress leader gave in London in March 2023, where he made certain remarks on the freedom fighter, citing a book written by him. Satyaki Savarkar, grandnephew of the Hindutva ideologue, had filed a complaint in a Pune court against the Congress MP. In the complaint, he had claimed that Rahul Gandhi, in his speech in London, stated that Veer Savarkar had written in a book that he and five to six of his friends once beat up a

Muslim man and he (Savarkar) felt happy. As per the complaint, Veer Savarkar has not written this anywhere in the book and Rahul Gandhi's remarks were defamatory.

Considering the facts (cited by Rahul Gandhi's lawyer) this court finds that the accused is the Leader of Opposition in the Lok Sabha. He has to attend many programmes. He is protected by Z+ security. The expenses of security are considerable. Manipur's troubles deeper than political fixes

Finally, the BJP and, through it, the Government of India have taken some decisive steps towards sorting out the mess in Manipur in the recent past. The government first posted a seasoned bureaucrat as the Governor of the state, then it asked Biren Singh, Chief Minister of Manipur, where the BJP was ruling, to step down and four days later, on February 13, it imposed President's rule in the state. All these steps were taken quickly, in conjunction. But they had been long overdue. The BJP and, hence, the BJP government in the state had been hoping against hope that the matters would get sorted by the feeble steps that the government had taken since the start of the violence in the state on May 3, 2023. The long strife continued almost unabated, with a few short periods of lull in between. It has led to very strained relations between the Meities and the Kukis. The problem got aggravated due to many other factors, too, which had serious implications from various corners.

Two factors were holding the BJP back from taking firm action: the fact that we are a democracy; and that the ruling party at the Centre was the same as that in the state. Putting such a state under President's rule would be an embarrassment for the party as it would mean a censure of its own functioning. Additionally, the party could not find a successor CM who was acceptable to all.

However, the ruling party has now bit the bullet. It is better late than never. Looking ahead, a lot of work is needed to be done. First, let us look at the genesis of the problem to help tackle it.

The military junta in Myanmar does not have full control over the entire territory of its country, especially in the areas bordering Manipur. Many groups in these areas are fighting their government and even have control over some parts. Also, due to the violence, the international drug trade from the infamous Golden Triangle, primarily through Moreh town and the area of Manipur, was suffering as the areas under opium cultivation there had reduced or were not increasing. Many Kuki and related tribes had started crossing over to Manipur, mainly in the Churachandpur area, which is dominated by the Kukis, with the help of their local kith and kin. They started growing opium in Manipur. Locals also joined them in this lucrative cultivation. When this came to the notice of the state government, action was taken to identify the illegal immigration. Locals, supported by powerful international drug lords loaded with tons of money, resisted this action. They wanted to put the government on the back foot. To their good luck — and bad luck for the state — an order by the Manipur High Court on the request of Meiteis to be given the Scheduled Tribe status gave them a reason to create trouble by misinterpreting that order.

The order, dated March 27, 2023, stated that "the state shall consider the case of the petitioners for inclusion of the Meetei/Meitei community in the Scheduled Tribe list, expeditiously...." It was only an order for consideration of the plea and not for giving the ST status to the Meiteis. But the Kukis deliberately misrepresented it, saying that the Meiteis had been given the ST status.

Though this paragraph was later deleted by the high court, the damage had been done. Both sides started taking out rallies, some violence also erupted and blockades and counter-blockades by the two communities came up. The Meiteis are from the valley side and the Kukis and other related tribes from the hills. The situation worsened. It turned so bad that people from the valley could not go to Churachandpur and vice versa. The Kukis demanded a separate administration. They did not want the Meiteis to have the ST status as they felt it would affect their job quota and also enable the Meiteis to legitimately buy land in the hills. So, a kind of full-scale civil war between the two communities erupted, with violence leading to loss of lives and displacement of people fro both sides.

It is alleged that drug lords, with their deep pockets, have played an important role in fuelling this situation. Soon, the government and its machinery were overwhelmed by the violence.

Role of universities crucial in creating inclusive AI systems

These statistics underscore the urgent need to embed ethics, inclusivity and cultural values into AI development. Beyond economic and technological considerations, we must ask ourselves: what is the use of AI if it contributes to the breakdown of families, loss of peace and the erosion of our value systems? Where is the inclusivity, the vision of Sarbat da bhala (welfare for all), espoused by Guru Nanak Dev? How can we reconcile AI's advancements with the ethos of the

Bharatiya gyan parampara (Indian knowledge tradition)? These pressing questions demand immediate attention.

Educational institutions hold a pivotal responsibility in addressing these concerns and shaping an ethical AI ecosystem. Universities and colleges, as centres of knowledge and innovation, must take proactive steps to integrate ethical considerations into AI development.AI education cannot remain limited to technical knowledge. Institutions must embed moral, philosophical and cultural dimensions into their curricula to prepare students to think critically about the societal impact of AI.For instance, Guru Nanak Dev University (GNDU) is working on introducing courses that merge AI with philosophy, sociology and the teachings of Guru Nanak Dev.

This ensures that students understand the importance of inclusivity and ethical frameworks.

mitigating AI biases, enhancing transparency and preventing misuse. Collaborative, interdisciplinary research can bridge the gap between technology and ethics, addressing diverse cultural and social contexts.Further, educational institutions should demystify AI for the public, explaining its benefits, risks and ethical implications. By engaging with policymakers, industries and communities, universities can play a critical role in fostering trust in AI systems.

While AI has global implications, its solutions must cater to local needs. For example, GNDU's initiative



to reserve 5 per cent seats for students from rural and border areas is a step towards inclusivity in technology education. Such initiatives ensure that the marginalised communities are not left behind in the AI revolution.Guru Nanak's philosophy of 'Sarbat da bhala' provides a guiding principle for the kind of AI we should aim to develop — one that uplifts humanity, bridges divide and fosters harmony. As stewards of our cultural heritage, universities must champion these ideals to create a technology-driven yet ethically grounded society.

The current laissez-faire approach adopted by countries like the US, driven by an impulse to dominate the AI race, is unsustainable and potentially dangerous. Policies must also reflect the cultural ethos and value systems of the nations implementing them. India, for instance, can draw from its rich heritage of Bharatiya gyan parampara, emphasising wisdom, inclusivity and harmony. AI development must be aligned with the

vision of creating a compassionate and just society for future generations. Governments should allocate funds to universities and research institutions for interdisciplinary studies on ethical AI. Partnerships between academia, industry and the government can accelerate innovation while ensuring ethical compliance.

repackaged in a more readable format. Provisions related to deductions, exemptions and penalties continue to be complex. Also, multiple crossreferences to the 1961 Act still exist, which may cause confusion rather than simplify compliance. Another contentious issue is the expansion of tax authorities' powers. The Bill allows officials to access electronic records, including emails and social media accounts, during investigations. While this is aimed at tackling tax evasion in the digital age, it raises concerns about privacy and potential misuse, necessitating strong safeguards.

The formation of a 31-member select committee to review the Bill is a prudent step, ensuring that all concerns are addressed before it becomes law. While the Income Tax Bill represents a move in the right direction, meaningful tax reform must go beyond simplification — it should focus on reducing compliance burdens, ensuring fairness and protecting taxpayer rights.

India must adjust to a whole new world

The CAPFs must have their own integral cadres, like the Coast Guard. The army, too, should yield control of the Assam Rifles.

In the chemistry of diplomacy, the camaraderie between Prime Minister Narendra Modi and President Donald Trump provides a constructive environment for relations between India and the US. Such rapport eases tensions and builds trust, although diplomacy cannot depend entirely on leadershiplevel chemistry. Relations between India and the US, fortuitously, are built also on several years of evolution in multiple areas of mutual benefit, strategic convergence and a solid framework of public support as well as national interest. But the world we live in is a fragmenting world, and complacency is outmoded. The realities we confront today are very different from those during Trump's first presidency. The dynamics of global diplomacy have changed. War and conflict, predatory competition, trade tensions and the waning attractions of globalisation define geopolitics. Trump has come to power on his 'America First' agenda, he is playing to his MAGA (Make America Great Again) base and riding a tidal wave of populism and nativism in the American body politic.

The outcomes of the Modi visit have been analysed across the media, and it is time for us to dwell on the impact of a Trumpian world on India. It is not that President Trump does not value the strategic partnership with India. During PM Modi's visit, it was clear that both sides are keen on elevating military cooperation to embrace various domains, including air, land, sea, space and cyberspace. There are plans to expand defence sales and co-production with the potential inclusion of advanced aviation systems like the F-35 jets. There is also the shared strategic vision for a free and open Indo-Pacific. Trade and immigration offer more complex challenges. President Trump's 'reciprocal' tariffs will fundamentally disrupt norms of international trade;

there will be increased business uncertainties and a deepening of geopolitical divides. Nations will have to reassess their trading relations with the US. Established supply chains may be affected, as also global economic stability. The imposition of US tariffs will impact production costs that will affect consumers and contribute to higher inflation. Of course, as the US diversifies its supply chains away from China, there are opportunities for our textiles, electronics and engineering goods sectors. However, Trump's protectionist approach to economic ties with the world poses challenges for India, and we should not downplay them.

There is a need for careful negotiation to balance our economic interests while maintaining and strengthening our strategic partnership with the US. The new reciprocal tariff policy should serve as a catalyst for India to rationalise its own tariffs, and for trade negotiations leading to a bilateral trade agreement that both countries want to conclude before the end of this year. Reaching such an agreement will be a true test of our negotiating skills. In the face of coercive American moves, our challenge will be to maximise the zone of potential agreement, as it is called in the science of

On immigration, the summary manner in which America is expelling illegal Indian immigrants, bound in shackles, has not gone down well. The deportation procedures followed have sparked significant controversy. There is a feeling that our nationals have been inhumanly treated. There is a risk that this could be interpreted as a failure to protect our citizens abroad. The ability of a nation to safeguard its citizens internationally is a component of smart power. Legal immigration and H-1B visa issues can no doubt be managed well by the two countries. Our

problem is how the human trafficking industry can be cracked down upon effectively by our agencies.

Another issue of concern is Trump's warning to the BRICS nations. He is playing the global hegemon on the power of the US dollar and threatening to serve a death warrant on BRICS if its members pursue alternative financial systems that deter the dollar's dominance. South Africa, a BRICS member, has come under a cloud because of land policies that allegedly affect the white Afrikaner minority,



something that Elon Musk highlights as "racist ownership laws" (Musk has also faced challenges for his Starlink project in South Africa). This has led to a halting of all US financial aid to South Africa and Trump's decision not to attend the forthcoming G20 Summit in Johannesburg. What this demonstrates is that Trump is ready to sacrifice diplomatic relations if policy 'principles' are seen as threatened.

There is much talk of a multipolar world today. In an interview, US Secretary of State Marco Rubio acknowledged this when he said, "It's not normal for the world to have a unipolar power. That was an anomaly. It was a product of the end of the Cold War, but eventually you were going to reach back to a point where you had a multipolar world, multi-great powers in different parts of the planet." This may sound soothing, but an 'America First' world view has inbuilt presumptions about American primacy. And the warning to BRICS is a wake-up call for plurilateral groupings, too. Exist if you must, but play according to American rules. In the post-World War II world, America was what some call a 'benign hegemon'. Judging by statements from President Trump and Vice-President Vance, it is recasting its image as a hegemon that sets new rules for the rest of the world, where American slash-and-burn selfinterest and interpretations of morality set global parameters, that America will not be "ripped off" by allies and adversaries alike. This is why some term the new Trump presidency as 'imperial'.

The 'stark strategic realities' that US Secretary of Defence Pete Hegseth spoke of recently suggest that America will withdraw from the defence of Europe, leaving this responsibility to the Europeans themselves, that peace in the Russia-Ukraine conflict means that Russia is the stronger side and that Ukraine cannot be a part of NATO or seek a return of territory taken by Russia, that Palestine and Palestinians are a lost cause since Israel is the champion in a winner-take-all world. As far as China is concerned, even as trade competition will be fierce, Trump seems ready to extend the olive branch to President Xi Jinping on other fronts, or at least, engage with him in a sustained manner. There are no friends and enemies in this scenario, only transactions to be made and deals to be secured. India must set its diplomatic compass accordingly.

नई दिल्ली। मार्केट कंट्रोलर सिक्योरिटीज एंड एक्सचेंज बोर्ड ऑफ इंडिया (सेबी) ने नियमों का उल्लंघन करने के आरोप में 19 फॉरेन कैपिटल इन्वेस्टर्स (एफवीसीआई) के खिलाफ कड़ा कदम उठाते हुए उनका रजिस्ट्रेशन रद्द कर दिया है। आरोप है कि ये फॉरेन वेंचर कैपिटल इन्वेस्टर्स अपने रजिस्टर्ड एडेस से कारोबार नहीं कर रहे थे। इसके साथ ही इन पर नियमित तौर पर तिमाही रिपोर्ट फाइल नहीं करने का भी आरोप है।

इस संबंध में मिली जानकारी के अनुसार, सेबी की जांच में इस बात का पता चला कि सभी 19 आरोपी फॉरेन वेंचर कैपिटल इन्वेस्टर्स ने 2013 से लेकर 2023 के बीच अपने रजिस्टर्ड ऐड्रेस से काम करना बंद कर दिया था। इन कंपनियों का रजिस्टर्ड ऐड्रेस सिंगापुर, मॉरीशस और साइप्रस में है। आरोप है कि इन 19 एफवीसीआई में से 6 ने कभी भी अपनी तिमाही रिपोर्ट दाखिल नहीं



प्रतिशत की कमजोरी के साथ बंद हुए। आज दिन भर के कारोबार के दौरान पब्लिक सेक्टर एंटरप्राइज. आईटी और एनर्जी सेक्टर के शेयरों में खरीदारी होती रही। इसके साथ ही मेटल, ऑयल एंड गैस और टेक इंडेक्स भी बढ़त के साथ बंद होने में रहे। एफएमसीजी. ऑटोमोबाइल और बैंकिंग सेक्टर के शेयरों में बिकवाली का दबाव बना रहा। इसके अलावा कैपिटल गुड्स,

गए नीलसन सर्वे में सामने आया कि तेजी से उभरते हुए देशों में महिलाएं बेहद दबाव में हैं, लेकिन उन्हें आर्थिक स्थिरता और अपनी बेटियों के लिए शिक्षा के बेहतर अवसर मिलने की उम्मीद भी दूसरों के मुकाबले कहीं ज्यादा है। सर्वे में 87 प्रतिशत भारतीय महिलाओं ने कहा कि ज्यादातर समय वे तनाव में रहती हैं और 82 फीसदी का कहना है कि उनके पास आराम करने के लिए वक्त नहीं

> होता। हालांकि तनाव में रहने के बावजूद इस बात की काफी संभावना है कि भारतीय महिलाएं आने वाले पांच साल के दौरान अपने ऊपर ज्यादा खर्च करेंगी। 96 प्रतिशत का कहना है कि वे कपड़े

खरीदेंगी जबिक 77 फीसदी कहती हैं कि वे लेकिन यदि उन्हें लक्ष्य दिया जाए तो वे सेहत और सुंदरता से जुड़े उत्पादों पर जेब खुद को सशक्त महसूस करती हैं, महिलाएं

बिजली से चलने वाली चीजें लाना चाहती हैं। सर्वे के अनुसार दुनिया भर में महिलाएं उच्च शिक्षा प्राप्त कर रही हैं और बड़ी संख्या में नौकरियां कर रही हैं। उनके काम करने से घर की आमदनी भी बढ़ रही है। महिलाओं ने सर्वेकर्ताओं को बताया कि जब उन्हें अपने लक्ष्य मिलते हैं तो वह खुद को सशक्त महसूस करती हैं, लेकिन इससे उनका तनाव भी बढ़ता

तनाव और समय न होने के मामले में मेक्सिको की महिलाएं दूसरे नंबर पर हैं। वहां 74 प्रतिशत महिलाएं इस समस्या से परेशान हैं। इसके बाद रूप में 69 प्रतिशत महिलाएं तनाव झेल रही हैं। सर्वे के मुताबिक इस तनाव के लिए एक हद तक सामाजिक बदलाव भी जिम्मेदार हैं। वहीं विकसित देशों में स्पेन में सबसे ज्यादा 66 प्रतिशत महिलाएं तनाव की शिकार हैं। इसके बाद फ्रांस में 65 प्रतिशत और अमेरिका में 53 प्रतिशत महिलाएं इस समस्या सजूझ रही हैं। सर्वे में उभरते हुए देशों

करेंगी और आर्थिक रूप से स्वावलंबी बनेगी।

महिलाएं अब पहले की तरह अबला नहीं रहीं। चाहे राजनीति का क्षेत्र हो या तकनीकि या फिर सेना का, हर क्षेत्र में महिलाओं की जबरदस्त भागीदारी है। उन्हें पहले से ज्यादा अधिकार मिले हैं और आगे बढने के अवसर भी। लेकिन ये भी सच है कि वे आज भी घर पर वे हिंसा का शिकार बनती हैं और दफ्तर में भी उनसे भेद भाव किया जाता है। मुमकिन है आप इस बात पर एकाएक यकीन न करें लेकिन संयुक्त राष्ट्र की एक रिपोर्ट में यह बात का खुलासा हुआ है। रिपोर्ट में कहा गया है ऐसी लाखों महिलाएं हैं, जो जीवन में कभी ना कभी अपने पति के हाथों हिंसा का शिकार हुई हैं। ऐसा बहुत बार देखा गया है कि महिलाओं को फैसले लेना का हक नहीं दिया जाता, उन्हें खुद को हिंसा से बचाने की भी अनुमति नहीं होती। रिपोर्ट में कहा गया है कि एसे 186 देश हैं जिन्होंने अंतरराष्ट्रीय नियमों के अनुसार देश में लिंग भेद खत्म करने की प्र


¹हिलाएं घर से लेकर दफ्तर ढीली करेंगी। वहीं 44 फीसदी महिलाएं घर में मानती हैं कि बेटियां उनसे ज्यादा शिक्षा हासिल ली है, लेकिन वे ऐसा करने में नाकाम रहे हैं। 127 देश तो ऐसे हैं जो बलात्कार की सजा भी नहीं दे पाते और 61 देशों में गर्भपात पर रोक है। संयुक्त राष्ट्र की एजेंसी यूएन वूमन ने यह रिपोर्ट प्रस्तुत की है। रिपोर्ट में कहा गया है कि आज से दो शतक पहले केवल दो ही देशों में महिलाओं को मताधिकार था लेकिन अब लगभग हर देश में महिलाओं को यह अधिकार प्राप्त हो गया है। इसके बावजूद उनके उत्पीड़न और प्रताडित किए जाने की घटनाएं सामने आती रही हैं।

महिलाओं को घर पर बुरे व्यव्हार के साथ-साथ दफ्तर में भी तनाव का सामना करना पड़ता है। रिपोर्ट में कहा गया है दुनिया में आधी से अधिक नौकरी पेशा महिलाएं ऐसी नौकरियां कर रही हैं, जहां वे सरक्षित महसस नहीं करती। इनकी संख्या करीब साठ करोड है और जिस तरह की नौकरियों में वे फंसी हुई हैं,

वह श्रम कानूनी के दायरे से भी बाहर है। रिपोर्ट में यह भी पाया गया है कि परुषों की तुलना में महिलाओं को तीस प्रतिशत कम वेतन मिलता है।

Arshdeep Singh over Harshit Rana to replace Jasprit **Bumrah: Ricky Ponting**

New Delhi Former Australia captain Ricky Ponting believes that India seamer Arshdeep Singh is the best choice to replace the injured Jasprit Bumrah in the playing XI for the upcoming Champions Trophy. While India named Harshit Rana as Bumrah's replacement in the squad, Ponting feels Arshdeep is better suited to lead the attack in Bumrah's absence.Bumrah's injury left a significant gap in India's bowling unit, raising concerns about who will step up to anchor the attack in a tournament where India will be aiming to end their long wait for an ODI silverware. Despite initially being named in India's 15-man squad, Bumrah was ruled out of the tournament due to a back injury sustained during the Sydney Test of the Border-Gavaskar Trophy.India handed Harshit Rana his ODI debut in the recent series against England, but he struggled with the new ball. Although he improved in his second spells, Ponting, speaking on The ICC Review, expressed concerns over Harshit's lack of control in the early overs and backed



Arshdeep as a better fit for the role."I would go with the left-armer and I'd go with Arshdeep (to replace Bumrah)...We know how good he's been in T20 cricket and if you think about the skill set, he probably provides a similar skill set to what Bumrah does with new ball and death overs and that's what India will miss," Ponting said."That's taking nothing away from Harshit Rana because I think he has got a lot of talent and we know what he can do with the new ball, but I don't think his death skills are as good as what Arshdeep Singh's are...And just that left-arm variation, someone that can bowl left-arm with a new ball and move the new ball. We know how important they are and crucial they can be, especially in big tournaments when you've got a lot of righthanders at the top. I would personally lean that way if I was India," he added. Harshit has shown promise across all formats, becoming one of the few bowlers to claim three-wicket hauls on his Test, ODI, and T20I debuts. He picked up 3/48 on his Test debut against Australia in Perth, followed by 3/33 against England in his first T20I in Pune, and 3/53 in his maiden ODI against England in Nagpur.

New Delhi. Fast bowler Awais Ahmad fulfilled his dream when he bowled to Rohit Sharma and Virat Kohli during India's nets session in Dubai ahead of the Champions Trophy. Hailing from Khyber Pakhtunkhwa, Pakistan, Ahmad impressed both Rohit and Virat, swinging the ball both ways. A video recently went viral in which Rohit praised the pacer for his skill.

Rohit also mentioned that Ahmad specifically targeted his boots with yorkers. After that, he batted perfectly and didn't make any mistakes in his stroke play," Ahmad said in an interview with Sports Today." After the net session, Rohit appreciated me. I tried to deceive Rohit Bhai with yorkers, similar to how Shaheen Shah Afridi bowls to him. Later, Rohit said that I aimed for his foot, and that gave me confidence."Both happy and nervous'

On February 23, India will be up against Pakistan in the marquee clash at the Dubai International Cricket Stadium. Ahmed said that he was privileged to have got the chance of bowling players of the calibre of Rohit and Virat."He was definitely practising with the thought that India would face Pakistan later. People dream of meeting Rohit Sharma and Virat Kohli, and I'm lucky that I got to bowl to them."I didn't feel nervous while bowling today, but when I received the message from Mohit (Raghav) bhai yesterday that I would be bowling to the Indian team, I was both happy and nervous at the same time," Ahmed added. New Zealand still has squad depth for Champions Trophy despite injuries: Shane Bond

New Delhi Former New Zealand cricketer Shane Bond believes that despite a series of injury setbacks, the Black Caps still possess strong squad depth heading into the Champions Trophy. Bond emphasized that the number of all-rounders in the squad provides balance and flexibility, making New Zealand a competitive force in the tournament.New Zealand has suffered multiple injury blows, including the losses of Ben Sears and experienced pacer Lockie

Ferguson, both of whom have been ruled out of the tournament. Their replacements, Jacob Duffy and Kyle Jamieson, have been drafted in to bolster the squad. However, Bond, while speaking to ESPN Cricinfo, explained that despite these disruptions, New Zealand remains a well-rounded team capable of fielding a strong playing XI. He particularly highlighted how the presence of several all-rounders enhances the squad's depth, allowing for a more balanced batting lineup."It's transitioning, but really there's still a lot of depth and experience within that New Zealand team.

If you look at who they've lost, they've lost probably (Trent) Boult and (Tim) Southee, and obviously a few others. (Lockie) Ferguson now through injury. But it's a very experienced lineup. It's a lineup that has got experience in subcontinent conditions, they've been successful over the last period of time. It's a very good one day side and New Zealand will take a lot of confidence into this

tournament given the recent success in the Tri-series," Bond said. "I think having four spin-bowling allrounders, and three of them being genuine batsmen means Mitch Santner will coming at eight. You could even potentially have a Nathan Smith at nine or a Matt henry at nine. So New Zealand's depth of batting, there's lif and right handers throughout the order and there's power hitting. So after the wickets turn, New Zealand have got their depth with (Rachin) Ravindra, who they'll come back in a spin bowler and experience through that batting lineup. Someone like Will Young's



likely to miss out, Mark Chapman, who's been very successful in Pakistan. I think New Zealand will take a great deal of confidence in the squad that they've got and the recent Tri-Series will really help their confidence, which is sort of very different to the T20 World Cup. Champions Trophy opener against co-hosts Pakistan on February 19 in Karachi. Their recent Tri-Series victory over Pakistan at the same venue gives them a psychological edge heading into the tournament. However, concerns remain over injuries, with star all-

rounder Rachin Ravindra also in doubt for the opener. Ravindra suffered a serious facial injury during the Tri-Series and is still undergoing recovery. New Zealand head coach Gary Stead recently stated that the 25-year-old is making gradual progress, but his absence would be a significant setback for the team.Despite these challenges, Bond remains optimistic about New Zealand's chances in the Champions Trophy. He believes that their recent successes, combined with the squad's versatility, will help them remain competitive. The

team will also be motivated to improve their ICC tournament record, having suffered heartbreak in the 2019 ODI World Cup final and an early exit in the 2023 edition at the hands of India. With a mix of experience, confidence, and a solid core of all-rounders, New Zealand will look to overcome their injury woes and make a strong statement in the Champions Trophy.

Is the Champions Trophy still relevant in the age of T20 cricket dominance

New Delhi. The return of the Champions Trophy could be a defining moment in the history of one-day international (ODI) cricket. After speculation that it would be scrapped despite a successful 2017 edition featuring a blockbuster India vs Pakistan final, the tournament remained in limbo for nearly eight years. The International Cricket Council (ICC) has now revived arguably the most competitive ODI tournament, announcing two editions-2025 and 2029—in a bid to revitalise the format.

It is tough being an ODI. It has neither retained the charm and loyalty of purists, as Test cricket has, nor has it generated the financial returns for cricket boards that the fast-paced, three-hour-long Twenty20 internationals (T20Is) bring. The decline in bilateral ODIs



serves as a stark reminder that the format

Champions Trophy 2025: Full coverage

It was no surprise that former ICC chief Jagmohan Dalmiya, one of cricket's finest administrators, introduced the Champion Trophy in 1998 (then known as the ICC KnockOuts) to generate revenue for the game. The initiative proved successful—the inaugural edition earned USD 20 million, according to ESPNcricinfo.However, since the success of the first T20 World Cup, ODI cricket has taken a significant hit. Between 1990 and 2006, when ODIs were the financial backbone of the sport, a total of 1,871 ODIs were played. During the same period, only 12 T20Is took place. The landscape changed dramatically after the inaugural T20 World Cup in 2007, which was a massive success, particularly with India winning the title. Since then, despite an increasingly packed cricket

calendar: 2,373 ODIs have been played. 3,080 T20Is have been played.

Among Test-playing nations, 2,040 ODIs and 1,320 T20Is have taken place.

The trend is even more striking when looking at the teams participating in the upcoming Champions Trophy: Since the end of the 2023 ODI World Cup, these eight teams have played 229 T20Is but only 101 ODIs.

New Delhi. Serbian tennis star Novak Djokovic's struggles in 2025 continued as he suffered a shocking defeat to Matteo Berrettini in the Round of 32 at the Qatar Open on February 18. Despite a hard-fought first set that ended in a tiebreaker, Berrettini dominated the second set to secure a 7-6 (4), 6-2 victory over the World No.7.Djokovic had been expected to make a strong comeback in Qatar after his hamstring injury forced him to retire hurt in the Australian Open semi-final against Alexander Zverev. Given that he had never lost to Berrettini in their previous four career meetings, the Serbian was heavily

favoured to win. However, the Italian displayed an aggressive game plan, outplaying Djokovic in key moments. After the match, Djokovic admitted that he was physically fine and played without pain from his recent injury. However, he expressed disappointment in his performance, acknowledging that he had not been able to execute his game plan

Eliesse Ben Seghir fired the visitors ahead but Vangelis Pavlidis struck from the spot to keep the score tied

on the night.French youngster George Ilenikhena netted in the 81st minute for Monaco but Kokcu prodded home to send Benfica through."It was a tough night, we knew Monaco would put pressure on us from the start and we felt it, we didn't play



our best game," Kokcu told SportTV."Still, we're happy to have progressed to the last 16, I'm happy to have contributed to the result."Monaco hammered Nantes 7-1 on Saturday in the French top flight, sharpening their pencils ahead of their crucial exam at the Estadio da Luz.Both sides were without

key players through injuy and suspension, with Benfica missing Angel Di Maria among others, while Monaco started with just one recognised midfielder. Wingers Maghnes Akliouche and Ben Seghir played more centrally than usual and both shone in Lisbon, despite ending up on the losing side.
