World Hamas released six Israeli hostages on Saturday as part of the deal. One of the hostages, Omer Shem Tov, surprised everyone when he kissed two of his captors on stage and blew kisses to the crowd before being released after more than 500 days. Omer Shem Tov, after coming back home, has now claimed that he kissed his captors under pressure and he was "told to do so", Daily Express reported. Shem Tov's father said that his captors "compelled him to wave and to kiss [on the top of the head] that [masked] guard who was standing next to his?" The minister expressed his condolences to the victims' families.Luis Roncal, head of the local fire department, confirmed that they "did not find any signs of life" as they monitored with rescue dogs, but that the search for survivors would continue.

Thousands attend Hezbollah leader Nasrallah's funeral five months after his death

BEIRUT. Tens of thousands of people gathered in Beirut early Sunday to attend the funeral of Hezbollah's former leader, nearly five months after he was killed in an Israeli airstrike on a southern suburb of the Lebanese capital. Hassan Nasrallah was killed when Israel's air force dropped more than 80 bombs on the militant group's main operations room. His death was a major blow for the Iran-backed group that the late leader transformed into a potent force in the Middle East.

Nasrallah was the group's leader for more than 30 years

and one of its founders. He enjoyed wide influence among Iran-backed groups in the region and was widely respected in the so-called Iran-led axis of resistance that included Iraqi, Yemeni and Palestinian factions.Officials from around the region including Iran's parliament speaker Mohammad Bagher Qalibaf and Foreign Minister Abbas Araghchi were expected to attend the funeral at the Lebanese capital's main sports stadium. Lebanese officials including the parliament speaker and representatives of the president and prime minister were expected to attend the funeral believed to be Lebanon's largest in two decades. Senior Hezbollah official Ali Daamoush told reporters Saturday that about 800 personalities from 65 countries will be attending the funeral in addition to thousands of individuals and activists who came from around the world."Come from every home, village and city so that we tell the enemy that this resistance will stay and is ready in the field," Daamoush said, referring to Israel.Nasrallah will be laid to rest later Sunday in Beirut while his cousin and successor Hashem Safieddine, who was killed in an Israeli airstrike on a Beirut suburb a few days later, will be laid to rest in his hometown in southern Lebanon. The two had temporarily been buried in secret locations. Hezbollah earlier this month announced plans for their official funerals. Hezbollah has been calling on its supporters to attend the funeral in large numbers in what appears to be a move to show that the group remains powerful after suffering major blows during a 14-month war with Israel that left many of its senior political and military officials dead. Another blow for Hezbollah was the fall in early December of the Assad family's five-decade rule in Syria that was a strong ally of the Lebanese group and a main route for the flow of weapons and money from Iran. As part of the U.S.-brokered ceasefire deal that ended the war with Israel on Nov. 27, Hezbollah is not supposed to have an armed presence along the border with Israel. Hezbollah's rivals have been calling on the group to lay down its weapons all over Lebanon and become a political faction.

Trump ramps up attack over USAID handouts to India: Taking advantage of us

World US President Donald Trump ramped up his attack on the United States Agency for International Development (USAID) funds to India, claiming that it gave "18 million dollars" to India to assist with its election. Trump said that providing money to India for elections was unnecessary since the country didn't need financial aid. He claimed that India "takes advantage" of the US and imposes some of the highest tariffs globally. "Giving money to India for elections. Well, they don't need money. They take advantage of us. They are one of the highest tariffs nations in the world. They have a 200 per cent tariff, and then we give them a lot of money for elections," Trump said.The US President has been raking up the issue time and again after the Elon Musk-led DOGE cancelled the \$21 million FUNDING payout to India and similar grants to On February 19, Trump questioned the

other nations earlier this month. This is the fourth time in five days that the US President reiterated his claim about USAID funding efforts to promote voter turnout in India.Trump had earlier hinted that the funds might have been used to interfere in the 2024 Lok Sabha elections without giving any evidence. 'We are asked to prove our identity, who we are, where we have come from," he added. "We are residents. Those who ask should identify themselves as to who they are."Hashim recalled memories, warm like the winter sunshine, of when Gwadar was part of Oman, not Pakistan, and was a stop for passenger ships heading to Mumbai. People didn't go to bed hungry and men found work easily, he said. There was always something to eat and no shortage of drinking water.

But Gwadar's water has dried up because of drought and unchecked exploitation. So has the work.

Israel delays release of 620 Palestinians over 'humiliating' hostage handover

Al-Sayed and Mengistu had been held by Hamas since they entered Gaza of their own accord around a decade ago. Shoham was abducted from Kibbutz Be'eri along with his wife and two children, who were freed in a brief truce in November 2023.

India Clinches Six-Wicket Win Over Pakistan in ICC Champions

Trophy, Kohli Shines with Century

Dubai: India secured yet another dominant victory over Pakistan in an ICC event, defeating their arch-rivals by six wickets in a Group A clash at the Dubai International Stadium on Sunday.

The match, which was expected to be a closely contested rivalry, saw India cruise to victory with 45 balls to spare, thanks to standout performances from Virat Kohli, Shreyas Iyer, and Kuldeep Ya-

Ahead of the match, former Indian spinner Harbhajan Singh had downplayed the hype surrounding the India-Pakistan rivalry, pointing out the disparity in the quality of both teams. His assessment proved accurate, as Rohit Sharma's side delivered a clinical performance, leaving Pakistan struggling to advance to the knockout stages of the Champions Trophy and relying on other results to secure a spot in the semifinals.

This loss nearly seals Pakistan's



exit from the tournament, with the defending champions all but eliminated. If Bangladesh loses to New Zealand on Monday, Pakistan will be officially out of the Champions

Chasing a target of 242, Virat Kohli starred with a matchwinning knock, scoring his 51st ODI century and 82nd international ton to guide India to a comfortable victory. Kohli was well-supported by Shreyas

Iyer, who contributed 56 runs. The duo put on a solid 114run partnership for the third wicket, and Pakistan bowlers had no answer to their patient yet aggressive approach. India's chase got off to a strong

start with Rohit Sharma and Shubman Gill. However, a brilliant inswinging yorker from Shaheen Shah Afridi dismissed Sharma for 20. Gill, showing his class, played some beautiful straight drives but

was dismissed for 46 by Abrar Ahmed's well-executed leg-

Kohli and Iyer then took control, with Iyer falling just 28 runs shy of the target while attempting an inside-out shot,

Kohli surpassed 14,000 runs, becoming the third batter after Sachin Tendulkar and Kumar Sangakkara to achieve this feat.

Washington Post refutes Trump's \$21 Million India Voter



New Delhi: The Washington Post has dismissed former U.S. President Donald Trump's assertion that \$21 million was allocated to India to enhance voter turnout, labeling the claim as false. An investigation by the newspaper revealed that no such program exists in India, contradicting Trump's allegations, according to India Today.

This revelation has given the Indian National Congress (INC) fresh political leverage in its ongoing dispute with the Bharatiya Janata Party (BJP).

In a report titled How a False DOGE Claim Ignited a Political Firestorm in India, The Washington Post clarified that the \$21 million grant was, in fact, awarded to Bangladesh, not India, by the U.S. Agency for International Development (USAID). The report, which referenced U.S. officials, corroborated an earlier story from The Indian Express, which noted that India has not received USAID funding for election-related activities since 2008.

The controversy began when Elon Musk's DOGE platform falsely claimed that it had canceled a \$21 million grant intended to boost voter turnout in India. DOGE linked the grant to a larger \$486 million disbursement to the Consortium for Elections and Political Process Strengthening (CEPPS), a coalition of non-profits backed by USAID. However, The Washington Post, citing multiple U.S. sources familiar with foreign aid programs, confirmed no such initiative was in place for India.

A U.S. official told The Washington Post, "We were all shocked to see that claim from DOGE. We don't know anything about elections in India because we've never been involved." Another official suggested that Musk's team may have confused figures from different programs.

The findings have further inflamed the political battle between Congress and the BJP. Congress spokesperson Pawan Khera seized upon the report, accusing the BJP and its supporters of spreading false information. "In this latest expose on the so-called US funding to increase voter turnout in India, The Washington Post discovers that no such program existed and no such funding came in. For the BJP and its blind supporters, crow is part of their daily diet plan. Who else will eat crow following this comedy of errors?" Khera

Meanwhile, Trump has continued to suggest that the Biden administration may be interfering in India's upcoming 2024 Lok Sabha elections. "Why do we need to spend \$21 million for voter turnout in India? I guess they were trying to get somebody else elected. We have got to tell the Indian government," Trump said earlier this week.

Despite his persistent claims, Trump has not provided any concrete evidence to back his allegations.

Affordable Cancer Care and Daycare Centres in Every District by 2027: PM Modi

New Delhi: In a significant milestone for India's fight against tuberculosis (TB), the Ministry of Health and Fam-Chhatarpur: Prime Minister ily Welfare has announced the detection of over five lakh TB cases during its 100-day TB elimination campaign. The campaign, which spanned 455 districts across the country, resulted in the diagnosis of more than 3.57 lakh TB patients. The Ministry also reported that as part of the intensified case detection efforts, over 10 crore vulnerable individuals were screened, reducing diagnostic delays, identifying drug-resistant cases early, and improving treatment out-As part of the initiative, 10 lakh Ni-kshay Shivirs were or-

ganized, bringing modern TB diagnostic tools closer to people's homes, especially in remote areas. To further extend the reach of TB services, 836 Ni-kshay Vahans were deployed, ensuring that even the most remote regions received coverage.

Over 5 Lakh TB Cases Detected in

100-Day National Campaign

A key feature of the campaign has been the participation of community members through the Ni-kshay Mitra initiative. Over 240,000 Ni-kshay Mitras have registered through Ni-kshay Shapaths, pledging to support TB patients with essential resources, including nutritional baskets and psy chosocial and vocational assistance. So far, over 230,000 food baskets have been distributed to patients.


In addition to these efforts, the campaign introduced a new strategy for the early identification of TB. As part of this initiative, chest X-rays have been used as a screening tool for individuals at higher risk of developing TB. More than 38 lakh people have been screened using chest X-rays, including many who showed no typical symptoms of the disease. These comprehensive measures reflect the government's commitment to achieving TB elimination in India and improving health outcomes for those affected by the disease.

Revanth Reddy urges Backward Class leaders to promote caste survey findings

The Telangana government has conducted a caste census. Chief Minister Revanth Reddy urged backward class leaders to campaign for its findings and called on the BJP to include caste data in the national census.

Hyderabad. Telangana Chief Minister A Revanth Reddy on Saturday criticised the Bharatiya Janata Party (BJP) and the previous Bharat Rashtra Samithi (BRS) government over the caste census, accusing them of obstructing social justice efforts. He said the BJP opposed the survey, while the BRS conducted a similar survey but never disclosed

The BJP is spreading misinformation because it is against the caste census," Reddy said addressing the representatives of several Backward Class (BC) associations on Saturday at Praja Bhavan.

According to a survey by KCR, "backward classes constituted 51 per

cent of the population. Our caste census shows it is 56.33 per cent. BC leaders should take note," he said.

He also criticised the BRS for not making public the findings of its Comprehensive Family Survey. "The last government used the survey report only



during elections and not for the people," he said. The Telangana government has now conducted a caste census, fulfilling a promise made by Congress leader Rahul Gandhi during the Bharat Jodo Yatra, Reddy said. He emphasised that the survey was carried out with full participation from the people and without legal hurdles. He urged backward class leaders to campaign for the survey's findings. "My responsibility ends with the completion of the process. Now it is your turn to take it forward." He called on the BJP to include caste data in the national census. "We are adopting a resolution demanding that the caste census be included in the national census.

He urged backward class communities to hold meetings and pass resolutions by March 10. "Show your unity. Only then will you get political, educational, and job benefits," he said. "The caste census is like the Bible, Bhagavad Gita, and Quran for all weaker sections,'

MSP talks between Centre, farmers' unions end without resolution

Chandigarh. Another round of negotiations between central ministers and farmer unions ended without a resolution, as discussions on the minimum support price (MSP) continued without agreement. Farmers sought a legal guarantee for MSP on all crops and demanded data on its implementation.Union and state government representatives described the meeting as constructive, with discussions covering various aspects of MSP. Another round of talks is scheduled for March 19 in Chandigarh.

This was the second meeting in eight days and the sixth in more than a year. A resolution to the crisis remains elusive as the central dispute concerns the financial viability of MSP for all crops. Farmers estimate the cost to be between Rs 25,000 crore and Rs 30,000 crore, while government argue that the actual requirement is much higher.

Union Agriculture Minister Shivraj Singh Chouhan said the talks were conducted in a positive environment. "We have heard the farmers properly. These talks will continue. The next meeting is on March 19 in Chandigarh," he said.

Punjab Finance Minister Harpal Cheema said the discussions were detailed and focused on MSP. "A data set on which crops are sold in open markets and in what quantity



will be shared with the union government in the next few days. MSP was the central point of the talks. Farmers' organisations stressed on getting a legal guarantee for MSP. The union ministers also requested Jagjit Singh Dallewal to end his hunger strike," he said. After the meeting, farmer leader Abhimanyu Kohad said the

The tryst with destiny of Delhi's woman Cms

The surprise choice of first-time MLA Rekha Gupta as the Chief Minister of Delhi has brought back the focus on woman CMs in the national capital. A buoyant BJP is showcasing Rekha Gupta's elevation as proof of Prime Minister Narendra Modi's thrust on 'Nari Shakti' and a reward for woman voters who opted for the saffron party.

Rekha Gupta is the second woman chief minister of the BJP (after Anandiben Patel in Gujarat) since 2014 and the only woman among the current CMs in 20 BJP/NDA-ruled states and UTs. Considering that women account for around 50 per cent of the voting population, this is a dismal record.

We must also remember that Indira Gandhi became prime minister way back in 1966, much before many western democracies got a woman PM. This highlighted the limited space for women in power in their own country. The late Khushwant Singh used to say that a significant presence of women in political-public spaces consisted of the anglicised, upper-class gentry of India and the working class did not have the same ease and access to power as the elite, upper-class women.

While the BJP under Modi is trying to change this, a cursory look at all woman MLAs and MPs shows a disproportionately high representation of dynastic politicians as compared to the inclusion of working class woman leaders. Yet, woman politicians, just like Indira Gandhi, have been successful in transforming politics in a big way. Take Sheila Dikshit, for example. Sonia Gandhi had turned to Sheila Dikshit in 1998 when the glory of Prime Minister Atal Bihari Vajapyee was on full display and Sonia Gandhi had just taken over as Congress president. There was mild rebellion over the manner in which her successor Sitaram Kesri was dumped and how the General Elections in 1998 had given the Congress lesser number of seats than the post-Emergency 1977 Lok Sabha polls.Sonia was desperate to do something spectacular to gain the confidence of her own rank and file. Elections in Delhi, Madhya Pradesh and Rajasthan were round the corner. The Delhi Congress unit was particularly in disarray, sharply divided between supporters and opponents of an ailing and aging HKL Bhagat. Sajjan Kumar and Jagdish Tytler were not an option as a sizeable Sikh population in Delhi was against them on grounds of their dubious role during the 1984 Sikh carnage. At a meeting of the Indira Gandhi Memorial Trust held at 10, Janpath, Sheila Dikshit's name was proposed as Delhi CM. While Sonia quickly came on board, Dikshit required encouragement from K Natwar Singh to take up the challenging assignment. The rest, as they say, is history. Sheila Dikshit rode high on the rising onion prices and delivered Delhi for Sonia, beating Sushma Swaraj who was the then BJP chief minister of Delhi. If there was anyone more stunned than Sushma Swaraj and Vajpayee, it was HKL Bhagat and a section of the Congressmen who had tried their level best to sabotage Congress' prospects. Sheila's sincerity, appeal to the great Indian middle class, simplicity and vision for big flyovers, metros, malls and parks helped her tide over all challenges. In 2016, however, Sheila Dikshit faced a rather unsurmountable challenge, when she was projected as the Congress chief-ministerial candidate in Uttar Pradesh. Age was not on her side as Sheila struggled to look for a 'safe constituency' for herself in UP. Unlike Delhi, the UP Congress unit was both defunct and demoralised.Interestingly, Sonia relied on Sheila Dikshit each time she faced a difficult situation. In 2012, when Pranab Mukherjee moved to Rashtrapati Bhavan and P Chidambaram shifted to the Finance Ministry, Sonia had toyed with the idea of making Sheila Dikshit the Home Minister y. But Sheila Dikshit reportedly declined the offer, hoping to win Delhi for a record fourth time in 2013. 'Kaun jaaye Dilli ki gallian chhod kar' was the refrain.But her calculations misfired when Sheila lost her own election to a former revenue service official, Arvind Kejriwal. Not only did she miss the North Block bus, she also saw the

Walls, chains & cheap labour: West's hypocrisy on migration

While right-wing politicians in destination countries reap the electoral benefits of demonising 'illegal' immigrants, their economies are in dire need of a cheap and docile foreign workforce.

Since the first US military aircraft carrying 104 deported Indians landed in Amritsar on February 5, a slew of comments has emerged in the Indian media addressing the inhumane condition of the deportees' transportation and the response (or lack of) of the Indian authorities.

Many heart-wrenching stories have been published about sacrifice of their families, including selling land, to send them abroad. Their socio-economic profiles and reasons for migration have also been highlighted.

As a scholar who has worked for 25 years on the Sikh diaspora, I found that though interesting, these stories miss a very important point — migration is not per se a access to. criminal activity. It has been projected as a criminal activity recently in the countries of destination of migrants. In the US, it has been done mainly since 9/11.

But in Europe, the process had started earlier in the context of the dismantling of EU's internal borders and the fortification of its external ones. Indeed, because of the seemingly unstoppable wave of populist anti-immigrant discourse and the resultant increasingly restrictive border regimes, illegality, criminality and a sense of threat have become the dominant lens through which the state in the destination countries sees migrants from the Global South.Let me argue here that we should apply a different lens and try to change the narrative around international migration and humanise it. To start with, we must change our terminology. Many scholars and activists promote the use of 'undocumented' migrants, which is a more neutral term, instead of 'illegal' migrants, which stigmatises and criminalises mobile people. The lack of humanity and dignity during the horrendous 40-hour journey of the

deportees, turbans removed, handcuffed and even legchained like criminals is for all to see, except for the Indian government, which seems to find not much wrong with the criminalisation and dehumanisation of its own citizens.

In contrast, Colombian President Gustavo Metro strongly protested against the way the deportations were carried out, stressing the need to treat the deportees with dignity and respect. Initially, he even denied entry to two US flights before backing down, when threatened by Trump of a 50 per cent rise in tariffs on Colombian imports. Among the reasons for the lack of a strong response by

Delhi seems to be a bid to placate the US government and protect H-1B visas for skilled Indian migrants. This narrative of skilled (read 'good', 'wanted') vs unskilled (read 'bad', 'disposable') migrants is used in many destination countries to exploit the latter and deprive them of basic human rights.

services and care sectors — are in dire need of a vulnerable foreign workforce. 'Illegal migration' is not a natural category. It is a political construct, an instrument that serves a purpose: of disciplining and coercing a docile and cheap immigrant labour force into accepting what sociologists call 3 Ds (dirty, dangerous, demeaning) jobs, shunned by the

national population. The hypocrisy of anti-immigrant rhetoric is probably best exemplified by none other than Trump himself. As reported by The Washington Post in 2019, his holding company, the Trump Organisation, has employed for

nearly two decades dozens of undocumented Latin-American construction workers at several properties owned by the company. And, guess why? Because they are cheap, hardworking and too afraid of deportations to complain about a back-breaking, harassing work.


Here, one needs to understand why 'unskilled' men and women from the Global South keep migrating to the Global North despite the increasingly expensive and dangerous journeys they are compelled to take due to the stringent immigration policies enforced by the destination countries. There are multiple reasons for the life-changing decision that emigration entails. They encompass a combination of push factors (socioeconomic or political conditions in the country of origin) and pull factors (what attracts people in the country of destination). To put it bluntly, one major reason lies with

the continuous economic and demographic demand for cheap migrant labour in the Global North despite the anti-immigration rhetoric. Take my own country, France. Who looks after our elderly, who cleans hotel rooms, collects garbage, builds bridges, schools, housing complexes, delivers our orders? Immigrants, of course. And, many of them irregular. They neither come to live on social benefits nor to steal the jobs of the French, as the far-right would have it. Mobility is not a crime. It is a natural human urge. Crossing an international border shouldn't mean losing one's basic rights and dignity. Migrants, whether skilled or unskilled, are not criminals.A hateful narrative dehumanising immigrants has become all too common in many western countries. In a debate with Democrat candidate Kamala Harris, Trump went as far as to refer to Haitian refugees in

Ohio as "eating the pets of the people that live there."Many people and advocacy groups oppose this rhetoric in the West. They argue that border enforcement policies are devastating for migrants, costly for the country of destination and ultimately ineffective because regardless of the risks, people will continue to move as they have done throughout human history. In the case of Punjabis, mass migration was triggered and organised by the British rule to its own advantage. This colonial engineering created a deeply embedded culture of migration that no deportation, no border regime and no walls will be able to uproot.

Beyond slogans

persistence of such figures signals that while awareness campaigns are loud, the societal mindset remains resistant to change. The tragedy extends beyond mothers. Newborn girls continue to be abandoned, their worth determined by outdated patriarchal norms.Gender discrimination is not merely an economic or policy issue; it is a societal failure. Financial aid schemes like the Sukanya Samriddhi Yojana or Kanyadan Policy cannot single-handedly erase centuries of entrenched bias. The need of the hour is grassroots-level transformation. Gender sensitisation in schools, active male participation in equality movements and strict monitoring of government schemes to ensure that they reach the most vulnerable families can make a difference. A decade after its launch, the BBBP must move beyond slogans. It's time for Haryana to prove that its daughters

are not just being 'saved', but also truly valued.

Uplifting stories of upward mobility

Go-getters are surmounting restrictions imposed by the deeply entrenched caste system

After 36 years in the Indian Police Service (IPS), followed by four years in Romania as India's Ambassador, I returned in 1993 to Mumbai, where I was born and where my father's forebears had settled in the first half of the 19th century. I decided to accede to my dear wife's wish to "settle down" in our permanent home, refusing offers that would require me to move out of the city.

complete rout of the Congress in Delhi.

My first thought after deplaning following a long journey from Bucharest via Lisbon (to touch base with my only uncle who had settled there) was to work for the constabulary that lived in the Police Lines near my permanent residence. One visit alerted me to the fact that the perennial problems of alcoholism, domestic violence and errant children were a thing of the past. The constabulary was vastly more educated, with only graduates having made the cut. In one sense, it reflected the paucity of paying jobs in the private sector or, what was more likely, a lack of skills required by industrial houses even at junior levels. There was one other dominant consideration that prompted cops' children to opt for a career in the police. That consideration was the need to assure the personnel who were about to retire from service of a roof over their heads in the 'maximum city'. If the sons and daughters managed to beat the competition, the paternal 'kholi' would be allotted to the new entrant as per the prevalent policy. That would mean that the father would continue to stay in Mumbai instead of being compelled to return to his village, where his siblings and their families had already established themselves. A far greater revolution had taken place. The new entrants to the ranks had married educated girls, many of whom were college graduates like them. The fact that girls are opting for education beyond the high school level is changing the entire dynamics of life in police colonies and beyond. Not every woman is employed, but the many who are have made a huge

impact on their living standards and the social outlook of

the family. They limit the number of their offspring and send their only child or two children to English-medium schools. About a decade ago, I was asked by some eager parents to plead with principals of English-medium schools to admit cops' children to their institutions. Many of them did oblige. My colleague in the IPS, D

Sivanandhan, when he was posted as Commissioner of the Thane police, opened a school in the Police Lines to cater to policemen's children in that city. When he moved to Mumbai as the Police Commissioner, I requested him to repeat the feat here. He did try hard, but found it difficult to locate a suitable and available plot for the school in this overcrowded

On January 1 this year, my former PSO (personal security officer) Rahul Laxman Bhoj and his wife called on me. They brought along their only child, a girl. Rahul's wife Swati is a software engineer who probably used to earn more than him before she became a mother and was forced to take a break from work. Their seven-year-old daughter, Ira, was clearly a very intelligent child, full of confidence and quick on the uptake. She impressed me immensely. I am sure that with the

personal attention that the mother is giving the child, Ira will turn out to be an asset not only to the family but also to Maharashtra and the country. Karthik is the son of Ramesh Wala, who sweeps the compound of the building where my former colleagues and I stay. He had been enrolled in an English-medium school, but his ability to speak the language needed a huge boost. I asked the boy to accompany me on my daily walk around the building, speaking only in English. His skill

improved. He went on to enter a university and landed a job as an event manager after graduation. It gives me immense satisfaction to mention these upward mobility cases that are helping to surmount the restrictions imposed by the deeply entrenched caste system. Even the four-centuries-old conversion to Christianity in Goa



had not made a proper dent in the caste configuration. The priesthood was thrown open to all, but inter-caste marriages continued to remain out of bounds. Ten years ago, I met Bernardo, the son of the landless labourer who had been allotted a small plot on my maternal grandparents' landed property in the Goan village from where they hailed. He had worked in Dubai, earned a tidy amount of dirhams, returned and built a proper house to replace the mud hut that passed for his dwelling

place. His two daughters had studied in English-medium institutions, graduated, done clerical jobs in Mumbai, got married and made a better life for themselves than their disadvantaged parents.

Bernardo offered me a beer. I asked him to share it with me, but he would not. No amount of gentle persuasion

could make him change his mind. I said we would drink to the fact that he had educated his girls so well. Even that was unable to do the trick. In contrast to Goa, Bihar has much catching up to do. After I broke the neck of my femur bone five years ago and underwent surgery, a famous physician, Dr Farokh Udwadia, warned me of worse consequences in case I fell again. I hired a boy from Bihar to ensure that I did not fall. He told me that he was a 'Maha Dalit'. I had not heard of any such category in Maharashtra. Five months ago, he approached me with tears in his eyes as the village medical clinic run by the government had detected a hole in the heart of his recently born son. The doctor in charge told him to take the child to Delhi or Mumbai. The very fact that the authorities have opened a medical unit in one village of a cluster

was a great advance. One or two decades ago, the hole in the heart would have gone undetected! Arrangements for mother and son to travel to Mumbai were made. My nephew, one of Mumbai's leading cardiologists, attended on the tiny one who has as much a right to live as you and I. These are positive stories of progress that should take my readers' minds away from Uttarakhand's Uniform Civil Code and the installation of the new Delhi



Hero to villain Dubai set to play defining role in Babar Azam's career once again

New Delhi. On Sunday, February 23, senior Pakistan batter Babar Azam will once again step onto Dubai International Stadium against India. The last time that Babar played India at an ICC event in Dubai, the match made him an international icon and a hero to millions of Pakistanis across the world.

In the 2021 game, Babar scored a brisk 68* against India, helping Pakistan secure their first-ever win in a World Cup match against India. Babar, the captain of the side, became the apple of the eye for the nation and the cricket board. Of course, he was also adored by fans across the world. Fast forward to 2025, Babar Azam, now removed from the post of captaincy, returns to the stadium once again. The conditions of Babar's return are drastically different. Since his win in 2021, many might argue that Babar lost his way in international cricket. Once lovingly dubbed as the 'King', Babar has not only failed to fulfil the promise, but many might say that he has overstayed his welcome in the Pakistan team. Since the highs of the 2021 and 2022 T20 World Cups, Babar Azam's career has gone downhill. Even though Pakistan reached the final of the 2022 World Cup,



Babar was criticised for his poor batting in the tournament. Since then, the criticism has only compounded on Babar, under whom Pakistan crashed and burned in the 2023 and 2024 editions of the ICC events. After Ramiz Raja's departure from the Pakistan Cricket Board, Babar lost his impunity and, with that, his captaincy in all three formats of the game. They say that you either die a hero, or live long enough to become a villain. It rings true for Babar as well, as he simply failed to upgrade himself in the rapidly shifting landscape in all three formats of the game. Will This be the End of Babar's Superstardom?

Once a mercurial batter, Babar Azam last scored an ODI century in 2023 - against Nepal in the Asia Cup at home. His last century away from home came way back in 2021 - against England. His records in Test cricket have not been any better either. The batter scored his last home and away red-ball hundred back in 2022 against New Zealand and Sri Lanka, respectively. The horrible patch of form saw Babar get sacked from the Test team earlier in 2025 when England toured Pakistan for a 3-match series

Virat Kohli vs Babar Azam: A tale of 2 'kings' looking to break out of form slump

New Delhi. When you talk about the greatest batters of the modern era, two names come to your mind. The all-conquering 'King of Indian cricket', Virat Kohli, has achieved major feats across all three formats of the game. Then Pakistan found their own king in the form of Babar Azam, who has gone from strength to strength since his debut in 2015.

Kohli broke Sachin Tendulkar's record for the most hundreds in ODIs during India's march to the final of the 2023 World Cup, while Babar became the fastest to 6000 runs in the 50-over format. Both men went on to captain their sides to varying success and have been pillars in the batting lineups for their teams. However, things weren't great for both men coming into the much-anticipated India vs Pakistan game in Dubai on Sunday, February 23.Kohli hasn't scored a hundred since the 2023 World Cup and Babar has been slammed massively for his intent to score





runs during high-pressure games. So what's been going wrong for both the stars and what do they need to do? Let's start with Babar. Where is the intent?

This has been the biggest criticism of Babar in the past few years, especially in the whiteball format. If you look at the New Zealand game, the 30-year-old had a simple job and that was to put the pressure early on the New Zealand bowlers. This role of senior player was amplified as Pakistan lost Fakhar Zaman to injury. So the tone had to be set by Babar early on, but what he did was essentially hold his team back. And mind you, this is a man who has scored 3 T20I hundreds and has hit 447 boundaries and 73 sixes during his 128 matches in the format. And all these hundreds came while he was batting as an opener. So the 30-year-old clearly knows how to take the attack to the bowlers and take apart attacks with his elegant shots. But the New Zealand game saw him go into a shell, with Salman Agha and Khushdil Shah's knocks helping them to get to a respectable total in the end.

Spinners are expected to dominate the upcoming fixture as well, which leaves India in a fix, who had their X factor Varun Chakravarthy warming the bench in the first game. Will India ponder unleashing him against Pakistan, which will give the wrist spinner to make amends for his horrible outing against the arch-rivals in 2021. On the other hand, Pakistan will rely on Abrar Ahmed to control the game in the middle overs and will attack with their three-pronged pace attack of Shaheen Afridi, Haris Rauf and Naseem Shah with the new ball. 3. India's dominance in recent times

In the 73-year-old rivalry, both teams have dominated each other in different phases. While Pakistan were a force to reckon with for the first 24 years (1978-2002 in ODIs)

4. Never count out Pakistan



After her dream run, Andreeva will also make her debut in the top 10 of the WTA rankings at No.9 when the new rankings come out."I'd set a goal for myself to be in top 10 by the end of the year. Now it's the end of February, and I've already made it, so this is something



incredible for me. I'm just super happy with the way I was playing today. I was hella (very) nervous. I think you could see it during the match with all those double faults, some mistakes," Andreeva said. Andreeva punched above her weight to beat three Grand Slam champions; Iga

Swiatek, Marketa Vondrousova and Elena Rybakina on her way to winning the tournament."So I'm just really happy that I could manage and deal with the pressure. And now it just feels amazing... This is something I dreamt of and now my dream

came true so I'm just, I'm speechless right now. Lastly, I want to thank me for never quitting and always believing in myself," Andreeva added. Andreeva found herself in early trouble after dropping her serve to go 0-2 down, but earned the break to make it 2-2 and took the set into a tie-breaker. Andreeva stayed unbeaten in tiebreaks this year, winning the first six points.

The second set was a completely one-sided affair as Andreeva stormed to a 5-1 lead. During this

while, Tauson took a medical time-out and also threw her racket on the ground in frustration. Sensing victory, Andreeva stepped up to serve for the title and clinched it as Tauson's return sailed long on her second championship point.
