## Supreme Court, for now, blocks order for Trump administration to release billions in US foreign aid

WASHINGTON. The Supreme Court on Wednesday temporarily blocked a judge's order giving the Trump administration a midnight deadline to release billions of dollars in U.S. foreign aid.

Chief Justice John Roberts said the order issued by

U.S.District Judge Amir H.Ali will remain on hold until the high court has a chance to weigh in more fully. Ali had ordered the federal government to comply with his decision temporarily blocking a freeze on foreign aid, ruling in a lawsuit filed by nonprofit groups and businesses

An appellate panel refused the administration's request intervene. The federal government froze foreign assistance after an executive order from President Donald Trump targeting what he called wasteful programs that do not correspond to his foreign policy

# Mysterious 'crying disease' kills over 50 in Congo: What we know

world. Unidentified illnesses have killed more than 50 people in north-western Congo's Equateur province over the past five weeks, with nearly half of the victims dying within hours of falling ill. Notably, 'crying' is also one of the symptoms reported by patients

Health officials report 419 cases and 53 deaths since the outbreaks began on January 21 in two remote villages separated by over 120 miles.

Authorities are still investigating the cause of the diseases and whether the cases in the two villages—Boloko and Bomate—are linked. It is still unclear how the diseases are spreading, including whether human transmission is involved.

Outbreak details The first outbreak was recorded in Boloko, where three children died within 48 hours after eating a bat. In Bomate, more than 400 people have fallen ill, with

malaria identified in some patients. However, no connection has been established between the outbreaks in the two villages, according to the World Health Organization (WHO).

Dr Serge Ngalebato, medical director of Bikoro Hospital and a member of the government response team, noted differences between the two outbreaks. The first one with a lot of deaths is an unusual situation that we continue to investigate. In the second episode, we see many cases of malaria," he

Symptoms and investigation

Congo's ministry of Health reported that about 80% of patients exhibit symptoms such as fever, chills, body aches, and diarrhoea. Patients experienced symptoms including neck and joint pain, sweating, and shortness of breath. Those under 59 years old reported intense thirst, while children exhibited persistent crying. Initially, concerns were raised about the possibility of a hemorrhagic fever like Ebola, due to the rapid progression from sickness to death. However, Ebola and similar diseases like Marburg have been ruled out after testing more than a dozen samples. The WHO is now investigating other potential causes, including malaria, viral hemorrhagic fever, food or water poisoning, typhoid fever, and meningitis.

# Trump administration says it's cutting 90 per cent of USAID foreign aid contracts

President Donald Trump and ally Elon Musk have hit foreign aid harder and faster than almost any other target in their push to cut the size of the federal government.

WASHINGTON: The Trump administration said Wednesday it is eliminating more than 90% of the U.S. Agency for International Development's foreign aid contracts and \$60 billion in overall U.S. assistance around the world, putting numbers on its plans to eliminate the majority of U.S. development and humanitarian help abroad. The cuts detailed by the administration would leave few surviving USAID projects for advocates to try to save in what are ongoing court battles with the administration. The Trump administration outlined its plans in both an internal memo obtained by The Associated Press and filings in one of those

Wednesday and temporarily blocked a court order requiring the administration to release billions of dollars in foreign aid by midnight. Wednesday's disclosures also give an idea of the scale of the administration's retreat from U.S. aid and development assistance overseas, and from decades of U.S. policy that foreign aid helps U.S. interests by stabilizing other countries and economies and building alliances. The memo said officials were "clearing significant waste stemming from decades of institutional drift." More changes are planned in how USAID and the State Department deliver foreign assistance, it said.President Donald Trump and ally Elon Musk have hit foreign aid harder and faster than almost any other target in their push to cut the size of the federal government. Both men say USAID projects advance a liberal agenda and are a waste of money. Trump on January 20 ordered what he said would be a 90-day program-by-program review of which foreign assistance programs deserved to

continue, and cut off all foreign assistance funds almost overnight. The funding freeze has stopped thousands of U.S.-funded programs abroad, and the administration and Musk's Department of Government Efficiency teams have pulled the majority of USAID staff off the job through forced leave and firings. In the federal court filings Wednesday, nonprofits owed money on contracts with USAID describe both Trump political appointees and members of Musk's teams terminating USAID's contracts around the world at breakneck speed, without time for any meaningful review, they say."There are MANY more terminations coming, so please gear up!" a USAID official wrote staff Monday, in an email quoted by lawyers for the nonprofits in the filigs. The nonprofits, among thousands of contractors, owed billions of dollars in payment since the freeze began, called the en masse contract terminations a maneuver to get around complying with the order to lift the funding freeze temporarily. So did a Democratic lawmaker."The administration is brazenly

attempting to blow through Congress and the courts by announcing the completion of their sham 'review' of foreign aid and the immediate termination of thousands of aid Connecticut Sen. Chris Murphy, a member of the Senate Foreign Relations Committee. The State Department said Secretary of State Marco Rubio had reviewed the terminations.In all, the Trump administration said it will eliminate 5,800 of 6,200 multiyear USAID contract awards, for a cut of \$54 billion. Another 4,100 of 9,100 State Department grants were being eliminated, for a cut of \$4.4 billion.The State Department memo, which was first reported by the Washington Free Beacon, described the administration as spurred by a federal court order that gave officials until the end of the day Wednesday to lift the Trump administration's monthlong block on foreign aid funding. "In response, State and USAID moved rapidly," targeting USAID and State Department foreign aid programs in vast numbers for contract terminations.

# What's next for Trump's agenda after House GOP approves tax breaks and slashed spending in US budget

WASHINGTON. Now that House Republicans have passed an ambitious budget blueprint for US President Donald Trump's agenda, it's time for the hard work of turning ideas for \$4.5 trillion in tax cuts and \$2 trillion of slashed spending into a bill that lawmakers warn could bring intense changes to Americans back home.

Republicans are insisting the costs of the tax breaks be partly paid for by the steep reductions in federal government spending as a way to ensure the nation's \$36 trillion debt load doesn't balloon to dangerous levels.But deciding what to cut—health care, food stamps, green energy, government regulations or student aid—is a politically agonizing choice. And it's not just the House that has to agree. GOP senators have their own plans. Their priority is to make the tax cuts permanent, rather than have them expire in a decade, as the House proposed. GOP senators see that as non-negotiable, but it would skyrocket the costs. Eventually, the House and Senate must vote on a final package.

'We have a lot of hard work ahead of us," House Speaker Mike Johnson said after the late Tuesday vote.



It's the start of a weeks-long-if not months—slog that is expected to consume Congress as Republicans try to deliver on Trump's agenda and their own campaign promises. Trump met Wednesday with Johnson and Senate Majority Leader John Thune at the White House, after Republicans also met with Treasury Scott Bessent. Trump's chief of staff Susie Wiles huddled privately with GOP senators at the Capitol.Republicans say if they fail to act, the lower tax rates first approved in 2017 will expire, which would amount to a massive tax hike for many Americans. They believe keeping the tax cuts in place will partly pay for themselves, unleashing economic growth and fresh revenues, though others say those projections are optimistic.Democrats put up stiff opposition against the House GOP plan—one lawmaker dashed from California after a week's stay in the hospital and another returned to Washington for the vote with her newborn son.Democrats will spend the weeks ahead warning Americans what's at stake."Republicans and Trump promised to lower costs on day

### Clip of Gaza as seaside resort posted on Trump's social media

WASHINGTON. US President Donald Trump's official social media accounts posted an apparently AIgenerated video depicting war-ravaged Gaza rebuilt into a seaside resort, replete with a towering golden statue of himself. The video, which racked up more than 15 million views on Instagram and was shared thousands of times on Trump's Truth Social network by Wednesday morning, prompted some commenters to question whether the president's accounts had been hacked. The 33-second clip remained on Trump's accounts without denial or retraction hours after the initial posting on Tuesday night.

The video "Gaza 2025 What's Next?" opens with people on a rubble-strewn street emerging from a tunnel onto a beach with palm trees and yachts. Trump has floated the idea of a US takeover of Gaza under which its Palestinian population would be relocated - a proposal met with global condemnation. He later appeared to soften his plan, saying he was only recommending the idea, and conceding that the leaders of Jordan and Egypt - the proposed destinations for relocated Gazans had rejected any effort to move Palestinians against



their will.In the social media clip, the soundtrack includes lyrics such as "Donald's coming to set you free, bringing the light for all to see", and "Feast and dance, the deal is done, Trump Gaza number one".

Seemingly AI-generated renditions of Trump and Israeli Prime Minister Benjamin Netanyahu sip cocktails in swimsuits by a pool, while other shots show what appears to be Elon Musk dancing under a shower of cash on the beach. Social media users reacted with both support and criticism, but many questioned whether Trump himself had posted the montage.

AFP did not find any evidence the video had been shared online before it was posted to Trump's Truth Social and Instagram accounts. One scene closely resembles an AI-generated image of Trump and Netanyahu drinking cocktails that began circulating in early February. Another scene shows belly dancers shimmying on the beach, sporting thick, long beards more typically worn by Islamists.

# Electrocuted, Whipped, Tortured: The Reality Of Southeast Asia Scam Centres

Nairobi, Kenya. Starved, beaten and electrocuted, Ahmed remains traumatised months after being trafficked to Southeast Asia, one of an untold number of Africans forced to work in scam centres far from home. The complexes have flourished across the region, often staffed by foreigners who are made to swindle people in what analysts say is a multibillion-dollar industry. Among them are Ethiopians, like 25-year-old Ahmed, who sign up for the promise of well-paid jobs.Instead, they run "love scams" -- often referred to as "pig butchering" -- inside infamous prisonlike compounds that have mushroomed across Laos, Cambodia and Myanmar.

The scammers operate fake profiles of wealthy Western women to lure men, and sometimes women, into investing in crypto-currencies -- before vanishing with their savings. Hundreds have been released from complexes in Myanmar in recent weeks, according to local sources.But the United Nations said in 2023 that "hundreds of

thousands" were "forcibly engaged by organised criminal gangs into online criminality" across Southeast Asia.Ahmed -- whose name AFP has changed to protect his identity -- endured months of captivity last year and returned home in December. 'I contemplated suicide," he said.

Imprisoned, abusedAhmed said he was approached by an old friend offering him a job abroad that paid up to \$500 a month.It was a fortune in Ethiopia where the median monthly wage hovers around \$24, according to the International Labour Organization.

His family raised \$1,600 to send him to Laos, but he soon realised his friend had betraved him when he was sucked into the scam world. He managed to talk his way out of a compound in Laos, only to be abducted by armed men and taken to another in Myanmar, where his captors demanded \$5,000 for his release.

'When I told them I'm poor and don't have money they laughed and then gave me electronic shocks that left me unconscious," he said.On the 11th day, governments.

he said, half-starved, he was presented with a choice: work for free for 18 months, pay the ransom, or have sex on camera.He chose to work for free, but conditions were significantly worse than in Laos."There were people in the compound who lost limbs because of torture," Ahmed said."The administrators of the place used to cut fingers of 'misbehaving or mediocre' staff," he added.

'I feel lucky... Even though I'm still suffering the effects of electrocution, my limbs haven't been amputated.'

Africa targetedAhmed said there were roughly 3,000 people working in the Myanmar centre, including Ethiopians, Kenyans and Ugandans. Africans are increasingly a target for scam centres, which require people who are proficient in English, desperate for work and digitally literate, said Jason Tower, Myanmar country director for the United States Institute of Peace who is based in the Thai capital Bangkok.

# Hamas hands over four dead hostages to Red Cross, as Palestinians leave Israeli prison

Hamas handed over four dead hostages to the Red Cross early Thursday in exchange for Israel's release of hundreds of Palestinian prisoners, days before the first phase of the ceasefire in the Gaza Strip was to end. An Israeli security official confirmed that Hamas handed the hostages' bodies to the Red Cross. Israel said the caskets were delivered with the help of Egyptian mediators through an Israeli crossing and an identification

time, a Red Cross convoy carrying several dozen released Palestinian prisoners left Israel's Ofer prison. Crowds of cheering families, friends and supporters gathered in the West Bank town of Beitunia, jostling for a glimpse of the bus as it arrived.

Well-wishers greeted the released prisoners, hugging them and snapping photos. One released man made a victory sign as he was carried on the shoulders of supporters, with the crowd chanted "God is Great." Hundreds of other prisoners were to be sent

#### India Brands Pakistan a "Failed State" at UNHRC, Criticizes Its Focus on India



New Delhi: India sharply criticized Pakistan as a "failed state" that survives on international aid during a speech at the 58th session of the United Nations Human Rights Council (UNHRC) in Geneva. Kshitij Tyagi, India's Permanent Mission representative, lashed out at Pakistan for spreading falsehoods and misusing the Organization of Islamic Cooperation (OIC) as a mouthpiece for its agenda.

Tyagi condemned Pakistan's continued rhetoric on human rights violations in Jammu and Kashmir and Ladakh, reiterating that these regions are an "integral and inalienable part" of India. He highlighted the progress made in these territories since the abrogation of Article 370 in 2019, which resulted in Jammu and Kashmir being split into two union territories

"Pakistan, a country plagued by human rights abuses, minority persecution, and systemic erosion of democracy, is in no position to lecture others," Tyagi said. He also emphasized that Pakistan's focus should be on improving governance and providing justice to its own citizens rather than obsessing over India.

Tyagi's remarks came amid decades of cross-border tensions and were a strong reminder of the challenges Pakistan faces both domestically and on the international stage.

# DRDO, Indian Navy successfully conduct flighttrials of Naval Anti-Ship missile

New Delhi: The Defence Research & Development Organisation (DRDO) and the Indian Navy have successfully conducted flight trials of the groundbreaking Naval Anti-Ship Missile (NASM-SR) from the Integrated Test Range (ITR) in Chandipur, Odisha, on Tuesday.

During the trials, the missile demonstrated its effectiveness against ship targets when launched from an Indian Naval Seaking Helicopter. The test highlighted the missile's Man-in-Loop capability, achieving a direct hit on a small ship target in sea-skimming mode at its maximum range. The missile's terminal guidance is powered by an Indigenous Imaging Infra-Red Seeker.

The mission also showcased the missile's high bandwidth two-way datalink system, which transmits live images from the seeker back to the pilot for in-flight retargeting. This



advanced feature allows the pilot to select a target midflight, as demonstrated during the trials.

The missile was launched in Bearing-only Lock-on after launch mode, where several targets were in close proximity. Initially, it locked on to a large target within a specified search zone, but during the terminal phase, the pilot successfully retargeted the missile to a smaller hidden target, resulting in a pinpoint hit.

# Moon to get First Mobile Network

# NASA Launches Athena Lander to Establish First Mobile Network on Moon

RNS: NASA successfully launched the Athena lander, introducing mobile connectivity to the lunar surface as part of Intuitive Machines' IM-2 mission. The mission deploys the Lunar Surface Communication System (LSCS), developed by Nokia, which utilizes cellular technology similar to that used on Earth to establish connectivity on the Moon.

The Athena lander, perched atop a SpaceX Falcon 9 rocket, lifted off from Launch Complex 39A at NASA's Kennedy Space Center in Florida on 26 February.

The mission paves the way for two U.S. lunar landings within a week. On Sunday, Firefly Aerospace's Blue Ghost lander is scheduled

to land on the near-side of the Moon, followed by Athena's landing on the lunar South Pole just four days later.

The mobile network deployed by the mission will enable seamless communication between the lander and vehicles, providing critical support for highdefinition video streaming, command-and-control, and telemetry data. Nokia Bell Labs President Thierry Klein emphasized the resilience of the network, designed to withstand the Moon's harsh environment, including radiation, extreme temperatures, and vibrations. The system operates in a compact "network in a box," which contains all components required for functionality except for the



antenna and power source. The IM-2 mission also features two lunar mobility vehicles: Intuitive Machines' Micro-Nova Hopper and Lunar Outpost's Mobile Autonomous Prospecting Platform (MAPP)

These vehicles will connect to the network on the Moon's surface, although the network's operation will

be limited to just a few days due to the challenges posed by lunar nights. This achievement is a critical step toward future lunar missions, including NASA's Artemis program, which aims to return astronauts to the Moon by 2028. Nokia is also working on integrating cellular communication technology into astronauts' spacesuits to facilitate communication during future lunar exploration. Klein pointed out that a single network tower could provide full coverage, similar to terrestrial cell networks on Earth.

Meanwhile, NASA's Polar Resources Ice Mining Experiment 1 (PRIME-1) is underway, studying lunar regolith and resources to support future missions. While the launch of the mobile network has been met with enthusiasm, it has also sparked some conquencies. Nokia received a special waiver for the IM-2 mission and is exploring alternative frequency bands for future deployments. As lunar exploration intensifies, the success of the



The case stems from Gandhi's controversial remarks about Savarkar during a speech in London before a group of Non-Resident Indians. Following these comments, Satyaki Savarkar filed a defamation case against him in a special court in Pune. In response, Gandhi's lawyer, Advocate Milind Pawar, submitted a petition requesting that the case be converted from a "summary trial" to a "summons trial".

In his petition, Gandhi argued that the case revolves around historical events from the pre-independence era. He stated that it is essential for the court to consider an accurate historical account of Savarkar's contributions to India's freedom struggle and suggested that relevant historical documents could be presented as evidence.

However, Satyaki Savarkar's lawyer, Advocate Sangram Kolhatkar, opposed this request.

Hindi is the mask, Sanskrit is the hidden face."His remarks come amid ongoing concerns over the Centre's three-language policy, which the ruling Dravida Munnetra Kazhagam (DMK) has fiercely opposed. The DMK has historically resisted Hindi imposition, with the anti-Hindi agitations of 1965 serving as a defining moment in Tamil Nadu's political and linguistic identity. # After Mustafad, BJP MLAs call for renaming of Najafgarh constituency

BJP MLA Neelam Pahalwan proposed renaming Najafgarh to Nahargarh in the Delhi Assembly, claiming Aurangzeb had changed its original name. She won the Delhi polls, defeating AAP's Tarun Kumar by over 29,000 votes.

New Delhi. BJP MLA from Najafgarh, Neelam Pahalwan, proposed in the Delhi Assembly to change the name of her constituency, Najafgarh, to Nahargarh. She claimed that Mughal ruler Aurangzeb had renamed Nahargarh as Najafgarh and demanded that its original name be restored.

Pahalwan won the Delhi elections by defeating AAP candidate Tarun Kumar by a margin of over 29,000 votes. Following her proposal, BJP MLA from RK Puram, Anil Sharma, also sought a name change for a village in his constituency. He stated that Mohammadpur should be renamed as Madhavpuram and announced that he would put forward this proposal in the Delhi Assembly.

The demand to rename areas is gaining momentum among BJP leaders in Delhi. After securing



victory in the Mustafabad constituency, senior BJP leader Mohan Singh Bisht declared that he would rename Mustafabad as either "Shiv Puri" or "Shiv Vihar" once he officially took office.

"I will change the name of the area from Mustafabad to Shiv Puri or Shiv Vihar. I have

stated this before. I fail to understand why political parties are insistent on retaining the name Mustafabad. Why can't an area predominantly inhabited by Hindus be named Shiv Puri or Shiv Vihar? # Navy to receive 'Tamal' from Russia, a stealth missile frigate with BrahMos power

- .India to induct advanced stealth frigate Tamal from Russia

New Delhi. India is set to welcome one of the world's most advanced multirole stealth guided missile frigates, Tamal, built at Russia's Yantar Shipyard. This warship, capable of launching the deadly BrahMos antiship missile, is part of the Indo-Russian agreement signed in 2016 for the construction of four Talwar-class stealth frigates, two in Russia and two in India. The second warship under this deal is now ready and is expected to be commissioned into the Navy by June 2025.

The first of the two Russian-built frigates, INS Tushil, has already joined the Navy. Defence Minister Rajnath Singh personally inducted it during his visit to Russia on December 9, 2024. After covering over 12,500 miles and passing

Russia. Once the warship is officially inducted, an Indian naval crew will sail it home. Tamal is designed for precision strikes and high maneuverability. It can cruise at speeds of up to 30 knots (55 km/h) and has an operational range of 3,000 kilometers on a single mission.

Key features include BrahMos missile capability where the warship can fire the supersonic BrahMos missile, making it a formidable threat to enemy vessels. Tamal is equipped with advanced anti-submarine rockets and torpedoes to counter underwater threats. Helicopter Deployment is

another important component of the warship as it can carry and operate a multirole helicopter for extended surveillance and combat missions. It is built to evade enemy radar detection, enhancing its survivability in modern warfare. Tamal weighs 3,900 tons, making it a heavily armed yet agile warship.

**IMPORTED WARSHIP** Like a sharpened sword (Talwar), INS Tushil and Tamal are part of the third batch of Talwar-class frigates. However, the Navy has declared that Tamal will be the last imported warship, showing a shift toward complete indigenous warship production.

> India has been operating Talwar-class frigates since 2003, with six currently in service. Four of these have already been armed with BrahMos missiles, while the remaining two are undergoing upgrades.

# This war is no longer about Ukraine

THREE years and counting — this is what we might have possibly said of Russia's conflict with Ukraine. But today, we may need to count no more. If this sounds too good to be true, it is. The big story on the third anniversary of the war is not the untold death and destruction, not the imminent collapse of the Ukrainian forces and not the rupture of Europe's relations with Russia. It is the arrival onto the diplomatic stage of the President of the United States, Donald Trump, with his determination to bring the war to an immediate end. President Trump is set to succeed, not because he says so but because the adversary is saying so. Russia is ready for closure. For India, and for most of the world, there could not be better news. India, for a very good reason, has been on the side of peace and has always wanted the conflict to end on the negotiating table. Not everyone is happy. The Munich Security Conference has been a celebration of the trans-Atlantic alliance. Its 2025 edition could well have been its funeral ceremony. The blunt admonition of Europe by US Vice-President JD Vance was the forerunner to even more dramatic events that followed. The US and Russia met face to face soon thereafter and in a historic breakthrough have set the ball rolling for an early summit meeting between their Presidents, and resetting the relationship. Ukraine will only be one piece of

Few would have imagined this turn of events. If Russia's invasion in 2022 was a geopolitical shock, the manner in which the war is being steered to an end is no less disruptive. Trump's diplomatic blitzkrieg has not happened in a vacuum. Apart from domestic causes within the US, it has come against the backdrop of a growing sense of frustration, despair and fatigue in Europe over the war. Europe's political institutions and its economy have not measured up to the challenge. The war has taken a heavy toll on the European project. Today, Europe is seething, bitter, divided and feeling let down. Trump has succeeded in convincing US voters that Europeans have become free riders. Europe is thus faced with its biggest crisis since the end of the Cold War.

Ukraine, and specifically President Zelenskyy, has been accused by Trump and Elon Musk of not only not avoiding the war, but of even causing it. The tables have been turned. Yesterday's allies are today's detractors. Ukraine's existence as a functional state is under question. It is on the brink of defeat with 20 per cent of its territory under Russian occupation and 60 per cent of its energy infrastructure damaged.On the Russian side, 30,000-35,000 troops are estimated to have been killed every month. According to British Defence Ministry sources, the war has led to 700,000 Russian casualties, the loss of 19,000 pieces of equipment and 9,000 tanks and APCs (armoured personnel carriers), giving it the epithet of a 'meat grinder'. In this war of attrition, Russia has won on the battlefield but at a high human cost and reputational damage. Even if not evident in the immediate term, sweeping sanctions have squeezed its economic choices.

The debate has shifted away from the minutiae of the terms of a settlement over Ukraine to the global chessboard. How far will the new version of US-Russia detente go? What will be its terms? And what impact will it have on the global order as we know it? A grand bargain is in the offing, reminiscent of the Ronald Reagan-Gorbachev moment. A new post-1991 architecture will be created to accommodate Russia's security interests in Europe, but with a deeply divided Europe. US and European approaches to Russia are set to diverge, and even within Europe, there are sharp differences. If Russia wants to build on the new opportunity that President Trump is offering it, and address European fears, it will have to make compromises and give concessions. Signals coming so far indicate that this is indeed the likely trajectory. The US is going it alone. Europe is watching and is a straggler, left to its own devices.

# Spare a thought for the unwept migrant

Shackling people does seem to come a bit too easily to the nation that boasts of the Statue of Liberty.

PUNJAB — the land of the five rivers; the Greeks referred to it as Pentapotamia (which means the same). The region was associated in ancient times with the Indus Valley civilisation, the Rigveda and the Mahabharata. Alexander fought Porus on the banks of the Jhelum, Babur fought Ibrahim Lodhi, the Anglo-Sikh wars were fought here — there have been very few examples of a land so continuously invaded, ravaged and pillaged as Punjab has been down the centuries. We will start from 1947 onwards i.e. from what was supposed to be the dawn of a glorious period. The dawn was one of sheer joy and sunshine in India, except in the states of Punjab and Bengal. The Partition that took place was largely a

partition of Punjab and Bengal. An imaginary line drawn by the British and accepted by the Congress leadership, Gandhi and Jinnah tore Punjab asunder. It was an amputation of the body and soul of Punjab. It left in its wake a tsunami of murder, rape and mayhem. It was a bloodbath like no other and led to probably the biggest forced migration in history. This enormous disruption was perhaps one of the main underlying causes for the first wave of migration that began to the Western world in the early 1950s. Initially, it was only a trickle and mainly to the UK, followed by Canada. The contribution of this region to the two World Wars was immense, and the returning

men brought back stories and experiences from Europe, Africa, Southeast Asia and the Middle East. Humans have always looked for better pastures, and when the opportunities at home were dismal, they looked outwards. Back home, the Punjabi spirit gradually prevailed and with the help of good leadership and administration, we picked up the pieces and overcame the horrors of the Partition and settled down to a near-normal life. For a few decades, it seemed that we were on the path of prosperity and peace. This proved to be a mirage, and the usual fault lines began to appear in the political and administrative setup. An already truncated Punjab witnessed demands of further division that finally succeeded. The Akalis wanted a Sikh-dominated state, the hill folk demanded their own refuge, as did the people of Haryana. A combined Punjab was split into three states and a UT. Chandigarh, the modern capital being developed as a replacement for Lahore, was also

lost. There were five divisions of the Punjab province before the Partition — Jullundur (now Jalandhar), Lahore, Delhi, Multan and Rawalpindi. This was lauded as a great achievement, but it actually heralded the decline of Punjab as the faltering economy and decadent leadership led to chaos. The mountains and their forest and water resources went to HP, the proximity of the national capital with its dynamism and the lands along the Yamuna to Haryana. Perhaps the region should be renamed 'tiny ab' as it no longer represents 'Punjab'. The three states are laggards in most development indexes. In a democracy, votes count, and in Parliament a state with 80 seats does have a louder




voice and presence as opposed to one with 10 or 13. Gradually, the radicalisation of the youth took place, and a new militant leadership came up with new slogans under the cover of religion related to a violent movement. Behind it was the hand and mind of politicians of all hues; things built up and violence increased, the forces of the state increased. All this led to the disaster of Operation Blue Star and the assassination of Indira Gandhi, which was followed by the slaughter of Sikhs throughout India. This was allowed to go on for days till the bloodlust was partially quenched. The next decade was a lost one, with killings of innocents occurring daily. Our neighbour to the northwest took full advantage of the situation and launched a proxy war in the garb of militant and terrorist action. Punjab paid the price. Pakistan had lost major wars in 1948, 1965 and 1971; it was looking for revenge and we gave it on a platter (it was Punjab again that bore the brunt of the war in 1965 as most of the action was confined to on this front). Things were never the same again in Punjab and it came under President's rule for almost a decade until elections were held. Despite popular demands, there was no financial package or special development programme for Punjab to compensate for decades of trauma for no fault of the people. It should be remembered that unlike the southern, western and eastern coastal areas, Punjab is a landlocked state, its only trade opened to the northwest and Central Asia. This avenue also closed and all pleas to open up have gone unheard. Events of the 1980s led to the second wave of migration, and this time it was big. The needle moved and pointed to Western shores for relief and employment.

The third wave is an ongoing one as the youth look for better pastures for education and livelihood. I call it the third wave because it now comprises the youth who have inherited an indebted (Punjab has a debt of around Rs 4 lakh crore) state devoid of opportunities or the education to create them. The Internet has brought awareness, and awareness has awakened desire. The youth aspire for the life and comforts of the Western world. Alas, they do not get it here or the tools and environment to create it here. People migrate from all over Punjab, legally or illegally. The nexus of politicians, police and travel agents operates openly; humongous amounts of money are paid. Land is sold, loans are taken and relatives mobilised to get the required amount.

Coaching centres came up to teach English and again money was extracted. All this action happened openly and was common knowledge in villages, towns and in the corridors of power. However, no action was initiated to stem this plunder of Punjab.Now, the great purge has begun, led by the US. They have started by deporting illegal immigrants in a manner so humiliating that no selfrespecting nation can take it lying down. Migrants are brought in shackles in military aircraft with their hands and feet in chains and without turbans. # Outrage, obscenity and our selective morality

#### It is almost Faustian how everyone is happy to defend free speech in the Allahbadia case, but is still putting on record how offended they are by his remarks.

ILIKE humour, though I could never quite take to the phenomenon of 'stand-up comedy'. Whenever I chanced to watch stand-up comedians, I often felt the humour didn't land well. Comedy is a tough act to pull off, comic timing is supposed to be the key, though that appears to have been replaced by a generous use of expletives to generate audience reaction. I am aware of the popularity of the genre and I believe in "In joco veritas — In jest, there is truth." Since my knowledge in this form of truth-telling is rather limited, I must admit I had no idea of who Ranveer Allahbadia was, except when I first saw his name in the news. I assumed him to be a poet. His utterances were far from poetic, though he seems to have taken the liberty of 'poetic licence' very seriously. I was told that Allahbadia also goes by the name of 'Beer Biceps' and is a popular podcaster who has gained political heft of the right hue. He manages to get people in high places on his shows, including Narendra Modi. But now that Allahbadia is running for cover, the regime he pandered to doesn't have his back. His joke (I still haven't got the joke!) on a YouTube show, India's Got Latent, about parents and sexual intercourse has 'offended' many Indians, who have liberally got FIRs registered in several states under provisions of the Bharatiya Nyaya Sanhita, 2023, the Information Technology Act, 2000 and the Indecent Representation of Women Prohibition Act, 1986. (Incidentally, another comic, Kanan Gill, reportedly made the same 'joke' a decade ago and no one paid any attention). Following threats and charges, Allahbadia approached the SC for relief, which was granted to him, though his freedom of speech was restricted and he was made to surrender his passport. It is now that the plot thickens. The Supreme Court inadvertently, or with clear intentions, stoked a dangerous fire when Justice

Surya Kant told the Additional Solicitor General: "We would like you (government) to do something, if the government is willing to do something, we are happy. Otherwise, we are not going to leave this vacuum and barren area the way it is being misused by so-called YouTube channels and YouTubers."

The government didn't waste time and has already announced the strengthening of its grip over OTT platforms that had in some ways succumbed to censorship. The government has now asked OTT platforms to adhere to an age-based classification of content, ensure self-regulation and follow the Code of Ethics prescribed in the IT Rules 2021. This is only a prelude and the parliamentary panel has asked the Ministry of Electronics and Information Technology to submit a note on the efficacy of the existing laws and suggest amendments to bring online platforms under legal scrutiny. Over the last few years, many journalists have taken to such platforms to produce news related content, much to the ire of the current regime. YouTubers like Ashish Chanchlani, Jaspreet Singh and Apoorva Makhija have been served notices by the Assam police. It is not surprising, given that the CM of the BJP-ruled state has been proactive in grabbing attention that gives him some national space and allows him to play to the gallery.

Once free speech is restricted, it will set a dangerous precedent. Whether it is Allahbadia or Umar Khalid, everyone should have their right to free speech. It is almost Faustian how everyone in this matter is happy to defend free speech, but is still putting on record how offended they are by his remarks. The controversy has singed not just the contours of free speech but has also invaded another space. "The words you have chosen, parents will be ashamed, sisters will be ashamed. The entire society will feel ashamed. The pervert mind. These are the levels of

depravity you and your henchmen have gone," said Justice Kant. He not only led the government to twist its censorship knife on freedom of expression but his observations on obscenity also take us back to colonial India. Colonial India continues to survive through laws on sedition, obscenity, blasphemy, etc.



It is telling how Saadat Hasan Manto's comment on cases of obscenity against him still rings relevant: "If you find my stories intolerably obscene, it is because the society you live in is obscene."

Manto had frequent run-ins with the law over his writings. The colonial state tried to punish and silence him in line with the emergency legislation of the period. His friend Ismat Chugtai was also summoned under the same charges for her story Lihaaf. The court could not quite define 'obscene', though an attempt was made. As a magistrate in Lahore put it: "The test of obscenity in all cases is

whether the tendency of the matter charged as obscene is to deprave and corrupt those whose minds are open to such immoral influences." Obscenity is not explicitly defined under the criminal law or the IT Act 2000. The erotic art of Khajuraho and Konark may appear obscene to some, but we have lived

through centuries with erotica in public view.

I have not understood why the depiction or mere mention of sex offends the average Indian even though there is only an occasional outrage over routine sexual assault. Or, why hate speech is not considered obscene. Justice Krishna Iyer attempted to articulate this grey zone in Raj Kapoor & Others vs State (1979), where the court quashed criminal proceedings against the makers of the film, Satyam Shivam Sundaram. He observed: "The relation between reality and relativity must haunt the Court's evaluation of obscenity, expressed in society's pervasive humanity, not law's penal perspective. Social scientists and spiritual scientists will broadly agree that man lives not alone by mystic, squints, ascetic chants and austere abnegation but by luscious love

of beauty, sensuous joy of companionship and moderate non-denial of normal demands of the flesh."While the jury on obscenity will continue to seek refuge under legalese, free speech is slowly but steadily being chained and gagged.

As an aside, Allahbadia may have truly assumed the role of 'disruptor of the year' (an award he won last year) for shifting the focus from the Maha Kumbh, where lives have been lost and there is an alert for toxic water.He may have done the PM a favour by distracting the bad press on Kumbh, but will the joke now be on free speech?

दिल्ली अंतरराष्ट्रीय हवाई अड्डा लिमिटेड (डायल) ने एक बयान में कहा कि टर्मिनल 2 (टी2) अप्रैल से चार से पांच महीने के लिए अस्थायी रूप से बंद रहेगा। इस अवधि के दौरान अपग्रेडेशन के लिए एक रनवे भी बंद रहेगा। इस हवाई अड्डे में तीन टर्मिनल टी1, टी2 और

टी3 हैं। डायल के मुख्य कार्यपालक अस्थायी रूप से बंद कर दिया मंजूरी मिलने के बाद उड़ानों के लिए अधिकारी (सीईओ) विदेह कुमार जाएगा। उन्?होंने कहा कि टर्मिनल-1



जयपुरियार ने कहा कि टी-2 को (टी-1) का काम 15 मार्च तक पूरा अप्रैल में चार से पांच महीने के लिए होने की उम्मीद है, इसे अपेक्षित

#### देश की अर्थव्यवस्था का 'खराब दौर' बीता, तीसरी तिमाही में जीडीपी ग्रोथ 6.2 फीसदी रहने का अनुमान

नई दिल्ली। अर्थव्यस्था के मोर्चे पर अच्छी खबर आई है। जर्मनी की ब्रोकरेज र्फम ने कहा कि भारतीय अर्थव्यवस्था के विकास की दिशा में सबसे खराब दौर अब समाप्त हो गया है। डॉयचे बैंक की रिपोर्ट में कहा गया है कि वित्त वर्ष 2024-25 की तीसरी तिमाही (अक्टूबर-दिसंबर) में सकल घरेलु उत्पाद (जीडीपी) वृद्धि दर 6.2 फीसदी रहने की उम्मीद है।डॉयचे बैंक ने जारी रिपोर्ट में कहा है कि चालू वित्त वर्ष 2024-25 की दूसरी तिमाही जुलाई-सितंबर में जीडीपी की वृद्धि 5.4 फीसदी थी, जो पिछली सात तिमाहियों में सबसे कम थी।

इसके बाद 31 दिसंबर को समाप्?त तीसरी तिमाही में जीडीपी की विद्ध दर 6.2 फीसदी रहने की उम्मीद है। इस रिपोर्ट में यह भी कहा गया है कि हाल में जारी होने वाले आधिकारिक आर्थिक आकंड़ों से पहले हमें भविष्यवाणियों को लेकर सतर्क रहना चाहिए, क्योंकि पिछले वित्त वर्षों के आंकडों में बदलाव हो सकता है। उल्लेखनीय है कि सरकार की ओर से चालू वित्त वर्ष 2024-25 की तीसरी तिमाही का जीडीपी का आंकड़ा 28 फरवरी को जारी किया जाएगा। भारतीय अर्थव्यवस्था की वृद्धि दर अप्रैल-जून तिमाही में 6.7 फीसदी रही, लेकिन आम चुनावों के कारण सरकार के पूंजीगत व्यय में कमी तथा कमजोर उपभोग मांग की वजह से जुलाई-सितंबर तिमाही में यह धीमी होकर सात तिमाहियों के निम्नतम स्तर 5.4 फीसदी पर आ गई थी।

नई दिल्ली। चालू वित्त वर्ष 2024-25 की तीसरी तिमाही की सकल घरेलू उत्पाद (जीडीपी) के आंकड़े कल जारी होंगे। भारत की जीडीपी की ग्रोथ रेट अक्टूबर-दिसंबर तिमाही में सकारात्मक बनी रहने की उम्मीद है। जानकारों का मामना है कि तीसरी तिमाही में यह लगभग 6.3-6.4 फीसदी के दायरे में रह सकती है।

एयरलाइन कंपनी मुंबई से इस्तांबुल के लिए दो वाइडबॉडी बोइंग 777 विमानों का संचालन करती है।

आप चाहे दिल्ली की सरोजिनी नगर में स्ट्रीट शॉपिंग कर रही हों या गोवा की फ्ली मार्केट में सामान खरीद रही हों, सबसे पहले आपको किसी एक सामान के लिए कई अलग – अलग स्टालों की जांच करनी चाहिए।ऐसा करके आप देखेंगे कि अधिकाश दुकानों और स्टालों में एक ही तरह के कपड़े और सामान हो सकते हैं। कई बार किसी कपड़े का पैटर्न, प्रिंट, कलर सब लगभग एक जैसा ही होता है लेकिन उनके दाम अलग होते हैं ऐसे में अगर आपको कोई ऐसी चीज मिलती है जो आपको पसंद है, तो कई दुकानों से उसके दाम पता करें। इससे

कई बार आपको स्ट्रीट शॉपिंग में कोई ऐसा सामान मिल जाता है जो आपकी पसंद का होता है और आप उसे बहुत दिनों से ढूढ़ रहे होते हैं।ऐसे में उस सामान को देखकर ज्यादा एक्साइटेड होने की बजाय अपने एक्सप्रेशन को न्युट्रल रखें। कभी भी दुकानदार के सामने



आपको यह पता लगाने में मदद मिलेगी कि क्या कोई दुकानदार कीमत को ज्यादा बढ़ाने की कोशिश कर रहा था। सामान्य तौर पर मार्केट की छोटी दुकानों की तुलना में सड़क के किनारे के स्टालों की दरें हमेशा सस्ती होंगी आप सही कीमत के हिसाब से बार्गेनिंग करके शॉपिंग करें।

ये न जटाएं कि आपको किसी सामान की बहुत ज्यादा जरूरत है। अगर दुकानदार आपकी जरूरत को समझ जाता हैं तो वो बढ़ चढ़ कर दाम बताता है । इसलिए आपका न्यूट्रल रिएक्शन बार्गेनिंग में मदद कर सकता है।

# दुकानदार की कीमत का आधा दाम बताएं

कोशिश करें जो वास्तव में डिफेक्ट न होकर उस कपड़े का डिजाइन या कलर ही हो। लेकिन आप डिफेक्ट के नाम पर अच्छी बार्गेनिंग करके स्ट्रीट शॉपिंग (भारत के इन राज्यों में उठाएं स्ट्रीट मार्केट का मजा) में चीजों के दाम कम करा सकती हैं। स्ट्रीट मार्केट में मिलने वाले बहुत से कपड़े वास्तव में ऐसे होते हैं जो होल सेल से आते हैं और इसमें कोई बहुत छोटा सा डिफेक्ट भी हो सकता है जैसे बटन का ढीला होना या किसी जगह की सिलाई खुलना । सामान सेलेक्ट करने से पहले यह सनिश्चित कर लें कि आप उसके हर इंच को स्कैन कर लें। यदि डिफेक्ट ज्यादा बडा नहीं है तो आप इसके दाम कम करा सकते हैं। वास्तव में यह एक स्मार्ट बार्गेनिंग टिक है।

# PAK vs BAN: Bangladesh, Pakistan look to salvage pride as rain threat looms large

Pakistan and Bangladesh have nothing to lose when they face off in the penultimate Group A match on Thursday, 27th February, in the Champions Trophy 2025 at the Rawalpindi Cricket Stadium. Both teams have already been eliminated from the competition but will aim to avoid finishing at the bottom of the points table. However, there is a significant chance that rain could spoil the game. With an 88 per cent likelihood of rain throughout the match and clouds hovering over the venue, there's a real possibility that the encounter could be interrupted. Earlier, the match between Australia and South Africa was abandoned without a ball being bowled, and the upcoming clash may end up being a damp squib. As the host nation, Pakistan has not had the best tournament. Despite having quality players, they failed to make it to the semi-finals. In their opening game, Pakistan suffered a 60-run defeat at the hands of New Zealand, followed by a sixwicket hammering by India at the Dubai International Cricket Stadium.

Mohammad Rizwan began his tenure as



Pakistan's captain with three consecutive series wins against Zimbabwe, Australia, and South Africa. However, the absence of key opening batsmen Saim Ayub and Fakhar Zaman significantly impacted their performance. Additionally, their decision to include just one specialist spinner, Abrar Ahmed, backfired. Also Read: Even MS Dhoni couldn't have done anything with Rizwan's team: Ex-Pakistan captain

The pace trio of Shaheen Shah Afridi, Naseem Shah, and Haris Rauf also leaked runs at an alarming rate. Babar Azam showed some promise against India, with five boundaries in his 23-run knock, but was unable to return to his best. The only thing Pakistan can now hope for is to finish with a win in front of their home crowd.

#### Can Bangladesh finish on a high?

Before the Champions Trophy began, Najmul Hossain Shanto stated that Bangladesh would enter the tournament with the aim of winning it. Unfortunately, the Tigers failed to live up to expectations, exiting the competition after back-to-back losses to India and New Zealand. It is clear that Shanto's side have not lived up to the promise they showed in pre-tournament statements.

## No emotional statements: Jos Buttler on captaincy future after England's exit

New Delhi. Jos Buttler opened up on his future as England captain after the Three Lions failed to qualify for the semi-finals of the Champions Trophy 2025. On Wednesday, February 28, England lost to Afghanistan by eight runs at the Gaddafi Stadium in Lahore. After losing to Australia by five wickets, Buttler's men faltered against the Afghans and failed to go through to the next round. Back in 2023, Buttler couldn't take his team through to the World Cup semis after which England failed to defend their T20 World Cup title under his leadership. Before the Champions Trophy, England lost 0-3 to India in the bilateral series and failed to take any momentum into the multi-nation event.

# Dope suspended wrestlers at IIS camp, Dangal raise eyebrows

The camp was organised in

CHENNAI. An international camp held for women wrestlers at the Inspire Institute of Sport (IIS) last month and Haryana Dangal organised by the charitable trust on February 19 and 20 have come under the scanner due to participation of athletes serving provisional suspensions for dope violations.

The camp was organised at the IIS, Vijayanagar, Karnataka close on the heels of a Memorandum of Understanding (MoU) signed between the United World Wrestling (UWW) and IIS during the 2024 Paris Olympics last year. "This strategic partnership is designed to foster collaboration and enhance the development of wrestling in India by establishing a

framework for mutually beneficial programs, projects, and activities," said an UWW statement soon after the signing of the MoU.Incidentally, an exposure trip to Italy was also planned for a few men and women wrestlers by the IIS after the completion of the camp. One of the selected wrestlers for the trip too was provisionally suspended by the World Anti Doping Agency (for SARMS) after prohibited substances were found in his sample taken during an international tournament in July 2023.

The trip, however, is unlikely to go ahead with

chances of selection trials for the Asian Championships next month. Besides, the Italy Federation has enquired its Indian counterpart (Wrestling Federation of India) about the trip and the latter has clarified that it is not part of the plan and the list contains a provisionally suspended wrestler."I cannot comment on the issue," was the response from an IIS official when queried about the participation of a provisionally suspended wrestler in the camp. He, however, said the tour may not go ahead due to the proposed selection trials. Meanwhile, Siyanand, head of IIS, Hisar, who was also the tournament director at the Haryana Dangal, accepted the woman wrestler had participated in the camp. "She has been provisionally

suspended, that's why she was allowed in the camp. Again that's what my opinion is as only higher officials at the IIS can talk about this elaborately," Siyanand told this daily. Speaking on suspended wrestlers



competing in the Dangal including the above-mentioned woman wrestler, he said, "The said woman wrestler was disqualified ahead of her bouts. We spoke to the National Anti Doping Agency and once we got confirmation from it then we didn't allow her to participate."Interestingly, quite a few suspended wrestlers competed at the tournament with a few of them winning a bout or two. "We prevented a few from competing but as we didn't have any comprehensive list of suspended wrestlers, there is a possibility that a few might have

gone to participate," added the tournament director. The competition was held at the Haryana Agriculture University, Giri Centre, Shahid Madan Lal Dhingra Multipurpose Hall in Hisar. Each participant was charged Rs 1000 as entry fee for the tournament, which was held in four weight categories in each style (men's freestyle and Greco-Roman and women's wrestling). Interestingly, a couple of coaches from the Sports Authority of India (SAI) also assisted the tournament director for the competition. The winners (gold, silver and bronze medallists) were also given cash prizes apart from the medals.

WFI source said the Italy federation mailed it seeking information on the proposed tour. "The WFI was not kept in the loop before organising the camp and holding the tournament. The federation told its Italian counterpart the same and also informed it about the presence of a suspended wrestler in the list. As far as the tournament is concerned, the guidelines clearly say the competition will be held according to the WFI and UWW Rules and Regulations but the same were not followed. How wrestlers serving suspension or provisional suspension can be allowed to compete," said the source.
