## Budget session from today; Waqf Bill, Kumbh deaths set to rock Parl

#### • FM to present record 8th Budget in a row tomorrow - Govt lists 16 Bills

New Delhi, Jan 31 (GNS) The Budget session of Parliament is set to commence on Friday with the government listing 16 draft legislations for consideration, including a Bill to regulate immigration and another to amend the Waqf Act of 1995. The principal highlight of the session will be the presentation of the Union Budget by Finance Minister Nirmala Sitharaman for the record eighth time on February 1. The session is expected to be a stormy affair with the Opposition all set to take on the government over Maha Kumbh stampede deaths and the Waqf Amendment Bill. The two-part session from January 31 to February 13 and then from March 10 to April 4 — will start with President Droupadi Murmu's address to a joint sitting of both Houses on Friday. After her address, the Economic Survey will be tabled by Sitharaman. Later part



of the session will be devoted to a debate on the Motion of Thanks on the President's address to which Prime Minister Narendra Modi will reply. On the legislative side, the ruling BJP is all set to push legislation on one of its major electoral planks - illegal immigration. The Immigration and Foreigners Bill 2025 has been listed among 16 legislative agendas. Although the contours of the Bill are unclear, it appears intended to regulate the entry of immigrants into India and could be framed as an overarching law on the subject currently governed by multiple legislations — The Foreigners Act 1946, The Passport Entry into India Act 1920, and the Registration of Foreigners Act 1939. The Bill, though listed for consideration, can only be taken up once the Union Cabinet approves it. The Cabinet is yet to take up this draft legislation for approval.

#### In a setback to AAP, 7 MLAs quit party ahead of Delhi polls

New Delhi, Jan 31 (GNS) In a major jolt to the Aam Aadmi Party (AAP) less than a week ahead of the Delhi Assembly elections, seven sitting MLAs have tendered their resignation and quit the party. The legislators who quit the party --Bhawna Gaur from Palam, Naresh Yadav from Mehrauli, Rajesh Rishi from Janakpuri, Madan Lal from Kasturba Nagar, Rohit Mehrauliya from Trilokpuri, Bhupinder Singh Joon from Bijawasan, and Pawan Sharma from Adarsh Nagar -- were not given a ticket by the party for the ensuing Assembly polls.

Most of the MLAs in their resignation letters cited that they had "lost faith" in the party over its leaders' involvement in corruption scandals."I joined the Aam Aadmi Party for honesty. But today I can't see that honesty anywhere. I spoke to several people of my Mehrauli constituency and most of them said that AAP is completely embroiled in corruption," Mehrauli MLA Naresh Yadav's letter read.Yadav in December, 2024 was sentenced to two years in prison in the 2016 Quran desecration case by a court in Punjab's Malerkotla.

Following his conviction, Yadav had on December 20 posted on X that he had requested Arvind Kejriwal not to give him a ticket for the Assembly polls." I will not contest elections until I am honorably acquitted. I am completely innocent and the allegations levelled against me are politically motivated and false. That



is why I have requested them to free me from contesting elections," Yadav had posted on X on December 20.Bijawasan MLA Joon stated that he took the decision after witnessing a significant deviation from the values and principles on which the party was founded.

"AAP was envisioned as a transparent, people-centric organisation committed to eradicating corruption and fostering ethical governance. However, over time, the party has increasingly exhibited traits of centralisation and a lack of internal democracy," Joon stated. He further said that the party initially took a strong stand against giving tickets or membership to individuals with criminal background. However, it has now chosen to field a candidate from Bijwasan AC-36 who has multiple criminal cases registered against him, including offences of moral turpitude.

#### Beware of Misleading Narratives: Syrian **Developments and the Islamic State Trap**

# Poor thing, was getting tired

ecent developments in Syria have sparked heated debates and diverse narratives, some of which are dangerously misleading. Among the most concerning is the attempt by certain radicals to portray these events as a victory of the Islamic State (ISIS) or to frame them as part of a broader, divinely sanctioned campaign that Muslim youths should join. This distorted interpretation is false and a dangerous trap, particularly for young and impressionable minds.

Like many others in the Middle East, the Syrian conflict is multifaceted, with various factions vying for control, influence, and survival. Some extremist groups, including remnants of ISIS, are trying to present these developments as part of their so-called "Caliphate," a concept rooted in their radical ideology. However, this narrative is far removed from the true Islamic understanding of governance, justice, and the concept of an Islamic state.

It is important to understand that the term "Islamic State" is not a mere political slogan, nor can it be achieved through violence, extremism, or territorial conquest. The true concept of an Islamic state in Islam is one that upholds justice, peace, and the rule of law based on the Qur'an and the Sunnah of Prophet Muhammad (PBUH). The actions of ISIS, or any such groups that claim to be establishing a caliphate, are rooted in extremism, violence, and a misinterpretation of Islamic teachings. The so-called "Islamic State" under ISIS was built on destruction, oppression, and terrorism.

It was a political entity that violated the fundamental principles of Islamsuch as justice, mercy, and respect for human dignity. Rather than bringing peace and prosperity to the Muslim ummah, ISIS brought suffering, bloodshed, and division. Its tactics of terrorism, sectarian violence, and brutality in the name of Islam have not only undermined the faith but also disillusioned many Muslims worldwide. Some radicals and extremists are now trying to frame the developments in Syria as a victory for the cause of the so-called Islamic State. They aim to recruit Muslim youths into their ranks by appealing to emotions and presenting themselves as the "true" defenders of Islam. They may use images of battles, slogans, and even references to "jihad" to paint a picture of a victorious caliphate being reborn. However, this narrative is based on a false understanding of what Islam teaches and what the concept of jihad truly means. Jihad, in the Islamic tradition, is primarily a struggle for personal improvement and striving to uphold justice and righteousness in society.

It is not a call for senseless violence or the establishment of power through terrorism. True jihad is about fighting oppression, injustice, and tyranny, and this can be done in many formsthrough education, charity, peaceful resistance, or defending one's community from aggression. It is never about joining a group that promotes violence and chaos under the guise of religious duty.

For Muslim youths considering involvement in any conflict, it is crucial to understand the conditions under which fighting in the cause of Allah (jihad) is permitted. Islam has clear guidelines about what constitutes legitimate self-defence and warfare, which primarily includes legitimate authority, just cause, protection of innocents, peaceful resolution and consultation/consensus. Only a legitimate Islamic state, led by a just and capable ruler, has the authority to declare war in defence of the Muslim community.

This means that no individual or group can unilaterally declare war on behalf of Islam without the sanction of a recognised Islamic government. The concept of a "caliphate" cannot be imposed through force by self-declared groups; it must come from a genuine, legitimate state that upholds the principles of Islam. Similarly, Jihad in Islam is permitted only to defend against oppression, tyranny, or aggression. It is not an excuse to initiate violence for personal gain or political power. The principles of justice, mercy, and human dignity must always be maintained. Needless to say that Islam strictly forbids targeting of innocent civilians,

women, children, and non-combatants. Any action that causes harm to innocent lives, under the guise of jihad, is against the teachings of Islam. Extremist groups that engage in terrorism violate these basic principles. Before resorting to any form of warfare, Islam encourages efforts to resolve conflicts through peaceful dialogue and negotiation. The path to peace should always be sought first. Moreover, decisions regarding warfare or significant political actions should be made through consultation (Shura) and with the consent of the broader Muslim community. This ensures that actions are taken with wisdom and in the best interest of the Ummah.

The radical attempt to frame the Syrian conflict and similar crises as the establishment of a caliphate is deeply misleading. The youth who are drawn into such movements may find themselves entangled in an ideological web that leads to violence, destruction, and personal harm, all in the name of a distorted understanding of Islam. The true path of Islam is one that promotes peace, justice, and the well-being of humanity, not senseless conflict or sectarian violence.

Muslim youths need to educate themselves, seek guidance from knowledgeable scholars, and understand the true teachings of Islam. Islam encourages seeking knowledge, striving for justice, and contributing positively to society. There is no glorification of violence or destruction in Islam, and it is the responsibility of every Muslim to safeguard the unity of the Ummah, promote peace, and stand against extremism in all its forms.Muslim youths should remember that the true path to success lies in following the teachings of the Qur'an and Sunnah, in working towards justice and righteousness, and in upholding the dignity of every human being. In this way, they can contribute positively to society, protect their faith, and stay far away from the dangerous traps set by those who seek to exploit them for their own extremist agendas.

Moments after Sonia's remarks on President Murmu, BJP chief JP Nadda hit back saying the Congress was back to insulting the top constitutional office."Former Congress President Sonia Gandhi's use of the phrase "poor thing" to refer to the President is deeply disrespectful and underscores the opposition's continued disregard for the dignity of the highest constitutional office. Unfortunately, this is not an isolated incident. While the President was highlighting the government's achievements, the opposi-

n July 28, as many as 20 people were killed in a Taliban attack at the office of the vice-presidential running candidate Amrullah Saleh in Kabul. He, however, was evacuated. Three days later, a bus ran over a roadside bomb, planted by the Taliban on the Kandahar-Herat highway, killing 34 passengers, mainly women and children - an act of inhuman, senseless killing. On August 1, 10 Afghan police officers were killed at the Daikundi province police checkpoint. Overall, in recent decades, one of the nations in the world which has been intensely afflicted with recurring fratricidal violence and tormented with grave externally driven political instability, unquestionably, has been the land of the Hindu Kush, namely Afghanistan. A victim of America's inability to bring about a modicum of peace despite the superpower's involvement in it for nearly 18 years — the longest war in its history with costs amounting to at least \$2 trillion and thousands of fatalities, Afghanistan displays no signs of normalcy returning to it. That the situation inside Afghanistan has been aggravated by regional rivalries, the unholy ambitions of the extremist Afghan Taliban and neighbouring Pakistan's eternal quest for a pliant regime in Kabul is beyond question. The major stakeholder in hapless Afghanistan since the launch of Operation Freedom in 2001 to rid Afghanistan of the then alive terrorist kingpin Osama bin Laden and his formidable network of terrorists has been, undoubtedly, the US. However, it is more than clear that, in the last five years or so, the US has shown signs of being militarily fatigued and financially exhausted with its prolonged deployment in Afghanistan. Thus, successive US administrations, including those of Barack Obama and Donald Trump, have been eagerly looking for an honourable exit from Afghanistan. Just the other day, the mercurial President Trump casually stated that if he desired, he could solve the Afghan problem in a week's time but did not do so as there would be 10 million casualties! That this statement coming from the head of the sole global super power is nothing short of being bizarre and irresponsible is to say the least.In the last two years, the US has

endeavoured to open up channels with the totally anti-Kabul government militant Taliban to strike some sort of a deal which would give the US a face-saving exit from Afghanistan. And now with the US General Election approaching early next year, President Trump appears to be in an ignoble hurry to strike an agreement with the same lot of terrorists, who continue to not only target US soldiers but also innocent Afghan civilians, with impunity and utter disdain. That the Trump administration is negotiating with the Afghan Taliban behind the back of the democratically elected government of Afghan President Ashraf Ghani, it officially supports, is reprehensible. The US talks with the Afghan Taliban, spearheaded by its special envoy Zalmay Khalilzad (himself of Afghan origin) and Secretary of State Mike Pompeo, too, appear to be in haste to arrive at some agreement with the wily, violence-sprouting Taliban. That the latter are more than conscious of the US' tearing hurry to depart from Afghanistan is enabling the Taliban to extract the maximum they can from the US, disregarding the Ashraf Ghani administration in toto.That the Taliban will mount their major offensive against any Kabul government, once the US departs, is beyond question. If that happens, Afghanistan will revert to the dark ages with a highly medieval fundamentalist Islamic government in power. Such an eventuality also portends likely instability and terrorism spreading throughout the region. Apart from the Taliban, Pakistan, largely isolated by the global community for years and ostracised by its one-time mentor, the US, is now back in business, thanks to its supposedly close links with the Taliban. Just last week in Washington, during his maiden visit to the US, Pakistan PM Imran Khan too was feted by Donald Trump to influence the Pak-friendly Taliban to arrive at a suitable agreement with the US. That the crafty Pakistanis would pull out all stops to extract maximum financial and military aid from the US for any socalled assistance vis-à-vis the Taliban is a foregone conclusion. Meanwhile, Pakistan has successfully ensured that India, despite having excellent relations with Afghanistan and being a major donor in civil

aid to Kabul has been marginalised in the current negotiations being conducted for the future contours of Afghanistan. India also appears to have, after many years, again been hyphenated with Pakistan by the US in regional affairs. The Government of India may wish to send a strong message to the US not to aggravate Kabul's misery by any hasty withdrawal from Afghanistan. The security situation demands a strong US presence in support of a democratically elected Afghan Government.

#### Debt Market Outlook: Term spreads remain attractive

What went by: Bonds continued their positive run with the 10year bond yield falling by 51 basis points (bps) while the 10-year 'AAA' and 10-year SDL eased by 33 bps on the decision of the government to stick to fiscal consolidation in their FY20 budget, announcement of sovereign bond (which could help balance domestic demand/ supply gap) and positive global cues. The curve bull flattened with the 10-year to 5-year G-Sec spread reduced to 6.5 bps from 15 bps on an average in June as market participants started pricing in more easing.

The FY20 Budget surprised the market by lowering the fiscal deficit target to 3.3 per cent of GDP vis-a-vis the indicated level of 3.4 per cent presented earlier in the interim budget in February 2019. In the final budget, FY20 estimates (versus the interim budget) were cut by Rs 51,000 crore for income tax and Rs 98,000 crore for total GST collections. However, no overall expenditure cuts or higher borrowing is planned. This reduction in revenue estimates is planned to be met by higher customs (Rs 11,000 crore), excise duties (Rs 40,000 crore), non-tax revenues (Rs 41,000 crore from higher RBI and nationalised bank dividends, possible spectrum auctions, among others) and higher nondebt capital receipts (Rs 17,000 crore from disinvestments, among others).

Furthermore, the government announced its decision to start raising a part of its gross borrowing programme in external markets in external currencies. The Finance Secretary has said first bond may take 3-5 months and that they will target borrowing 10-15 per cent of gross borrowing offshore. India's merchandise trade deficit was broadly flat month-onmonth (m/m) at \$15.3 billion in June (May was at \$15.4 billion). Exports fell 9.7 per cent year-on-year (y/y) in June, the weakest print since January 2016 (May was at +3.9 per cent), and imports declined 9.1 per cent (May was at +4.3 per cent), a 31-month low. Industrial production growth for May 2019 saw a moderation in growth to 3.1 per cent from 4.3 per cent a month back and 3.8 per cent, a year ago. Economic activitywise classification show that this moderation was largely due to the manufacturing sector which grew by 2.5 per cent.

# Game theoretic approach to India-Pakistan conflict

The tensions between India and Pakistan refuse to abate. Ties between the two countries are probably at their lowest point in two decades. The deep hostilities today are only overshadowed by the ghosts of the Kargil war in 1999 and the 2001 Parliament attacks. Even the 2008 Mumbai attacks did not bring the relations between the two nations to such a low. This comes riding on a series of events starting from the shocking Pathankot attack (2016), Uri attack (2016), Amarnath Yatra Attack (2017) to the recent Pulwama attack (2019). As a result, the leaders of the two nations have not met since 2015. The matter reached a crescendo when India abrogated Article 370, which ended the special status that had been accorded to Kashmir and brought it under central control. Even though the matter is a domestic issue for India, Pakistan has made concerted efforts to internationalise the issue. Imran Khan even went on to appeal to the international community through The New York Times for wider involvement over the issue arguing that a "threat looms over the world ... under a nuclear shadow." The developing animosity does not seem to be nearing its end anytime soon. While the

threat of nuclear war has been repeatedly used by Pakistan to rile up international support over the Kashmir issue, India needs to practice restraint in its approach towards the issue. The gains from peace far exceed the returns from adopting a belligerent payoff would be higher than the dominant strategy Nash equilibrium. Hence, reconciling their differences and not attacking can indeed provide higher gains to both. This is so because the country attacking first might have first-mover advantage, but it would be followed by a series of counter strikes and eventually both would receive negative payoffs. Thus, even though both countries have a dominant strategy of attacking each other, both would be better off by cooperating. The NFU policy acts as an assurance for Pakistan that India would not attack first, which allows it to choose the strategy of not attacking. If India abandons the policy, then it brings an element of uncertainty into the game. In such a case, when there is a deterioration in ties the next time, Pakistan will be uncertain of India's actions. And given the history of wars that both countries have fought, Pakistan would be skeptical of winning a conventional military strike.So, the best strategy for Pakistan would be to use nuclear weapons at the very beginning. Uncertainty in such case would indeed act as a catalyst in a nuclear strike from Pakistan's end. This is because Pakistan will be afraid of India's possible actions. If India uses its nuclear weapons, it will in all likelihood

destroy its neighbour's nuclear capabilities. Fearing that if such a situation arises, the chances of Pakistan losing the war using conventional force would be extremely high, the country will strike first. Thus, ambiguity is likely to escalate the chances of a nuclear war. The NFU policy is a tool to ensure peace in the region and should not be abandoned. If India sticks to its no-first-use policy, Pakistan's best response should also be to not attack. The policy ensures that the countries do not gravitate towards the Nash equilibrium where both countries attack each other. It acts as a deterrent that forces both countries to remain at the Pareto superior condition of not attacking where both of them are better off. This game theoretic model also shows that if India asserts its commitment to NFU, Pakistan would choose to attack in spite of its warmongering. Pakistan would be fully aware of the repercussions that would follow if it attacks India. Apart from destruction, the fear of a social boycott by the world would also be a deciding factor for Pakistan. Thus, calmer heads should prevail in such times instead of a needless engagement in a futile standoff.

stance. In this regard, the idea of reconsidering India's no first use (NFU) posture on nuclear weapons is quite problematic. This can be understood from a game theoretic viewpoint.What remains of utmost importance is whether India should revoke its no first use policy or not. This question can be answered using a classic example of a "Prisoner's dilemma." The game involves two players - India and Pakistan, each having two sets of strategies to choose from, i.e. to launch a nuclear attack (called "attack") or not to attack. If only one country attacks, the attacker receives a positive payoff, and the opponent gets a negative one. Fixing the strategy of other players as attack or not attack, attacking will always give the maximum payoff to each. Therefore, the dominant strategy of each player is to attack, which is the only Nash equilibrium in the game. However, both the players would be understandably better off by choosing not to attack at all. Their overall

# It's advantage BJP in Haryana, Maharashtra

he BJP-led NDA is never short of showcasing virtues of holding simultaneous polls. But when it came to holding the Jharkhand Assembly polls along with those of Haryana and Maharashtra, it developed cold feet. There has been no plausible explanation as to why Chief Minister Raghubir Das did not toy with the idea of recommending the dissolution of the House a month ahead of its schedule. As per the constitutional provisions, an elected government, enjoying majority in the House, can advance polls by six months. The North Block, which has been proactive under the leadership of BJP chief Amit Shah, too, has maintained a stoic silence. Political grapevine has it that advancing Jharkhand polls did not get the go-ahead as the political situation in the state is not conducive, as in Haryana or Maharashtra. This is one state where alliance talks are still on among the Congress, Jharkhand Mukti Morcha, Jharkhand Vikas Morcha

(Prajatantrik), RJD and the Left parties. The Congress alliance with the JVMP and JMM was, however, not rewarding in the 2019 Lok Sabha elections as the BJP had walked away with 12 out of the 14 seats. An opinion poll conducted by ABP News-C-Voter has shown that both the Manohar Lal Khattar- and Devendra Fadnavis-led BJP-NDA governments are set to return home with ease. The survey findings for Haryana predict 78 seats for the BJP and a single digit tally of eight for the Congress out of 90 Assembly seats in Haryana. In Maharashtra, the BJP-Shiv Sena combine is projected to get 205 out of 288 Assembly seats. The opposition seems happy to be unhappy. Going by this survey's indication, the electoral chances of the Congress in Haryana and Maharashtra appear to be next to nothing. But the party is making no attempt to reach out to anti-BJP parties in these states to put up a joint fight. Perhaps, the failure of the Samajwadi Party and Bahujan Samaj

Party in Uttar Pradesh during the 2019 Lok Sabha polls has had a demoralising effect on the entire opposition. In Parliament, too, there were no signs of floor coordination on triple talaq or even on gaining control of the parliamentary panels that were constituted recently. The Trinamool Congress was treated shabbily, but it found itself protesting alone. The BSP, which has some presence in Maharashtra and Haryana, is going solo in the coming round of Assembly polls. BSP supremo Mayawati is not sitting idle. Rather, she plans to consolidate her traditional support base of Dalits in these states. The development is bad news for the Congress which has bravely made Selja, a Dalit, as Haryana PCC chief. The painstakingly-worked out efforts to retain Bhupinder Singh Hooda have averted a split in the Haryana Congress, but the grand old party would be struggling to get 30-odd Assembly seats in the state. The Congress-NCP ugly spat hugely helped the BJP to come to power, reducing its ally, the Shiv Sena, to a poor second spot. The BJP had won 122 seats in the 288-member Assembly, while the Shiv Sena won 62 seats. The Congress and the NCP bagged 42 and 41 seats, respectively.Both the Congress and NCP have been badly hit by exodus. Senior NCP leader Udayanraje Bhosale, a descendant of warrior king Chhatrapati Shivaji Maharaj, quit his Lok Sabha membership to join the BJP.

June wholesale, or WPI, inflation further moderated sharply to 2.02 per cent (consensus: 2.25 per cent) as against 2.45 per cent in May owing to favourable base effects and moderation in manufacturing, fuel and power inflation.In a widely expected move, the US Federal Reserve cut interest rates by 25 bps to a new range of 2.00-2.25 per cent. The Fed also announced plans to end the reduction of its \$3.8 trillion asset portfolio, effective August 1, two months earlier than previously expected. In the press conference post the meet, the Fed chair described the cut as a mid-cycle "insurance" cut in order to make sure that the recovery prolongs in the face of global and trade related headwinds and also to give support to inflation. In particular, he was focused on the cumulative change in financial conditions since early in the year during which the Fed has turned from being on a hiking cycle, to being on a patient hold, to finally cutting rates by 25 bps.

#### Outlook:

The RBI's MPC in its August policy cut the repo rate by 35 bps to 5.40 per cent, while maintaining the policy stance as accommodative. The move to cut was decided with the 35 bps to 25 bps vote counting as 4:2. It may be recalled that RBI Governor Shaktikanta Das had earlier floated the idea of challenging the conventional 25 bps moves, with unconventional steps like this one possibly reaffirming the signalling effect of policy direction as well. The policy is largely in line with the dovish end of expectations. There is no decision with respect to the working group on liquidity management framework. However, the Governor did note the very large surpluses in the system today and reaffirmed the commitment to provide abundant liquidity. Thus, the implementation basis to the recommendations of the framework is very likely to be consistent with the current market view that the RBI has already moved to targeting surplus liquidity.

New Delhi, Jan 31 (GNS) India's leading sportspersons and administrators expressed surprise and helplessness after the country's medal prospects took a hit with the exclusion of hockey, shooting, cricket, badminton and wrestling from the roster of a heavily scaled-down 2026 Glasgow Commonwealth Games.

Relocated to the Scottish capital after Victoria's withdrawal as host due to an increase in projected costs, the Games will feature just 10 events, which is nine less than the previous edition held in 2022 in Birmingham.Table tennis, squash and archery are also not part of what will

be a massively pruned down Games. The organisers have said having lesser events at just four venues will ensure that the showpiece is able to manage the financial and operational risks involved.

But the roster has stunned the Indian sports fraternity."It's a shocking news and very disappointing but it's not in our hands," said Harmanpreet Singh, under whose captaincy the Indian men's hockey team won a bronze medal at the Paris Olympics in August. Table tennis great Sharath Kamal, who has won innumerable medals at Commonwealth Games over the last two decades,

understood the impact the games organisers' decision could have on the country's overall tally."It is a pity that table tennis has been taken off the CWG programme but the organisers have informed they had very short notice as it moved from Melbourne to Glasgow.

One of the country's finest squash players, Dipika Pallikal expressed her disappointment when reached out for a reaction."I think squash really deserves to be part of all the multi sport events and it's definitely a huge loss that our sport cannot be showcased at the CWG," she said. The news of hockey's
