Earthquake of magnitude 6.1 strikes Nepal, tremors felt in Bihar

world. An earthquake with a magnitude of 6.1 struck Nepal early on Friday, causing tremors felt across the Himalayan region. Tremors were also felt in Patna, Muzaffarpur and nearby areas of Bihar.

The earthquake struck around Bhairab Kunda of the Sindhupalchok district in Nepal at around 2.35 am, sindiupalchok district in Nepal at around 2.35 am, according to news agency Reuters. The German Research Centre for Geosciences measured the earthquake at a magnitude of 5.6, while India's National Centre for Seismology estimated it at 5.5. However, it was not immediately clear whether multiple quakes had occurred. A 6.1 magnitude earthquake is considered strong and can cause significant damage, especially near the epicentre, including the shaking of buildings and the formation including the shaking of buildings and the formation of cracks. The extent of Friday's seismic activity is yet to be ascertained, and no reports of damage or casualties have been reported so far.

'It shook us from our sleep strongly. We rushed out of home. People have now returned back to homes. We have not received any report of damage or injuries so far," Ganesh Nepali, a senior Nepali official told Reuters.People shared videos online showing buildings and ceiling fans shaking due to the earthquake in Patna. An X user mentioned that the tremors lasted for a "good 35 seconds". "Felt a strong earthquake in Patna, Bihar. Everything was shaking but no visible damage so far," another user, Nikhil Singh, wrote.In January this year, a series of six earthquakes struck Tibet's Himalayan region, with the strongest measuring 7.1 magnitude, claiming

'We don't need to talk': Heated confrontation between Jordan Schultz & Ian Rapoport at NFL combine

UPDATED Jordan Schultz of FOX Sports and Ian Rapoport of NFL Media engaged in a verbal confrontation on Wednesday afternoon at a Starbucks inside the JW Marriott in Indianapolis. Multiple witnesses confirmed the incident that took place during the NFL Scouting Combine.

What Led to the Confrontation?

According to NBCSports, Rapoport was speaking with an agent when Schultz approached him and said, "We need to talk." Rapoport dismissed the request, responding, "We don't need to talk." That response sparked a heated exchange. Witnesses say Schultz accused Rapoport of something unknown, which Rapoport viewed as unfounded. The two then stood face to face as Schultz allegedly said, "If you have anything to say to me, say it to my face," followed by, "If this continues, we're going to have a problem.

Rapoport asked Schultz to step back, but Schultz reportedly repeated the warning before eventually

stepping away.

NFL Security gets involved The situation was reported to NFL Security, which gathered statements from multiple witnesses. Rapoport declined to comment, but Schultz later acknowledged the confrontation via text to ProFootballTalk (PFT), saying:

It really isn't anything too much. Ian Rapoport and I had a verbal confrontation. It lasted a little over a minute. Multiple agents and reporters were nearby. Rapoport was the one who called security shortly after, but it never escalated further."Schultz also disputed the number of expletives in the account, later claiming he did not use profanity. The altercation stems from Schultz's report earlier this week that Rams quarterback Matthew Stafford met with Raiders minority owner Tom Brady in Montana. Rapoport later downplayed the report, describing the meeting as a coincidence rather than an intentional recruiting

effort. Schultz, however, stood by his reporting. Tensions between the two reporters are clearly high, so it remains to be seen whether this confrontation is a one-time incident or the beginning of a larger feud. Either way, the exchange added unexpected drama to a business-focused week at the NFL Scouting Combine.

Zelensky, Trump to meet at White House for deal on US access to Ukraine's rare minerals

The extraordinary turnaround caps a week of frantic international diplomacy centered on Washington, as Kyiv seeks to shore up support despite Trump's recent pivot towards Russia.

WASHINGTON. A week ago Donald Trump branded Volodymyr Zelensky a dictator. On Friday he will host the Ukrainian president at the White House and sign a deal granting Washington access to Ukraine's rare minerals. The extraordinary turnaround caps a week of frantic international diplomacy centered on Washington, as Kyiv seeks to shore up support despite Trump's recent pivot towards Russia.Trump upended years of US policy on Ukraine two weeks ago when he spoke to Russian President Vladimir Putin and started talks on ending the threeyear-old war—without Kyiv.He also alarmed allies as he appeared to turn on

without elections" and blaming Ukraine for Trump, a billionaire real estate tycoon, Russia's February 2022 invasion.

But Trump's tone has softened in recent days after visits by French President Emmanuel Macron and British Prime Minister Keir Starmer. "I have a lot of respect for him," Trump said of Zelensky on Thursday. "We're going to get along really well."

Trump also backtracked on the "dictator" broadside he launched on social media at Zelensky last week—a jibe he had previously refused to retract even as he declined to call Putin a dictator too.

'Did I say that? I can't believe I said that," Trump responded when asked about the Zelensky comment by journalists during a meeting with Starmer.

The dictator outburst was sparked in particular by Zelensky's initial rejection of the deal to give Washington preferential access to Ukrainian natural resources, including oil, gas and rare earth metals.

Zelensky demanded US security guarantees as part of any deal but Trump has refused to

insisted the deal was necessary for Washington to recoup the billions of



dollars it has given Ukraine in military and other aid. Finally, Zelensky relented and agreed to come to the White House to sign it. The deal would give the United States a share in much of Ukraine's mineral wealth. "We'll be dig, dig, digging" for Ukraine's resources, Trump told reporters Thursday. Few details of the minerals deal have

emerged. Zelensky told reporters this week

that it would act as framework for broader deals.Further discussions between US and Ukrainian officials would determine the

nature of security guarantees for Ukraine and the exact sums of money at stake in the accord, he said.But Trump has repeatedly refused to commit to any guarantees.Britain and France have both offered peacekeepers in the event of a deal to end the Ukraine war but say there must be a US "backstop" -- including American intelligence and possibly air power.The US president told Starmer Thursday he was "open to many things' in terms of security guarantees but that he wanted to get a Russia-Ukraine deal in place first. Trump added that there had

been a "lot of progress" towards a deal but then added: "It'll either be fairly soon or it won't be at all."US and Russian fficials met on Thursday in Istanbul in a new round of talks. Putin and Trump said after their February 12 phone call that they had agreed to meet personally -- but they have not finalized any meeting yet

Russian tourist dies after being attacked by sharks in Philippine diving spot, another drowns

MANILA. Two Russian tourists died when they were swept away by strong undercurrents while scuba diving in waters south of Manila, with one believed to have drowned and the other attacked by sharks, a Philippine coast guard official said Friday.

Two other Russian tourists managed to swim back safely to their dive boat Thursday off Verde Island, a popular diving destination in the province of Batangas, Philippine coast guard provincial commander Capt. Airland

Lapitan said. The four Russian tourists traveled by boat to the waters off Verde Island from the nearby town of Puerto Galera in Oriental Mindoro province



diving, the five were swept away by strong undercurrents, Lapitan said.

Two of the Russians managed to surface with the dive instructor but the two other Russians, who were identified as Ilia Peregudin, 29, and Maksim Melekhov, 39, went missing. The dive instructor and other divers in the area,

along with Philippine coast guard personnel, immediately launched a search, according to Lapitan.Melekhov was found unconscious at sea an hour later and was declared dead by doctors in a Batangas hospital, he said."The other Russian diver was found while being attacked by sharks. His right arm, unfortunately, had been severed and the sharks were moving around him," Lapitan told The Associated Press. "They

somehow managed to pull him away.' An investigation is underway and the coast guard will meet provincial officials to discuss ways to prevent such deadly incidents at Verde Island

Is New Orleans on the brink of a Fiscal crisis City officials disagree

UPDATED. Earlier this month, when New Orleans Mayor LaToya Cantrell announced that she intended to renege on a \$20 million settlement with the Orleans Parish School Board, she said the city couldn't afford

The settlement with the school board was brokered last fall by the New Orleans City Council and Cantrell's own top deputy, Chief Administrative Officer Gilbert Montaño. It would have ended yearslong litigation over the fees the city collected on property taxes intended for schools and provided an infusion of money for the cash-strapped district. But City Attorney Donesia Turner said that the settlement wasn't a done deal because the mayor hadn't been actively involved and, further, that it would be too costly for the city. This was later echoed by Chief Financial Officer Romy Samuel."The city's financial positioning has taken a major shift," Samuel said at a special meeting to discuss the school board settlement on Feb. 11. "Budgetary obligations, the continued rise in inflation accompanied by unexpected expenditures beginning in 2025 and various other factors have weighed heavily on the city's operating costs."The about-face from the city's executive leadership caught both the school board and the council by surprise. The council had approved the deal with Montaño's apparent approval and without any objection from Cantrell's office. And Cantrell had just signed a 2025 city operating budget that was more than \$200 million higher than the one she approved for 2024. Now, councilmembers — and even a top official within Cantrell's administration are pushing back on the mayor's claims, saying that the city is not only able to afford the school board settlement but also is prepared to handle the budgetary challenges heading its way."This is something that's been manufactured, and is now trying to be reverseengineered to explain where we are," said Councilmember Joe Giarrusso, who chairs the budget committee. "And I am extraordinarily troubled that we're going to hold the city captive for the next month or two because we're saying we don't have any money and we can't move forward." Cantrell's office, which has been criticized for a lack of transparency around budgeting and other matters, did not respond to requests for comment on this story.

It's no secret that the city of New Orleans has faced a slate of potential challenges since the year began. First, following a New Year's Day attack on Bourbon Street in the French Quarter, the city had to drastically ramp up its security - replacing old, insufficient bollards with new ones to better block high-speed vehicles, bringing in the National Guard to patrol high-traffic areas and even hiring a homeland security expert to evaluate their security plans – all in preparation to host a series of tourist-heavy events from the Super Bowl on through the rest of the Mardi Gras season.

Vatican says Pope Francis continues to improve but his prognosis remains guarded

ROME. Pope Francis continued to improve from double pneumonia Thursday, the Vatican said, working from his hospital room and going to his private chapel to pray, though doctors said he needs more days of "clinical stability" before they revise their guarded prognosis. The 88-year-old pope, who had part of one lung removed as a young man, was able to begin alternating high-flow

supplemental oxygen, delivered by a nasal tube, with a mask in a sign of his improved respiratory condition, the Vatican said in a late update. For the second day in a row doctors

avoided saying Francis was in critical condition. But they said that given the complexity of his lung infection, "further days of clinical stability are needed" before they revise their prognosis and decide he is out of danger.Francis has been in Rome's Gemelli hospital since Feb. 14 after a bout of bronchitis worsened.

Ie has shown steady, albeit slight improvements since a respiratory crisis and kidney trouble over the weekend sparked fears for his life. The improvements, as he nears the twoweek mark on Friday, beat back speculation of an imminent death, resignation or conclave and signaled that he was still very much in charge. Beyond that, Francis has a few major events coming up that he presumably would hope to keep if well enough. On April 27, he is due to canonize Carlo

Acutis, considered to be the first millennial and digital-era saint. The Vatican considers the Italian teenager, who died of leukemia in 2006 at the age of 15, as an inspiring role model for today's young Catholics.

Another important appointment is the May 24 commemoration of the 1,700th anniversary of the Council of Nicea, Christianity's first ecumenical council. The spiritual leader of the world's Orthodox Christians, Patriarch Bartholomew I, has invited Francis to join him in what is today's Iznik, Turkey to commemorate the anniversary, which he has called an important sign of reconciliation between the Catholic and Orthodox churches. Before he got sick, Francis said he hoped to go, though the Vatican hasn't confirmed the trip.

Israel and Hamas have begun negotiating next phase of Gaza ceasefire: Egypt

KHAN YOUNIS. Negotiations between Israel and Hamas on the next phase of the Gaza ceasefire began Thursday, Egypt said, averting a collapse ahead of Saturday's expiration of the agreement's first phase.

Officials from Israel, Qatar and the United States started "intensive discussions" on the ceasefire's second phase in Cairo, Egypt's state information service said.

The mediators are also discussing ways to enhance the delivery of humanitarian aid to the Gaza Strip, as part of efforts to alleviate the suffering of the population and support stability in the region," its statement said. Phase 2 talks are meant to negotiate an end to

the war, including the return of all remaining hostages in Gaza who are alive, and the withdrawal of all Israeli troops from the territory.Return of remaining deceased hostages would happen in Phase 3. According to Israel, there are 59 remaining hostages — 24 of whom are still believed to be alive.It will be difficult to reconcile a deal with the war objectives of Israeli Prime Minister Benjamin

Netanyahu, who has called for dismantling Hamas' governing and military capabilities. After suffering heavy losses in the war, Hamas has nonetheless emerged intact during the ceasefire, and the group says it will not give up its weapons. Hours before talks began, an Israeli official said the country would not withdraw from a strategic corridor in the Gaza Strip as called for under the ceasefire, a refusal that could severely complicate negotiations with Hamas and key mediator Egypt at a sensitive moment for the fragile truce. Overnight, Hamas released the remains of four hostages in exchange for over 600 Palestinian prisoners, the last planned swap of the ceasefire's first phase.

U.S. President Donald Trump's Mideast envoy, Steve Witkoff, was expected in the region in the coming days. Blatant violation'An Israeli official, speaking on condition of anonymity in line with regulations, said the army needed to remain in the so-called Philadelphi corridor, on the Gaza side of the border



with Egypt, to prevent weapons smuggling. Hamas said any Israeli attempt to maintain a buffer zone in the corridor would be a "blatant violation" of the ceasefire agreement. Hamas says that sticking to the agreement is the only way for Israel to secure the release of dozens of hostages still held in Gaza.Israel was supposed to begin withdrawing from the Philadelphi corridor on Saturday, the last day of the first phase, and complete it within eight days. There was no immediate comment about the corridor from Egypt, which is opposed to any Israeli presence on the Gaza side of its border. Remains of four

hostages identifiedThe remains released Thursday were confirmed to be those of Ohad Yahalomi, Itzhak Elgarat, Shlomo Mantzur and Tsachi Idan, according to the Hostages and Missing Families Forum, which represents families of the captives. Hamas confirmed that over 600 prisoners had been released overnight. Most were detainees returned to Gaza, where they had been rounded up after the Oct. 7 attack and held without charge on security suspicions. Israel releases dozens of women and teenagersDozens of Palestinian teenagers as well as women detained by Israel in Gaza were released Thursday back to hugs and tears from their loved ones. The teenagers looked gaunt and skinny as they disembarked from Red Cross buses in the southern town of Khan Younis. Many fell into the arms of relatives, who spent days waiting for them after Israel held up their release last weekend to protest what it called cruel treatment of hostages by Hamas during their releases. India's First Air Taxi Set to Launch by 2026

Currently, The ePlane Co faces competition from Bangalore-based Sarla Aviation

RNS: Chennai-based startup, The ePlane Co, is preparing to launch India's first electric air taxi by 2026.

The company, incubated at IIT-Madras, plans to develop three prototypes within the next two years, bringing the dream of a "Made-in-India" air taxi to life.

The Directorate General of Civil Aviation (DGCA) has established new regulations for air taxis, covering aircraft standards, landing ports, and pilot Additionally, training. five testing sites are being set up in Gujarat and Andhra Pradesh, where air taxi testing will begin later this year.

Air taxis could be a potential solution to the traffic



congestion issue in Indian cities, such as Bangalore, which loses an estimated \$2.3 billion annually due to traffic jams.

Air taxis are expected to reduce travel time to airports significantly, offering a quicker alternative to metro and road trans-

Currently, The ePlane Co faces competition from Bangalore-based

Aviation, which recently raised \$10 million in funding. Internationally, the UK's Archer Aviation has signed a deal with IndiGo's parent company for

300 air taxis.

The ePlane Co is also expanding internationally, with plans to enter markets in the UAE, Indonesia, and Thailand.

Discussions are underway with aviation authorities in Malaysia and Singapore, while Indonesia's DGCA is keen on adopting the company's air taxi model after it receives approval in India.

Additionally, the company has signed a \$1 billion agreement with ICATT for the supply of 788 air ambulances.

So far, The ePlane Co has raised \$20 million and is seeking additional funding of \$30-50 million. Founder Satyanarayan Chakravarthy revealed that the company is open to raising up to \$100 million in the next investment round.

The first commercial air taxi service is expected to begin by the end of 2026 or early 2027.

Suicide Blast Targets Pakistani Cleric, Kills 5 at Khyber Pakhtunkhwa Mosque

Pakistan: Jamiat Ulema Islam (JUI) leader Maulana Hamidul Haq Haqqani and four others were killed in a suicide bombing that struck a mosque during Friday prayers in the Khyber Pakhtunkhwa province. The explosion occurred in the main prayer hall of a madrassa, which is known for training Afghan Taliban members, as worshippers gathered for their prayers.

Khyber Pakhtunkhwa Police Inspector General Zulfiqar Hameed confirmed that three policemen were also injured in the blast. The mosque's location was quickly cordoned off, and security officials rushed to the scene, transporting the bodies to a nearby hospital. Emergency measures were implemented across all hospitals in Peshawar.

Hameed speculated that Maulana Hamidul Haq may have been the primary target of the attack. No group has yet claimed responsibility for the bombing. An investigation is underway, and rescue officials have evacuated at least 20 individuals from the site.

The madrassa, often referred to as the "University of Jihad," was founded by Maulana Samiul Haq. The tragic event occurred during Pakistan's hosting of the Champions Trophy, raising concerns about national security.

Both President Asif Ali Zardari and Prime Minister Shehbaz Sharif expressed their condolences over the loss of life. Khyber Pakhtunkhwa's Chief Minister, Ali Amin Khan Gandapur, condemned the attack and called for a detailed

A spokesperson for JUI, Aslam Ghauri, condemned the bombing, lamenting that even mosques and madrassas were no longer safe. Ghauri criticized the government for failing to ensure peace and security, accusing them of prioritizing cricket over national safety.

Massive Blaze at Kanpur's Galla Mandi **Engulfs Goods Worth Lakhs**

Kanpur: A devastating fire broke out at Galla Mandi in Kanpur late last night, destroying goods worth lakhs in 10 godowns. The fire, which started around midnight, spread rapidly, fueled by tarpaulins outside the warehouses. Over 12 fire engines from Fazalganj, Jajmau, and Kidwai Nagar were deployed to tackle the blaze, which was visible from 2 km away. After hours of intense efforts, the fire was finally brought under control around 2 a.m.

The flames consumed wheat and other goods stored in the warehouses, but fortunately, no casualties were reported. The cause of the fire is still unknown, and authorities have begun assessing the extent of the damage. Fire officials confirmed that the fire was contained without loss of life, but the financial loss is expected to be significant.


The conference marked the beginning of impactful discussions and collaborations, laying a strong foundation for innovation and sustainable development in electrical engineering.

Badrinath Avalanche: 25 BRO Workers Still Trapped, 10 Rescued

Chamoli: At least 25 Border Roads Organisation (BRO) workers remain trapped after an avalanche struck the Chamoli district of Uttarakhand, media sources reported on Friday. The avalanche occurred near the border village of Mana, located about five kilometers from the Badrinath temple.

A total of 57 workers were in the area when the avalanche hit, with 22 successfully escaping the disaster. The rescued workers are currently being treated for injuries.

Rescue operations are ongoing, with around 65 personnel from the Indian Army and ITBP involved. Deepam Seth, Uttarakhand's Director General of Police, stated that the primary challenge in the operation is the harsh weather conditions, including heavy snowfall and strong winds. Road access is blocked, and snow cutters have been



Karnataka Chief Minister Siddaramaiah is facing allegations of frivolous spending after the state Public Works Department estimated Rs 2.6 crore for renovations at his official residence, Cauvery. Criticism arose following a government notification from the finance department, which outlined planned upgrades, including a new helper's room with a bathroom, additional storage rooms, storage racks, upgraded lighting, water points, and other miscellaneous work. Reportedly, Rs 1.7 crore was allocated for construction of the helper's



room and kitchen items, while Rs 89 lakh will be used for electrical upgrade and air conditioning.

BJP MLA from Chikpet Uday Garudachar called the expenditure outrageous. "Isn't it atrocious? Something that shouldn't be done is being done by the Chief Minister himself. This change will expand the board of directors of the apex bank from 22 to 25 members, potentially enhancing government influence in decision-making processes. The Karnataka Souharda Sahakari (Amendment) Bill, 2024, proposes changes to the Karnataka Souharda Sahakari Act, 1997. The bill aims to amend definitions, adjust voting rights, refine election procedures, and modify the management structures of cooperative societies. Notably, it introduces provisions to grant voting rights to all members, including defaulters, and implements reservations in the boards of secondary cooperatives, federal cooperatives, and apex cooperatives.

Europe unsure if US is still an ally

SINCE the end of World War II, America's grand strategy was to ensure that no hostile power arose on either flank of Eurasia. To this end, the US initiated the Marshall Plan and helped rebuild ruined Europe. This, in turn, became an important factor in raising US prosperity in the 1950s and 1960s. It also shaped the North Atlantic Treaty Organisation (NATO) alliance and provided men and material to ensure the security of Europe.

In the east, the US went further in the pursuit of its goal. It fought a war in Korea that cost it over 35,000 lives and another in Vietnam, where it lost over 58,000 soldiers. The US occupied Japan till 1952 and completely remade its society and government in its own image, and it still retains substantial forces in the country at over a dozen bases. American President Donald Trump seems to be wanting to turn this policy inside out. He seems to want to make deals with the Eurasian powers the US targeted — Russia and China — and write off America's erstwhile friends. His pursuit of territorial expansion with regard to Canada, Panama and Denmark looks like a "sphere of influence" policy where the US will be the dominant Western Hemisphere power, while Eurasia will be left to the tender mercies of Vladimir Putin and Xi Jinping. His new posture is manifesting itself in his approach to the war in Ukraine, where he has adopted what can, at best, be termed as a "Russia-leaning neutrality". This is apparent in the stark difference visible in a US draft resolution circulated at the United Nations to mark the third anniversary of the Russian invasion. The draft has mourned the loss of life in the "Russia-Ukraine conflict" and sought "a swift end to the conflict, including by addressing its root causes", while calling for a lasting peace between Ukraine and Russia. This is a rival resolution to the one that Ukraine and Europe have backed, which speaks of Russian aggression and the implementation of past resolutions demanding that the Russians end the war and withdraw from Ukraine's internationally recognised territory.

Trump has adopted a hard approach towards Kyiv. After freezing out Volodymyr Zelenskyy from the first US talks with Russia, Trump falsely accused Ukraine of starting the war that has ravaged that nation and killed thousands of people. When Zelenskyy criticised him for living in a "disinformation bubble", Trump lashed out, calling the Ukrainian President a "dictator". He attacked Ukraine for tricking the US into spending \$350 billion "to fight a war that couldn't be won" And he has demanded a deal through which the US would control half the mineral rights of Ukraine to repay the money that Washington has spent in supporting Kyiv. According to US News & World Report, the US has actually spent around \$100 billion, while the Europeans have put in nearly \$400 billion till now.The Trump plan is based on delivering a systemic shock to Europe and Ukraine to destabilise, if not destroy, the older system where the US was a firm NATO ally and a key backer of Ukraine in its war with Russia. The second objective has been to freeze out Europe and embrace Russia as a partner in making peace in Ukraine, even while blaming it for causing the war. Earlier this month, Trump called Putin and talked to him about ending the war without consulting either Ukraine or its European allies.

As for China, things seem to be moving towards a major trade deal which would take up from where the Phase I trade deal between the US and China in the last year of his previous administration left off. His advisers such as Treasury Secretary Scott Bessent have been pushing a new deal, while his new alter ego, Elon Musk, has extensive business interests in China. Just how deep the shift against Europe is was manifested by the speech of US Vice-President JD Vance at the Munich Security democracy were under attack in Europe, but not from Russia or China, but mainstream political parties that were attacking European right-wing parties like the Alternative for Germany (AfD). It is no coincidence that the Far Right in Europe is soft towards Putin.

Nation's Security: Why Hindus are Responsible Communities?

India is home to religions like Buddhism, Hinduism, Jainism, and Sikhism. The country is also shelter to world religions like Islam and Christianity. There are some other faiths and beliefs professed in a small scale. The citizens of the country mainly belong to any one of the above religions. Despite the diversity, RSS and several other outfits advocate that the Hindus are 'responsible communities' for the security of the country. Is there any logic behind this argument? Why not citizens belonging to other religions? In this essay, I try to see how far the claim of RSS and others is authentic.

inclusive of all Indian origin faiths and beliefs like Sikhism, Buddhism, adivasi religions, etc. In its specific sense it is one of the religions like Buddhism, Jainism, etc. The term Hindu is used in its inclusive sense but in some context in its specific sense. Incisive sense is synonymous with traditional sense of Hindus. Who are Hindus? Article 25 (2) b, Explanation II includes Sikh, Buddhist and Jaina under Hindu fold. There are several Acts which uphold the above definition. For example, The Protection of Civil Rights Act 1955 states that

Hindu is a generic term,

'Persons professing the Buddhist, Sikh or Jaina religion or persons professing the Hindu religion in any of its forms or developments including Virashaivas, Lingyats, Adivasis, followers of Brahmao, Prarthana, Arya Samaj and the Swami Narayan Sampradaya shall be deemed to be Hindus'. Looking through the lens of colonial knowledge that is based on the principle of categorisation (in specific sense) of apparent differences in name or practice, some of us see Hinduism as a category different from Sikhism, Buddhism, etc. In fact there was no name for Hinduism; the Hindu word is an exonym and the developments in Hinduism by reformers like Guru Nanak, Siddhartha Gautama and Mahavir in later years assumed distinct names which are endonymies. The diversity of Indian tradition unfortunately has been looked through the lens of categorisation. But the Constitution recognises the diversity in tradition as a unity, called the Hindus or

Hinduism. The citizens of India who own responsibility of protection of tradition, people and territory are (i) tra-ditional, and (ii) migrant Indians. The time line between the two could be beginning of the Christian era because major migrants after this era are Muslim invaders and colonisers who maintain their distinct religious identity. While maintaining their religious identity they are converting traditional Indians. Other invaders like Saka, Hun

and Ahom have assimilated with Indian tradition, i.e. the Hindu tradition. The adivasis who are Hindus as mentioned in the above Act are traditional Indians and migrants. Some migrant tribes like Monpa, Khamti, Singphow, Meyor, Memba, etc. have adopted Buddhism and embedded in traditional fold of India. Even the adivasis who are converted have traditional origin contributing in the making of the pluralistic culture of India. Then why Hindus only are responsible communities?

Generally, what one thinks, one executes thought through words and deeds. Behind the behaviour and action of a person are mental forces. One thinks or one's metal force is shaped on the basis of the image formed in mind. Formation of image in mind depends on person's exposure to ideas, education, and environment. One becomes Marxist, forming an image on the basis of Marxian ideology and it reflects in his or her communication, action and behaviour.

The religion that is not based on Indian tradition contains a different ideology having suitability to a different context and tradition. Certainly, Christianity and Islam do not belong to India's tradition. The ideology behind Christianity or Islam does not believe in diversity like Hinduism where many apparent gods and goddesses are worshipped. The person, who is born and grows in diversity, recognises and respects differences in beliefs and

faiths. Therefore, a traditional tribesperson is never a fundamentalist; never kills another tribesperson if his belief and faith differ. One who lives in diversity does not attach exclusivity to life or any aspect of it though due to ignorance of the core principle one may consider one's faith superior but does not claim to be the only best and true. Idea of exclusiveness in Islam or Christianity is behind the practice of preaching their tenets to be the only belief and only the truth. This belief accompanied by ego leads to forceful conversion also. Buddhism is also propaganda type; but it does not propagate a belief around a Supreme Being or Beings. It advocates right behaviour; it is relational and is based on cause and effect rationality. It does not teach fanaticism. The claim of only the truth has caused many wars to show superiority of a religion. A few important ones are mentioned below.

Crusade- The Holy War (1096-1291), history of Jihads and several research works like Bernard Lewis's The Roots of Muslim Rage (1990), Basil Mathews 's Young Islam on Trek: A Study in the Clash of Civilisations (1926) with reference to Middle East, and Ahemed Al-Dawoody's Islamic Law of War Justifications and Regulations (2011) state about the tradition of war in Christianity and Islam. These wars are primarily based on religion unlike political wars between kingdoms and nations. Clash of Civilisa-

tions (1996) by Samuel P. Huntington believes in the clashes of all civilizations, though some civilisations like Hinduism, Buddhism or Jainism have no history of fighting on religious ground. Recent Israel and Palestine war between Islamic and Jewish tradition or Armenia and Azerbaijan

war in 2023 has religious essence at the core. In Israel-Palestine war, Jerusalem, the birth place of Jesus is the bone of contention. When one is trained in an ideology and attaches exclusiveness, the person is blind to other truths. For the person the loyalty to religion supersedes loyalty to a nation based on secularism or is different religions. In India the loyalty to Hinduism(specific sense), Buddhism, Jainism, Sikhism or adivasi religions do not expose followers to a foreign land. That is why adivasi and other Indian origin Christians demand for Indianisation or Indigenigetion of Church. Their loyalty to religion and territory is balanced because they lived in the territory before converted to Christianity. Muslims of Indian origin have started understanding of territorial loyalty. It is to be informed that a large section of Christians and Islam has exposure to religious ideology than valuing territorial importance because narratives about the former make round through their own men. Other religions in India have remote possibility of being influenced by outside ideology. Though a section of Sikhs demand for Khalistan-a separate


state, it is not the influence of Sikh ideology. It is rather against the principle of what Sikhs have been struggling against- to protect Hinduism and the country. History stands as testimony. Derailed sections of the Sikhs is an aberration.

But there is a larger possibility that more of Indian Christians and Muslims could be influenced by narratives which hold superiority of religion than the territory they live in. There could be also misguided Hindus who are likely to fall victim to it due to exposure to non-Indian narratives. Hindu unity is the call to avoid such aberrations because they have no outside loyalty like Muslims and Christians. They have greater potentiality than Hindus for outside influence, for their religion has outside existence and origin, which may be fatal for the country. However, as they have started understanding the importance of territorial loyalty and religious loyalty simultaneously, the future will have a different consideration. But at present, caution is the need. Territorial loyalty and religious loyalty of Hindu communities have no outside influence and so the country will be safe in their hands till others balance between outside loyalty and territorial loyalty and recognition to the cruciality of diversity.

ISN'T it absurd that we can't think of anything beyond a set of technical solutions — say, the installation of 'suicide proofing' fans in hostel rooms, or nets in balconies and lobbies — to the recurring problem of suicides or the abrupt end of the life-journey of broken/shattered/ disillusioned young students in Kota, which is a site of the demonic coaching industry?

Well, in recent times, the business of the Kota coaching industry has somewhat declined because of the 'bad' name it got as newspapers began to report regularly about the pathetic mental health of young aspirants. In fact, the number of students in Kota is falling and, as a report reveals, the annual revenue of this business enterprise has been reduced to Rs 3,500 crore from

Rs 7,000 crore. However, nothing seems to have changed as far as the agony of young minds is concerned. In this year only, seven students have ended their lives by suicide and sought to convey the message that they could not bear the pressure and fulfil the parental aspirations for 'good' careers/lucrative salary packages.

It is sad that we are not yet ready to think of a meaningful solution to this sort of suicide beyond the parameters of the typical 'law and order' discourse or even a set of routine 'counselling sessions'. In fact, it is high time some of us began to raise certain critical issues we seldom talk about. In this context, as a teacher and concerned citizen, let me make four observations.First, what has severely damaged the intellectual/ psychic growth of our children is the faulty pattern of education that has attached almost one-sided importance to one's performance in standardised tests, like the JEE, NEET and CUET. It has systematically devalued what really matters for the intellectual, aesthetic and moral development of the child.

And, I have no hesitation in saying that these standardised tests destroy the joy of learning and kill the ecstasy of a Instead of arousing the learner's curiosity or activating his/her ability to think, interpret, contemplate and go deeper into the exciting domain of sciences and humanities, these problematic MCQ-centric tests transform him/her into a 'war strategist', continually And, it is not a mistake on the part of your child if she/he mastering the 'technique' of identifying the 'one and only one correct answer' - instantly and mechanically.

It is not surprising that under these circumstances,

Second, in addition to the obsession with standardised tests, we are witnessing another disturbing phenomenon — the growth of 'dummy schools'. As these schools have a setting with coaching centres, young students need not attend regular classes and take part in the dynamics of school culture. Instead, they do what coaching centres dictate - say, the act of mastering the 'success manuals' or all sorts of strategies for cracking such tests as the JEE and NEET.Be it physics or mathematics, biology or chemistry, everything is reduced to an MCQ question. No wonder, the formative years of these youngsters are spent in an environment that promotes endless drilling, mental fatigue and hyper-competitiveness and the chronic fear of failure.It destroys the joy of learning, or the art exploring the domains of science, culture and aesthetics holistically, creatively and mindfully.

No wonder, they miss what a comprehensive school culture provides - say, a life-long relationship with good teachers, a spirit of fellow feeling and the joy of music, theatre, sports and other 'non-utilitarian' creative pursuits.

Third, it is equally important on the part of the parents to accept a set of fundamental facts about their children's unique aptitudes, inclinations, capabilities and mental

is not particularly inclined to science and mathematics. Likewise, it is possible for a child to have deep interests in the so-called 'soft' domains — say, music, literature, aesthetics, theatre or social work.

needs some breathing space for exploring and



understanding what she/he really wishes to do in life. However, as the anxiety-ridden middle class parents abhor any 'risk', they want their kids to follow what is seen as the standardised path towards a 'secure' career.

So, these youngsters, irrespective of their inclinations and capabilities, are compelled to nurture the same ambition that is seen as 'acceptable': the desire to become a software engineer or a doctor. Quite often, it becomes exceedingly difficult for them to bear the resultant

psychic pressure and fulfil the unnatural parental ambitions. No wonder, it is now common to find a suicide note like this: "I am the worst daughter. Sorry mummy, papa. Yahi lasts option hai."

And finally, let us accept that the routinised acts like pariksha pe charcha or a set of counselling sessions fail to address the real issueThe fact is that these youngsters

are suffering because we live in an overpopulated society of perpetual scarcity.Moreover, because ofthe neoliberal/market-driven doctrine of hyper-competitiveness and the resultant logic of the 'survival of the fittest', the commodification of almost every aspect of life seems to have become normal. As education is increasingly commodified and marketed, it loses its libertarian potential. Nobody joins the coaching industry to think critically or activate the faculties that make us truly humane, compassionate and sensitive.

ikewise, these days, the worth of being educated is measured primarily in terms of "placement and salary package." And this reckless pressure to emerge as a saleable commodity or a "resource" that the market needs to use tends to cripple

one from deep inside. Alienation or chronic nervousness is the price of 'success'. Indeed, as the latest National Crime Records Bureau data suggests, with 13,044 student suicides in a year, an "epidemic is sweeping

When will we wake up, initiate a movement for structural and cultural transformation and give a life-affirming vision of education and vocation to our children?

आज दिनभर के कारोबार के दौरान ऑटोमोबाइल, रियल्टी और एनर्जी सेक्टर के शेयरों में बिकवाली का दबाव बना रहा। इसके साथ ही पब्लिक सेक्टर एंटरप्राइज. एफएमसीजी, आईटी, कैपिटल गुड्स, कंज्यूमर ड्यूरेबल, हेल्थ केयर, ऑयल एंड गैस और टेक इंडेक्स भी गिरावट के साथ बंद हुए। दूसरी ओर, मेटल और बैंकिंग सेक्टर के शेयरों में तेजी का रुख बना रहा।

उम्र बढ्ने पर होता है स्त्रावित

उम्र को लेकर किए गए अध्ययन में यह बात सामने आई है कि एक दूसरा हार्मोन आईजीएफ (इंसुलिन

के 1000 व्यक्तियों के खून के नमूने प्राप्त कर यह निष्कर्ष निकालने में कामयाबी पाई। सर माइकल ने कहा, हमने स्पष्ट रूप से पाया कि कम धनी लोगों के बीच तनाव, मोटापा और अनियमित शारीरिक व्यायाम, धुम्रपान की अधिकता तथा हरी सब्जियों और फलों का कम मात्रा में सेवन कुछ ऐसे कारक थे, जो उनके बीच मधुमेह और उच्च रक्तचाप की समस्या को उत्पन्न करने के लिए जिम्मेदार थे।



Jose Mourinho banned for four matches and fined after Turkish referees comment

ISTANBUL: Fenerbahce manager Jose Mourinho was given a four-match ban and fined by the Turkish Football Federation following his comments about Turkish referees after a match at Galatasaray. The Turkish federation on Thursday fined the 62year-old Portuguese coach 1.6 million Turkish lira (\$44,000) after he criticized the match officials in a media conference following a 0-0 Super Lig draw on Monday. Mourinho served one of his suspended four

games on Thursday when he was absent from the bench for Fenerbahce's 4-1 Turkish Cup win at Gaziantep.Britain's Sky Sports News said Fenerbahce had appealed the four-game ban. It means that if Fenerbahce's appeal is unsuccessful, he will miss their next three domestic games. In his post-match interview on Monday, Mourinho welcomed the decision to bring in a foreign referee for the



game and also praised Slavko Vincic of Slovenia for a "top performance."

Mourinho said he'd gone to see the referee and thank him following the game. When he saw the fourth official — a Turkish referee — Mourinho said he told him: "If you are the referee ... would be a disaster."

Asked about a challenge early in the match, he said a Turkish referee would have reacted with a yellow card "after the big dive and their bench jumping around like monkeys.'

The Turkish federation said the ban and fine were instituted due to "derogatory and offensive statements towards the Turkish referee" and accusations of chaos and disorder in Turkish football.It said Mourinho's remarks violated sports ethics, promoted violence and disorder and could încite fan incidents.Fenerbahce issued a statement on Tuesday defending Mourinho, saying his comments were taken out of context and deliberately distorted.Former Chelsea, Manchester United and Tottenham Hotspur manager Mourinho has previously been fined and suspended for his comments about Turkish match officials.

Prague Masters: Praggnanandhaa held again, Chithambaram scores crushing win against Keymer


