Elon Musk's DOGE sends 2nd 'what did you do last week' e-mail to federal workers

world. The Elon Musk-led Department of Government Efficiency (DOGE) has sent a second "what did you do last week" e-mail to US federal workers, asking them to list their weekly accomplishments by midnight on Monday, despite widespread criticism over its decision to fire hundreds of thousands of over its decision to fire hundreds of thousands of government employees as part of a broader budget overhaul. The new e-mails, with the subject line, "What did you do last week? Part II" were sent out on Saturday night, less than a week after the first "what did you do last week?" mail on February 23, prompting hundreds of thousands of workers to list five tasks that they had completed over the past five tasks that they had completed over the past week. Several government agencies, including the Departments of Defence, Homeland Security, the US Office of Personnel Management, NASA and the FBI, among others, had asked employees to ignore DOGE's directive at the time. However, staffers at the Departments of Treasury and Transportation, as well as independent agencies like the Federal Communications Commission and the Federal Trade Commission were asked to respond.

Under the latest work directive, which came from "hr@opm.gov", the same OPM address that sent the first version, federal employees have until 11.59 pm (local time) on Monday to list five bullet points in an e-mail, describing their accomplishments in the past week. "Please reply to this email with approx. 5 bullets describing what you accomplished last week and cc your manager," the message read.

The second e-mail, however, added a new requirement for agencies that handle classified information, exempting their workers from filling in additional paperwork. "If all of your activities are classified or sensitive, please write, 'All of my activities are consistive, raid Employees at a third according to the control of the con sensitive," it said. Employees at a third agency received the email from an internal department address. Although it remains unclear which government departments and agencies would respond to the second e-mail, Musk said in a post on X on Saturday, "All federal government departments are cooperating with DOGE. For State, DoD and a few others, the supervisors are gathering the weekly accomplishments on behalf of individual

Israel accepts Witkoff's proposal for temporary ceasefire during Ramzan, Passover period: What it means

world. Israel on early Sunday backed a US-proposed plan to extend the first phase of the Gaza ceasefire through Ramzan and Jewish festival Passover, offering a temporary truce in exchange for the release of hostages. However, Hamas has so far rejected the proposal, insisting on moving directly to the second phase of the truce, which is aimed at ending the war and securing the return of all captives.

This extension of truce followed the expiration of the first phase on Saturday, March 1, which was originally finalised on January 19. What is Israel proposing? Israel has agreed to a framework put forward by US envoy Steve Witkoff, which would extend the ceasefire through April 20. Under the plan:

On the first day, half of the remaining hostages—both living and deceased—would be released. At the end of the truce, if an agreement is reached on a permanent ceasefire, the remaining hostages would also be freed.A statement from Israeli Prime Minister Benjamin Netanyahu's office confirmed the decision, stating:"Israel adopts the framework of US presidential envoy Steve Witkoff for a temporary ceasefire during the Ramadan and Passover period. On the first day of the framework, half of the living and deceased hostages will be released and upon its conclusion - if agreement is reached on a permanent ceasefire - the remaining living and deceased hostages will be released."The statement pointed out that Israel remains committed to the hostage deal but maintains the option to resume fighting if the negotiations fail."While Hamas has repeatedly violated the agreement, Israel has not been found in violation. According to the agreement, Israel could return to fighting after the 42nd day if it gains the impression that the negotiations have been ineffective.'

Japan wildfire: Thousands evacuated amid biggest blaze in decades

world. Thousands of people have been forced to evacuate from the northern Japan city of Ofunato of Japan as the country struggles with its largest wildfire in more than 30 years. Officials informed that nearly 2,000 people fled the areas to stay with friends or relatives, while more than 1,200 were evacuated to shelters. The blaze, which erupted on Wednesday in the forests around Ofunato, Iwate Prefecture, continues to burn out of control and has already scorched an estimated 1,800 hectares (4,450 acres), making it the country's most severe wildfire since 1992. Officials confirmed that at least one person has died, with local police discovering a burned body in the affected area. More than 80 buildings have been damaged, and around 1,700 firefighters have been deployed from across Japan in an effort to contain the flames."We're still examining the size of the affected area, but it is the biggest since the 1992 wildfire" in Kushiro, Hokkaido, which had burned 1,030 hectares, a spokesperson from the fire and disaster management agency told news agency AFP.Aerial footage from NHK showed thick columns of white smoke engulfing the mountains, as military helicopters worked to douse the flames from above. Evacuations have intensified, with around 2,000 residents seeking refuge with friends and relatives, while more than 1,200 have taken shelter in emergency facilities.

Indonesians swindled by scams using President Prabowo deepfakes

JAKARTA. Wearing a traditional Indonesian black hat and shirt, President Prabowo Subianto speaks to the camera in an Instagram video, asking his people how he can help them after his election last year. 'Who hasn't received aid from me? What are your needs right now?" Prabowo appears to

ask viewers in the clip posted in November. But while the Indonesian leader's mouth moves and his eyes blink, the words he utters are part of a fraudulent deepfake scam uncovered by police last month that has swindled Indonesians across 20 provinces. Those ensnared by the message were asked to contact a WhatsApp number

and hand over between 250,000 and one million rupiah (\$15-\$60) as an "administrative fee" to get aid that never materialised. Since last year's Indonesian election, experts have warned of a tidal wave of deepfakes -- audio, images and video appearing to come from a known person but which are in fact the work of scammers using artificial intelligence tools.And victims say the hoaxes are so sophisticated they leave others vulnerable to being conned too.People should be more careful. Don't be easily fooled by the lure of prizes," said Aryani, 56, who handed over 200,000 rupiah to fraudsters after seeing a deepfake video of a prominent Indonesian businessman."I need money, but instead I'm asked to send money. They even made video calls with me, as if I were talking directly to them."During the Southeast Asian country's presidential campaign, deepfakes became a prominent tool to spread misinformation both harmful and helpful to candidates.But now that technology has fallen into the hands of criminals looking to make cold, hard



cash.Wide circulationAFP's fact-checkers found the account behind the Prabowo clip has posted dozens of similar videos appearing to show various high-profile figures, including Indonesian Vice President Gibran Rakabuming Raka. Those videos also promote the bogus financial aid. Police arrested a suspect who pocketed 65 million rupiah (\$4,000) from the scam, Himawan Bayu Aji, director of the Indonesian National Cyber Crime Unit told reporters in February.He said officers detained a second person involved in another scam that also used deepfake technology, without disclosing the amount

raised.AFP Fact Check's investigation found the spread of such videos had a much wider reach than the two accounts that police announced.Deepfake videos of the president, a popular ex-general, were still circulating on social media after the arrests, including dozens on TikTok with the hashtag "Prabowo shares blessings". At least 22 TikTok accounts were touting the same fraudulent scheme since Prabowo took office in October, AFP journalists found, with some appearing to take advantage of his recent rise to the presidency. One account with more than 77,000 followers racked up 7.5 million views on a fabricated video of Prabowo apparently doling out financial assistance. Another account with thousands of followers has shared 100 videos since January alone, the majority featuring deepfake videos of the president offering cash. TikTok said it had removed one of the deepfake scam videos and the associated account, adding it would continue to remove any that violated the platform's community guidelines.

At least 37 dead in Bolivia after two buses collide



La Paz. Two passenger buses collided Saturday on a highway in southern Bolivia, leaving at least 37 people dead including eight minors, police said, in the country's worst bus accident to date this year. "So far we have 37 confirmed deaths," Colonel Wilson Flores told AFP of the crash near the city of Uyuni in the department of Potosi. Another 41 people were injured and transported to hospitals, police said. Six foreigners were among those killed: five Peruvians and a three-year-old German girl. Seven other minors also died The

road early Saturday.ne of the buses was heading to the city of Oruro, the scene this weekend of the Oruro Carnival, one of the largest festivals in Latin America that attracts tens of thousands of people.Potosi prosecutor Gonzalo sparicio told state-run news agency ABI that the driver of one of the buses had been drinking and was speeding when he strayed into the opposing lane where he crashed into the oncoming vehicle."So far it is known that a driver of one of the buses was under the influence of alcohol," he said. Earlier an accident occurred on a narrow two-way official had said one of the drivers, who driving causing fatalities

survived the crash in grave condition, had "alcohol breath," so a blood test was performed.Bolivia's winding mountain roads are notoriously deadly.Road accidents kill an average of 1,400 people every year in the country of about 12 million inhabitants, according to government data.Potosi accounts for 10.6 percent of all traffic accidents with fatalities in the South American country, according to the Bolivian Observatory of Citizen Security.Before Saturday's collision, 64 people had died in traffic accidents in Potosi alone this year, according to a police report. Saturday's accident comes less than two weeks after at least 30 people were killed when a passenger bus plunged into an 800-meter-deep ravine in southern Bolivia.he accident happened on a narrow two-way road between the cities of Potosi and Oruro, with the route running along a ravine nearly half a mile deep. Authorities said the crash was potntially caused by speeding, with the driver unable to control the bus.In January, another nineteen people were killed when a bus careened off a road, also near Potosi. The driver in that accident was

Zelenskyy embraced by British prime minister a day after White House blowout

LONDON. British Prime Minister Keir Starmer embraced Ukrainian President Volodymyr Zelenskyy on Saturday and told him he had the U.K.'s unwavering support, a day after the blowout at the White House with President Donald Trump.Zelenskyy arrived to cheers from people who had gathered outside of 10 Downing St., where Starmer gave him a hug and ushered him inside. The two leaders met on the eve of a meeting of European leaders in London. Called to discuss how European nations can defend Ukraine — and themselves — if the U.S. withdraws support, it has taken on new urgency following Trump's televised berating of Zelenskyy.

And as you heard from the cheers on the street outside, you have full backing across the United Kingdom," Starmer told the leader of the war-torn country. 'We stand with you, with Ukraine, for as long as it may take."Zelenskyy thanked him and the people of the U.K. for their support and friendship. After the meeting, Britain announced it was extending a 2.26 billion pound (\$2.84



billion) loan to Kyiv for military procurement, with the money coming from the profits on frozen Russian assets. It's Britain's contribution to a \$50 billion package of support pledged by the G-7 group of wealthy indutrialized nations.

Zelenskyy thanked Britain in a statement on X, saying: "This is true justice – the

one who started the war must be the one to pay."Starmer spoke to both Trump and French President Emmanuel Macron on Saturday evening after meeting Zelenskyy, the prime minister's office said.

The meeting comes the day after an extraordinary diplomatic meltdown when Trump and Vice President JD Vance blasted Zelenskyy in the Oval Office on live television for not being grateful enough for U.S. support.

Zelenskyy had been poised to ink a deal to give the U.S. access to mineral riches as Trump pressures Ukraine to reach a deal to end the war with Russia. But he left town without signing anything. Zelenskyy had been scheduled to meet with Starmer on Sunday before the European summit, but the timetable for their bilateral meeting was apparently sped up in the aftermath of the Washington visit.

Israel supports a US proposal to extend Gaza ceasefire's first phase; Hamas wants Phase 2

CAIRO. Israel's government said early Sunday it supports a proposal to extend the first phase of the ceasefire in Gaza through Ramadan and Passover, though Hamas has insisted on negotiating the truce's second phase instead. The statement by Prime Minister Benjamin Netanyahu's office came minutes after the first phase ended, and as talks have begun on starting the second phase that's aimed at ending the war and seeing all remaining living hostages in Gaza returned

The statement gives new details on what Israel described as a U.S. proposal: A ceasefire extension through Passover, or April 20. On the first day, half the hostages, alive and dead, would be released. The rest would be released if agreement is reached on a permanent ceasefire. The statement said it was proposed after U.S. envoy Steve Witkoff got "the mpression that at this stage there was no possibility of bridging the positions of the parties to end the war, and that more time was needed for talks on a permanent ceasefire."There was no immediate comment from Hamas, which earlier rejected an Israeli proposal to extend the ceasefire's first phase by 42 days doubling its length — saying it goes against the truce agreement, according to a member of the group who requested anonymity to discuss the closed-door negotiations. Officials from Israel and mediators Qatar, Egypt and the United States have been involved in negotiations on starting the ceasefire's second phase in Cairo. But Basem Naim, a member of Hamas' political bureau, told The Associated Press there had been "no progress" before Israeli negotiators returned home on Friday. Hamas did not attend, but its position has been represented through Egyptian and Qatari mediators.

Under the ceasefire deal's terms, fighting should not resume while negotiations are underway on phase two. Israel's new statement says it can return to fighting "if it believes that the negotiations are ineffective," noted Hamas' refusal to accept the proposal for an extension of the first phase.

However, "if Hamas changes its position, Israel will immediately enter into negotiations on all the details of the Witkoff plan," the statement says. Before Israel's new statement, an Egyptian official involved in the talks spoke on condition of anonymity to discuss the negotiations. The official said Hamas, Qatar and Egypt wanted to continue with the existing ceasefire deal, and they rejected Israel's proposal to extend the ceasefire for four weeks with a release of hostages every Saturday without officially entering negotiations on the second phase.

The Egyptian official said the U.S. wants to start negotiations on the second phase but called for hostage releases during the negotiations. Hamas insisted on a full implementation of the ceasefire terms.

The first phase, which paused 15 months of fighting in Gaza, saw the release of 33 hostages, including eight bodies, in exchange for nearly 2,000 Palestinian prisoners. Hundreds of thousands of people returned home to northern Gaza, aid into the territory increased and Israeli forces withdrew to buffer zones.

Anti-DOGE protests at Tesla stores target Elon Musk's bottom line

BOSTON. Demonstrators gathered outside Tesla stores across the U.S. Saturday to protest the automaker's billionaire CEO, Elon Musk, and his push to slash government spending on behalf of President Donald Trump. The demonstrations are part of a growing backlash in North America and Europe to Musk's disruptive role in

Washington.Critics of Trump and Musk hope to discourage and stigmatize purchases of Tesla, the electric car company that is the world's most valuable automaker.Liberal groups for weeks have organized anti-Tesla protests in hopes of galvanizing opposition to Musk's Department of Government Efficiency and energizing Democrats still demoralized by Trump's November victory. "We can get back at Elon," said Nathan Phillips, a 58-year-old ecologist from Newton, Massachusetts, who was protesting in Boston on Saturday. "We can impose direct economic damage on Tesla by showing up at showrooms everywhere and boycotting Tesla and telling everyone else to get out, sell your stocks, sell your Teslas."Musk is taking direction from Trump to slash federal spending and sharply reduce the workforce, arguing that Trump's victory gave the president and him a mandate to restructure the U.S. government. DOGE officials have swiftly gained access to sensitive databases, directed thousands of federal job cuts,



canceled contracts and shut down sections of the government, including the U.S A g e n c y f o r I n t e r n a t i o n a l Development. Musk's critics say his actions defy Congress's power to control the U.S. budget and present a host of ways for him to enrich himself. Musk leads several other companies, notably SpaceX, which conducts launches for NASA and the intelligence community, and the social media platform X."Protests will not deter President Trump and Elon Musk from delivering on the promise to establish DOGE and make our federal government

more efficient and more accountable to the hardworking American taxpayers across the country," said White House spokesperson Harrison Fields.

Tesla did not respond to an emailed request for comment.ore than 50 demonstrations were listed Saturday on the website Tesla Takedown, with more planned later in March from coast to coast in the United States along with England, Spain and Portugal. News reports showed demonstrations in recent days in U.S. cities including Tucson, Arizona; St. Louis; New York City; Dayton, Ohio; Charlotte; and Palo Alto, California.Some Tesla owners have also reported their vehicles vandalized with spray painted swastikas amid what Jewish groups and observers fear is a rise in antisemitism.Federal prosecutors charged a woman in connection with a string of vandalism against a Colorado Tesla dealership, which included Molotov cocktails being thrown at vehicles and the words "Nazi cars" spray painted on the building.

Uttarakhand Avalanche: 46 Rescued, 8 Confirmed Dead

Chamoli: Indian Army has officially concluded its search and rescue operations at the site of the Mana Avalanche in Uttarakhand, following several days of intense efforts. A total of 46 workers have been successfully rescued and are now receiving medical treatment.

Tragically, eight workers lost their lives in the avalanche. The Army has expressed its condolences to the families of the deceased and pledged support during this difficult time.

At the time of the avalanche, 54 workers were stationed at the site. The powerful snow slide buried their containers, which served as living quarters. While eight lives were lost,



the remaining workers either managed to escape or were rescued by the Army's dedicated teams. With the recovery efforts now complete, the search operation has officially been called

To facilitate the rescue,

eight helicopters were deployed, including five from the Army, two from the Air Force, and one civilian helicopter hired by the Army. All rescued individuals were transported to the Joshimath Military Hospital for medical care.

In an update provided on Sunday, Lt. Colonel Manish Srivastava reported that a drone-based 'intelligent buried object detection system' was airlifted from Delhi and arrived in Joshimath via Dehradun to assist in

locating the final missing

worker. A 17-member National Disaster Response Force (NDRF) team was also deployed to support the operation. The body of the last missing worker was eventually recovered, marking the conclusion of the search.


The eight victims have been identified as Mohinder Pal and Harmesh Chand from Himachal Pradesh; Jitender Singh, Manjeet Yadav, Alok Yadav, and Ashok Paswan from Uttar Pradesh; and Anil Kumar and Arvind Kumar Singh from Uttarakhand.

In the wake of the disaster, the National Disaster Management Authority (NDMA) issued an avalanche warning for parts of Uttarakhand and Jammu and Kashmir. The alert, issued on Sunday, cautioned that a mediumlevel avalanche is likely to occur above 2,500 meters in the next 24 hours. The warning follows the deadly avalanche in Uttarakhand's Chamoli district, which resulted in the loss of eight workers' lives at a Border Roads Organisation (BRO) camp.

The NDMA advisory covers the higher altitudes of Uttarakhand's Chamoli, Pithoragarh, Rudraprayag, and Uttarkashi districts, as well as Baramulla in Jammu and Kashmir. Officials have warned that the avalanche threat is expected to continue due to ongoing snow conditions over the coming

WHO Warns of 38% Increase in **Breast Cancer Cases & 68% Rise** in Deaths by 2050

RNS: The World Health Organization (WHO) has issued a stark warning, predicting a 38% increase in breast cancer cases and a 68% rise in related deaths by 2050. According to a new report from the International Agency for Research on Cancer (IARC), if current trends continue, 3.2 million new cases and 1.1 million deaths will occur annually by mid-century.

The surge will disproportionately affect low- and middleincome countries, where access to early detection and treatment remains limited. "Every minute, four women are diagnosed with breast cancer, and one woman dies," said Dr. Joanne Kim, co-author of the report. She emphasized that nations could mitigate these trends through better prevention policies and investment in healthcare.

Breast cancer is already the most common cancer among women, with 2.3 million new cases and 670,000 deaths in 2022. The highest incidence rates were observed in highincome regions like Australia and North America, while the highest mortality rates were seen in Melanesia, Polynesia, and Western Africa, where healthcare access is limited.

The WHO's Global Breast Cancer Initiative, launched in 2021, aims to reduce mortality by 2.5% annually, potentially preventing 2.5 million deaths by 2040. The report stresses the need for stronger healthcare systems, better screening, and cost-effective prevention measures to address global disparities and prevent more deaths.

India reports sharp decline in poverty, inequality over last decade

New Delhi: India has witnessed a considerable decrease in poverty over the last decade according to a new paper. The paper, published by economists Surjit S Bhalla and Karan Bhasin, analysed data from recently released household expenditure data for 2022-23 and 2023-24.

Data from these surveys indicate a substantial decline in poverty levels in India.

The paper claimed that extreme poverty in the country has dropped to negligible levels. The paper also stated that there is strong evidence that India has experienced a sharp reduction in inequality over the last twelve years from 2011-12 to 2023-24.

SAIL-BSL Workers Set to Stage Massive Protest Over Unmet Demands



Bokaro: In a show of growing frustration with the SAII BSL (Bokaro Steel Plant) management's failure to address long-standing worker demands, employees from the Coke-Oven and Coke-Chemicals Department at Bokaro Steel Plant (BSL) have announced plans for a large-scale protest on 7 March. The demonstration is set to focus on the ongoing neglect of worker welfare and safety concerns by the plant's management.

On Saturday, workers gathered outside the Chief General Manager's office to voice their discontent and stand in solidarity ahead of the planned protest.

The demonstration was led by Rajendra Singh, General Secretary of KIMS and a member of the National Joint Council of Action (NJCS), who condemned the management for failing to honor commitments made in previous meetings.

Singh expressed grave concern over the deteriorating situation, highlighting the lack of progress on promised medical checkups and the worsening conditions of workers who are struggling to access basic healthcare. He pointed out that hundreds of workers, now without jobs, are being denied essential medical support, with skilled workers left out of the ESIC scheme and deprived of treatment

In addition to the healthcare crisis, Singh accused the management of exploitation, citing the inadequate handling of the Additional Work Allowance (AWA) and neglect of workers' safety. He criticized the management's response to frequent workplace accidents, claiming that instead of addressing the issue, officers are focused on covering up incidents rather than safeguarding employ-

The protestors also drew attention to the stark contrast between the lavish incentives enjoyed by the management and the dire conditions faced by permanent workers. Despite their hard work, the workers continue to endure exploitation and neglect, with little to show for their efforts. Singh made it clear that the workers would no longer accept empty promises, vowing to escalate their actions. "Now there will be war, not pleas. Only struggle will bring the solution," he declared, announcing plans to block the coke ovens and blast furnaces on 7 March as part of their

The demonstration was supported by other union leaders, including RK Singh, Shashi Bhushan, Jumman Khan, Hareram, Nagendra Kumar, Amit Yadav, Siraj Ahmed, and Tuntun Singh, all of whom reinforced the message of unity and collective action. Singh urged workers to remain strong and united, emphasizing that their solidarity was the key to securing their rights and achieving victory.

India Triumphs Over New Zealand by 44 Runs to Reach Semifinals in ICC Champions Trophy match

Dubai: India triumphed over New Zealand by 44 runs in their ICC Champions Trophy match in Dubai on Sunday.

After opting to bat first, India posted a total of 249/9 in their 50 overs, setting a target of 250 for New Zealand.

New Zealand, in pursuit of the target, was bowled out for 205 runs, handing India the victory.

This result propelled India to the top of Group A, securing a semifinal clash with Australia on Tuesday. Meanwhile, Group B toppers South Africa will face New Zealand in the second semifinal in Lahore on Wednesday.

New Zealand won the toss and chose to bowl first. Despite a valiant 81-run knock from Kane Williamson, who fought hard to keep New Zealand in the hunt, the Kiwi team fell short of the target.

Varun Chakaravarthy was the standout performer for India, claiming five Hardik Pandya's quickwickets for 42 runs, as New Zealand struggled against his spell. Axar Patel, Hardik Pandya, and

Congress worker's body found in suitcase in Rohtak day before Haryana civic polls

The body of 22-year-old Congress worker Himani Narwal was found stuffed in a suitcase in Haryana's Rohtak, prompting the police to launch an investigation and file a case. The party demanded a high-level probe into the matter.

Rohtak. The body of a Congress worker was found stuffed in a suitcase near a bus stand in Haryana's Rohtak district on Saturday, police said. The Congress demanded a high-level probe into the death of Himani Narwal (22), who was associated with party MP Rahul Gandhi's Bharat Jodo Yatra. The incident came on the eve of municipal elections to 33 bodies across the state, with the results to be out on March 12.

The suitcase was spotted by passers-by near the Sampla bus stand and they informed the police. On receiving information about the incident,

the police and a forensic team reached the spot and found Narwal's body inside the suitcase.

Police said the victim's neck was wrapped with a dupatta and the victim had mehendi on her hands. Police suspect that Narwal, a resident of Rohtak's Vijay Nagar area, may have been murdered by strangling



her with the dupatta. Her body was taken to PGIMS Rohtak for a postmortem examination. The Congress, in a post on X, expressed condolences over the party worker's death and demanded an impartial investigation into the matter.

Narwal had posted many photos of herself with former Chief Minister Bhupinder Singh Hooda's son and Congress MP Deepender Singh Hooda, and party MLABB Batra on social media.

Reacting to the development, Batra demanded an SIT investigation into the matter and said Narwal used to participate in every programme of the Congress party. Congress MP Deepender Singh Hooda questioned Haryana's law and order situation and demanded the accused be arrested soon.Sampla police station in-charge Vijendra Singh said an investigation into the case began after he and his team reached the spot. He also said that a case had been registered. Police said further action would be taken after the post-mortem was conducted.

Same Voter ID Number In 2 States? Election **Body On Mamata Banerjee's Charge**

West Bengal Chief Minister Mamata Baneriee cited duplication in EPIC numbers and accused the BJP of colluding with the poll body to add take voters to the state's electoral rolls

New Delhi. A duplication in EPIC numbers on voter ID cards does not imply fake voters, the Election Commission clarified today. The poll body attributed this duplication to decentralised, manual mechanism that was followed before the voters' database was shifted to a digital platform. The commission, however, said these cases of duplication would be rectified by allowing unique EPIC numbers to all voters. This comes days after West Bengal Chief Minister Mamata Banerjee cited duplication in EPIC numbers and accused the BJP of colluding with the poll body to add fake voters to the state's electoral rolls ahead of the Assembly polls next year. "I have proof from all districts. Here it is. Names of people from Haryana and Gujarat appear alongside those of West Bengal residents under the same EPIC (Election Photo Identity Card) number. Fake voters have been added online," Ms Banerjee alleged.



The Trinamool chief said Opposition parties in Maharashtra and Delhi had failed to spot this tactic. "But we did. That is how the BJP won in Maharashtra and Delhi. Now, they are targeting West Bengal. We will respond strongly," she said, adding, "It is evident how the BJP is tampering with the voters' list with the blessings of the

Election Commission". The Election Commission's statement did not mention Ms Banerjee and said that the poll body took note of social media posts and media reports flagging duplicate EPIC numbers of people from different states.

In this regard, it is clarified that while EPIC numbers of some of the electors may be identical, the other details including demographic details, Assembly Constituency and polling booth are different for the electors with the same EPIC number. Irrespective of the EPIC number, any elector can cast a vote only at their designated polling station in their respective Constituency in their State/UT where they are enrolled in the electoral roll and nowhere else," it said. The poll body explained that this duplication was due to a decentralised and manual mechanism followed before the shifting of states' electoral roll database to the ERONET platform.

But what happened around twelve hundred years ago? Nalanda, the intellectual jewel of ancient India, housed ten thousand students and two thousand teachers in a nine-storey building. However, in 1193, Bakhtiyar Khilji, a reckless destroyer of our culture and academic institutions, set the premises on fire. For months, the fire consumed vast libraries, reducing hundreds of thousands of irreplaceable manuscripts on mathematics, medicine, and philosophy to ash."He concluded by noting that the loss was not just architectural but a systematic erasure of centuries of knowledge.

Sajjan jailed, but 1984's wounds remain open

IT has taken 40 years to convict former Congress MP Sajjan Kumar for his murderous role in the anti-Sikh pogrom, that raged unchecked across New Delhi after Prime Minister Indira Gandhi was shot dead by her two Sikh bodyguards on October 31, 1984, ending only with her cremation three days later.But, unfortunately, Kumar is the only prominent Congress politician to be thus sentenced despite the culpability of numerous others in organising Hindu mobs to hunt down droves of Sikhs, including women and children, on streets, in their homes and workplaces during these 72 hours and slaughtering them. Many victims were brutally 'necklaced' by pinioning their chests and arms with car tyres soaked in petrol and setting them alight. By the time some semblance of order was enforced in the city by the Army, the organised massacres by the State-turned-avenger for the first time in independent India's history, had left some 2,733 Sikhs dead in Delhi alone. Human rights organisations, however, put this number in the capital close to 4,000. Over decades thereafter, around 15 inquiry commissions, committees and special investigation teams (SITs) determined variously beyond reasonable doubt that these killings were engineered by Congress party loyalists like Kumar and his fellow MPs Kamal Nath, Dharam Dass Shastri, Jagdish Tytler and HKL Bhagat, who died in 2005 without even being tried. These multiple probes also determined that the extended slaughter was executed by a crosssection of largely Congress party members, sympathisers and bands of hired criminals, all of who carried voter lists to identify Sikh households across Delhi's neighbourhoods. Armed with crude swords, cleavers, scythes, kitchen knives and even scissors and an 'inflammable white powder', these mobs executed their retribution relentlessly, assured immunity from arrest.

Justice SN Dhingra, who was appointed in 2018 to head the SIT to relook at the 186 cases related to the 1984 pogrom, stated in 2022 that the entire endeavour of the Congress government was to ensure that none of the major perpetrators of violence was punished. Consequently, it appointed Justice Ranganath Misra to head the commission inquiring into the unrest, fully aware that he was in line to become the 21st Supreme Court Chief Justice — which he did in 1990 — and, therefore, would be 'cautious' in his findings. Expectedly, Justice Misra indicted 19 Congress workers, who, ironically, were charged by the People's Union for Civil Liberties with having abetted the massacres, but blatantly absolved the Congress party of all blame. Subsequently, the Nanavati Commission — the 10th such inquiry committee in 16 years instituted in 2000 and headed by GT Nanavati. a retired SC judge, recommended prosecutions in 2005 only against Kumar and Tytler. This was despite several witnesses, including this writer, accusing several other Congress MPs and party cadres of their involvement in the violence. Criminal proceedings against Nath are underway, albeit proceeding at a glacial pace.

The Nanavati Commission also revealed that of the original 587 FIRs registered after the 1984 violence, only 25 had resulted in convictions, of which just 12 were for murder. And, of the 440 overall convictions, many cases featured the same person being found guilty of as many as seven counts each. Subsequently, the SC-monitored SIT was formulated in 2018 and continues to ramble

Meanwhile, Indira Gandhi's son and successor Rajiv Gandhi justified the pogrom, declaring at a public rally in Delhi's Boat Club on November 19, 1984 that 'Jab bhi koi bada ped girta hai, to dharti thodi hilti hai' (When a big tree falls, the earth shakes a little). The new PM had fittingly delivered the Congress party's metaphor for the pogrom, even though officialese and media reports at the time, and even now, continue to refer to it as the 1984 anti-Sikh riots, ignoring the reality that the state machinery, including the local police, had openly and wantonly turned vigilante in seeking vengeance against an entire community for Indira Gandhi's murder.

Rock Garden's legacy crumbles under urban pressure

The unique character of City Beautiful, shaped by its cultural and artistic heritage, is being slowly erased, leaving behind a regimented and soulless urban landscape.

In India, a debate is on about doing away with Mughal or British heritage sites. The Central Vista and Lutyens' Zone in New Delhi, integral to India's history, are being redeveloped, with many heritage buildings already razed. Based on ideological leanings, people take sides on such emotional issues while the larger question of historical consciousness gets overlooked.

When Connaught Place was rechristened Rajiv Gandhi Chowk and Mughalsarai renamed Pandit Deen Dayal Upadhyaya Nagar, my first thoughts were that history should not be meddled with. Even if we deplore the history of the Mughal rule and the British Raj in India, we should let it be, perhaps, as a reminder of the past, and, largely, because you cannot undo history by wiping out its traces with shifting power equations.

This raises important questions about how we treat our cultural heritage and what we choose to preserve. It is not just a local issue, but a reflection of a broader problem. Preserving cultural heritage is not just about safeguarding tangible assets like monuments and artefacts but also about protecting intangible aspects like traditions, customs and the history of a city that ensures the continuity of our identity, values and beliefs. The last few days have witnessed a storm swirling around the demolition of a wall of the Rock Garden in Chandigarh. The administration's decision to prioritise parking over preservation is a cultural travesty that distorts the site's cultural significance. We cannot wipe the damage done to the Rock Garden and its green space but we can certainly bring it to the forefront and maybe rectify the decision of the Punjab and Haryana High Court.Indeed, the memorial to Nek Chand and his unique imagination enables visitors to emotionally respond to the contempt for waste matter and the love of metamorphosing it into a work of art, a living example of creativity and public memory. Such symbolic objects rekindle the critical response to the past by fearlessly confronting it to set the stage for the future. To wipe out history would be to betray the values a city needs to bring home to its future generations. The decision to knock down the wall or cut down the long-preserved trees is offensively distasteful. The creation of parking spaces, ostensibly a practical necessity, will be perceived as a symbol of colonial-era values and a blight of unchecked urbanisation, leaving an indelible mark on our city's landscape. Tearing down parts of the heritage is not the answer to the reality of confronting the nightmare of plunder and mindless occupation for the expediency of finding space for the burgeoning vehicles.

For those deeply invested in preserving our city's cultural heritage, this decision is nothing short of tragic, and we cannot help but feel outraged by the shortsightedness of it all. The destruction of the heritage wall is an unjust act, considered offensive and disrespectful to its cultural significance. Urbanisation, while bringing numerous benefits, often comes at the cost of cultural heritage and artistic spaces. As cities expand and develop, historic buildings, monuments and public art installations are frequently demolished to make way for new infrastructure, high-rise buildings and parking lots. This



erases the physical manifestations of a city's history and threatens the intangible cultural heritage that is rooted in these spaces. The unique character and identity of City Beautiful, shaped by its cultural and artistic heritage, are being slowly erased, leaving behind a regimented and soulless urban landscape. The encroachment of urbanisation on artistic and cultural spaces is particularly devastating because it severs the connection between a city's past and its present. When these spaces are destroyed or neglected, the stories, memories and cultural practices that they embody are lost forever. As a result, urbanisation can be seen as a form of cultural amnesia, where the relentless pursuit of development leads to the erasure of a city's cultural heritage and artistic identity. Moreover, the unremitting march of expansion has brought human advancement to the threshold of nature, menacing the very existence of the natural world. As cities grow, forests are cleared, wetlands are drained and wildlife habitats are destroyed to make way for new buildings, roads and parking lots. This impingement on the natural world has shattering consequences for birds, animals and wildlife that consider these ecosystems home. The loss of habitat around the Rock Garden and disruption of delicate ecosystems, all contribute to the disquieting decline of biodiversity in urbanising areas.

The end of nature, as we know it, is a stark reality that threatens us as we gaze out upon the rambling metropolises of the world. The once pristine landscapes, teeming with life and colour, are now a distant memory, replaced by the steel and concrete of urbanisation. The songs of birds, the rustle of leaves and the gentle babbling

of brooks are silenced, replaced by the cacophony of car horns, construction and human chatter. As we stand at the rock face of this ecologicalcrisis, we are forced to confront the consequences of our actions and to consider the future of the natural world in the face of inexorable development. Preserving cultural heritage, therefore, is a collective responsibility that requires concerted efforts from individuals, communities and governments. Moreover, cultural heritage conservation promotes cross-cultural understanding, nurtures community engagement and contributes to justifiable expansion.

As keepers of our cultural legacy, it is essential that we prioritise preservation efforts, raise mindfulness about the status of cultural heritage and support initiatives that protect and promote our shared cultural treasures. As we move forward, it is crucial that we learn from history, acknowledge and engage with it and build an intellectual environment that is critical, inclusive and civil.

The goal of citizens and preservationists is to critically examine the high court's decision and its far-reaching consequences. It might also help in grasping the material designs behind the installation or dismantling of walls or buildings that apparently reflect the political ambitions of the ruling class, supported by conformist historians.

The damage that the decision to flatten the wall of the Rock Garden does to our cultural sensibilities is as vital as the damage it does to the cultural heritage of this iconic monument. In the wake of the brutal demolition, discussions and demonstrations must target the urban symbols of atrocities and aggression against art and

The 2025 edition was special as it witnessed an innovative confluence of tradition and technology. Digital lost-and-found centres helped reunite thousands of missing people with their family members. AI-driven systems played a vital role in estimating crowd density and tracking people. snan' became the new buzzword a offered a service for those who were unable to attend the Maha Kumbh: prints of photos sent by devotees through WhatsApp were collected and immersed in the sacred waters on their behalf — it was as simple and convenient as that.Crowd control was a major



challenge throughout the festival, and the authorities did fairly well on this front despite huge odds. However, things went horribly wrong on Mauni Amavasya last month when crores of pilgrims jostled to take a dip. The resultant stampede led to the death of at least 30 people, according to the police, even as the Opposition has accused the Yogi government of concealing the actual death toll. Delhi gone, all AAP eyes now on Punjab

The CAG report on the Delhi excise policy has flagged glaring irregularities that have further dented the party's image.

It is not easy for a party that rode to power on the lofty plank of good governance to come to terms with a crushing defeat. The Aam Aadmi Party (AAP) burst onto the scene in 2012 on the back of a dubious anticorruption campaign, made a mark in the 2013 Delhi But it was not the battered and bruised AAP Assembly polls and then went on to accumulate huge political capital. What clicked with voters of Delhi in 2015 as well as 2020 was its promising agenda — zero tolerance to corruption, investment in basics such as education, healthcare and public transport, and

establishing an accessible and responsive bureaucracy. The party came down with a thud in the recent Delhi polls for not delivering on some of these pledges. Its leaders failed to confront the BJP, which unleashed its mammoth propaganda machinery that flattened AAP and crucially, its founder and leader, Arvind Kejriwal. There is no respite in sight for him and his colleagues. The CAG report on the Delhi excise policy, tabled in the Assembly earlier this week, has flagged glaring irregularities that have further dented the party's image.For Kejriwal, AAP's national convener, the loss in Delhi is a rude shock as well as a wake-up call. His party had routed the BJP and the Congress in two successive polls. The Delhi 'governance model' he crafted and implemented even won adherents in the BJP camp who were otherwise wedded to Hindutva and their brand of nationalism. Having lost its underpinning of governance, AAP now exists as a hollowed-out entity. It faces the onerous task of retaining power in Punjab, the only state it governs at present. Days before the verdict was out, Jasmine Shah, a close aide of Kejriwal, while releasing his book, 'The Delhi Model: A Bold New Roadmap to Building a Developed India', said in a statement, "For the first time in India, here is a model of the people of India." That boast flew out of the window

on February 8. Some AAP insiders believe that it is time to reassess the leadership and restructure the organisation to regain public trust.

in Delhi that figured immediately on Kejriwal's radar. Following the poll reversal, he held a meeting with Punjab Chief Minister Bhagwant Mann and state party MLAs in Delhi, ostensibly to discuss how to make Punjab a 'model state' in the run-up to the 2027 elections. AAP insiders regard Punjab as the party's 'best bet' despite the state government being besieged by problems such as a run-down economy, compounded by a lack of Central funds. The Mann government is also bogged down by the drug menace, farm distress, the sand mafia and corruption, all of which have tied the CM's hands while offering direct financial aid to women and increasing subsidies. The government is also being criticised for securing loans at a high rate of interest and amending property tax

laws amid mounting debt. The prospect of some AAP MLAs jumping ship is also not ruled out. Has Kejriwal applied his mind to such crucial concerns that have electoral ramifications? He is too much of a political animal to leave the affairs of Punjab to Mann and confine himself to rejuvenating the party in Delhi, where he is no longer even an MLA. The fact that he convened the Punjab meeting promptly shows that he is unwilling to rely entirely on Mann, a first-time CM.

governance that prioritises investing in the masses, in Kejriwal has entrusted Jasmine Shah with retooling Punjab, even as state observers have cautioned against



Delhi's alleged overt interference and diversion of the state's resources for AAP's campaigns in other states. At the end of the day, Punjab's political dynamics are distinct. While Mann recently said his government would focus on education, healthcare, electricity and water and turned the spotlight on initiatives like the closure of toll plazas and the abolition of numerous pensions for MLAs, do these assurances and achievements add up to a persuasive Punjab model? Doling out freebies alone may not make for a winning formula. Mann's main obstacle is inadequate industrial investments that have not generated enough revenue to

create infrastructure such as roads. Although the Punjabi diaspora is unlikely to make the state significantly investible, AAP's outreach to the expats is continuing.

Even as Punjab has become the centre of AAP's attention, the reversal in the Capital has curtailed Kejriwal's soaring national ambitions that were evident in the Gujarat and Goa Assembly polls in 2022. AAP bagged five seats and got a vote share of 12.91 per cent in Gujarat, but its projected leaders Isudan Gadhvi and Gopal Italia lost their seats. In Goa, AAP won two seats with a 6.77 vote share. AAP is silent on foraying into Bihar, which votes later this year, even as it is confused about remaining with the INDIA bloc nationally and notionally. Its relations with the Congress have only worsened after the latter targeted Kejriwal during campaigning in Delhi. The

Congress is also AAP's main rival in Punjab.AAP began as a party that spanned the social arc in its outreach to the affluent, the professionals and the less well-off. The Delhi outcome revealed that with a 44 per cent vote share, it retained its base among the less well-off and the Muslims, although the BJP worked hard to win over the Dalits.Kejriwal has a long way to go before he can reappropriate the anti-corruption plank and restore AAP's standing as a party of good governance. The BJP will not give him an easy passage. His salvation will lie in consolidating his social base — or whatever is left of it.



रिजर्व बैंक के मुताबिक दो अब भी रिजर्व बैंक के 19 निर्गम कार्यालयों में उपलब्ध है। आरबीआई के निर्गम कार्यालय 9 अक्टूबर, 2023 से व्यक्तियों और संस्थाओं से उनके बैंक खातों में जमा करने के लिए 2000 रुपये के बैंक नोट स्वीकार कर रहे हैं।

इसके अलावा आम लोग देश के किसी भी डाकघर से भारतीय डाक के जरिए 2000 रुपये के नोट को अपने बैंक खाते में जमा कराने के लिए आरबीआई के किसी भी कार्यालय में भेज सकते हैं।

उल्लेखनीय है कि रिजर्व बैंक ने 19 मई, 2023 को 2000 रुपये मूल्य के बैंक नोटों को प्रचलन से वापस लेने की घोषणा की थी। हालांकि, दो हजार रुपये के नोट अब भी वैध मुद्रा बने रहेंगे।

जीएसटी राजस्व संग्रह फरवरी में 9.1 फीसदी बढ़कर 1.84 लाख करोड़ रुपये

नई दिल्ली। वस्तु एवं सेवा कर (जीएसटी) राजस्व संग्रह से सरकार का खजाना फिर भर गया है। फरवरी महीने में जीएसटी राजस्व संग्रह सालाना आधार पर 9.1 फीसदी बढ़कर 1.84 लाख करोड़ रुपये रहा। हालांकि, जनवरी में जीएसटी राजस्व संग्रह 1.96 लाख करोड़ रुपये रहा था। जीएसटी महानिदेशालय ने जारी आंकड़ों में बताया कि फरवरी माह में जीएसटी राजस्व संग्रह के जरिए 1.84 लाख करोड़ रुपये आए हैं। इस दौरान घरेल स्तर पर वस्तु एवं सेवाओं से प्राप्त राजस्व 10.2 फीसदी बढ़कर 1.42 लाख करोड़ रुपये रहा है। आयात राजस्व 5.4 फीसदी बढ़कर 41,702 करोड़ रुपये हो गया। जीएसटी संग्रह बढ़ने की वजह घरेलू

आंकडों के मृताबिक फरवरी महीने के दौरान केंद्रीय जीएसटी से 35,204 करोड रुपये, राज्य जीएसटी से 43,704 करोड़ रुपये,

है। जीएसटी महानिदेशालय के मृताबिक फरवरी 2025 में शुद्ध जीएसटी राजस्व संग्रह 8.1 फीसदी बढ़कर लगभग 1.63 लाख करोड़ रुपये रहा। एक साल पहले इसी



एकीकृत जीएसटी से 90,870 करोड़ रुपये और क्षतिपूर्ति उपकर से 13,868 करोड़ रुपये प्राप्?त हुए हैं। फरवरी के दौरान जारी किए गए कुल रिफंड 20,889 करोड़ रुपये था, जो एक साल पहले की समान अवधि की तुलना में 17.3 फीसदी अधिक अवधि में सकल और शुद्ध जीएसटी संग्रह क्रमशः 1.68 लाख करोड़ रुपये और 1.50 लाख करोड़ रुपये था। उलेखनीय है कि अबतक सर्वाधिक जीएसटी संग्रह अप्रैल 2024 में 2.10 लाख करोड़ रुपये से अधिक रहा है।

सीतारमण ने कहा कि केंद्र और राज्य सरकार की 1,200 योजनाओं में से 1,100 अब प्रत्यक्ष लाभ हस्तांतरण (डीबीटी) के तहत हैं, जिससे यह सुनिश्चित



होता है कि पैसा सीधे लाभार्थियों के बैंक खातों में भेजा जाए। उन्होंने अपने संबोधन में डीबीटी को बेहतर बनाने में सार्वजनिक वित्तीय प्रबंधन प्रणाली (पीएफएमएस) की महत्वपूर्ण भूमिका पर प्रकाश

वित्त मंत्री ने कहा कि 1200 में से 1100 केंद्रीय और राज्य योजनाएं अब डीबीटी के तहत हैं, जिससे बिचौलिए खत्म हो गए हैं। पीएफएमएस की उपलब्धियों पर प्रकाश डालते हुए

वेजिटेबल सूप

- मौसमी सिंजयों के साथ आप मिक्स वेज सूप तैयार कर सकते हैं। इसके लिए आप किसी एक सब्जी को उबालकर उसका सूप बनाएं और शिमला मिर्च, बीन्स, मशरूम, हरी प्याज और आलु को महीन टुकडों में काटकर इन्हें अलग उबाल लें।
- पहले से तैयार सुप में इन सब्जियों को मिलाएं और अपने स्वाद के हिसाब से काला नमक, जीरा पाउडर आदि मिलाएं।ध्यान रखें सूप को गाढ़ा करने के लिए कॉर्नफ्लोर मिलाया जाता है।आप इसका उपयोग कर सकते हैं लेकिन अधिक मात्रा में इसे मिलाने से बचें। नहीं तो यह आपके वजन को बढाने की वजह बन सकता है।

चुकदर का सुप

- चुकंदर का सूप बनाने के लिए आप टमाटर, आलू, प्याज, लहसुन, काली मिर्च का पाउडर और नींबु का रस जैसी चीजों का उपयोग करते हैं। ये सभी बहुत पौष्टिक और सेहत को फिट रखनेवाली चीजें हैं।

- तैयार मिश्रण को मिक्सी में डालकर पीसें और गाढा लिक्विड तैयार करें। इसे छान लें और काली मिर्च पाउडर तथा नींबू का रस मिलाकर सूप तैयार करें और इसे हरी धनिया पत्तियों के साथ गार्निंश करके सूप का लुत्फ उटाएं।

मंग दाल का शोरबा



- मृंग दाल का शोरबा मात्र 10 मिनट में तैयार हो जाता है। इसके लिए आप बिना छिलके की मूंग दाल को धुलकर कुकर में 3 से 4 सीटी लगा लें । इसे तैयार करतें समय आपको पानी की मात्रा सामान्य दाल बनाने से दोगुना रखें और गैस की धीमी आंच पर रखकर ही पकाएं।
- अब इसमें हरी धानया पत्ती, बारीक कटी हरी मिच, बारीक कटी कच्चा प्याज मिलाकर तडका लगा दें। मसलों के नाम पर इसमें सिर्फ हल्दी पाउडर का उपयोग करें, हल्का काला नमक मिलाएं और काली मिर्च पाउडर मिक्स करके गर्मागर्म शोरबा का लुत्फ उठाएं।



गर्म पानी के साथ घी और नींबू

आजकल, बाजार में आयुर्वेदिक चाय की ढेर सारी वैराइटीज उपलब्ध हैं। लेकिन अच्छा होगा कि आप घर पर अपनी चाय खुद ही बना लें। इसके लिए 1 चम्मच जीरा, 1 चम्मच सौंफ, 1 चम्मच धनिया के बीज, 1 इलायची और थोड़ी सी अजवाइन को लेकर 500 मिलीलीटर पानी में तब तक उबालें, जब तक पानी की मात्रा आधी न हो जाए।

मेटाबोलिज्म बढ़ाने के लिए चाय आजमाएं

कच्चे फल सुबह खाली पेट हर्बल चाय पीने के बाद, कच्चे

फलों का सेवन करें जो प्रकृति में थोड़े से कसैले हो सकते हैं।ग्रीन और रेड एपल, क्रैनबेरी, ब्लूबेरी, चेरी, स्ट्रॉबेरी, ब्लैकबेरी, अनानास, आंवलाँ और अनार जैसे फलों को ही चुनें । यह फल शरीर में वॉटर रिटेंशन को कम करते हैं और आपकी त्वचा में कोलेजन को बढ़ाते हैं, जिससे वजन कम करने में मदद मिलती है।

Prague Masters: Praggnanandhaa outwits Keymer to join Aravindh in lead

PRAGUE. Grandmaster R Praggnanandhaa scored his second victory on the trot, outwitting Vincent Keymer of Germany to join compatriot Aravindh Chithambaram at the top on three points after the end of the fourth round of the Prague Masters here.

Aravindh survived some initial hiccups before signing peace with Sam Shankland of the United States, while top seed Wei Yi of China finally found his form at the expense of local star David Navara. Anish Giri of Netherlands played out his fourth draw in as many games with Gurel Ediz of Turkey, while Czech GM Nguyen Thai Dai Van also drew with Quang Leim Le of Vietnam in the other two games of the 10-player round-robin tournament. With Praggnanadhaa and Aravindh in front, Shankland, Keymer, Giri and Le share the third spot a full point behind and it looks like the race for the title will be between the two Indians only with five rounds still to come. Almost a month back Keymer had beaten Praggnanandhaa in the Tata Steel Masters and the Indian avenged his defeat fighting from what looked like a shaky French defense with black.

Keymer was caught off guard in the



middlegame. Praggnanandhaa went for the trade of queens and got his counter attack rolling.eymer, meanwhile, ran low on time and wasted some moves moving his rook back and forth to just draw. The Indian obviously understood it better and used his pieces well to win a couple of pawns. The rest was easy and it was all over in 44 moves. Aravindh faced the Sicilian defense and Shankland equalised quite easily. An exchange spree led to a very slight advantage for Shankland but the endgame was always closer to a draw. The players eventually arrived at a theoretically drawn rook and pawns endgame where an extra pawn for Shankland did not matter much.

The next round will see the two leaders pitted against each other and Praggnanadhaa will play with white. In the challengers' section, Divya Deshmukh played out a draw with Ma Qun of China and took her tally to 1.5 points from four games. This section is jointly led by Nodirbek Yakubboev of Uzbekistan and Jonas Buhl Bjerre of Denmark, who both have three points apiece.

After Virat Kohli, can Rohit Sharma light up Champions Trophy

New Delhi. India will aim to continue with their winning momentum as they take on New Zealand in their last group fixture of the ICC Champions Trophy 2025 on Sunday, March 2 at Dubai International Cricket Stadium, Dubai. The Men in Blue have ticked most of their boxes in the first two matches as both the spinners and the pace bowlers were amongst the wickets. With the bat, Shubman Gill and Virat Kohli starred with centuries against Bangladesh and New Zealand respectively, along with crucial contributions from KL Rahul and Shreyas Iyer in the middle order. Hence, India have pretty much covered up as they embark into the semi finals after the New Zealand. However, the only missing piece of



their captain Rohit Sharma. The India skipper has registered scores of 41 and 20 in the two innings respectively against Bangladesh and Pakistan but a big innings from Rohit's bat would do his confidence a word of good heading into the semi finals. Over the last few months, the opening batter was seen struggling for runs in the Test format. However, he didn't carry those demons into 50-over cricket as he recently slammed his second fastest century in ODIs against England. His innings of 112 (90) was a clear indication that the India captain is far from done and his willow is hungry to clobber some monstrous sixes against the fiercest bowlers of international cricket. Holding a placard above her head, the young girl was sending a message to not just her country, but the cricketing world. The English translation of the pashto message read along the lines of: "I'm an Afghan girl, I want to become a doctor. Please don't oppress us and take away my dreams."That young girl in the stands of the Gaddafi Stadium, Lahore on Saturday is not alone. About 10,500 kilometres away, in Melbourne and Canberra, Australia, several women cricketers from Afghanistan were staying up in the night to watch the men's

The UN has termed the situation of women in the country as gender apartheid with a real threat to the lives of women in

up in the oasis city of Herat in the western part of Afghanistan, Firooza Amiri did not like cricket. Football was the popular sport in her city. "I was completely in shock for a couple of days. Taliban, they are a terrorist group and how hard is living in a situation where they are in the regime. So, I was worried so much about how am I going to still survive here? Am I going to go somewhere?," her thoughts lingered.

Ricky Ponting backs Virat Kohli to match Tendulkar's ODI record: Never write him off

Legendary batter Ricky Ponting backed Virat Kohli to match Sachin Tendulkar's record for most ODI runs. Last Sunday, Kohli broke Tendulkar's record as the fastest batter to 14,000 ODI runs, also becoming the third cricketer to reach the milestone. Although he is more than 4,000 runs away, Ponting believes Kohli will be motivated to approach Tendulkar's all-time record. Ponting, who led Australia to glory in the 2003 and 2007 ODI World Cups, said the 36-year-old Kohli would aim to build a legacy for himself and be "remembered as the all-time leading run scorer." With someone like Virat, you never



write him off, because I'm sure he'd be motivated by that [achieving the record], I think," Ponting said on the ICC Review Podcast.Champions Trophy: Full Coverage | Points TableKohli is in prime form after scoring his 51st ODI hundred in the marquee clash of the 2025 Champions Trophy against Mohammad Rizwan's Pakistan at the Dubai International Cricket Stadium. Kohli failed to get going against Bangladesh, where Rishad Hossain dismissed him, but he made amends against Pakistan.Kohli is also nearing second place on the list of most ODI runs. The veteran is only 149 runs short of surpassing Kumar Sangakkara's tally of 14,234 runs in the 50over format. Ponting said that if Kohli stays hungry, he can surpass not only Sangakkara but also Tendulkar. Now that he's gone past me and only two ahead of him, I'm sure he wants to give himself the best chance to be remembered as the all-time leading run scorer in the game."

IND vs NZ: India, New Zealand battle to keep momentum going in Group A finale

New Delhi. If you head into the India vs New Zealand game on Sunday thinking that it is a dead rubber, then you're mistaken. Yes, Group A has been settled with India and New Zealand making it to the semi-finals after

beating Bangladesh and Pakistan respectively. India will play their semi-final in Dubai and New Zealand will head over to Lahore for their match. However, the game on Sunday will all be about momentum. It was perfectly summed up by Sunil Gavaskar when he talked to India Today ahead of the game. The Indian legend said it was all about finishing at the top and keep the winning feeling going into the business end of the tournament. "I actually don't think it's an inconsequential game in terms of, you know, points maybe, but how do you say it's inconsequential?

Because whoever gets to win the game becomes No.1, and they get to play the No.2 of the other group. So I don't think it's inconsequential. Also, as far as the rhythm is concerned, you want to keep the winning rhythm going, the winning momentum going, the winning feeling going. Because

anytime you lose, suddenly, just like any batter, you play and miss, you tend to have that little doubt in your mind before the next ball comes along. So you don't want anything like that to happen. So India has to keep on winning to be able to get that



feeling, and also send a message to the opposition that look, we are there. Try and beat us to win the championship," said Gavaskar.India and New Zealand's performances are almost mirror images. Take their matches against Bangladesh, for

example. A good bowling performance ensured that they had restricted Bangladesh to scores below 250. But the chase was tricky in the end and both teams needed their young guns in the form of Shubman Gill and Rachin Ravindra to step up and hit hundreds.

Against Pakistan, it was utter domination from both teams as they beat Mohammad Rizwan's side comfortably.Interestingly, this will be the first time India and New Zealand will face in the Champions Trophy. They faced off in the final in 2000 when the tournament was known as the ICC Knockouts, but this will be the first time they lock horns in the current iteration of the tournament. The Blackcaps have been a thorn in India's side in ICC events. The 2000 final they defeated India and then went on to knock India out of the 2019 World Cup in the semi-final.

India got their revenge in the 2023 edition as they beat New Zealand twice, with one being the semi-final in Mumbai. Both teams look ready for the contest, and we could expect a thriller at the Ring of Fire.

India series was good for Champions Trophy preparation: England coach McCullum

Brendon McCullum admitted

New Delhi. England head coach Brendon McCullum admitted that his side's early exit from the Champions Trophy was a bitter pill to swallow but maintained that their ODI series against India was the best possible preparation leading up to the tournament.

Despite their efforts, England endured a forgettable campaign, failing to register a single win, which ultimately led to captain Jos Buttler stepping down from his role. England's tournament came to a disappointing end with a seven-wicket defeat to South Africa, extending their ongoing struggles in ODI cricket. Speaking at the post-match press conference, McCullum emphasised the need for reflexion, acknowledging that England must assess their performances not just in the Champions Trophy but also in their lead-up series against India. He also noted that discussions will take place regarding the appointment of a new ODI captain following Buttler's resignation.I felt India was actually really good preparation for us, even though we obviously got beaten quite comfortably there. I thought that was as good a preparation as you could have coming into a major tournament and obviously we had our chance in those first couple but what we saw



tonight was probably an example of why we're out of the tournament," McCullum said. "I'll get home in the next couple of days and then start to think about, and start having some conversations with Rob Key and the guys at the ECB about who is the right person for us to put in that position of white ball captain and then what do they need and how do we start to learn some of the lessons that we've been dealt on this tour and in this tournament to ensure that we're a lot more

competitive than what we've been," he added.McCullum further hinted at the possibility of restructuring England's white-ball leadership, leaving open the option of having separate captains for ODIs and T20Is. This potential shift comes as England look to rebuild after their disastrous Champions Trophy campaign and prepare for future tournaments. Group B, featuring Afghanistan, Australia, South Africa, and England, turned out to be highly competitive. England's last group match had significant implications for Afghanistan, who needed them to beat South Africa by at least 207 runs to progress. However, England's batting unit once again collapsed under pressure, failing even to post 207 runs. England's aggressive 'Bazball' approach backfired once more, as reckless shot selection led to yet another underwhelming total. In Buttler's final game as captain, the batting order crumbled, with

Joe Root being the only notable contributor.
