Trudeau to discuss Canada's sovereignty with King Charles after Trump threat

London Canadian Prime Minister Justin Trudeau said his priority in talks with King Charles on Monday will be protecting his country's sovereignty after US President Donald Trump recently suggested making Canada the 51st US state. Trudeau said nothing is more important to his citizens than "standing up for our sovereignty and our independence", ahead of the meeting with Charles, who is Canada's head of state.Last week, Charles invited Trump to what would be a historic second state visit to Britain, with Prime Minister Keir Starmer handing over the invitation during a meeting before the world's media in the Oval Office."I look forward to sitting down with His Majesty tomorrow (Monday), as always we will discuss matters of importance to Canada and Canadians, and I can tell you that nothing seems more important to Canadians than standing up for our sovereignty and our independence as a nation," Trudeau told reporters.Trudeau, the outgoing Prime Minister, said last month that Trump's talk about absorbing Canada "is a real thing" and is linked to the country's rich natural resources.Trump has repeatedly suggested Canada would be better off if it agreed to become the 51st US state.

UK Police Discover Remains In Search For Woman Murdered By Husband In 2013

- world.Police searching near a main road in North Yorkshire believe they have found the remains of a woman murdered by her husband more than a decade ago. Rania Alayed was 25 when she was murdered by Ahmed al-Khatib in a Salford flat in June 2013 in what police at the time described as an "honour" killing, the Guardian reported.
- A court heard that Khatib, enraged after Alayed left him, lured her to her death and later wore her clothing to deceive friends and family into believing she was still alive. It was known that Alayed's body had been transported to North Yorkshire and buried near the A19. Despite multiple searches over the years, her remains had not been found. However, following new information, Greater Manchester Police launched a fresh search in Thirsk on Monday, which led to the discovery of human remains. While formal identification is still pending, a police spokesperson stated, "We strongly suspect the remains are that of Rania." Alayed's son, Yazan, speaking on behalf of the family, described the discovery as "surreal" and said, "For the past 11 years, all we have wanted is to provide my mother with a final resting place. To finally be able to lay down a few flowers for her is more than I can ask for from this world."
- Originally from Palestine, Alayed had moved to the UK with Khatib from Syria. Her marriage was marked by domestic violence, but after leaving Khatib, she was striving to build a better life for herself and her three

Wildfires engulf North and South Carolina, states declare emergency; check affected areas

South Carolina Governor Henry McMaster declared a state of emergency on Sunday amid the ongoing wildfire crisis across the state.

World. The raging wildfires across North and South Carolina have affected the normal lives of thousands as crews evacuated residents amid strong winds and dry conditions. On Sunday, firefighters faced challenges containing the blazes due to dry fuels and very low relative humidity. Fire crews worked tirelessly to contain a large wildfire near Carolina Forest, located west of Myrtle Beach. Horry County Fire Rescue had ordered evacuations for several neighborhoods as the fire spread. According to the South Carolina Forestry

Commission, the fire had burned nearly 1.9 square miles (4.9 square kilometers) by Sunday afternoon and was not contained. However, no casualties or injuries have been reported so far.

State Of Emergency Declared In South Carolina

South Carolina Governor Henry McMaster declared a state of emergency on Sunday amid the ongoing wildfire crisis across the state. With more than 175 fires having scorched large areas of the state, a statewide burning ban has also been imposed. As smoke enveloped the air and

entire communities faced evacuation, the situation remained tense. However, in some regions, including Carolina Forest near Myrtle Beach, firefighters made significant progress which helped evacuees safely return home by late Sunday afternoon.



North Carolina

In western North Carolina, a separate fire near the towns of Tryon and Saluda, caused by a fallen power line along US Highway 176 on Saturday afternoon, quickly spread uphill, threatening structures in the area.

By Sunday evening, the fire had burned over 500 acres, with only 30 percent of it contained, according to Polk County Emergency Management. Meanwhile, the Polk County Emergency Management/Fire Marshal's office reported that the North Carolina Forest Service was carrying out helicopter water drops and backburning operations on the ground.

In North Carolina, the US Forest Service reported multiple wildfires burning across the state, with crews actively working to contain the blazes that have consumed over 400

acres (161.87 hectares) in four different forests. The largest fire reported at Uwharrie

National Forest, nearly 50 miles (80.47 kilometers) east of Charlotte, has burned around 300 acres (121.41 hectares).

Israel supports a US proposal to extend Gaza ceasefire's first phase; Hamas wants Phase 2

CAIRO. Israel's government said early Sunday it supports a proposal to extend the first phase of the ceasefire in Gaza through Ramadan and Passover, though Hamas has insisted on negotiating the truce's second phase instead. The statement by Prime Minister Benjamin Netanyahu's office came minutes after the first phase ended, and as talks have begun on starting the second phase that's aimed at ending the war and seeing all remaining living hostages in Gaza returned home

The statement gives new details on what Israel described as a U.S. proposal: A ceasefire extension through Passover, or April 20. On the first day, half the hostages, alive and dead, would be released. The rest would be released if agreement is reached on a permanent ceasefire. The statement said it was proposed after U.S. envoy Steve Witkoff got "the impression that at this stage there was no possibility of bridging the positions of the parties to end the war, and that more time was needed for talks on a permanent ceasefire."There was no immediate comment from Hamas, which earlier rejected an Israeli proposal to extend the ceasefire's first phase by 42 days doubling its length — saying it goes against the truce agreement, according to a member of the group who requested anonymity to discuss the closed-door negotiations. Officials from Israel and mediators Qatar, Egypt and the United States have been involved in

Preserving records of 'atrocities' by Hasina regime critical: Yunus

DHAKA. Bangladesh's interim government's Chief Adviser Muhammad Yunus has called for the "meticulous preservation" of records documenting alleged "atrocities" committed under the administration of deposed prime minister Sheikh Hasina.

During a Sunday meeting with United Nations officials, Yunus emphasised that without a proper archival system "it is difficult to know the truth and ensure justice", the Dhaka Tribune newspaper reported.

A statement issued by the chief adviser's press wing said the chief adviser during his conversation with UN Resident Coordinator Gwen Lewis and UN human rights expert Huma Khan cited the crackdown on demonstrators at Shapla Chattar, police brutality against protesters following the Delwar Hossain Sayedee verdict, and years of



alleged extrajudicial killings.The UN officials, in response, reaffirmed their willingness to assist Bangladesh in documenting human rights abuses.

Pope Francis's Condition Stable But Complex

Rome, Italy.Pope Francis is in a "stable" condition in hospital but the clinical picture remains complex, the Vatican said Sunday, as the 88-year-old issued a statement thanking well-wishers for their support.

The head of the Catholic Church was admitted to Rome's Gemelli hospital on February 14 with bronchitis, which later developed into pneumonia in both lungs. After appearing to recover slightly during the week, the Argentine pope suffered a breathing crisis on Friday, causing widespread concern, but he passed a quieter weekend."The clinical conditions of the Holy Father remained stable today," the Vatican said on Sunday in its regular early evening medical update.

at London summit amid growing US tensions LONDON. European leaders closed ranks Sunday in support of Kyiv at a London summit, where they pledged to spend more on security and assemble a coalition to defend any truce in Ukraine.Bringing together 18 allies, the talks were devoted to the key

questions of how to provide security guarantees for Ukraine and bolster Europe's future defences while keeping the United States under President Donald Trump onside.Just days after a thunderous row between Trump and Ukraine's Volodymyr Zelensky raised fresh questions over the US leader's commitment to Ukraine and NATO, British Prime Minister Keir Starmer warned that Europe found itself "at a crossroads in history"."This is not a moment for more talk -- it's time to act. It's time to step up and lead and unite around a new

plan for a just and enduring peace," the premier added.With no guarantee of US involvement, "Europe must do the heavy lifting" in securing peace in Ukraine, Starmer said, indicating that several countries were ready to help defend any truce.Zelensky was warmly embraced by many of the summit's attendees, including Starmer, Canadian Prime Minister Justin Trudeau and NATO chief Mark Rutte, while protesters rallied outside the UK

leader's home in support of Ukraine.That welcome stood in stark contrast to Zelensky's treatment in the White House on Friday, where he was berated by Trump for not being grateful enough for US aid and not being



for peace with Russia.Avoid "ready dividing WestTheir argument, played out in front of the world's news cameras, raised fears that Trump wants to force Kyiv into a peace deal giving Russian President Vladimir Putin what he wants while leaving Ukraine broken and insecure. After the leaders gathered on Sunday, European Commission chief Ursula von der Leyen warned that "we urgently have to rearm Europe' and "prepare for the worst" on the continent.Polish Prime Minister Donald Tusk meanwhile called for the United States and Europe to "speak

with one voice" in showing Putin "that West has no intention of the capitulating before his blackmail and aggression".Starmer and France's President Emmanuel Macron have said

they are prepared to deploy British and French troops to Ukraine to help preserve the peace in the event an agreement is signed to end the war.Rutte pointed to promises from more European countries to "ramp up defence spending", while insisting the United States remained committed to the transatlantic alliance.The London meeting brought together allies from around continental Europe, including France, Germany,

Denmark and Italy as well as Turkey, NATO and the European Union.In addition to attending the security summit, Zelensky also met King Charles III at his Sandringham estate in England.'Very welcome'As Sunday's gathering got underway dozens of protesters draped in the yellow and sky-blue flag of Ukraine gathered outside Starmer's office, some holding signs bearing the legend "Putin's end is near" and "Stop vermin, Stop Putin". That mirrored the hero's welcome Zelensky received on Saturday when his convoy swept into Downing Street to a cheering crowd.

The official said Hamas, Qatar and Egypt wanted to continue with the existing ceasefire deal, and they rejected Israel's proposal to extend the ceasefire for four weeks with a release of hostages every Saturday without officially entering negotiations on the second phase.

The Egyptian official said the U.S. wants to start negotiations on the second phase but called for hostage releases during the negotiations. Hamas insisted on a full implementation of the ceasefire terms.

The first phase, which paused 15 months of fighting in Gaza, saw the release of 33 hostages, including eight bodies, in exchange for nearly 2,000 Palestinian prisoners. Hundreds of thousands of people returned home to northern Gaza, aid into the territory increased and Israeli forces withdrew to buffer zones.

USAID official warns of unnecessary deaths from Trump move, put on leave: Report

USAID official Nicholas Enrich warns of deaths due to agency dismantling Enrich placed on leave after memo criticising leadership 🕳 Trump's administration cut \$60 billion in foreign aid

Washington.A senior official with the US Agency for International Development in an email on Sunday warned that the Trump administration's dismantling of the agency will result in unnecessary deaths -- only to email his staff less than 30 minutes later to say that he had been placed on leave.

Nicholas Enrich, USAID's acting assistant administrator for global health, in the seven-page memo shared with staff, and

which was seen by Reuters, said "political leadership" had made it impossible to deliver lifesaving humanitarian assistance around the world, contradicting assurances from Secretary of State Marco Rubio that such aid would continue despite President Donald Trump and billionaire Elon Musk's cost-cutting campaign.

The shuttering of USAID is part of an unprecedented downsizing of the

federal government by Musk's so-called Department of Government Efficiency. The agency's sudden demise has thrown global humanitarian relief efforts into chaos.In a separate memo seen by Reuters, Enrich estimated that a year-long pause in lifesaving aid from USAID would cause between 71,000 and 166,000 additional malaria deaths, a nearly 40% increase; an increase of between 28% and 32% in tuberculosis cases worldwide; and up to 28,000 cases of emerging infectious diseases such as Ebola.After Trump ordered all foreign aid frozen in January pending a review, Secretary of State Marco Rubio issued a temporary waiver for lifesaving assistance, such as essential medicines, food and shelter.

But Enrich said DOGE workers and other political appointees have made it impossible to approve payments for those critical programs. According to Enrich's memo, various officials at USAID and the State Department issued conflicting guidance on what programs would qualify for the waiver and how they would be funded.

India's River Dolphin Population Surpasses 6,300: Survey

PM Modi Chairs 7th National Board for Wildlife Meeting in Gujarat

New Delhi: India's first-ever population estimate of river dolphins shows a promising count of 6,327 dolphins across the Ganga, Brahmaputra, and Indus River systems.

The comprehensive survey, spanning 28 rivers in eight states, covered over 8,500 kilometers and utilized 3,150 man-days of effort. Uttar Pradesh led the tally, followed by Bihar, West Bengal, and Assam.

Prime Minister Narendra Modi unveiled the report during his visit to Gir National Park in Gujarat, where he also attended the 7th National Board for Wildlife meeting. In his address, the Prime Minister emphasized the critical role of local communities in dolphin conservation and the potential of eco-tourism to drive wildlife protection. He also stressed the need



for better connectivity to boost wildlife tourism in the country.

Today Prime Minister Narendra Modi chaired the seventh meeting of the National Board for Wildlife (NBWL) at Sasan Gir in Junagadh district, Gujarat, coinciding with World Wildlife Conservation Day. The meeting was attended by Environ-

ment Minister Bhupendra Yadav, state representatives, NGO officials, chief wildlife wardens, and secretaries

from various states. The meeting focused on discussions related to wildlife conservation and management. The National Board for Wildlife, which works towards promoting the conservation and development of wildlife and forests, operates under the leadership of the Prime Minister. During the session, PM Modi virtually inaugurated the foundation stone for the National Referral Centre for Wildlife in Junagadh.

He also unveiled the 16th Asiatic Lion Population Estimation 2025 and inaugurated the Centre of Excellence in Human-Wildlife Conflict Management in Coimbatore. Before the meeting, the Prime Minister embarked on a jungle safari at Gir National Park and took part in a tree plantation drive at Sinh Sadan Campus in Gir. He flagged off patrolling bikes for field staff working on wildlife conservation and manage-

ment. Modi also interacted with eco-guides, trackers, and women field staff.

In a post on social media, the Prime Minister praised the collective efforts in Gir forest, highlighting the rise in the Asiatic lion population. He also acknowledged the role of tribal communities and women in preserving the lion's habitat

Visually Impaired Can Join Judicial Services

New Delhi: In a landmark decision, the Supreme Court today ruled that visually impaired individuals cannot be denied the opportunity to work in judicial services. A bench consisting of Justices J B Pardiwala and R Mahadevan delivered the judgment after reserving its decision on six petitions

Justice Mahadevan, while pronouncing the verdict, emphasized that persons with disabilities should not face discrimination in their pursuit of judicial service positions. He stated that the state must implement affirmative action to create an inclusive recruitment framework that ensures equal opportunities for all, regardless of disability.

The Apex Court struck down a provision in the Madhya Pradesh Judicial Services (Recruitment and Conditions of Services) Rules, 1994, which previously barred visually impaired and low-vision candidates from entering judicial service in the state. The court highlighted the importance of ensuring substantive equality, urging the state to take necessary steps for the inclusion of persons with disabilities in the judicial system.

Ranchi: The Jharkhand Pradesh Sanyukt Shikshak Morcha raised concerns over the eVV portal during a hearing with the Secretary of the School Education and Literacy Department, Umashankar Singh, on 3 March 2025. The hearing followed a court order regarding petition WPS-4571/2024, and was attended by Front representatives including State Convenor Amin Ahmed, District Convenor Somesh Kumar Mishra, Spokesperson Arun Kumar Das, and Senior Advocate Sahdev Chaudhary. At the meeting, the Front highlighted several issues with the biometric attendance system, including the use of personal mobile phones by teachers to mark attendance, which violates the 2015 Aadhaar-based Biometric Rules. The Front called for the provision of proper devices and the implementation of an offline system to address technical problems like fingerprint mismatches and network issues.

Bihar Govt. Presents Rs 3.16 Lakh Crore Budget for 2025-26 with Focus on **Education and Welfare**



Patna: In the Bihar Legislative Assembly today, Finance Minister and Deputy Chief Minister Samrat Chaudhary presented the state budget for the financial year 2025-26, totaling Rs 3,16,895 crore. This represents an increase of Rs 38,169 crore from the previous year. The budget allocates Rs 61,000 crore to education, the highest expenditure in this year's budget.

Chaudhary outlined a revenue target of Rs 2,60,000 crore for the coming year, marking an increase of Rs 34,033 crore. Key allocations include Rs 60,954 crore for education, Rs 20,335 crore for health, and Rs 16,193 crore for rural development. Notable initiatives include establishing Mahila Haat in Patna, setting up Kanya Vivah Mandaps in all panchayats, and opening one degree college in 358 blocks over time.

The budget also includes Rs 1,289 crore for modernizing 21 market committees. The Chief Minister's SC-ST hostel grant has also been increased from Rs 1,000 to Rs 2,000 to support students living in hostels.

Replacing humans with robots: Akhilesh Yadav rips into calls for 90-hour workweek

New Delhi. The debate over long workweeks has intensified, with Samajwadi Party chief and former Uttar Pradesh Chief Minister Akhilesh Yadav weighing in on the argument. Responding to recent remarks by corporate leaders advocating for extreme work hours, Yadav strongly criticised the notion, questioning whether employees were being treated as humans or robots.

Those who are advising employees to work for 90 hours - are they talking about replacing humans with robots, because humans want to live with their emotions and family," Akhilesh Yadav said, adding that true economic progress should benefit all and not just a select few.

His comments come amid growing discussions surrounding statements by prominent industrialists such as Infosys co-founder Narayana Murthy, who suggested young Indians should work 70 hours a week to



boost national productivity. More recently, L&T Chairman SN Subrahmanyan further escalated the debate by advocating a staggering 90hour workweek, even suggesting that employees should give up Sundays for work. Yadav condemned

such proposals, arguing that they disregard employees' well-being and the importance of work-life balance. He emphasised that productivity is not merely about clocking excessive hours but about working wholeheartedly and efficiently.

- Quality of work is most important, not quantity. The truth is that the people sitting at the top get the maximum benefit of the hard work of the youth without doing anything, that is why some such people give impractical advice like 'working for 90 hours'," he said.
- He also took a dig at the BJP government, questioning the economic benefits of extended work hours. "If economic progress only benefits a few, then whether the economy reaches USD 30 trillion or USD 100 trillion, what difference does it make to the common people? True economic justice means prosperity is shared by all, but that is not possible under this government," Yadav said.



Security dynamics of the Siliguri corridor

- THE turbulence and violence in the neighbouring Bangladesh reflect latent security threats and implications which may well spill over across the border, especially in the sensitive region of the Siliguri corridor. The geographical attributes and cartographic peculiarities of this area create vulnerabilities which can be exploited by inimical elements using non-conventional methods
- This corridor, which links India with eight of its states in the north-east, is formed due to the sudden decrease in width as the Indian territory extends eastwards across the land mass linking north Bengal with Assam and with Nepal, Bhutan and Bangladesh hedging in this area from the west, north and south, respectively. The shortest expanse is 20 km, between Naxalbari on the India-Nepal border and Phansidewa on the India-Bangladesh border. Close to this is the 30-km transit route for third-party trade permitted by India between the border checkpoints of Kakarbhitta in Nepal and Banglabandha in Bangladesh. The Indian territory's width between Bhutan and Bangladesh is 43 km at its narrowest. Known as the 'gateway to the Northeast', major communication arteries, including NH 17 and 27, broad gauge rail lines, oil and gas pipelines and the national power grid, pass through it. The strategic airfields of Bagdogra and Hasimara, important military formation HQs, and the large towns of Siliguri, Jalpaiguri and Cooch Behar are located within this corridor. In the north, this area is over 40 km from the Chinese territory of Chumbi Valley, across the undeveloped mountainous terrain of south Bhutan till the Indian border. However, all along its southern length, it is flanked by the undulating border with Bangladesh as it meanders across the riverine terrain and swampy areas.
- Guarding such a border, primarily against illegal immigrants and smugglers, is a herculean task as it is also densely populated on either side.
- The conventional threats to the Siliguri corridor appear overhyped. Whether it is the Chinese People's Liberation Army (PLA) through Bhutan or the Bangladesh forces from the south, the Indian armed forces can deter them and may well carry the battle across in the unlikely scenario of hostilities breaking out. The real threat lies in the unconventional domain. The high volume of illegal crossings driving a rapid demographic change, ethnic assertion turning to insurgency and support for both from across the borders — these are the actual security challenges.
- Illegal immigration from Bangladesh has always been the bane of this region. It has impacted the ethnic composition of the populace in towns and villages. It has built up over the years in the garb of labour, domestic workers and petty businesses, including trans-border smuggling. All this provides a human resource for creating unrest in a vital part of India.A strong vein of Islamic fundamentalism had existed in East Bengal even before and after 1947, when it became the East of Jinnah's Pakistan. 1971 did not exorcise these elements. Pakistan recognised Bangladesh in 1974. Ironically, Pak PM Bhutto got a hero's welcome in Dhaka barely three years after the Pakistan army's infamous Operation Searchlight in 1971, which led to the Bangladesh liberation war.Khaleda Zia's tenure from 2001 to 2006 was the high noon of Pakistan/ISI influence with radical Islamists in government. Harkat-ul-Jihad al-Islami ran terror operations, targeting Indian interests with impunity. Sheikh Hasina did focus on this common enemy, but she could not eliminate the powerful strain of opinion.

Post the regime change in Bangladesh, the emerging alignment between Bangladesh and Pakistan not augur well for peace and stability in the adjoining regions. The fundamentalist elements who have come to fore in the post-Hasina era would find mutuality of interests with a rogue state like Pakistan, whose ISI, for one, would like to get involved in this part of the sub-continent.

Why India's Oscar submissions need a makeover



India's submissions reflect stories that align with the western perception of India, focussing on poverty rather than the full breadth of its storytelling, including its heritage and achievements

THE 97th Academy Awards, popularly known as the Oscars, will dazzle the audiences on March 2 in Los Angeles, celebrating the finest achievements in global cinema. While anticipation runs high for the winners, the journey to the coveted golden statuette has already seen its share of surprises and heartbreaks. Amidst it all, one enduring question remains: What kind of stories does Indian cinema choose to tell on this stage and why?

India's journey in the 'Best International Feature Film' category at the Oscars has been a complex tapestry of artistic ambition, cultural representation and pursuit of global recognition, often sparking debates about the selection process and narratives chosen to represent its diverse cinema. While the country boasts a rich and varied film industry, its official submissions frequently reflect a preference for stories that align with the western perception of India. They focus on poverty, caste struggles and socio-political unrest rather than the full breadth of India's cinematic storytelling, including its cultural heritage, achievements and progress.

This pattern raises an important question: are we truly showcasing the best of Indian cinema or are we curating narratives that cater to a western gaze? A closer look at past selections suggests that India's choices on the global stage may not always reflect the full spectrum of its cinematic excellence, fuelling discussions about what truly defines Indian storytelling and how India chooses to represent itself internationally. The global reception of Indian films is often shaped by western perceptions. Slumdog Millionaire (2008), not an Indian film, but the United Kingdom's official submission, won multiple Oscars for its portrayal of Mumbai's slums. Similarly, Lion (2016), an Australian production about an Indian child's struggles, gained worldwide acclaim. This year, All We Imagine as Light (2024), which won the Grand Prix at Cannes, was overlooked as India's official submission, reportedly for being 'too European.' Instead,

.

Laapataa Ladies (2024) was chosen, sparking debates about the criteria used by the Film Federation of India (FFI). Likewise, Santosh (2024), again UK's official entry for the 2025 Oscars, directed by British filmmaker Sandhya Suri, reinforces stereotypes about caste oppression and systemic injustice in India. Though the film is in Hindi and rooted in rural north Indian settings, it represented the UK at the Oscars!

This raises another important question: why do so many foreign productions choose to tell stories about India's struggles, injustices and poverty?India's own submission for the same category, Laapataa Ladies (2024), also follows a similar path, highlighting the challenges faced by rural women. Though distinct in storytelling, both Santosh and Laapataa Ladies cater to an audience eager to see a certain version of India - one of hardships, inequality and deeply ingrained social issues. This fuels the perception of India as a country still trapped in poverty and injustice rather than a rapidly evolving, diverse and modern nation.

Similarly, Anuja (2024), produced by Guneet Monga and Priyanka Chopra, was selected as India's official entry for the 2025 Academy Awards and secured a nomination in the Best Live Action Short Film category.

A poignant tale, but again on the same lines - it follows the journey of a poor nine-year-old girl, portraying struggles and triumphs of working children, while addressing such critical issues as child labour and girls' education.

ndia's Oscar journey began in 1957 when Mother India became its first official submission. The film, depicting a woman's resilience against poverty and societal oppression, resonated globally and secured a

nomination. This set a precedent - Indian films recognised at the Oscars often portray struggle and hardship.Continuing this trajectory, films like Salaam Bombay! (1988) and Lagaan (2001) focussed on themes of street life and drug addiction and colonial oppression, respectively. Notably, these remain the only three Indian films to have secured nominations in the Best



International Feature Film category.Bandit Queen (1994), which explored caste violence and oppression, was the official Oscar entry, while Hum Aapke Hain Koun..! (1994), a cultural phenomenon celebrating Indian weddings and traditions, was overlooked. Similarly, Earth (1998) and Hey Ram (2000) delved into communal conflicts while Newton (2017) highlighted electoral challenges in a politically volatile region. The selection of Newton over more popular contenders like

Dangal or Baahubali 2 raised the question if commercial viability and mass appeal should be factored in decisionmaking. Though thought-provoking, these selections reinforced the narrative of India's struggles rather than its achievements. Consider The Lunchbox (2013) and Court (2014), both internationally acclaimed, but ignored for Oscar submission. Sardar Udham (2021), a

powerful historical drama, was sidelined, as was Kantara (2022), rooted in indigenous traditions. Even Rocketry: The Nambi Effect (2022), celebrating ISRO scientist Nambi Narayanan's contributions, failed to make the cut. Meanwhile, The White Tiger (2021), a critique of class struggles, found favour globally.

So, are these choices a reflection of the reality or are they curated to fit western expectations? While acknowledging social issues is crucial, should India not also showcase its progress, scientific excellence and cultural richness? Perhaps, it's time for India's selections to reflect the full spectrum of its storytelling. The Oscars' Best International Feature Film category has often been criticised for favouring narratives that align with western

perspectives. Yet, countries like South Korea and Mexico have successfully reshaped their global cinematic image through strategic Oscar campaigns. Parasite (2019) blended dark humour with social critique while Drive My Car (2021) explored human relationships beyond national struggles. Winners like Perfect Days (2023) from Japan and Emilia Pérez (2024) from France highlight diverse storytelling that transcends stereotypes.



CHENNAI. Shooting was one of the very few sports that helped India capture the coveted Olympic medals during the 2024 Paris Games. After some period of relaxation, the shooters have been looking to recalibrate and gradually find their zone ahead of competitions ahead. There were some notable scores during the national trials that were conducted recently and now, the shooters are set for a national camp ahead of their first international assignment this year.

- It's a phase that national rifle coach, Deepali Deshpande, is excited about. "This is the first year in the new Olympic cycle. This time we have a very strong bench strength. It is a very interesting situation right now. We have to maintain it for the next three, four years now," she noted.
- With rich talent pool in hand, the National Rifle Association of India (NRAI), the governing body of the sport in the country, and the coaches are looking to ensure that more shooters can get the platform to display



their talents. "More shooters will be getting exposure tours this time. It won't be just No 1, 2 and 3 ranked shooters. The last Olympic cycle was very short, so we need to plan well. This year will be more about training and preparing teams and assessing the shooters. There are many established shooters who have been around for a long but there are some new faces in the squad and we need to check their performances at the international level," she said.

National camp from March 14

During the upcoming national squad camp, which is expected to be held from March 14 in New Delhi, as many as eight shooters (at least) are expected to be part of it. The coaches, who were named recently by NRAI, will also get a close look at the talented bunch. "The camp was originally meant for the team for the upcoming World Cups. But we proposed to have a national squad camp so that we can meet all the should camp so that we can have three camps or so, that would be ideal," the Dronacharya Awardee said.

The size of the squad is fine. Since the shooters are of really high standards, the work at the base level will be much less and it will be different. That is quite exciting. There's more order this time and I hope everything goes smoothly," she added.

Atletico hoping Alvarez can end Real Madrid heartbreak in Europe

Atletico have reached three Champions League finals and lost every time, including against Real Madrid in 2014 and 2016.

MADRID. For Atletico Madrid it has been a Diego Simeone's team were ousted repetitious and painful tale whenever they have faced city rivals Real Madrid in Europe, but they signed Julian Alvarez to try and rip up the script. New Delhi. Australia have announced allrounder Connor Connolly as the replacement for injured opener Matthew Short ahead of their crucial Champions Trophy semi-final clash against India. Short sustained a calf injury during Australia's rain-affected match against Afghanistan on February 28, ruling him out of the remainder of the tournament.

Short picked up the injury while fielding and was seen in visible discomfort after his brief knock of 20 runs off 15 balls before being dismissed by Azmatullah Omarzai. Despite initial hopes of a quick recovery, Australia's



medical staff confirmed that he would not regain full match fitness in time for the semi-final.Champions Trophy: Full Coverage | Points Table His replacement, Connolly, was already part

of the Australia squad as a travelling reserve. The 24-year-old all-rounder has played six international matches for Australia, including three ODIs, and will now step into the squad at a crucial stage of the tournament. While primarily a middle-order hetter Gamedic's ghility to head off anis batter, Connolly's ability to bowl off-spin gives Australia an extra bowling option in what is expected to be a high-pressure contest against India.Australia's return to the Champions Trophy semi-finals marks

their first appearance in the tournament's final four since 2009. The five-time ODI World Cup winners last won the Champions Trophy in 2006 and will be aiming to add another ICC title to their illustrious record.

Steve Smith, who has been leading Australia in the absence of regular captain Pat Cummins due to injury, confirmed Short's unavailability after the Afghanistan game. The semi-final against India on March 4 will be a major test for Australia, with both teams coming in strong form. With the conditions in Dubai likely to favour spin, the inclusion of Connolly could prove valuable in providing an extra bowling option alongside Adam Zampa and Glenn Maxwell.

fter 26 years, Jyotika returned to Hindi films with Srikanth in 2024. Entourage Costs 'Mental', Urges Actors To Cut Down Fees: 'We Are Suffering'



ohn Abraham recently expressed his take on why the film industry is suffering. He called out actors

- U demanding a hefty fee and loading a film with their entourage costs. He introspected the dire condition of the film industry, stating that it is "bleeding". The Satyameva Jayate actor also suggested that actors accept a pay cut and work on a film from the backend.
- "It's already hurting Hindi cinema," John Abraham told The Hollywood Reporter. He added, "At this point of time, we shouldn't be paying people to act in films because we don't justify those huge budgets. The huge fees that we get paid, and we can't load a film with entourage costs as well. It's ridiculous. Don't know if actors are thinking this way or is it their agent making them think differently. I understand you are put in a bubble, but you can't be so daft. You need to see the real world. If people are blowing sunshine from your backside, you need to wake up and smell the coffee. As an industry, we are really suffering."
- The actor said that stylists these days charge Rs 2 lakh per day, which is "mental". He called this one of the reasons why the film industry is not able to rake in money. "First thing to make amends is by cutting your personal cost. When a director tells you that you aren't worth that much, you need to take that in cognizance. We don't have that thought yet. We compare ourselves to other actors, and we want to broadcast our fees, and that's the worst thing to do," explained John. The Jism star further expressed his concern for the industry and said that it's time actors realise the "deep black hole" they are steadily seeping into. He felt artists should go to the backend to work on a film. He further added that actors' profit-making from films should be dependent on the film's box office business. "How much more will you suck the system dry?", a concerned John said
