#### **Netflix Issues Warning** About Phishing Emails, Scam Texts Impersonating The **Platform**

world. With online scams becoming increasingly prevalent globally, cybercriminals are constantly developing sophisticated tactics to defraud individuals. These methods range from phone scams to phishing links and now include targeted campaigns against Netflix users through deceptive emails.

As reported by the Mirror, a new phishing scam targets Netflix users via email, falsely claiming payment problems. The emails direct recipients to a fraudulent link to update billing information, which, if clicked, allows scammers to steal login credentials and financial data, and commit identity theft.

How the Netflix Scam Works A new Netflix phishing scam is circulating, disguised as an urgent email with the subject line, "Let's tackle your payment details." Unlike typical phishing attempts riddled with typos and suspicious designs, this scam appears highly polished and legitimate,

featuring Netflix's branding, colours, and fonts When users open the email, they are informed that their Netflix account is on hold due to a billing issue and are urged to update their payment details immediately to avoid service disruption. The email even includes a red banner with a call-to-action button labelled "UPDATE ACCOUNT NOW," making it look like an official Netflix notification. Clicking the button leads to a fake Netflix login page, where users are prompted to enter their login credentials, home address, and credit card details. If users input this information, they unknowingly hand it over to cybercriminals, who can then steal money, make unauthorized transactions, or access other linked accounts.

#### Australia's East Coast Braces For Cyclone Alfred

Sydney. Australia's east coast braced on Wednesday for a tropical cyclone that is swirling towards Brisbane, the country's third-most populous city, as authorities warned thousands of properties were at risk due to strong winds and flash flooding.

Destructive wind gusts of up to 155 kph (96 mph) could develop from Thursday afternoon as tropical cyclone Alfred is expected to cross the coast as a category-two storm early on Friday morning near Queensland state capital Brisbane, Australia's weather bureau said.

The weather system will bring heavy rainfall leading to life-threatening flash floods, the Bureau of Meteorology said.Category two cyclones - on a fivelevel scale - are three rungs away from the most dangerous and can cause major damage to trees and caravans, and break boats from their moorings.

If you're told to leave, you should leave. I can't be more blunt than that," Queensland Premier David Crisafulli told ABC News, calling on residents to heed evacuation orders.Storm warnings on Wednesday



stretched for more than 500 kilometres (311 miles) across the coast in the states of Queensland and New South Wales, impacting millions of people. A total of 122 schools in the north of New South Wales will be closed on Wednesday and Thursday, and vulnerable residents will be urged to relocate by Thursday morning, New South Wales Premier Chris Minns said."We need to bunker down over the next 48 hours and get through what may be a very difficult time," he told reporters. Many residents have left their homes as authorities rush to open evacuation centres. Sandbags are in short supply and supermarket shelves have been stripped bare as people stock up on essentials. ## Trump administration to drop lawsuit against Louisiana petrochemical plant, sources say

WASHINGTON. President Donald Trump's administration plans to drop a federal lawsuit against a synthetic rubber manufacturer accused of worsening cancer risks for residents in a majority-Black community near its Louisiana plant, two sources familiar with the matter said Tuesday. The move would undo one of former President Joe Biden's highestprofile targets for an environmental justice effort aimed at improving conditions in places disproportionately harmed by decades of industrial pollution.

Biden's Environmental Protection Agency sued the Denka Performance Elastomer plant in early 2023, alleging it posed an unacceptable cancer risk and demanding cuts in toxic emissions of cancer-causing chloroprene. The AP sources, who spoke on condition of anonymity because the action has not yet been made public, said court action is expected in coming days. The plan to drop the lawsuit, filed in U.S. District Court in the Eastern District of Louisiana, was first reported by the New York Times.The Trump administration has

moved quickly to reverse the environmental justice focus of Biden's administration, placing roughly 170 environmental justice-focused staffers on administrative leave. Dropping the Denka case relieves pressure on a company that has spent years fighting federal lawsuits and investigations over its impact on public health.Denka, based in Japan, bought the former DuPont plant in LaPlace, Louisiana a decade ago. It's located near an elementary school in a community about 30 miles outside New Orleans. The site produces neoprene, a synthetic rubber that is found in products such as wetsuits and laptop sleeves. The Department of Justice sued the company in early 2023, accusing it of emitting unacceptable levels of chloroprene, a chemical that may be especially harmful to children. A judge had scheduled a bench trial for April.David Uhlmann, who oversaw enforcement and compliance assurance for the EPA in the Biden administration, said Justice officials under

### Trump's halt on military aid will hurt Ukraine's defenses. But it may not be fatal

LONDON. The U.S. has been Ukraine's biggest military backer since Russia's full-scale invasion began three years ago. The suspension of that aid by the Trump administration doesn't mean Ukraine's defenses will quickly collapse.But it's a major blow that threatens to remove some of the most formidable weapons in Ukraine's battlefield arsenal, and ratchets up pressure on Kyiv to accept a peace agreement.

Here's a look at the decision and its implications. How much of Ukraine's aid comes from the US?

The United States has given the Ukrainians more than \$180 billion in assistance since Russia launched an all-out war on February 24, 2022, including more than \$66.5 billion in military aid.Washington provides about 20% of Ukraine's military supplies, and that includes the most lethal and important equipment,



## NASA's stranded astronauts nearing return to earth after nine months in space

CAPE CANAVERAL. NASA's two stuck astronauts are just a few weeks away from finally returning to Earth after nine months in

Butch Wilmore and Suni Williams have to wait until their replacements arrive at the International Space Station next week before they can check out later this month.They'll be joined on their SpaceX ride home by two astronauts who launched by themselves in September

alongside two empty seats. During a news conference Tuesday, Wilmore said that while politics is part of life, it did not play into his and Williams' return, moved up a couple weeks thanks to a change in SpaceX capsules.

President Donald Trump and SpaceX's Elon Musk said at the end of January that they wanted to accelerate the astronauts' return, blaming the previous administration.But Williams, in response to a question, did take issue with Musk's recent call to dump the space station in two years, rather than waiting until NASA's projected deorbit



in 2031. She noted all the scientific research being performed at the orbiting lab.

'This place is ticking. It's just really amazing, so I would say we're actually in our prime right now," said Williams, a three-time space station resident. "I would think that right now is probably not the right time to say quit, call it quits."Williams said she can't wait to be reunited with her Labrador retrievers. The hardest part about the unexpected extended stay, she added, was the wait by their families back home. "It's been a roller coaster for them, probably a little bit more so than

for us," she said. "We're here. We have a mission. We're just just doing what we do every day, and every day is interesting because we're up in space and it's a lot of fun."Wilmore and Williams expected to be gone just a week or so when they launched last June aboard Boeing's new Starliner capsule, making its crew debut after years of delay.The Starliner had so many

problems getting to the space station that NASA ruled it too dangerous to carry anyone and it flew back empty. Their homecoming was further delayed by extra completion time needed for the brand new SpaceX capsule that was supposed to deliver their replacements. Last month, NASA announced the next crew would launch in a used capsule instead, pushing up liftoff to March 12. The two crews will spend about a week together aboard the space station before Wilmore and Williams depart with NASA's Nick Hague and the Russian Space Agency's

month at a press briefing in Florida and said that "we have millions and millions of people over 100 years old" receiving Social Security benefits. "They're obviously fraudulent or incompetent," Trump said."If you take all of those millions of people off Social Security, all of a sudden we have a very powerful Social

Security with people that are 80 and 70 and 90, but not 200 years old," he said. He also said that there's one person in the system listed as 360 years old. Social Security's new acting commissioner, Lee Dudek, acknowledged recent reporting about the number of people older than age 100 who may be receiving benefits from Social

Security. "The reported data are people in our records with a Social Security number who do not have a date of death associated with their record. These individuals are not necessarily receiving benefits.

WHAT'S THE TRUTH?

According to a 2023 Social Security inspector general report, only 44,000 people age 100 or older in the system were getting payments. A July 2024 report from Social Security's inspector general states that from fiscal years 2015 through 2022, the agency paid out almost \$8.6 trillion in benefits, including \$71.8 billion — or less than 1% — in improper payments. Most of the erroneous payments were overpayments to living people.Besides, in early January, the U.S. Treasury clawed back more than \$31 million in a variety of federal payments—not just Social Security payments—that improperly went to dead people, a recovery that former Treasury official David Lebryk said was "just the tip of the iceberg.

## Sunrise on the moon!

#### #Private Blue Ghost lander captures amazing shot after historic lunar touchdown

RNS: Firefly Aerospace's Blue Ghost lander has captured a breathtaking image of a lunar sunrise following its successful landing on the Moon on March 2. The lander set down near Mons Latreille, a solitary lunar peak in the Mare Crisium region on the Moon's near side, marking a significant achievement in lunar explora-

The Blue Ghost began its operations immediately after landing, activating its scientific instruments and sending back incredible images of its surroundings, including the Earth in the distance. The most recent image, shared by Firefly on social media, shows a dramatic lunar sunrise, with the bright sunlight contrasting sharply against the shadowed craters of the Moon's rugged

"Rise and shine! Firefly's Blue Ghost lander captured its first sunrise on the Moon, marking



the start of the lunar day and the beginning of surface operations," Firefly posted on X.

The soft, stable landing was a historic moment for Firefly, making it the first commercial company to achieve a successful soft landing on the Moon as part of NASA's Commercial Lunar Payload Services (CLPS) initiative. The mission, dubbed

"Ghost Riders in the Sky," represents a milestone in cislunar exploration and sets the stage for future lunar missions.

"We're literally and figuratively over the Moon," said Jason Kim, CEO of Firefly Aerospace. "Our Blue Ghost lunar lander now has a permanent home on the lunar surface, carrying 10 NASA payloads and a plaque with the names of every Firefly employee." Kim emphasized that this achievement demonstrates Firefly's capability to provide reliable, affordable access to the Moon and its role in leading future lunar exploration efforts.

The Blue Ghost, which landed with 10 NASA instruments on board, achieved a precision touchdown in Mare Crisium at 2:34 a.m. CST, landing just 100 meters from its target near Mons Latreille. The lander's

shock-absorbing legs ensured it remained upright, confirming the success of the mission.

## **DRDO Successfully Conducts High-Altitude Trials of** Indigenous Oxygen System for LCA Tejas

New Delhi: The Defence Bio-Engineering & Electro Medical Laboratory (DE-BEL) in Bengaluru, under the Defence Research and Development Organisation (DRDO), has successfully completed high-altitude trials of the Indigenous On-Board Oxygen Generating System (OBOGS)-based Integrated Life Support System (ILSS) for the LCA Tejas aircraft.

The trials were conducted on Tuesday, marking a significant milestone in India's aerospace capabilities.

The OBOGS-based ILSS is an advanced system designed to generate and regulate breathable oxygen for pilots during flight, replacing traditional liquid oxygen cylinder-based svstems.

The ILSS was tested on the LCA-Prototype Vehicle-3 aircraft developed by Hindustan Aeronautics Limited (HAL) and the Aeronautical Development Agency (ADA).

It underwent rigorous evaluations under various flight conditions, including altitudes of up to 50,000 feet Above Mean Sea Level and high-G maneuvers, ensuring compli-



ance with strict aeromedical standards.

According to a statement from the Indian government, the performance assessments covered vital functions such as oxygen concentration, demand breathing, availability of 100% oxygen, and testing of the Anti-G Valve and Breathing Oxygen System (BOS) during taxing, take-off, cruising, G turns, and landing. The system passed all tests and met the required parameters after flight clearance from the

Centre for Military Airwor-

thiness & Certification (CE-MILAC).

The ILSS integrates 10 Line Replaceable Units, including the Low-Pressure Breathing Regulator, BOS, Emergency Oxygen System, Oxygen Sensor, and Anti-G valve, among other components. This will enable real-time oxygen generation, enhancing the pilot's endurance and operational efficiency.

Manufactured by L&T as a Development and Production Partner, the ILSS boasts 90% indigenous content, advancing India's self-reliance in aerospace technology. The system can also be adapted for use in other aircraft such as the MiG-29K with suitable modifications.

This achievement is the result of a collaborative effort between DEBEL, ADA, HAL CEMILAC, the National Flight Test Center, the Directorate General of Aeronautical Quality Assurance, and the Indian Air Force (IAF), marking a significant step forward in India's military aviation capabilities.

#### Ranya Rao, Kannada Actress, Arrested at Bengaluru Airport for Smuggling **Rs 12 Crore Gold**



Bengaluru: Kannada actress Ranya Rao was arrested at Kempegowda International Airport on Tuesday for allegedly attempting to smuggle 14.8 kg of gold, valued at over Rs 12 crore, from Dubai. The Directorate of Revenue Intelligence (DRI) apprehended Rao on Monday night after receiving a tip-off.

Rao, who arrived on an Emirates flight from Dubai, was immediately taken into custody and later remanded to judicial custody for 14 days by a court handling economic offences. Authorities had been monitoring her due to her frequent overseas trips, with investigators noting she had visited Dubai four times in just 15 days, raising suspicions of smuggling.

Officials revealed that Rao allegedly hid gold bars in her clothing, including concealing a significant portion in her jacket. Investigators suspect that she may have used her connections to bypass customs inspections.

Upon landing, Rao reportedly identified herself as the daughter of senior IPS officer Ramachandra Rao, who heads the Karnataka State Police Housing Corporation, and allegedly sought police assistance for an escort from the airport. Authorities are now investigating whether any law enforcement officials, including her father, were aware of or inadvertently assisted in her actions.

The DRI is also looking into whether Rao was acting alone or was part of a larger gold smuggling network between Dubai and India. Rao, known for her role in the 2014 Kannada film Maanikya alongside actor Sudeep, has appeared in several South Indian films.



Ukraine: Ukrainian President Volodymyr Zelenskyy has proposed a peace plan aimed at ending the ongoing conflict with Russia, expressing willingness to work under the "strong leadership" of U.S. President Donald Trump. Zelenskyy's remarks came just days after a tense encounter with Trump during their White House meeting.

In an effort to mend ties with Washington after the U.S. paused military aid to Ukraine, Zelenskyy wrote on X: "None of us wants an endless war. Ukraine is ready to negotiate for lasting peace. Nobody wants peace more than Ukrainians, and my team and I are prepared to work under President Trump's leadership to achieve that."

Zelenskyy outlined several initial steps for peace, including the release of prisoners, a ceasefire in the sky (with bans on missiles, drones, and attacks on civilian infrastructure), and a ceasefire at sea-if Russia



He also reiterated Ukraine's appreciation for U.S. support, particularly remembering when President Trump provided Ukraine with Javelin missiles, which Zelenskyy credited

as a turning point in the war.

Referring to the recent White House meeting, Zelenskyy acknowledged that it did not go as planned, calling it regrettable, and expressed a desire to make things right. He emphasized the need for constructive future cooperation and communication between Ukraine and the U.S.

The U.S. had previously paused military aid to Ukraine following the tense exchange between the two leaders, with a White House official stating that the pause was part of a review process to ensure aid contributes to peace. The U.S. has been a major supplier of arms to Ukraine since Russia's invasion in 2022, though there has been a shift in U.S. strategy since Trump's return to office

## Trudeau Hits U.S. Goods with 25% Tariff in Response to Trump's Trade War

Canada: Prime Minister Justin Trudeau has imposed a 25% tariff on U.S. goods, responding to U.S. President Donald Trump's sweeping tariffs on Canadian imports. Trudeau called the move a "trade war" that would ultimately "harm American families?

Speaking from Parliament Hill, Trudeau criticized Trump's decision as "dumb" and questioned the logic of collaborating with Russian President Vladimir Putin while targeting Canada, a close ally. He stated, "Today, the United States has launched a trade war against Canada, its closest partner and ally."

In retaliation, Canada has levied 25% tariffs on \$155 billion worth of American goods, starting with \$30 bilimmediately and the



remaining \$125 billion in 21 days. Trudeau also pledged to challenge the U.S. tariffs at the World Trade Organization, arguing that they violate the free trade agreement between the two nations.

Trudeau warned that the tariffs would drive up inflation imports. He urged Trump to reconsider, stressing the need for cooperation to secure prosperity for North America. "There is absolutely no justification for these tariffs," he added.

The Canadian government announced support measures for citizens affected by the trade war, including expanded assistance for those losing jobs and aid for struggling businesses. Trudeau vowed to "relentlessly fight" to protect Canada's economy.

# BJP accuses Trinamool of caste survey bias: Diverting resources towards Muslims

**∡**The Bengal unit of the BJP accuses the **Trinamool government** of conducting a caste survey to favour Muslim **OBCs** over Hindu OBCs, calling it communal and <u>illegal.</u>

Kolkata. The BJP has launched fresh allegations against the Trinamool Congress (TMC) government in West Bengal, accusing it of conducting a caste-based benchmark sample survey to benefit Muslim Other Backward Classes (OBCs) at the expense of Hindu OBCs.

The allegations come amid Chief Minister Mamata Banerjee-led party's counterclaims that BJP was

adding fake names to the electoral rolls with the help of the Election Commission of India (ECI) for the 2026 Bengal Assembly polls. Speaking to reporters, BJP General Secretary Jagannath

Chatterjee claimed that the ruling party was using the survey as a tool for political appeasement. He alleged that the West Bengal government is seeking detailed financial data of Muslim communities to redistribute benefits in their favour while sidelining Hindu

"The TMC government is conducting a benchmark sample survey on backward

classes with the intention of diverting resources towards Muslim OBCs. This is a clear attempt at appeasement under the guise of welfare," Chatterjee stated.He further argued that the nature of the survey questions was designed to foster division between communities, calling it "both communal and illegal". Referring to the survey documents shared by the BJP, Chatterjee highlighted certain



questions, including whether respondents had access to water in their locality and whether they shared food with their neighbours.

"Never before in history have we encountered such questions. This is a deliberate attempt to create struck down the OBC list, and now the matter is pending before the Supreme Court," he added.Notably, the controversy stems from a 2024 Calcutta High Court ruling, which

> struck down the OBC status of several castes granted by the state government since 2010, deeming the reservations for public sector jobs and state-run educational institutions as illegal. Following the ruling, Chief Minister Mamata Banerjee had vowed to challenge the decision in the Supreme Court, where the matter currently remains subjudice. The Trinamool

supremo has called the duplication of EPIC (Electronic Electoral Photo Identity Card) numbers in West Bengal an "epic scam" and gave the poll panel a 24-hour deadline to "accept its mistake".

## Rs 30 crore in 45 days: Yogi Adityanath shares success story of Kumbh boatman

Lucknow. Uttar Pradesh Chief Minister Yogi Adityanath on Tuesday rebuffed opposition criticism of the Maha Kumbh, citing a family's massive earnings as proof of the event's economic impact. He claimed that a single family operating 130 boats made Rs 30 crore in profit during the 45-day religious gathering in Prayagraj between January 13 and February 26.

Breaking down the figures in Legislative Assembly, the Chief Minister highlighted that a single boat generated daily earnings ranging between Rs 50,000 and Rs 52,000. The remarkable financial success, he said, underscores the economic opportunities created during the Kumbh Mela for local communities. Reacting to the Samajwadi Party's allegation that the boatmen of Prayagraj were 'exploited', the Chief Minister said, "I am telling the success story of a boatman's family. They have 130 boats. In 45 days (of Maha Kumbh), they have profited Rs 30 crore... This means each boat has earned Rs 23 lakh. On a daily basis, they earned Rs 50,000 to 52,000 from each boat."

Furthermore, the Chief Minister said that the recently-concluded 45-day mega-event, calling it a testament to India's rich heritage and development. "We talk about Sabka Saath, Sabka Vikas. This event has left an indelible mark not just



in India but across the world. Its success will resonate globally for a long time," he said. Yogi Adityanth also slammed the opposition parties for questioning the religious congregation and said that only those who actively participated in the Maha Kumbh can truly understand its significance.

During the Maha Kumbh, several members, parties and organisations made baseless statements. Instead of getting distracted by such remarks, we remained committed to our responsibilities and were witness to the grand event," he said. Adityanath emphasised that an investment of Rs 7,500 crore in the Maha Kumbh yielded a record Rs 3 lakh crore in business, boosting multiple sectors.

## Arvind Kejriwal in Punjab for Vipassana, slammed for convoy: Bigger than Trump's

New Delhi. Amid an ongoing buzz over his potential entry into the Rajya Sabha, Aam Aadmi Party (AAP) Arvind Kejriwal is currently in Punjab to attend a 10-day Vipassana meditation camp. The former Delhi Chief Minister was, however, criticised for his massive cavalcade, with AAP MP Swati Maliwal taking a sarcastic dig, saying the convoy was "bigger than Donald Trump's". Kejriwal and his wife Sunita will attend the meditation course at the Dhamma Dhaja Vipassana Centre near Hoshiarpur, slated to commence on

Accompanied by the cavalcade, which included more than 100 Punjab Police personnel and bulletproof vehicles, the couple arrived at the Forest Rest House in Chohal, about 14 km from Hoshiarpur, late Tuesday night.In a tweet on Wednesday, Maliwal, the AAP Rajya Sabha MP, who recently accused Kejriwal of shifting priorities for power following speculations that he may enter the Upper House from Punjab, asked why he was "so afraid of the people of Punjab who have

g i v e n s o m u c h love"."Kejriwal, who criticises the whole world for VIP culture, is today roaming around with a security cover bigger than Donald Trump," she quipped.

Also criticising the former Chief Minister, Delhi Minister Manjinder Singh Sirsa asked, "What

## TVK chief Vijay demands fair delimitation, questions commission's independence

Tamilaga Vettri Kazhagam (TVK) chief Vijay raised concerns over the delimitation process, emphasising fairness and the need for public consultation. He questioned the independence of the Delimitation Commission, arguing that its head is appointed by the ruling government.

New Delhi. Tamilaga Vettri Kazhagam (TVK) chief and actor Vijay raised concerns over the proposed delimitation process, urging fairness and public consultation. In a fivepage statement, he emphasised that his party is not against delimitation but stressed that no state should lose its rightful representation in Parliament due to constituency redistribution.

Vijay argued that instead of simply increasing the number of parliamentary seats in the 543member Lok Sabha, alternative solutions should be explored. He suggested leveraging technology,



enhancing governance mechanisms, and ensuring better ballot representation to address issues of representation. The focus, he said, should be on public welfare, industrial growth, quality education, and sustainable development, rather than just expanding the number of Mps.

Highlighting global democratic practices, Vijay pointed out that several parliaments have provisions like the "Prime Minister's Question Time," where leaders directly address representatives' concerns. One of his criticisms was directed at However, in India, he noted, such structured opportunities for direct political accountability are

lacking. He questioned whether increasing the number of MPs alone would lead to better governance, asserting that fundamental issues like political integrity, accountability, and direct public

engagement must be addressed first. "The issue is not about the shortage of MPs." The real concern is not the number of representatives but ensuring fair democratic representation. This is a matter of principle rather than just a numerical increase in seats," he said.

Tamilians, even children, know what language they need," he said

Tamil Nadu has viewed the three-language formula as an attempt to impose Hindi on the state, while the Centre has argued that the policy was meant to ensure that youth get employment across regions.

On the proposed delimitation, which will adjust parliamentary constituencies based on population, Haasan said there was no need to

# Myths of Shimla's Mall and Scandal Point


I have received calls from friends asking about the origin of the word 'Mall'. These enquiries have been tied to Shimla's eponymous and famous promenade. A little bit of truth, mixed with a substantial amount of falsehood, has been passed around somewhat convincingly and seems to have been quite effective. This is still doing the rounds like a never-ending wheel on the Internet and on that fount of infinite knowledge, 'WhatsApp forwards'. One claim was that the word 'Mall' is an acronym for 'Married Accommodation Living Lines'. In some, the word 'Married' has been substituted for 'Military'. Well, the military had its lines at a considerable distance from Shimla's Mall and unless the living was done under shop counters and in drawers stuffed with linen, the story is as false as many of the others that have been connected with the street. That is not to say that people did not live on the Mall. Many shopowners or bankers lived above their commercial premises. These shop-houses were something that gave the place much of its character and ensured that the Mall remained lively even after the banks had closed, and the shops had pulled down their shutters. It did not seem like the deserted places that Chandigarh's Sector 17 or New Delhi's Nehru Place become after shop hours.

Across India, apart from Shimla, many colonial towns or westernised expansions of older cities had a Mall — Lahore, Amritsar, Mussoorie, Kasauli and Darjeeling, to name just a few. While the process of transfer of the word 'Mall' from England to far-flung former colonies, taking on the role of a 'high street', remains open to calculated conjecture, there is no doubt that it originated in London. There is the kilometre-long Mall that connects Buckingham Palace to Trafalgar Square and continues to serve as a ceremonial route. The second, also in London, is the famous and fashionable Pall Mall, which goes back to the 17th century and is lined with smart shops and clubs. Both owe the origin of their names and purpose to the game of 'pall-mall', or 'pell-mell', a precursor of croquet and played with a ball and mallet. In turn, the English word for the game is derived from the Italian pallamaglio, meaning a 'ball and

Other whiffs of false news, fake stories and accepted reality have also meandered over the Mall. One being that no Indians were permitted there. Any number of old photographs belie this fact. Also, there was an overwhelming number of Indians who owned shops and other establishments and almost all the staff were Indian. This, however, does have a small ring of truth. There was a municipal bylaw that proclaimed that no jobporter or 'coolie' would 'solicit employment, loiter or carry loads' during the evenings on specified streets — including the Mall. This bylaw was twisted to include 'ill-dressed' Indians and later, to khadi-clad freedom fighters, who would be hustled off the street.But perhaps nothing has been as accepted as the multiple myths of Scandal Point. Sadly, the most salacious story of them all is that there was no scandal. When the soon-to-befamous Rudyard Kipling came to Shimla, the 'summer capital' of India, he wrote of its glittering social swirl and endless gossip. He created a world that was part-fiction, part-fable and part-reality. Those word-images are still with us. In 1888, Kipling's story 'The Education of Otis Yeere' was first published. Of his creation, two characters appear in the story. There is Mrs Mallow and the formidable Mrs Hauksbee, who "...was sometimes nice to her own sex", while she had "the wisdom of the Serpent, the logical coherence of Man, the fearlessness of Child and the triple intuition of the woman". It is in this story that the phrase 'Scandal Point' first appears in print: "Your salon would become a glorified Peliti's," says Mrs aint' by lamplight this moment on, this phrase from Kipling's pen enters perceived reality and with passing years, steadily gathers more stories. Going by the popular tale, a Maharaja of Patiala carried off a British Viceroy's daughter (or wife) from this spot on Shimla's Mall.

## At Corbett park, once more

Credit for raising awareness in our natural world must be given to the British



faithful dog, Robin, followed him wherever he went and his jungle tales make for fascinating reading no matter how many times you may have read them. Corbett's home in Nainital, Guerney House, was close to where we lived in Ayarpata, a thickly-wooded part of Nainital where many old zamindar and taluqdar families had cottages and homes to escape the heat and sultry

monsoons of the plains. The Terai was also where many refugee families from West Punjab were allotted farms to compensate for the lands they had left behind. In the 1950s and 1960s, the Terai was a marshy, unhealthy tract full of tigers, snakes and killer malarial mosquitoes. This is why many chose to send their families and children to the cooler hills just hours away and study at the public schools Nainital was famous for.

This long introduction is because when I went to the lovely resort we stayed in this time, I was delighted to meet the person who runs it as he turned out to be the grandson of someone we knew as the Raja of Pilibhit. I remember Pilibhit House, where his grandparents lived in (now run as a posh hotel), and one of his aunts was in school with me. There is something about the Kumaon hills that compels you to come back over and over again. Each time I go, I get the feeling of returning to my mother's womb. In fact, I can name the exact spot where this happens. Chatting with the owner of this delightful Riverview Retreat, I felt I had met a soulmate because he spends most of his time here while running his huge chain of hotels and resorts. The Corbett Park is strictly guarded and only the old Forest Department dak bungalow (named Dhikala) is inside the park. Naturally, you need serious sarkari connections to be able to stay there, so a number of resorts have sprung up all the way from Ramnagar to the forest limit of the Corbett National Park. Spread over 2,800 sq km and divided into six zones, you have to be very lucky to spot a tiger. On the first day of our morning safari, I'm afraid, all the tiger had left for curious visitors was a lump of shit to let us know what he thought of idiots like us. Sadly, elephant safaris are not allowed any longer, so we were stuffed into an open jeep that made such a racket that only monkeys and langoors stayed on to



see what fools announce their entry so noisily. However, on our next safari, in another zone, we finally managed a tiger sighting and all the noisy chatter from other jeeps with cranky kids and chattering adults came to a halt. The magnificent king of the jungle is the lord of all he surveys and we could only gape at the confidence of his royal gait as he walked across the savannah grass.

Believe me, a visit to a natural wildlife park is what all parents of young children must make. Quite apart from the serenity and silence of the forest is the feeling that Man is the lowest form of life on earth. Watching a tiger in a zoo will never show you the magnificent camouflage the savannah grass and stripes provide this regal animal. It takes the trained eye of a guide to spot pugmarks and observe the claw marks on a tree trunk to calculate when a tiger last passed that route. The alarm system set in motion by the parakeets, the barking deer and the chattering monkeys warns the deer that they are being stalked. I am sad that our schoolchildren are rarely taken on expeditions to familiarise them with the flora and fauna of the country. Discovery Channel or Animal Planet can never replace the thrill of actually being able to hear, see and experience the beauty of the Indian

A museum has been created by the Forest Department where, apart from the stuffed animals, simulated sounds of rain and thunder are played in a dark room for visitors to demonstrate how frightening the sound of thunder and the crack of lightning can be when you are in a forest at night. The stygian darkness of a stormy night or the eerie feeling that you are being watched can send shivers down the spine. Credit for raising awareness in our natural world must be given to the British, who were intrepid walkers and left a valuable legacy of records. Today, our Forest Department officers ensure that this legacy is

# Scientific spirituality, is it possible


Science, to me, is not just about the latest technology, medicine and other gadgets. It is a humanistic and ethical way of living. Science guides me how to deal with my professional, emotional and psychosocial needs, fears and anxieties. I derive all my ethical principles and actions from science. In recent times, with generally fading practices of the ritualistic aspects of organised religions, a trend is emerging trying to blend the rationality and objectivity of science with the subjective faith of religion and spirituality. Is it possible, meaningful and necessary to do so?I wish to share my understanding of what is scientific thinking, and what is the scientific way of life. Science inspires me to live a good life in an ethical, responsible, and joyful manner. Being a lifelong student, researcher and teacher of science, my understanding of the foundational elements of scientific thinking are as follows:1. Science is not any supernatural and transcendental knowledge revealed to one person or a select group of people in one step or in a short span of time.2. Scientific knowledge is a collective and continuous derived chain of explanations put forward by human beings to resolve the queries, questions and doubts about the natural universe.3. Scientific explanations are ad hoc and can

be repeatedly modified, revised or changed based on new observations and facts.4. Science neither claims nor tries to search, discover or reveal any ideal, perfect, absolute and single eternal truth.5. Scientific explanations are eventually evident and testable, and these are neither dependent upon nor based on the will of any real or imaginary entity.

Science thrives and evolves by questioning and challenging its concepts, observations, facts, beliefs, and persons.7. Scientific concepts, values and technologies apply equally to all.It is not enough to know theoretically what is science, and then claim that I have a scientific attitude and way of life. It is crucial to be also able to recognise the "unscientific" in our behaviour. According to me, I will be unscientific: 1. If I have an unquestionable belief, faith and devotion in one or more assumed transcendent powers or entities imagined to be omnipresent, omniscient, eternal and supernatural.2. If I perform any kinds of prayers, and other acts and rituals out of want, fear or helplessness in handling uncertainties and emotional challenges of life.3. If I consider others whose ways of living, dressing up, food habits and physical appearances are different from mine, as being bad, inferior and sinful;



Punjab's move reflects a broader demand — one that seeks not just recognition but also respect for India's linguistic plurality. The real challenge,

however, is ensuring that this respect translates into policies that empower all languages, not just a select

## Repositioning God as a marketable product

The spiritual and ascetic in Hinduism has been replaced with the commercial and extravagant



Hindu religion being one of the main pillars of the BJP's very existence and power play, it has to be constantly glorified, burnished and made larger than life. As Yuval Noah Harari asserts, a religion is not just its deities but also the social functions it performs. The BJP's aim is to ensure that one of these 'social functions' is legitimising and consolidating its power and narrow worldview. Given these high stakes, Hinduism can no longer be left to the tender mercies of the Shankaracharyas, Mahamandeleshwars, priests, purohits or the humble devotee and pilgrim in the villages. It must be ornamentalised, over-hyped and aggrandised, made a TV spectacle, a platform for projecting the party and the PM as its prime custodian.

This is a continuation of a medieval mindset we thought the modern world had left behind: did not the emperors and kings of that time build cathedrals, pyramids, gigantic statues, temples and monuments to perpetuate their own myths, dogmas and personalities, to remain in the public eye and memory? Were kings and pharaohs not considered embodiments of the divine power? Religion may be fiction, so it has to be dressed up, for the



swallow it.

It is in this backdrop that we must understand this government's hostile takeover of religion, and its obsession with the Disneyfication of our religious places and the conversion of all major Hindu festivals into a Cecil DeMille type of Hollywood productions. A few recent instances will help to establish this point:

n The inauguration of the new Parliament building on May 28, 2023, was done with the splendour of a Roman coronation, complete with the Sengol substituting for a sceptre and a procession of high priests. A secular political function was transformed into a religious one.

The consecration of the Ram temple in Ayodhya, built at a reported cost of Rs 1,800 crore, was an even grander event, the tempo having been built up for weeks before, like some gladiatorial show at the Colosseum.

- grander the fiction, the easier it is to get the public to n The Kashi Vishwanath corridor, which will cost Rs 800 crore when all its phases are complete, was hyped up as the rebirth of Varanasi, another re-affirmation of a resurgent Hinduism; the destruction of hundreds of houses and private temples to make way for the corridors was, of course, acceptable collateral damage.
  - n The Char Dham Highway, ripping through the heart of the Himalayas and built against all environmental considerations, is again an emblem of religious revivalism, even though it is rationalised on strategic defence grounds. It will cost about Rs 12,000 crore.
  - n A dedicated and wholly unnecessary highway is being built for the Kanwariyas in UP at a cost of Rs 650 crore and a reported 33,000 trees, once again to project religion in a larger-than-life format and to milk religious
  - n The exaggerated claims of the Maha Kumbh, its

deafening publicity and 24x7 media coverage, the Guinness scale of infrastructure created at a reported cost of Rs 7,000 crore (and Rs 5,000 crore by the Railways) is again meant to amplify the same message.

t's the same with festivals. The Kumbh has been celebrated since time immemorial, but the frenzy this year was unprecedented, with even Blinkit homedelivering sangam water, dips being offered online, and someone else taking a dip on your behalf for a nominal charge! I have lived in Delhi for 50 years, but have never witnessed occasions like Ganesh Chaturthi, Chhat Puja or Kanwariya yatras being magnified to the kind of spectacles we witness nowadays. This resurgence of a placid faith is clearly contrived, funded and Disneyfied with a purpose.

Somewhere along the way, the spiritual and ascetic in Hinduism has been replaced with the commercial and extravagant, to serve the 'function' of a political party. Which should not surprise anyone, because religion has always been a business and tool for power. As Prof Paul Seabright says in his extraordinary book, 'The Divine Economy', the divine science (religion) has always had a large element of the dismal science (economics) mixed with it. It offers a product (salvation), has a network of providers (priests) and well established distribution channels. There are many 'products' in the market (Christianity, Islam, Hinduism, Buddhism, etc) and they all compete with each other for market share.

It should not surprise anyone, therefore, that the corporatisation of Hinduism now has a righteous, if not liturgical, angle to it, to serve a political purpose. It has become a bustling share market where the common investor gets returns in divine indulgence, and the new corporates in votes. And those who do not buy into this stock market are the new kafirs. Nietzsche famously said that God is dead. He was wrong — God has now been repositioned as a marketable product.

## टैरिफ वॉर की आशंका से सहमा शेयर बाजार, लगातार १०वें दिन निफ्टी में गिरावट

नई दिल्ली। टैरिफ वॉर तेज होने की आशंका के कारण घरेलू शेयर बाजार एक बार फिर गिरावट के साथ बंद हुआ?। निफ्टी ने आज लगातार 10वें कारोबारी दिन लाल निशान में अपने कारोबार का अंत किया। सेंसेक्स आज 73 हजार अंक के स्तर से नीचे फिसल कर बंद हुआ। इंडेक्स शेयरों के विपरीत स्मॉल और मिडकैप शेयरों में खरीदारी होती रही। बाजार खुलते ही लिवालों और बिकवालों के बीच खींचतान शुरू हो गई, जिसकी वजह से दिन भर शेयर बाजार की चाल में भी उतार-चढ़ाव होता रहा। पूरे दिन के कारोबार के बाद सेंसेक्स 0.13 प्रतिशत और निफ्टी 0.17 प्रतिशत

की कमजोरी के साथ बंद हुए। आज दिन भर कारोबार के दौरान पब्लिक सेक्टर एंटरप्राइज, ऑयल एंड गैस तथा एनर्जी सेक्टर के शेयरों में खरीदारी होती रही।

इसी तरह बैंकिंग, कैपिटल गुड्स, कंज्यूमर ड्यूरेबल, हेल्थ केयर और मेटल इंडेक्स भी बढ़त के साथ बंद हए। आईटी, ऑटोमोबाइल, टेक और एफएमसीजी सेक्टर के शेयरों में बिकवाली होती रही।

इंडेक्स शेयरों में बिकवाली होने के बावजूद ब्रॉडर मार्केट में आज खरीदारी होती रही. जिसके कारण बीएसई का मिडकैप इंडेक्स 0.08 प्रतिशत की मजबती के साथ बंद हुआ। इसी तरह स्मॉलकैप इंडेक्स ने 1.28 प्रतिशत की तेजी के साथ आज के कारोबार का अंत किया। आज मिडकैप और स्मॉलकैप शेयरों में हुई खरीदारी के कारण बाजार की कमजोरी के बावजूद स्टॉक मार्केट के निवेशकों की संपत्ति में 95 हजार करोड रुपये से अधिक की बढ़ोतरी

बीएसई में लिस्टेड कंपनियों का मार्केट कैपिटलाइजेशन आज के कारोबार के बाद बढ़ कर 384.97 लाख करोड़ रुपये (अस्थाई) हो जबिक पिछले कारोबारी दिन गया. यानी सोमवार को इनका मार्केट कैपिटलाइजेशन 384.01 लाख करोड़ रुपये था। इस तरह निवेशकों को आज के कारोबार से करीब 96 हजार करोड़ रुपये का फायदा हो गया। आज दिन भर के कारोबार में बीएसई में 4,086 शेयरों में एक्टिव ट्रेंडिंग हुई। इनमें 2,217 शेयर बढ़त के साथ बंद हुए, जबकि 1,740 शेयरों में गिरावट का रुख रहा, वहीं 129 शेयर बिना किसी उतार चढ़ाव

नई दिल्ली। ऑटोमोटिव कंपोनेंट निर्माता बेलराइज इंडस्ट्रीज लिमिटेड को आरंभिक सार्वजनिक निर्गम (आईपीओ) लाने के लिए भारतीय प्रतिभृति एवं विनिमय बोर्ड (सेबी) से मंजूरी मिल गई है। कंपनी की योजना इस इश्यू के जरिए 2,150 करोड़ रुपये जुटाने की है। बेलराइज इंडस्ट्रीज ने 19 नवंबर, 2024 को सेबी के पास अपना आईपीओ लाने के लिए कागजात दाखिल किए थे। पूंजी बाजार नियामक के मृताबिक बेलराइज इंडस्टीज को आईपीओ के जरिए 2,150 करोड़ रुपये जुटाने के लिए मंजुरी मिल गई है। कंपनी का 5 प्रति इक्रिटी शेयर के अंकित मूल्य वाला यह आईपीओ पूरी तरह से 2,150 करोड़ रुपये तक का नया इश्य है, जिसमें बिक्री के लिए कोई ऑफर फॉर सेल (ओएफएस) का प्रस्ताव नहीं हैं। कंपनी के मुताबिक वह इश्यू से प्राप्त धनराशि के एक हिस्?से का उपयोग कर्ज के भगतान के लिए 1,618 करोड़ रुपये करने का इरादा रखती है। पुणे स्थित ऑटोमोटिव कंपोनेंट कंपनी बेलराइज इंडस्ट्रीज लिमिटेड दोपहिया, तिपहिया, चार पहिया, वाणिज्यिक वाहनों और कृषि वाहनों के लिए सुरक्षा संबंधी महत्वपूर्ण प्रणालियों और अन्य इंजीनियरिंग समाधानों की विविध रेंज पेश करती है। कंपनी के उत्पाद पोर्टफोलियो में मेटल चेसिस सिस्टम, पॉलीमर कंपोनेंट, सस्पेंशन सिस्टम, बॉडी-इन-व्हाइट कंपोनेंट और एग्जॉस्ट सिस्टम आदि शामिल है। कंपनी के प्रमुख ग्राहकों में बजाज ऑटो लिमिटेड, होंडा मोटरसाइकिल एंड स्कूटर, हीरो मोटोकॉर्प लिमिटेड, जगुआर लैंड रोवर लिमिटेड और रॉयल एनफील्ड मोटर्स लिमिटेड जैसे प्रमुख बहराष्ट्रीय ओईएम शामिल हैं।

Gambhir hoped that India can produce that "perfect game" in the Champions Trophy title clash on March 9.

'We still have one more game to go. Hopefully, we can play a perfect game. We want to keep improving, we want to be ruthless on the cricket field but absolutely humble off the field as well," he added.India have taken some bold calls such as playing four spinners, promoting Axar Patel to No. 5 and pushing down KL Rahul to No. 6 to suit the



It may look illogical from the outside but for Gambhir they were minor pieces in the grand plans of keeping the players "out of the comfort zone" to extract the best out of them.

I think cricket is all about being out of your comfort zone, and that is how you grow. If everyone is in their comfort zone, then there is stagnation. So, I believe, and you've seen the results. I know you guys will keep going back to 3-1 in Australia. But everyone in the dressing room is staying out of the comfort zone be it the coaching staff, be it the players and hopefully we continue to do what is important for Indian cricket," he said.

At some stage in the near future, Gambhir will have to sit down with some senior players to study about their future plans.

But for now, the former Indian opener is focussing on the Champions Trophy final without losing sight of that important and impending discussion."I'm someone who tries to stay, as much as I can, in the present and at the moment, all I can say is that the entire focus is going to be on the game which is on the 9th. The 35-year-old, who was leading the world champion side in the absence of an injured Pat Cummins, informed his teammates after the match that he would be stepping away from th 50-over format with immediate effect.Reflecting on his decision, Smith said it was the right time to step aside as Australia builds itself for the 2027 ODI World Cup."It has been a great ride, and I have loved every minute of it," Smith said.

"There have been so many amazing times and wonderful memories. Winning two World Cups was a great highlight along with the many fantastic team-mates who shared the journey," he added in a media release shared by Cricket Australia.A key member of Australia's victorious 2015 and 2023 ICC World Cup-winning teams, Smith was named Australia's men's ODI Player of the Year in 2015 and 2021 and earned a place in the ICC men's ODI Team of the Year in 2015.

He took over the ODI captaincy in 2015 and, fittingly, led the side one last time in his final

Rice was afforded far too much space in the PSV box, allowing him to chip a cross to the far post, gratefully headed home by Arsenal's own flying Dutchman, Jurrien Timber. The visitors doubled their lead shortly afterwards following more generous Dutch defending.Lewis-Skelly, the 18-year-old English defender, found himself in acres of space in a dangerous area, squaring to fellow teenager Nwaneri, who smashed the cross into the top corner.PSV's shambolic defending turned to embarrassment as Arsenal made it three after just over half an hour played. The defence squandered four chances to make an easy clearance, the ball eventually falling to makeshift striker Mikel Merino, who rolled past Walter Benitez. It was a lifeline for the Dutch champions, who went into half-time 3-1 down after a breathless first 45 minutes.Lewis-Skelly meanwhile had been substituted, arguably fortunate to escape a second yellow card after a clumsy challenge on Richard Ledezma.

#### **Amitabh Bachchan Asked For THIS To Capture His Emotions During Baghban Climax:** 'Mere Andar Bhara Hua Hai'



alim-Javed, the famous screenwriting duo behind hits like Deewaar and Sholay in the 1970s, are respected icons in Indian cinema. Although they split and never worked together again, many may not know that they contributed to Ravi Chopra's Baghban. The film's story was written by B.R. Chopra, with dialogues by Achala Nagar, but Javed Akhtar wrote the emotional climax where Amitabh Bachchan's character delivers a heartfelt speech. Salim Khan wrote the dialogues for Salman Khan's character. In a recent interview with Pinkvilla, Renu Chopra, Ravi Chopra's wife, shared these details. between Salim



Renu remembered that the climax scene, where Amitabh's character receives an award and speaks about giving everything to his children, was 11 pages long. After reading it, Amitabh asked Ravi for three days to prepare for the shoot at a hotel. He told the director to use as many cameras as needed because he knew he couldn't capture the emotions again. They set up three cameras and began filming. Renu recalled Amitabh saying, "Mere andar bhara hua hai (It's all inside me, bursting to come out.)'

In the same interview, Renu Chopra, shed light on the challenges they encountered while making and distributing the film. Renu revealed that finding a distributor for Baghban was no easy feat, as most dismissed the project as "old-fashioned." "The film struggled during its first four days in theaters. Ravi even questioned why he made it. But everything changed on the following Tuesday, and the film picked up momentum," she recalled.

Skepticism about the project wasn't limited to distributors. Legendary filmmaker BR Chopra, Ravi's father, was also doubtful. The original story, penned by BR Chopra two decades earlier, was reworked by Dr. Achala Nagar. "Ravi's father discouraged him from making Baghban, saying it was outdated. Many believed films like Avtaar and Zindagi had already explored similar themes. But Ravi saw it differently—not as a social drama but as a love story between an elderly couple," Renu explained.
